**RACE 1: MORPHETTVILLE EQUINE CLINIC / SABOIS THREE-YEAR-OLD BENCHMARK 60**  
**HANDICAP - 1210 metres**

**MIRTHDALE** (T. Pannell) – rolled out in the vicinity of the 100 metres onto LADY CONQUISTADOR.

**GREEN GRASS** (V. Wong) – struck a perimeter fence in the mounting yard. Underwent a pre-race veterinary examination and passed fit to race. Laid in under pressure in the straight. In the vicinity of the 100 metres shifted in onto LADY CONQUISTADOR. Rider reminded of his obligations when his mounts commence to shift ground. A post-race veterinary examination revealed no visible abnormalities.

**HARDASHIAN** (D. Caboche) - A post-race veterinary examination revealed no visible abnormalities.

**LADY CONQUISTADOR** (S. Fawke) – had to be steadied in the vicinity of the 100 metres when disappointed for a run between MIRTHDALE, which rolled out slightly at the same time as GREEN GRASS laid in.

**HORIZON WATCH** (C. Davies) – jumped away awkwardly and was slow into stride. Raced keenly in the early and middle stages of the event.

**RACE 2: LINCOLN RURAL SUPPLIES BENCHMARK 80 HANDICAP - 1390 metres**

**KILLAWARRA** (T. Pannell) – shifted out on jumping away contacting LAKE JACKSON.

**LAKE JACKSON** (J. Maund) – shifted in on jumping away contacting KILLAWARRA.

**RACE 3: VAL HANCHANT MEMORIAL / SABOIS MAIDEN PLATE - 1390 metres**

**AL ZAFIR** (C. Davies) – contacted on jumping away.

**CAPTAIN OASIS** (A. Lindsay) – shifted out on jumping away onto MR JAZZ MAN.

**MR JAZZ MAN** (S. Fawke) – hampered on jumping away when tightened between CAPTAIN OASIS and PENGE. A post-race veterinary examination revealed no visible abnormalities.

**PENGE** (S. Cahill) – shifted in on jumping away onto MR JAZZ MAN. Laid in under pressure in the straight.

**SHEZA PROPHET** (D. Caboche) – shifted in on jumping away contacting AL ZAFIR.

#### **RACE 4: FIRE EQUIPMENT & MAINTENANCE GROUP / SABOIS MAIDEN PLATE - 1000 metres**

The start of this event was delayed approximately five minutes.

**HARDAZ** (S. Cahill) – laid in under pressure in the straight. In the vicinity of the 150 metres was inconvenienced when taken wider by **ETHELAIDES**.

**WHISTLING MIKADO** (K. Bishop) – knuckled on jumping away and shifted out onto **TELEPHON QUEEN**.

**WHITWAY** (A. Lindsay) – shifted in on jumping away onto **TELEPHON QUEEN**. Had to be checked in the vicinity of the 600 metres when **ETHWLAIDES** shifted in.

**GLOSSY GANODERMA** (J. Maund) – held up from the vicinity of the 400 metres until the entrance to the straight.

**LOOK ABOUT** (B. Paterson) – bucked en route to the start dislodging B. Paterson. Galloped riderless for a short distance prior to being re-captured. Underwent a pre-race veterinary examination and passed fit to race. Rider was uninjured in the incident, however, advised Stewards that he was withdrawing his services from this event. **LOOK ABOUT** was a late scratching at 5.00 pm. Trainer advised that the mare would be required to proceed to the start without delay in an Official Barrier Trial prior to accepting for a future race.

**ETHELAIDES** (V. Wong) – underwent a pre-race veterinary examination as it was in an adjoining stall to **FLOP** and passed fit to race. Jumped away awkwardly. Raced extremely greenly throughout the event. In the vicinity of the 600 metres shifted in abruptly onto **WHITWAY**. In the vicinity of the 150 metres shifted out abruptly onto **HARDAZ** taking that gelding wider. Trainer advised a warning had been placed on the filly in relation to its racing manners.

**FLOP** (D. Caboche) – difficult to load. After being loaded, became fractious and reared over in its stall. Underwent a pre-race veterinary examination and ruled unfit to race. A late scratching at 5.08 pm. Trainer advised that the filly would be required to load without delay and be tractable in the barriers prior to accepting for a future race.

**TELEPHON QUEEN** (C. Davies) – hampered on jumping away when tightened between **WHISTLING MIKADO** and **WHITWAY**.

**WITCH KID** (S. Fawke) – proved extremely difficult to load. Trainer advised the filly would be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

#### **RACE 5: AIT SPECIALISTS BENCHMARK 72 HANDICAP – 1000 metres**

**MY LESSON** (S. Cahill) - jumped away awkwardly.

**HEAVENS FLIGHT** (B. Paterson) - jumped away awkwardly. Inclined to lay in under pressure in the straight.

**ROMULUS FLIGHT** (D. Caboche) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 6: PORT LINCOLN GOURMET MEATS BENCHMARK 60 HANDICAP - 1390 metres**

**SLIDE OF HAND** (D. Caboche) – rolled in at the entrance to the straight inconveniencing **TICKET TO PARIS**. Shortly after, the gelding commenced to shift out under pressure and in the vicinity of the 150 metres shifted onto **TICKET TO PARIS**, which was obliged to take hold and alter course to **SLIDE OF HAND'S** inside to obtain clear ground. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 10 February and to conclude at midnight on Thursday, 15 February 2018: a period of three meetings.

**HOW JAMMY'S THAT** (J. Maund) – shifted in on jumping away onto **BOUTONNIERE**.

**TICKET TO PARIS** (S. Fawke) – inconvenienced at the entrance to the straight when **SLIDE OF HAND** rolled in. In the vicinity of the 150 metres had to take hold and alter course to the inside of **SLIDE OF HAND** to avoid the heels of that gelding.

**BOUTONNIERE** (B. Paterson) – contacted on jumping away.

**RACE 7: VETS ON EYRE BENCHMARK 80 HANDICAP - 1960 metres**

**ROOBOY** (T. Pannell) – inclined to lay out under pressure in the straight, inconveniencing EYE THE WORLD on a number of occasions. Rider reminded of his obligations when his mounts commence to shift ground.

**EYE THE WORLD** (J. Potter) – disappointed on a number of occasions in the straight when attempting tight runs between ROOBOY and LOTION, which both shifted ground and was untested to the line.

**LOTION** (S. Fawke) – shifted in slightly on a number of occasion in the straight onto EYE THE WORLD. Rider reminded of his obligations when his mounts commence to shift ground.

**A CHILLER** (K. Bishop) – lost its position in the vicinity of the 1900 metres when tightened between HEZA GUNN and TASSIE.

**TASSIE** (D. Caboche) – inclined to shift about under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HEZA GUNN** (B. Paterson) – raced keenly in the early stages of the event.

**RACE 8: LAWRENCE & HANSON BENCHMARK 60 HANDICAP - 1210 metres**

**INVINCIBLE ME** (A. Lindsay) – inconvenienced on jumping away when contacted by THE HEADLINER.

**THE HEADLINER** (J. Maund) – shifted in on jumping away onto INVINCIBLE ME.

**MORE THAN MOST** (S. Fawke) – lost its position on jumping away when tightened onto INVINCIBLE ME by NIPPY LIPPY.

**NIPPY LIPPY** (D. Caboche) – shifted out on jumping away onto MORE THAN MOST.

**NITRO MAGIC** (B. Paterson) – rider reported the mare over-raced in the early and middle stages of the event.
