**RACE 1: NRC MEMBERS / SABOIS PLUS MAIDEN / CLASS 1 PLATE - 2000 metres**

**GO WALLY** (S. Fawke) - jumped away awkwardly. Laid out under pressure in the straight.

**MIEL DE LAGO** (D. Tourneur) - raced keenly in the early and middle stages of the event.

**SPECTRUMS BITE** (R. Hurdle) – held up for clear running from the vicinity of the 500 metres until the entrance of the straight.

**TRY TRY TRY** (J. Potter) - raced keenly in the early and middle stages of the event.

**RACE 2: MINI JUMBUK / SABOIS MAIDEN PLATE – 1000 metres**

**PAARTAPAE** (S. Fawke) – brushed on jumping away when BRADY STREET jumped away awkwardly and shifted out.

**BRADY STREET** (J. Potter) - jumped away awkwardly and shifted out brushing PAARTAPAE. A post-race veterinary examination revealed no visible abnormalities.

**EVERY BREATH** (J. Huxtable) – lost its position shortly after the start when NATLIRUTH shifted out and away from PAARTAPAE. In the vicinity of the 300 metres rider accidentally dropped his whip. Rider pleaded guilty to a charge under AR137(a) for carelessness and was fined \$50.

**JUST WANTO RUN NOW** (E. Finnegan) – rider reported the mare made abnormal breathing noises throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**MISTY HALO** (R. Hurdle) – jumped away awkwardly and shifted out.

**RACE 3: SE SADDLERY / SABOIS MAIDEN PLATE - 1430 metres**

**BRONSKI** (J. Huxtable) – laid in throughout the event. Rider reported the gelding had not travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

**DABAY** (E. Finnegan) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**YADSEMOD** (S. Cahill) – slow into stride. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3: SE SADDLERY / SABOIS MAIDEN PLATE - 1430 metres (Cont'd)**

**SHAKAMBER** (S. Fawke) - slow to begin.

**SHELLEY BANK** (K. Crowther) – slow into stride.

**VEIN CHOICE** (J. Lorensini) – rider reminded of his obligation in relation to AR137(b) in that he failed to ride his mount out to the finish.

**RACE 4: CADGEE PARK RACING BENCHMARK 56 HANDICAP - 1200 metres**

**ATARARTZI** (J. Potter) – a late scratching at 8.53 am on veterinary advice as the gelding was found to be lame.

**NORMANDY LAD** (D. Tourneur) - jumped away awkwardly and shifted out.

**RED QUIRINA** (E. Finnegan) – inconvenienced on jumping away when NORMANDY LAD jumped away awkwardly and shifted out and TRIPLE ESS jumped away awkwardly and shifted in. Rider explained after being inconvenienced shortly after the start, the mare had not travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**TRIPLE ESS** (J. Maund) - jumped away awkwardly and shifted in.

**SWEET DESIGN** (E. Boyd) – inconvenienced on jumping away when NORMANDY LAD jumped away awkwardly and shifted out and TRIPLE ESS jumped away awkwardly and shifted in.

**GREEN VIPER** (A. Lindsay) – inconvenienced on jumping away when NORMANDY LAD jumped away awkwardly and shifted out and TRIPLE ESS jumped away awkwardly and shifted in. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5: BLACKSMITHS CAFÉ BENCHMARK 60 HANDICAP - 1430 metres**

**REDEEKA** (D. Tourneur) - raced keenly in the early and middle stages of the event. Rider reported the gelding made abnormal breathing noises throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**NASEEB** (E. Finnegan) - raced keenly in the early and middle stages of the event.

**RACE 6: MADDIE'S CAFÉ BENCHMARK 64 HANDICAP - 2000 metres**

**BRAEVIEW MISS** (J. Huxtable) – raced ungenerously in the early and middle stages of the event. Rider explained from the vicinity of the 400 metres, he felt, in his opinion, that the mare was awkward in its action and as a result did not ride the mare out in his normal manner. A post-race veterinary examination revealed the mare was lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 7: STORE 21 BENCHMARK 72 HANDICAP - 1200 metres**

**CHESTNUT CHARLIE** (K. Crowther) - jumped away awkwardly, shifted out bumping PASS THE GLASS. At the entrance to the home straight shifted out when insufficiently clear. Rider reprimanded under AR137(a) for careless riding.

**PEPPER THE PIN** (C. Lindop) – at the entrance to the home straight was inconvenienced when CHESTNUT CHARLIE shifted out when insufficiently clear.

**MILLENIA** (K. Bishop) - at the entrance to the home straight was inconvenienced when CHESTNUT CHARLIE shifted out when insufficiently clear.

**PASS THE GLASS** (J. Huxtable) – bumped on jumping away when CHESTNUT CHARLIE jumped away awkwardly and shifted out. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 8: HEARD'S MENSWEAR BENCHMARK 60 HANDICAP - 1000 metres**

The start of this event was delayed approximately two minutes.

**BATTISTONI** (A. Jordsjo) – shortly after the start had to be checked and lost its position when BRIMARVI EQUIADA shifted in when insufficiently clear. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**JOCKA'S TRUCE** (C. Puls) – inside the 100 metres shifted out when insufficiently clear of MISTER FLYN, resulting in that horse being taken out onto THE OTHER GUY, which was inconvenienced when taken wider. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 23 March and to conclude at midnight on Wednesday, 28 March 2018: a period of three meetings.

**BRIMARVI EQUIADA** (S. Fawke) – shortly after the start shifted in when insufficiently clear of BATTISTONI. Rider was found guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 21 March and to conclude at midnight on Sunday, 25 March 2018: a period of three meetings.

**THE OTHER GUY** (J. Huxtable) – fractious in the barriers, reared and became cast. Underwent a pre-race veterinary examination and passed fit to race. Trainer advised a warning had been placed on the gelding. Inside the 100 metres was inconvenienced when taken wider when MISTER FLYN was taken wider by JOCKA'S TRUCE, which shifted out when insufficiently clear.

**MISTER FLYN** (C. Lindop) – inside the 100 metres was inconvenienced and bumped when taken wider by JOCKA'S TRUCE, which shifted out when insufficiently clear.
