**RACE 1: FESTIVAL HIRE / SABOIS MAIDEN PLATE - 1700 metres**

**NEWBOLD LAD** (A. Chan) - jumped away awkwardly and as a result was slow to begin.

**MAYFAIR LADY** (E. Boyd) – rider reported the filly travelled well during the event, however from the vicinity of the 400 metres weakened and was disappointing in its finishing efforts. She further stated in her opinion her mount was not suited to today's distance. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: OMNIZAR / SABOIS MAIDEN PLATE – 1400 metres**

**EVERY BREATH** (K. Bishop) – held up from inside the 400 metres until the entrance to the straight. In the vicinity of the 200 metres was reluctant to improve into a run between SHAKAMBER and DREAM ON GIRL for a number of strides.

**SHELLEY BANK** (E. Finnegan) – stood flat-footed losing several lengths. Trainer advised a warning had been placed on the mare.

**DREAM ON GIRL** (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 3: HEYWARD'S ROYAL OAK HOTEL / SABOIS MAIDEN PLATE - 1100 metres**

**PAARTAPAE** (S. Fawke) – laid out under pressure in the straight.

**RED SKIES** (R. Hurdle) - jumped away awkwardly, shifted out and contacted PEACHEY STREET.

**PEACHEY STREET** (K. Bishop) – contacted on jumping away.

**BEL ROBBIE** (D. Bates) – laid in under pressure in the straight.

**RACE 4: COOPERS BREWERY BENCHMARK 56 HANDICAP - 1700 metres**

**CARAK** (D. Bates) – stood flat-footed missing the start several lengths. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning had been placed on the gelding.

**RACE 4: COOPERS BREWERY BENCHMARK 56 HANDICAP - 1700 metres (Cont'd)**

**BUNUMBURT** (J. Lorensini) – raced keenly in the middle stages of the event.

**RACE 5: DIGIORGIO FAMILY WINES BENCHMARK 60 HANDICAP - 1400 metres**

The start of this event was delayed approximately 15 minutes due to a power outage.

**WOOLSTHORPE STORE** (C. Collins) – slow into stride.

**RHYTHMATIC** (R. Hurdle) – raced keenly in the middle stages of the event.

**KILOWATT** (A. Lindsay) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**QUARCK** (D. Bates) - underwent a pre-race veterinary examination as the gelding struck a perimeter fence en route to the barriers and was passed fit to race.

**RACE 6: ADRIAN THOMAS INDUSTRIAL BENCHMARK 64 HANDICAP- 1400 metres**

**KNIGHTOFTHEREALM** (C. Collins) - jumped away awkwardly and was slow to begin.

**ATHOS** (E. Finnegan) - jumped away awkwardly and was slow to begin.

**SOJU WARRIOR** (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 7: KATNOOK ESTATE PENOLA CUP - 1700 metres**

**MR LEBROCK** (D. Bates) – held up for a short distance on entering the straight.

**RED FELLA** (R. Hurdle) - underwent a pre-race veterinary examination as the gelding had not raced for over 12 months and was passed fit to race.

**HASTA LA THOMAS** (E. Finnegan) – rider reported it was not her intention to settle at the back of the field, however after beginning only fairly, she was not able to obtain a position closer to the speed due to the formation of the field.

**IAMTHEKEY** (J. Potter) – inside the 400 metres shifted in abruptly for no apparent reason. Inside the 200 metres bumped with SATURDAY SORCERER on a number of occasions as that gelding rolled in.

**WANNON WARRIOR** (J. Maund) – over-raced in the early and middle stages of the event. In the vicinity of the 1400 metres got its head up on a number of occasions when being restrained. Inside the 200 metres rolled in bumping IAMTHEKEY on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

**BASSONS** (J. Lorensini) – held up from in the vicinity of the 400 metres until the entrance to the straight.

**RACE 8: WATTLE RANGE COUNCIL BENCHMARK 60 HANDICAP - 1100 metres**

**SIRIUS BLACK** (D. Bates) – Trainer advised the gelding would attempt to settle more forward in today's event. SIRIUS BLACK settled on pace. Laid in under pressure in the straight.

**VISUAL IMAGE** – underwent a pre-race veterinary examination on arrival at the barrier, which revealed nasal discharge. A late scratching at 5.08 pm. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.
