**RACE 1: WESTSIDE VEGIE PATCH / SABOIS MAIDEN PLATE - 1396 metres**

**DESERT MINTY** (K. Crowther) – approaching the 400 metres improved onto the heels of LESONDEA, which was weakening, had to be steadied and lost its position.

**UNCLE KENNETH (NZ)** (A. Jordsjo) – jumped away awkwardly and shifted out. When Stewards questioned the rider as to her reason into not riding her mount out to the finish, she explained that in the vicinity of the 300 metres she became concerned with the gelding's breathing and in her opinion, it may have choked down. She added that for this reason from the vicinity of the 100 metres she elected not to ride her mount out to the finish. When further questioned regarding her decision to again place the gelding under pressure over the concluding stages, she stated that she panicked when being challenged approaching the finish. Stewards advised A. Jordsjo that in future if she has concerns with her mounts she must not continue to place them under pressure. Rider was reprimanded under AR140(b) for failing to report anything that may have affected the runner's performance during the event. A post-race veterinary examination revealed no visible abnormalities.

**LESONDEA** (K. Lau) - jumped away awkwardly and weakened from the 400 metres.

**ONLINE GIRL** (J. Maund) – laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: AUGUSTA COURTYARD MOTEL / SABOIS MAIDEN PLATE - 1100 metres**

**ROBBO'S RESET** (S. Fawke) – raced ungenerously in the middle stages of the event.

**TOUGH TALKIN'** (J. Maund) - jumped away awkwardly and as a result was slow to begin.

**AWESOME STAR** (J. Toeroek) - jumped away awkwardly and shifted in and inconvenienced LOOK ABOUT.

**LOOK ABOUT** (R. Hancock) – tightened for room shortly after the start and lost its position.

**RACE 3: IAN'S CHICKEN HUT BENCHMARK 60 HANDICAP - 1867 metres**

**GRACEFUL WOLF** (R. Clark) – raced keenly in the early and middle stages of the event.

### **RACE 3: IAN'S CHICKEN HUT BENCHMARK 60 HANDICAP - 1867 metres (Cont'd)**

**LEMON ZEST** (K. Bishop) – failed to maintain contact with the field. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr M. Moosha advised a warning had been placed on the mare. Trainer will recommend to owners that mare be retired.

### **RACE 4: IAN'S WESTERN HOTEL BENCHMARK 72 HANDICAP - 1498 metres**

**COPPER COAST RAID**A (K. Crowther) – rider reported she became concerned with the gelding's action in the home straight and for that reason did not ride the gelding out in her usual manner. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**EIGELSTEIN (GB)** (G. Lo) – contacted shortly after the start and taken wider on the track.

**IT'S HUMPHREY** (R. Sakai) - jumped away awkwardly, shifted out and contacted **EIGELSTEIN (GB)**.

**PARENTIVE** (S. Fawke) – rider reported the gelding failed to respond to his riding in the early and middle stages of the event. He added that in the vicinity of the 500 metres the gelding started to pick up the bit and finished off the event well. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms P. Trenwith advised that a warning had been placed on the gelding.

### **RACE 5: PORT AUGUSTA BUS SERVICE BENCHMARK 56 HANDICAP – 1200 metres**

**YOU REMEMBERED ME** (K. Bishop) – jumped away awkwardly, shifted out and contacted **JOHN D'NON**.

**JOHN D'NON** (A. Jordsjo) – contacted at the start. Rider dismounted before returning to scale as she became concerned with the gelding's action. A post-race veterinary examination revealed no visible abnormalities. Lost its near hind plate during the event

### **RACE 6: FESTIVAL HIRE BENCHMARK 56 HANDICAP - 1200 metres**

The start of this event was delayed approximately three minutes.

**WHISTLING MIKADO** (R. Sakai) - a post-race veterinary examination revealed no visible abnormalities.

**TYPHON BREEZE** (E. Boyd) – dislodged its rider en route to the barriers and galloped for some distance. Stewards declared **TYPHON BREEZE** a late scratching at 3.32 pm on veterinary advice. Rider was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

**WHITE JADE** (S. Fawke) - jumped away awkwardly and shifted out. A post-race veterinary examination revealed no visible abnormalities.

**TICKLE ME ERNIE** (A. Lindsay) – laid out from the vicinity of the 800 metre until the 500 metres.

**GRAND MARTINI** (K. Bishop) – dipped on jumping away.

### **RACE 7: MOTEL POINSETTIA BENCHMARK 72 HANDICAP - 1100 metres**

**KUNGSLEDEN** (D. Caboche) – raced ungenerously throughout and in the vicinity of the 900 meters shifted out taking **WILANDER PRINCESS** out onto the heels of **CLASSY CARMEN**. A post-race veterinary examination revealed no visible abnormalities.

**WILANDER PRINCESS** (K. Bishop) – in the vicinity of the 900 metres was taken out across the heels of **CLASSY CARMEN** by **KUNGSLEDEN**, which laid out and was obliged to be steadied.

**CLASSY CARMEN** (A. Jordsjo) – rider reported the mare travelled well until in the vicinity of the 600 metres when placed under pressure, failed to respond to her riding and finished the race off disappointingly. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8: MILHINCH HOURGLASS JEWELLERS BENCHMARK 56 HANDICAP - 1396 metres**

The start of this event was delayed approximately two minutes.

**CERUTTY (NZ)** (D. Caboche) - approaching the 1300 metres rolled out.

**ONEWOOD** (M. Henderson) – contacted at the start and as a result was taken wider on the track.

**ORATINI** (K. Crowther) - jumped away awkwardly, shifted out and contacted **ONEWOOD**.

**IRISH MAMBO** (A. Chan) – shortly after the start shifted in onto **DEVIOUS FELLA**.

**MINTRICE** (J. Maund) – in the vicinity of the 1300 metres was taken wider and tightened onto **BALZAC** by **WRIST WATCH**, which shifted out. Rider reported the mare travelled well until the 600 metres when placed under pressure and failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

**WRIST WATCH** (G. Lo) – underwent a pre-race veterinary examination and passed fit to race. In the vicinity of the 1300 metres shifted out and away from **CERUTTY (NZ)** and tightened **MINTRICE**. Laid out under pressure over the concluding stages.

**BALZAC** (R. Clark) – in the vicinity of the 1300metres taken wider and across the running of **ROCKEY VALLEY** by **MINTRICE** contacting and inconveniencing **DEVIOUS FELLA**.

**DEVIOUS FELLA** (S. Fawke) – tightened on jumping away between **IRISH MAMBO**, which shifted in onto **ROCKY VALLEY**. In the vicinity of the 1300 metres was hampered between **IRISH MAMBO** and **BALZAC**, which was taken wider.

**BURGUNDEE MISS** (R. Sakai) – dislodged rider en route to the barrier. Stewards declared **BURGUNDEE MISS** a late scratching at 4.41 pm on veterinary advice. Rider examined by the First Care Medical Personnel and was cleared of injury.

**ROCKY VALLEY** (A. Lindsay) – contacted at the start. In the vicinity of the 1300 metres was obliged to be steadied to avoid the heels of **BALZAC**, which was taken wider on the track.
