Report on Race Meeting held at Balaklava Racecourse

RACE 1: BIRNIE SANDERS HOTEL BROKERS / SABOIS MAIDEN/CLASS 1 PLATE - 2200
metres

PAT THE WEAPON (T. Pannell) – laid in under pressure in the straight.

CALM JUSTICE (S. Fawke) – a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr M. Faust, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DEVIL'S EDGE (A. Chan) – Trainer, Mr J. Frew, advised Stewards that he would instruct his rider to attempt to settle midfield with cover.

SASKO (J. Kah) – laid in under pressure in the straight. Lost its near fore plate during the event.

TURF MAN (J. Bowditch) – laid in under pressure in the straight.

WARRASIDE FAIRY (K. Bishop) – raced three wide without cover throughout the event.

RACE 2: HENSON LLOYD ACCOUNTANTS / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050
metres

CITY BEATS (A. Jordsjo) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RIZSKI (A. Chan) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ST GEORGES VAULTS (T. Pannell) – jumped away awkwardly and shifted in bumping HELPENY.

WHITE HEATH (C. Lindop) – raced greenly throughout the event.

HELPENY (G. Lo) – bumped on jumping away when ST GEORGES VAULTS jumped away awkwardly and shifted in and MABEL JOSEPHINE jumped away awkwardly and shifted out. Inclined to race keenly and greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MABEL JOSEPHINE (J. Potter) – jumped away awkwardly and shifted out bumping HELENY.

SHE'S NEVER LATE (K. Crowther) – jumped away awkwardly and was slow into stride. Inside the 400 metres was inconvenienced when SWEET REBEL shifted in abruptly while racing greenly. A post-race veterinary examination revealed no visible abnormalities.

SWEET REBEL (R. Clark) – Inside the 400 metres shifted in abruptly while racing greenly,

RACE 3: MY BUTCHER - RIVERINE MAIDEN PLATE - 1050 metres

REAL EASY (P. Gatt) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

TECTONIC MOVES (J. Toeroek) – in the vicinity of the 700 metres shifted out whilst racing greenly inconveniencing SHUCK, which was taken wider.

SHUCK (J. Bowditch) – in the vicinity of the 700 metres was inconvenienced when taken wider. Rider reported that the mare felt awkward in its action over the concluding stages. A post-race veterinary examination revealed minor lacerations to near fore knee and near hind cannon.

CALYPSO CLASSIC (A. Chan) – jumped away awkwardly and shifted out bumping VACANCE.

VACANCE (R. Clark) – bumped on jumping away when CALYPSO CLASSIC jumped away awkwardly and shifted out.

RACE 4: ADELAIDE GALVANISING INDUSTRIES / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1400 metres

ALWAYS THE KING (T. Pannell) – racing inside the 1200 metres rolled out marginally bumping SHIRLEY'S EAGLE. Rider pleaded guilty to a charge under AR137A(5)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

CHUBBY RAIN (O. Ridge) – rider pleaded guilty to a charge under AR137A(5)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

GOOD IDEA (D. Caboche) – laid in under pressure in the straight.

HAHNDORF (J. Holder) – inclined to race keenly in the early stages of the event. Racing inside the 1200 metres, whilst racing keenly, improved onto the heels of SHIRLEY'S EAGLE, clipping that gelding's heels and lost its position.

SANT ANGELO (J. Bowditch) – approaching the 1000 metres dipped for no apparent reason.

SHIRLEY'S EAGLE (P. Gatt) – racing inside the 1200 metres was bumped by ALWAYS THE KING and as a result lost its position. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: SAGLE CONSTRUCTIONS BENCHMARK 60 HANDICAP - 1400 metres

FULLY STOKED (D. Caboche) – approaching the 800 metres had to be steadied and lost its position when restraining off heels. From the entrance to the home straight until racing to the 200 metres was held up for clear running.

DE JORVIK (R. Clark) – approaching the 800 metres had to be steadied and lost its position when restraining off heels. From the entrance to the home straight until racing to the 200 metres was held up for clear running. A post-race veterinary examination revealed no visible abnormalities.

PALE ALE (E. Finnegan) – approaching the 800 metres had to be steadied and lost its position when restraining off heels. From the entrance to the home straight until racing to the 200 metres was held up for clear running.

BIG CALL (J. Kah) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

UNFLYNNCHING (J. Toeroek) – raced keenly in the early and middle stages of the event. Approaching the 800 metres had to be steadied and lost its position when restraining off heels.

BURGUNDEE MISS (A. Chan) – from the vicinity of the 800 metres reduced the speed of the race and as a result inconvenienced a number of runners. Rider reprimanded under AR137(d).

RACE 6: UNTOLD SPICED RUM BENCHMARK 60 HANDICAP - 1600 metres

BEAU RIVAGE (J. Toeroek) – in the vicinity of the 1000 metres had to be steadied and lost its position when WISH LIST shifted in and TRAFFIC MAESTRO shifted out marginally. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

TRAFFIC MAESTRO (J. Kah) – in the vicinity of the 1000 metres shifted out marginally. Racing from the entrance to the home straight to the vicinity of the 400 metres was held up for clear running.

BALLAST (E. Finnegan) – rider reported that she was concerned with the gelding's action. A post-race veterinary examination revealed no visible abnormalities.

FANDANGO (J. Potter) – slow to begin.

WISH LIST (R. Clark) – in the vicinity of the 1000 metres shifted in marginally when insufficiently clear of BEAU RIVAGE. Rider severely reprimanded under AR137(a) for careless riding.

RACE 7: COOPERS SESSION ALE BENCHMARK 64 HANDICAP - 1200 metres

ABU DHABI (J. Bowditch) – in the vicinity of the 800 metres was inclined to pull hard and race keenly, and shifted out inconveniencing CERRO BLANCO, which was taken wider. A post-race veterinary examination revealed no visible abnormalities.

BABITZIN (S. Fawke) – at the entrance to the straight was inconvenienced when taken wider when FRENCH ROCK shifted out.

FRENCH ROCK (K. Crowther) – at the entrance to the straight shifted out bumping BABITZIN, which was taken wider.

ROSIE LOUISE (P. Gatt) – difficult to load. Trainer, Mr W. Bencic, was advised that a warning had been placed on the mare in relation to its barrier manners.

CERRO BLANCO (D. Tourneur) – in the vicinity of the 800 metres was inconvenienced when taken wider when ABU DHABI shifted out.

HATTAN MAN (D. Caboche) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 8: TAYLORS WINES BENCHMARK 64 HANDICAP - 1050 metres

WAR THUNDER (A. Lindsay) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

SWISS DESIGN (T. Pannell) – jumped away awkwardly and shifted out.

ROTHMOORE (J. Bowditch) – inconvenienced at the start when SWISS DESIGN jumped away awkwardly and shifted out and CASH IS COMING jumped away awkwardly and shifted in.

CASH IS COMING (K. Lau) – jumped away awkwardly and shifted in.

BOLDACIOUS GIRL (S. Fawke) – was inconvenienced on jumping away when SWISS DESIGN jumped away awkwardly and shifted out and CASH IS COMING jumped away awkwardly and shifted in. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.
