# Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 12 May 2018

#### RACE 1: JEANNERET WINES HANDICAP - 1200 metres

**GO THE JOURNEY** (A. Chan) – shifted in, in the vicinity of the 700 metres onto FALCOOL. Rider severely reprimanded and advised in future to ensure he was sufficiently clear prior to commencing to shift ground.

**BROWN BEN** (K. Crowther) – rider reported that the gelding travelled well in the early and middle stages of the event; however, failed to let down as she had anticipated when placed under pressure.

 $\label{eq:FALCOOL} \textbf{FALCOOL} \ (J.\ Toeroek) - in the vicinity of the 700 metres was inconvenienced and obliged to alter course to the outside of GO THE JOURNEY when that gelding shifted in. Rider reported that the gelding over-raced in the middle stages of the event when GO THE JOURNEY improved to its outside.$ 

**EXALTED ADAM** (D. Dunn) – slow to begin. Lost its near fore plate during the running of the event.

**ROCKETS RED GLARE** (S. Baster) – raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 2: TERRY HOWE PRINTING HANDICAP - 1050 metres

**EXPERIMENTATION** (J. Bowditch) – jumped away awkwardly and shifted out.

**RASPBERRY ROSE (NZ)** (D. Oliver) – hung out rounding the home turn. In the vicinity of the 200 metres rolled in as it commenced to weaken onto BEERZATBERNZ (NZ). Rider reported that the filly did not feel comfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

I AM SOMEONE (D. Bates) – jumped away awkwardly and shortly afterwards was inconvenienced when WHITE KAPS shifted out.

#### RACE 2: TERRY HOWE PRINTING HANDICAP - 1050 metres (cont'd)

**KABINI** (K. Bishop) – raced greenly in the early stages of the event. Tightened in the vicinity of the 700 metres when BEERZATBERNZ (NZ) rolled our slightly at the same time as ZARACE laid in. Had difficulty obtaining clear ground in the straight. Stewards questioned K. Bishop in relation to her options in the vicinity of the 450 metres. Rider explained that she felt that if she had commenced to improve to the outside of ZARACE at that stage that she would expose the filly too far from home and for that reason she elected to alter course back to the inside and ride for luck.

**GOLDEN LUSTRE** (D. Caboche) – hung out rounding the home turn. Rider reported that the filly raced flat. A post-race veterinary examination revealed the filly to be lame in the off foreleg. Trainer, Mr P. Stokes, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**BEERZATBERNZ (NZ)** (J. Kah) – inconvenienced in the vicinity of the 200 metres when RASPBERRY ROSE (NZ) rolled in.

**ZARACE** (T. Pannell) – laid in, in the vicinity of the 700 metres onto KABINI.

### RACE 3: M & J CHICKENS AUTUMN SERIES FINAL - 1400 metres

**TATOOSH** (K. Crowther) – shifted in on jumping away onto MANUEL. A post-race veterinary examination revealed the gelding to have cardiac arrhythmia. Trainer, Mr W. Clarken, was advised the results of an EXG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

**MANUEL** (L. Currie) – lost its position shortly after the start when tightened between TATOOSH, which shifted in, and RAHEEBA, which had been taken out by PLUCKIT. Raced keenly in the early and middle stages of the event.

**SET TO SPARKLE** (J. Kah) – struck a perimeter fence when exiting the mounting yard dislodging J. Kah. Underwent a pre-race veterinary examination and passed fit to start. J. Kah was examined by the First Care Medical personnel and passed fit to ride.

**STRATEGIC GLASS** (S. Baster) – rider reported that the gelding was reluctant to stretch out throughout the event despite his efforts and he had become concerned with its action in the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mrs S. Jaensch, was advised the gelding was now required to perform competitively in an Official Barrier Trial prior to a future race start.

**COSMIC LIGHTS** (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

**PLUCKIT** (A. Chan) – shifted out on jumping away onto RAHEEBA.

**EXALTED TRAVELLER** (D. Thornton) – held up from the vicinity of the 400 metres until inside the 300 metres.

**CRONAUER (NZ)** (G. Cartwright) – laid out rounding the home turn and under pressure in the straight.

**JUST RESTING** (A. Jordsjo) – laid out under pressure in the straight.

**RAHEEBA** (S. Fawke) – rider was permitted to ride this gelding only claiming half a kilogram rather than one kilogram as was required by his minimum riding weight. Rider was fined \$200 under AR120(b) for being overweight. Taken out on jumping away by PLUCKIT, onto MANUEL. Raced fiercely in the early and middle stages of the event.

**DEVILISHLY** (D. Dunn) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

#### RACE 4: UBET SA SIRES' PRODUCE STAKES - 1400 metres

**SECRET BLAZE** (L. Currie) – laid in under pressure in the straight.

**STAR STATUS** (R. Clark) – slow to begin.

#### RACE 4: UBET SA SIRES' PRODUCE STAKES - 1400 metres (cont'd)

**PERSUADER** (M. Walker) – inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**MISS HELLBENDER** (D. Bates) – a post-race veterinary examination revealed a lower than expected heart rate.

**HAVANA HEAT** (J. Bowditch) – raced keenly in the middle stages of the event.

SIR GARFIELD (H. Coffey) – laid in under pressure in the straight.

#### **RACE 5: ADELAIDE GALVANISING ADELAIDE GUINEAS - 1600 metres**

**PEACEFUL STATE** (J. Allen) – shifted in abruptly in the vicinity of the 100 metres onto DANGER DEAL.

SIRCCONI (S. Baster) - jumped away awkwardly and shifted in onto SMOOTH LANDING.

**OVER EXPOSURE** (J. Kah) – jumped away awkwardly.

**DEBT COLLECTOR** (D. Dunn) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**DANGER DEAL** (C. Lindop) – taken in by PEACEFUL STATE in the vicinity of the 100 metres into the running line of LOSTARC.

**CHAROSSA** (J. Bowditch) – raced keenly in the middle stages of the event.

**LOSTARC** (L. Innes) – had to be steadied momentarily in the vicinity of the 100 metres when DANGER DEAL was taken in across its running line.

**SMOOTH LANDING** (D. Lane) – contacted on jumping away.

**BLACK AND TAN** (J. Childs) – slow to begin.

## RACE 6: GOLDIN FARMS PROVINCIAL SUPER SERIES FINAL - 1800 metres

**ENKI** (J. Holder) – approaching the 200 metres attempted a tight run to the inside of NICOISE and was disappointed and had to be steadied momentarily when that gelding rolled in slightly.

**DANCES ON STARS (NZ)** (D. Dunn) – a post-race veterinary examination revealed the geling to be lame in the off hind leg. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

BERTWHISTLE (A. Chan) - in the vicinity of the 200 metres shifted out and brushed GRACENA.

**GRACENA** (K. Crowther) – was held up from the entrance to the straight until the vicinity of the 300 metres when it shifted out across the heels of MORE THAN FABULOUS into the running line of TARANTINA (NZ), which had to be momentarily steadied. Rider was severely reprimanded and advised in future to ensure she was sufficiently clear prior to shifting ground. Inconvenienced and taken wider in the vicinity of the 200 metres when BERTWHISTLE shifted out. A post-race veterinary examination revealed no visible abnormalities.

**ALL BAR TWO** (H. Coffey) – slow to begin.

**NICOISE** (G. Cartwright) – rolled in marginally approaching the 200 metres onto ENKI.

**GRAND ARMADA** (D. Thornton) – slow to begin.

**GOING GAGA** (S. Baster) – got its leg up in the barrier gates after being loaded. Underwent a pre-race veterinary examination and was ruled unfit to start. Late scratching at 3.28 pm. Trainer, Mr M. Hickmott, was advised that a warning had been placed on the gelding in relation to its barrier manners.

#### RACE 6: GOLDIN FARMS PROVINCIAL SUPER SERIES FINAL - 1800 metres (cont'd)

**DR DEPENDABLE** (C. Lindop) – a post-race veterinary examination revealed a minor wound to the near hind heel. First aid administered.

**JUST LIVE ON** (J. Toeroek) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 7: UBET SOUTH AUSTRALIAN DERBY - 2500 metres**

**TANGLED** (M. Walker) – shifted out on jumping away onto BOX ON COLLINS. A post-race veterinary examination revealed no visible abnormalities.

MONEY MAHER (J. Noske) – shifted out at the entrance to the straight and contacted SHERRIF (NZ).

**LEICESTER** (D. Lane) – inside the 100 metres shifted out onto REZEALIENT, which was momentarily inconvenienced as it rolled in.

**CIVIL DISOBEDIENCE (NZ)** (J. Allen) – raced keenly in the early stages of the event. A post-race veterinary examination revealed the colt to be lame in the off hind leg. Trainer, Mr D. Weir, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**MAIN STAGE (NZ)** (D. Oliver) – raced fiercely in the middle stages of the event and in the vicinity of the 800 metres was inclined to shift about, making contact with NOTHIN' LEICA HIGH to its outside and BOX ON COLLINS to its inside.

**SHERRIF (NZ)** (L. Innes) – raced fiercely for a number of strides when in restricted room approaching the 2000 metres. Inconvenienced at the entrance to the straight when contacted by MONEY MAHER. Had difficulty obtaining clear ground for a number of strides inside the 200 metres.

**REZEALIENT** (J. Kah) – rolled in slightly inside the 100 metres at the same time as LEICESTER shifted out under pressure, resulting in the gelding being momentarily inconvenienced.

**INTO RIO (NZ)** (D. Thornton) – raced keenly in the early stages of the event.

NOTHIN' LEICA HIGH (D. Tourneur) - contacted by MAIN STAGE in the vicinity of the 800 metres.

**BOX ON COLLINS** (L. Currie) – jumped away awkwardly and shortly afterwards was inconvenienced when TANGLED shifted out. Contacted by MAIN STAGE in the vicinity of the 800 metres. Was held up from the entrance to the straight until the vicinity of the 300 metres.

### RACE 8: ROBERT & FAY GERARD SA SPRINT SERIES FINAL - 1100 metres

**DESERT LASHES** (G. Cartwright) – examined by the Club's Veterinary Surgeon on arrival on course who reported the mare had injured its off side hip en route to the course and was unfit to race. Late scratching at 1.37 pm.

**SPLIT LIP** (T. Pannell) – rider explained that he settled further back than anticipated due to the barrier draw and the formation of the field. He added that when asked for an effort the filly initially laid in; however, had then finished the race off well. A post-race veterinary examination revealed no visible abnormalities.

**ROCK STATUS** (K. Crowther) – jumped away awkwardly.

**STRAGUN** (A. Chan) – shifted out on jumping away onto AZAZEL.

**BRYAN** (H. Coffey) – slow to begin. Held up from the 400 metres to the 100 metres.

**JUST A BIGGER DASH** (J. Toeroek) – inconvenienced in the vicinity of the 200 metres when TILDY LAD shifted out.

**MILITARY FORCES** (D. Yendall) – a post-race veterinary examination revealed no visible abnormalities.

#### RACE 8: ROBERT & FAY GERARD SA SPRINT SERIES FINAL - 1100 metres (cont'd)

FRANCE'S BOY (R. Clark) – jumped away awkwardly.

**TILDY LAD** (A. Jordsjo) – dipped on jumping away. Shifted out under riding in the vicinity of the 200 metres onto JUST A BIGGER DASH. Rider severely reprimanded and advised in future to make a greater effort to keep her mounts straight when they commence to shift ground.

**AZAZEL** (L. Currie) – contacted on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**INVISIBLE GIRL** (D. Thornton) – inside the 200 metres laid in and became awkwardly placed on the heels of SO YOU TOO.

Correct weight for this event was delayed to allow J. Holder (ASCENDANCE) placed third to view the Official Vision in the straight.
