**RACE 1: HEINEKEN 3 PORT ADELAIDE CUP - 2500 metres**

**MAIL IT IN** (C. Lindop) – over-raced in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**BENZINI** (B. Allen) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**YOGI (NZ)** (D. Lane) – laid in under pressure in the straight.

**DELOS (NZ)** (S. Baster) – rider explained the gelding travelled well in the early and middle stages of the event, however was under pressure at the entrance to the straight and became awkward in its action over the concluding stages. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 2: M&J CHICKENS NATIONAL STAKES – 1200 metres**

**SECRET BLAZE** (L. Currie) – lost its near fore plate during the event.

**MARCEL FROM MADRID** (D. Lane) – shifted in abruptly inside the 100 metres towards TEQUILA TIME.

**HEAVEN'S DEAL** (J. Toeroek) – rider reported the filly did not see out the 1200 metres in today's event. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**GRACEFUL STORM** (D. Dunn) – rider reported the filly was inclined to lay out during the event and had been disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 2: M&J CHICKENS NATIONAL STAKES – 1200 metres (Cont'd)**

**CRACK THE CODE** (D. Oliver) – inconvenienced on jumping away when tightened onto YULONG MERCURY by GRACEFUL STORM. At the entrance to the straight was disappointed when attempting a tight run between GRACEFUL STORM and YULONG MERCURY and was obliged to alter course to obtain clear ground.

**YULONG MERCURY** (C. Parnham) – contacted on jumping away by CRACK THE CODE, which was taken out. Laid in, in the early stages of the event and over-raced. Rider explained, in his opinion, the filly had not handled the track conditions. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 3: UBET SA FILLIES CLASSIC – 2500 metres**

**MISS ADMIRATION** (D. Oliver) - a post-race veterinary examination revealed no visible abnormalities.

**SO YOU LEICA** (B. Allen) – inclined to shift about under pressure in the straight.

**MISS LILLIAN** (S. Baster) - a post-race veterinary examination revealed no visible abnormalities.

**ABSOLUTION** (D. Dunn) – inclined to lay in during the event. Inconvenienced rounding the home turn by EPERDUMENT, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

**LEMON SPLICE** (C. Parish) – in the vicinity of the 500 metres became awkwardly placed on the heels of MEADOWS LASSIE for a number of strides when that filly commenced to weaken.

**EPERDUMENT** (J. Potter) –raced wide without cover throughout the event. Rolled in rounding the home turn and inconvenienced ABSOLUTION.

**MISS AMERICAIN** (B. Thompson) – lost its position on jumping away when tightened onto BERKSHIRE LADY by MEADOWS LASSIE, which shifted out.

**FIBBERS (NZ)** (J. Bowditch) – a late scratching on veterinary advice by order of Stewards at 7.40 am.

**MEADOWS LASSIE** (K. Crowther) – shifted out on jumping away onto MISS AMERICAIN.

## **RACE 4: EFX CENTAUREA STAKES - 2019 metres**

**SAVAPINSKI (NZ)** (T. Clark) - a post-race veterinary examination revealed no visible abnormalities.

**TAHANEE (ARG)** (D. Lane) – rider reported, in his opinion, the mare had not seen out the distance of today's event. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**HUSSTERICAL** (S. Baster) – rider reported, in his opinion, the mare did not handle the track conditions in today's event. A post-race veterinary examination revealed no visible abnormalities.

**BERTWHISTLE** (A. Chan) – shifted out onto LADY SILHOUETTE approaching the 200 metres. Rider reminded of his obligations when shifting ground.

**LADY SILHOUETTE** (D. Caboche) - raced keenly in the early and middle stages of the event. Approaching the 200 metres lost its position when SHENANDOAH (NZ) rolled in slightly at the same time as BERTWHISTLE shifted out.

**SHENANDOAH (NZ)** (R. Bayliss) – rolled in onto LADY SILHOUETTE approaching the 200 metres and in being corrected shifted out and became awkwardly placed on the heels of SAVAPINSKI (NZ). A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 5: ROBERT & FAY GERARD R A LEE STAKES - 1600 metres**

**LITE'N IN MY VEINS** (J. Kah) – lost its near fore plate during the event. A post-race veterinary examination revealed a laceration to the near fore heel. First Aid administered. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**CALDERON (IRE)** (L. Currie) – Trainer Mr T. McEvoy advised that he would instruct his rider to attempt to settle further forward in today's event due to the wide barrier, if circumstances permit.

**BALF'S CHOICE** (J. Bowditch) - raced keenly in the early and middle stages of the event.

**FASTNET TEMPEST (IRE)** (R. Bayliss) – a post-race veterinary examination revealed no visible abnormalities.

**RAW IMPULSE (GB)** (B. Allen) – shifted out in the vicinity of the 200 metres onto HUSSYBAY. Rider was reprimanded and advised in future to make a greater effort to keep his mounts straight when the commence to shift ground.

**EXCITES ZELADY** (J. Toeroek) – inclined to lay in, in the straight and approaching the 200 metres shifted in onto HUSSYBAY.

**RHYTHM TO SPARE (NZ)** (D. Oliver) – in the vicinity of the 200 metres had difficulty obtaining clear ground for a number of strides.

**ROYAL RUMBLE** (C. Lindop) - raced keenly in the early and middle stages of the event.

**HUSSYBAY** (J. Winks) – in the vicinity of the 300 metres raced in restricted room for a number of strides when EXCITES ZELADY rolled in. Approaching the 200 metres had to ease when tightened onto EXCITES ZELADY by RAW IMPULSE (GB), which shifted out. Stewards questioned rider in relation to his riding between the 300 metres and approaching the 200 metres, as in their opinion they considered that J. Winks may have had the opportunity to continue to ride his mount in an effort to hold RAW IMPULSE (GB) in behind CALDERON (IRE). After considering his explanation Stewards were not satisfied to the level required to proceed with the matter, however advised J. Winks that he should ride in a manner that did not invite question. A post-race veterinary examination revealed no visible abnormalities.

**OVER EXPOSURE** (C. Parnham) – held up from the entrance to the straight until near the 200 metres.

**KIRONA** (D. Thornton) – raced in restricted room for a number of strides approaching the 200 metres.

#### **RACE 6: UBET PROUD MISS STAKES - 1200 metres**

**DAINTY TESS** (J. Kah) – lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

**GOGO GRACE** (C. Lindop) – raced fiercely in the early and middle stages of the event and in the vicinity of the 800 metres had to be steadied to avoid the heels of MISS SISKKA, which had been taken in.

**MISS GUNPOWDER** (D. Dunn) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**ONE MORE DAISY** (K. Crowther) – rider reported in her opinion the mare may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

**MAMZELLE TESS** (S. Baster) – inconvenienced when contacted by SHE'S SO HIGH approaching the 200 metres.

**SET TO SPARKLE** (T. Clark) - jumped away awkwardly and shifted in bumping MISS SISKKA. A post-race veterinary examination revealed no visible abnormalities.

**MYSTIFIED** (J. Bowditch) – held up from the vicinity of the 500 metres until inside the 300 metres.

#### **RACE 6: UBET PROUD MISS STAKES - 1200 metres (Cont'd)**

**ALTA STELLA** (J. Holder) – rolled in, in the vicinity of the 800 metres onto MISS SISKA. Laid in under pressure in the straight.

**MISS SISKA** (L. Currie) – contacted on jumping away. Taken in by ALTA STELLA in the vicinity of the 800 metres onto GOGO GRACE.

**SHE'S SO HIGH** (D. Oliver) – held up from the vicinity of the 500 metres until approaching the 200 metres when it shifted out contacting MAMZELLE TESS.

#### **RACE 7: DARLEY GOODWOOD - 1200 metres**

**VEGA MAGIC** (D. Oliver) – shifted out in the vicinity of the 150 metres onto OVERSHARE, which had to be checked. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 26 May and to conclude at midnight on Wednesday, 6 June 2018: a period of five meetings. In arriving at this penalty Stewards took into account D. Oliver's guilty plea and good record.

**SANTA ANA LANE** (B. Melham) - jumped away awkwardly.

**THRONUM** (T. Clark) - jumped away awkwardly. Rider reported he had become concerned at the entrance to the straight and for this reason eased the horse from the event. A post-race veterinary examination revealed the horse had strained its near fore flexor tendon. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. First aid administered.

**SECRET AGENDA** (D. Dunn) – rider reported the gelding was awkward in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

**VIDDORA** (J. Bowditch) – in the vicinity of the 800 metres was obliged to alter course to the inside of MICA LIL, which shifted out abruptly. A post-race veterinary examination revealed a slow recovery.

**FERRANDO (NZ)** (S. Baster) - a post-race veterinary examination revealed no visible abnormalities.

**STEEL FROST** (T. Pannell) - jumped away awkwardly and shifted in onto SUPER CASH. In the vicinity of the 800 metres rolled in slightly onto MICA LIL.

**OVERSHARE** (J. Winks) – had to be checked in the vicinity of the 150 metres when VEGA MAGIC shifted out. Had to be steadied again near the 50 metres when VEGA MAGIC rolled out.

**I'LL HAVE A BIT** (C. Parnham) - jumped away awkwardly. In the vicinity of the 800 metres rolled out and bumped MICA LIL. Had difficulty obtaining clear ground from the vicinity of the 500 metres until inside the 200 metres.

**MICA LIL** (D. Thornton) – in the vicinity of the 800 metres became awkwardly placed between I'LL HAVE A BIT, which shifted out and STEEL FROST, which rolled in, resulting in the mare shifting out abruptly across the heels of STEEL FROST, losing its position. Disappointed in the vicinity of the 200 metres when attempting a tight run between STELLA COLLISION and SECRET AGENDA.

**NIPPERKIN** (K. Bishop) – in the vicinity of the 900 metres became awkward for a short distance when taken in by FLAMBERGE.

#### **RACE 8: CHALK HILL HANDICAP - 1200 metres**

**BLUE TYCOON** (R. Clark) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**ARTIE DEE TWO** (D. Lane) – kicked by another runner on arrival at the start. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on this advice, Stewards withdrew ARTIE DEE TWO at 4.37 pm.

**RACE 8: CHALK HILL HANDICAP - 1200 metres (Cont'd)**

**BEAUTIFUL FLYER** (J. Winks) - slow to begin.

**SEE ME FLY** (D. Thornton) - slow to begin.

**DISGRACEFUL** (J. Kah) – laid in under pressure in the straight.

**VIEIRA** (J. Holder) - raced keenly in the middle stages of the event. Laid in under pressure in the straight.

**ROCK STATUS** (K. Crowther) – held up from the vicinity of the 300 metres until near the 200 metres when awkwardly placed on the heels of ESCHIELE. A post-race veterinary examination revealed gelding to be lame in the off hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**INVISIBLE GIRL** (C. Parnham) – a late scratching by order of Stewards at 7.40 am on veterinary advice.

**GOOD THERAPY** (P. Gatt) – raced keenly in the middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

**PORT VALE** (O. Ridge) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**MILITARY FORCES** (D. Yendall) - a post-race veterinary examination revealed no visible abnormalities.

**WEATHER CHANNEL** (R. Bayliss) – as there was no available rider on course to ride at the weight, R. Bayliss was permitted to rider the gelding one kilogram over its allotted weight.
