**WEATHER:** Fine

**RAIL:** Out 6 metres 1700 metres to 1500 metres and 800 metres to 400 metres, out 4 metres remainder.

**RACE 1: BAROSSA VOLKSWAGEN / SABOIS MAIDEN PLATE – 1722 metres**

The start of this event was delayed approximately two minutes.

**GOLD MAESTRO** (J. Maund) – laid in, in the straight. Rider reported that as a result of the gelding laying in he had difficulty in riding it to the line over the concluding stages.

**HE'S A VALLEYBOY** (J. Bowditch) – slow to begin.

**INDIAN MO** (R. Hurdle) – had to be re-saddled on arrival at the barriers. Near the 100 metres shifted in and contacted LOSTARC, which was taken in as a result. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr P. Day, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**LOSTARC** (R. Sakai) – near the 100 metres shifted out and contacted INDIAN MO, which shifted in, and as a consequence was hampered when taken in. A post-race veterinary examination revealed no visible abnormalities.

**TENOSSUH** (R. Clark) – laid in approaching the 800 metres, shifted in slightly onto MISS VERNE as that horse laid out and shifted out.

**MEADOWS LASSIE** (D. Tourneur) – rider reported that the filly laid in throughout the event.

**MISS VERNE** (K. Lau) – laid out in the early stages of the event and approaching the 800 metres continued to lay out, shifted out slightly and clipped the heels of TENOSSUH, which laid in and shifted in, resulting in K. Lau being dislodged. Rider examined by the First Care Medical staff and passed fit to fulfil his remaining engagements. A post-race veterinary examination revealed no visible abnormalities.

**SHOW 'EM SHARKIE** (J. Holder) – slow to begin.

**RACE 2: SANDERS FODDER / MITAVITE / SABOIS MAIDEN PLATE – 1215 metres**

**FLYING STRIDE** (R. Hurdle) – underwent a pre-race veterinary examination on arrival on-course as the gelding had not raced since July 2017 and was passed fit to start. Raced greenly in the straight and laid out over the concluding stages.

## **RACE 2: SANDERS FODDER / MITAVITE / SABOIS MAIDEN PLATE – 1215 metres (Cont'd)**

**WOODCROFT** (R. Sakai) – near the 1000 metres brushed with HURRY HOME HARRY, which shifted out on several occasions, and then raced in restricted room between HURRY HOME HARRY and REGINA MARGHERITA, which shifted in for a short distance inside the 1000 metres. Thereafter laid in for some distance near the 800 metres.

**ECLAIR LIGHTNING (NZ)** (T. Pannell) – inside the 1000 metres got its head up and became awkward on the heels of MISS EBONY ROSE and raced ungenerously for several strides. Thereafter, near the 400 metres shifted out to improve and contacted HURRY HOME HARRY taking that horse wider. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Lost its near fore plate during the event.

**HURRY HOME HARRY** (P. Gatt) – near the 400 metres was contacted and taken wider by ECLAIR LIGHTNING (NZ), which shifted out to improve. A post-race veterinary examination revealed no visible abnormalities.

**REGINA MARGHERITA** (J. Bowditch) – laid in, in the straight.

## **RACE 3: UBET / SABOIS TWO-YEARS-OLD MAIDEN PLATE - 1115 metres**

**EXALTED TRAIL** (T. Pannell) – laid in, in the straight and near the 100 metres was inconvenienced by FIRST DIAMOND, which was taken wider by SCHILLDORA, and had to alter course to the inside of FIRST DIAMOND.

**SWANKYTOFF** (J. Potter) – approaching the 100 metres shifted in and was then inconvenienced by SCARY GO ROUND, which shifted out.

**FIRST DIAMOND** (J. Kah) – taken wider by SCHILLDORA inside the 100 metres.

**RAGING QUEEN** (D. Tourneur) – laid in, in the straight.

**SCARY GO ROUND** (S. Fawke) – awkward to begin. Shifted out near the 100 metres and inconvenienced SWANKYTOFF. A post-race veterinary examination revealed no visible abnormalities.

**SCHILLDORA** (K. Lau) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Shifted out near the 100 metres taking FIRST DIAMOND a little wider on the track.

## **RACE 4: KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE - 1115 metres**

**HAYAKU MISS** (T. Pannell) – contacted at the start. Held up for clear running near the entrance of the straight for a number of strides and was obliged to shift in to obtain clear ground. A post-race veterinary examination revealed no visible abnormalities.

**LANNISTER GOLD** (D. Morgan) – underwent a pre-race veterinary examination on arrival on course as it had not raced since July 2017 and was passed fit to start. Rider explained that it was his intention to settle more forward in today's event but owing to the formation of the field, the manner in which the mare began and the pace in the race he was obliged to settle further back than intended.

**BLAME RODNEY** (J. Huxtable) – approaching the 800 metres commenced to over-race, shifted out taking COSMIC IMPACT wider for a short distance. Thereafter raced wide without cover.

**COSMIC IMPACT** (J. Bowditch) – awkward to begin, shifted in and contacted WITCH KID. Approaching the 800 metres taken wider for a short distance by BLAME RODNEY, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

**FOIE GRAS** (J. Kah) – awkward to begin, shifted out and contacted HAYAKU MISS.

**FROSTY GREY** (D. Caboche) – inside the 1000 metres got its head up and raced ungenerously for a short distance.

**ROCK FORWARD** (P. Gatt) – near the 1000 metres raced ungenerously for a short distance.

**RACE 4: KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE**  
**- 1115 metres (Cont'd)**

**WITCH KID** (A. Lindsay) – awkward to begin and was contacted at the start. Rider presented to weigh out for this event without a surcingle and was reprimanded under AR118(b)(iii) and advised in future to present at the scale in a proper manner. As a consequence of weighing out without the surcingle A. Lindsay had to re-weigh.

**POETIC DIVA** (D. Tourneur) – Trainer, Mr G. Young, was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified by records held by Stewards. Over-raced for a short distance near the 1000 metres.

**RACE 5: CRABB SHELLGRIT CLASS ONE HANDICAP - 1215 metres**

**OH MO** (J. Holder) – slipped behind on jumping away. Rider explained that it was his intention to settle on pace in this event but owing to the manner in which the gelding began he was unable to do so and was obliged to settle further back. A post-race veterinary examination revealed no visible abnormalities.

**LUCKY WICK** (J. Kah) – approaching the 200 metres was inconvenienced when awkward outside the heels of SHUCK, which shifted out.

**EQUIDAME** (T. Pannell) – contacted at the start.

**SHUCK** (J. Bowditch) – shifted out approaching the 200 metres and inconvenienced LUCKY WICK. Rider reminded of his obligations when shifting ground. Rider also reminded of his obligations to ride his mount out fully to the line. A post-race veterinary examination revealed the mare to be exhibiting signs of mild thumps and a poor post-race recovery. First aid administered.

**ANGEL'S WISH** (P. Gatt) – awkward to begin, shifted in and contacted EQUIDAME. A post-race veterinary examination revealed no visible abnormalities.

**PARK BENCH (NZ)** (R. Clark) – the reins fitted to this gelding had to be replaced on arrival at the barriers. Trainer, Ms C. Brander, was spoken to in regard to presenting this horse in a set of reins which Stewards considered not suitable in the circumstances. In the vicinity of the 200 metres was disappointed for clear running between MANHATTAN MELODY, which shifted out, and EQUIDAME and shortly thereafter when attempting to improve to the inside of MANHATTAN MELODY was obliged to shift further inwards as MANHATTAN MELODY shifted in when being corrected. As a consequence of shifting in the horse reacted sharply away from MANHATTAN MELODY and shifted in onto OH MO, which was momentarily inconvenienced. Rider corrected her mount before continuing to ride to the line.

**MANHATTAN MELODY** (R. Hurdle) – shifted out sharply in the vicinity of the 200 metres and shortly thereafter after being corrected shifted in, inside the 200 metres.

**KAPINETTE** (K. Bishop) – awkward to begin.

**RACE 6: COOPERS SESSION ALE BENCHMARK 64 HANDICAP - 2122 metres**

**DR DEPENDABLE** (R. Clark) – raced keenly in the early stages of the event.

**VINTAGE GROVE** (K. Lau) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

**ESCALATOR (NZ)** (J. Bowditch) – late scratching by Order of Stewards at 2.00 pm acting on confirmed advice from Mr G. Kennewell acting on behalf of Trainer, Mr L. Kennewell, that the float transporting this gelding had broken down and as a result he was unable to present the horse by the required time.

**BON ELISE** (K. Crowther) – a post-race veterinary examination revealed no visible abnormalities.

**STAR WARS (NZ)** (D. Tourneur) – slow to begin.

#### **RACE 6: COOPERS SESSION ALE BENCHMARK 64 HANDICAP - 2122 metres (Cont'd)**

**BLAZING CHEERS** (A. Chan) – late scratching by Order of Stewards at 2.00 pm acting on confirmed advice from Mr G. Kennewell acting on behalf of Trainer, Mr L. Kennewell, that the float transporting this mare had broken down and as a result he was unable to present the horse by the required time.

**SHOGUN'S REIGN** (E. Finnegan) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

#### **RACE 7: GOLDIN FARMS - AKEED MOFEED BENCHMARK 64 HANDICAP - 1722 metres**

**BEAU'S MY BOY** (K. Crowther) – in the vicinity of the 500 metres laid in and became awkward outside the heels of BALTIC PRINCE for a short distance placing K. Crowther at a disadvantage. Thereafter laid in throughout in the straight.

**KING RED** (E. Finnegan) – obliged to be steadied shortly after the start when awkwardly placed on the heels of TABLE OF WISDOM and thereafter over-raced in the early stages of the event.

**TABLE OF WISDOM** (J. Kah) – rider reprimanded regarding using her whip forward of the horse's shoulder on one occasion over the final 100 metres.

**FANDANGO** (J. Potter) – a post-race veterinary examination revealed no visible abnormalities.

#### **RACE 8: THETERRACEFUNCTIONCENTRE.COM.AU BENCHMARK 60 HANDICAP - 1515 metres**

**ECLAIR FIESTA (FR)** (G. Lo) – inside the 300 metres when improving into a run to the outside of ANYPORTINASTORM was taken out as ANYPORTINASTORM shifted out and away from IN THE FAST LANE, which shifted out slightly. As a consequence ECLAIR FIESTA (FR) shifted out onto BEERZATBERNZ (NZ), which attempted to improve to its outside, resulting in BEERZATBERNZ (NZ) being hampered for several strides.

**ANYPORTINASTORM** (E. Finnegan) – inside the 300 metres shifted out and away from IN THE FAST LANE, which shifted out, and momentarily inconvenienced ECLAIR FIESTA (FR), which was taken out. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres. Having regard for E. Finnegan's guilty plea, her record and her use of the whip over the concluding stages Stewards determined that she be fined \$500.

**BEERZATBERNZ (NZ)** (J. Kah) – inside the 300 metres was hampered when attempting to improve to the outside of ECLAIR FIESTA (FR) as that horse was taken out by ANYPORTINASTORM, and had to be steadied and was unable to further improve its position. Thereafter was held up for clear running and unable to obtain clear running until inside the 100 metres where it was obliged to shift to the inside of ECLAIR FIESTA (FR) to attempt to improve its position.

**HE'S GOT SKILLS** (K. Crowther) – held up for clear running from shortly after the entrance to the straight when attempting to improve to the outside of BEERZATBERNZ (NZ) and was unable to obtain clear running until inside the 100 metres where it was obliged to shift to the inside of BEERZATBERNZ (NZ) to improve its position. A post-race veterinary examination revealed no visible abnormalities.

**IN THE FAST LANE** (R. Clark) – shifted out slightly inside the 300 metres taking ANYPORTINASTORM outwards.

**RONG DOOR REGGIE** (J. Bowditch) – rider reported that he was not comfortable with the manner in which the gelding finished the event off. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 9: HOLDFAST INSURANCE BENCHMARK 60 HANDICAP - 1115 metres**

**QUIVERS** (G. Lo) – shifted out in the vicinity of the 100 metres and inconvenienced VIVALDI'S QUEST. A post-race veterinary examination revealed no visible abnormalities.

**RACE 9: HOLDFAST INSURANCE BENCHMARK 60 HANDICAP - 1115 metres (Cont'd)**

**VIVALDI'S QUEST** (A. Chan) – began awkwardly and stumbled at the start. Approaching the 800 metres raced keenly, shifted out when being restrained after becoming awkward on the heels of L'AMARYBELLE. Hampered approaching the 100 metres by QUIVERS, which shifted out and had to be steadied for a number of strides. Rider was spoken to with regard to riding his mounts out to the finish over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**EXTREME WITNESS** (J. Bowditch) - underwent a pre-race veterinary examination and passed fit to race. Awkward and slow to begin. At the entrance to the straight was obliged to alter course to the inside of QUIVERS, which shifted out. Shifted in, inside the 100 metres and inconvenienced SPIEGEL GROVE. Rider was reminded of his obligations when shifting ground.

**MASTER BLACK** (K. Crowther) – awkward to begin. Approaching the 800 metres clipped the heels of VIVALDI'S QUEST, which shifted out after being restrained when awkward on the heels of L'AMARYBELLE after racing keenly. In the vicinity of the 150 metres was disappointed for clear ground between CASH IS COMING and SPIEGEL GROVE, which shifted out and was obliged to alter course to the inside of SPIEGEL GROVE approaching the 100 metres.

**PANDEIA** (D. Tourneur) – held up for clear running from near the 500 metres until the entrance to the straight.

**ATLANTICA** (J. Kah) – shifted out shortly after the entrance to the straight and inconvenienced RUSTYDUSTYSUNSHINE. Rider was severely reprimanded for shifting ground when insufficiently clear.

**SPIEGEL GROVE** (R. Hurdle) – near the 150 metres shifted out and inconvenienced MASTER BLACK. Inside the 100 metres raced in restricted room between RUSTYDUSTYSUNSHINE, which shifted out slightly and EXTREME WITNESS, which shifted ground inwards.

**RUSTYDUSTYSUNSHINE** (J. Potter) – laid in, in the straight. Shortly after the entrance to the straight was inconvenienced by ATLANTICA, which shifted out.
