**Report on Race Meeting held at Morphettville Parks Racecourse**

**RACE 1: STOYANOFF IS A HANDBRAKE / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1000 metres**

**BRYBECK** (J. Holder) – raced greenly throughout the event and in the vicinity of the 700 metres shifted out abruptly onto THRONES. Shifted in, in the vicinity of the 200 metres and bumped GOOD NIC. A post-race veterinary examination revealed no visible abnormalities.

**SNIP OF TIME** (S. Fawke) – jumped away awkwardly.

**THAT'S TWO SLABS** (J. Maund) – slow into stride. In the vicinity of the 200 metres shifted out and away from LASANTA contacting ZAGATO STAR.

**THRONES** (A. Jordsjo) – inconvenienced in the vicinity of the 700 metres when BRYBECK shifted out. Stewards questioned trainer, Mr S. Adams, and that gelding's rider, A. Jordsjo, in relation to the horse being presented in the mounting yard without a surcingle. After considering their explanations Mr S. Adams was reprimanded under AR140A(2) and A. Jordsjo was reprimanded under AR175(k).

**VOLUM** (L. Currie) – a post-race veterinary examination revealed no visible abnormalities..

**ANNIFRID** (K. Crowther) – slow into stride.

**GOOD NIC** (A. Chan) – contacted in the vicinity of the 200 metres.

**LASANTA** (O. Ridge) – laid out under pressure in the straight and in the vicinity of the 200 metres shifted out towards THAT'S TWO SLABS. A post-race veterinary examination revealed no visible abnormalities.

**ZAGATO STAR** (R. Sakai) – contacted in the vicinity of the 200 metres.

## **RACE 2: TERRY HOWE PRINTING HANDICAP – 1250 metres**

**POISED TO STRIKE** (C. Parish) – laid in under pressure in the straight.

**CITY BEATS** (S. Fawke) – raced keenly in the early and middle stages of the event and in the vicinity of the 900 metres improved onto the heels of ST GEORGES VAULTS and had to be steadied.

**EASY TIGER** (J. Holder) – slow to begin.

**ST GEORGES VAULTS** (P. Gatt) – made the turn in the vicinity of the 900 metres awkwardly and lost ground. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 3: UBET HANDICAP – 1300 metres**

**DIAMOND TYCOON** (A. Chan) – rider explained that the filly had travelled well in the early and middle stages of the event; however, when placed under pressure in the vicinity of the 350 metres failed to respond to his riding and in his opinion may have gotten its tongue back. A post-race veterinary examination revealed no visible abnormalities.

**COACHES AWARD** (C. Parish) – a post-race veterinary examination revealed no visible abnormalities.

**BOOMER BEACH** (J. Holder) – raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

**LORD ROSENTHAL** (P. Gatt) – rider reported that the gelding was awkward in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 4: MEDALLION HOMES HANDICAP - 1300 metres**

**OPTIMIZE** (K. Crowther) – in the vicinity of the 1000 metres shifted in when insufficiently clear of NIGHT QUEEN, taking that runner in onto AMPLE ON OFFA, which was taken in across the running of SNOWBROOK resulting in SNOWBROOK clipping the heels of AMPLE ON OFFA and knuckling. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence midnight Saturday, 16 June 2018 to midnight Wednesday, 27 June 2018, a period of five race meetings.

**SAVE ME NED** (R. Clark) – in the vicinity of the 300 metres was disappointed when attempting a tight run to the inside of SNOWBROOK, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

**AMPLE ON OFFA** (J. Huxtable) – taken in across the running of SNOWBROOK in the vicinity of the 1000 metres by NIGHT QUEEN.

**BEAUTIFUL FLYER** (J. Bowditch) – rider reported that the mare had travelled well in the early and middle stages of the event; however, when placed under pressure failed to respond as he had anticipated and he had become concerned with its action over the concluding stages. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr L. Jarvis, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**EMBECEE LIL** (R. Sakai) – jumped away awkwardly and shifted in contacting TOO TUFF TARA.

**DEVILISHLY** (C. Parish) – a post-race veterinary examination revealed no visible abnormalities.

**SNOWBROOK** (E. Finnegan) – in the vicinity of the 1000 metres clipped the heels of AMPLE ON OFFA and knuckled. Rolled in, in the vicinity of the 300 metres onto SAVE ME NED. A post-race veterinary examination revealed a laceration to the near hind leg. First aid administered.

**TOO TUFF TARA** (E. Boyd) – contacted on jumping away.

**NIGHT QUEEN** (A. Chan) – in the vicinity of the 1000 metres taken in by OPTIMIZE onto AMPLE ON OFFA.

#### **RACE 5: DARLEY HANDICAP - 1950 metres**

**EXALTED LIGHTNING** (C. Parish) – lost its position on jumping away when tightened onto GRACENA by ROYAL RUMBLE. Rider explained after being interfered with at the start he found himself further back than anticipated and in his opinion due to this reason and the shorter distance of today's event the gelding was unable to improve into the race despite his efforts. A post-race veterinary examination revealed no visible abnormalities.

**ROYAL RUMBLE** (R. Clark) – shifted out abruptly on jumping away onto EXALTED LIGHTNING.

**BERTWHISTLE** (A. Chan) – rider explained that the mare travelled well in the early and middle stages of the event; however, failed to respond to his riding from the 400 metres. He added in his opinion the mare may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

**LADY SILHOUETTE** (D. Caboche) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer, Mr G. Searle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

#### **RACE 6: EVRIGHT HANDICAP - 1250 metres**

**THIS KID ROCKS** (J. Holder) – rider reported that the gelding felt flat. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Ms B. O'Loughlin, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**SET TO SPARKLE** (C. Parish) – inclined to lay out under pressure in the straight. Rider reported that the mare travelled well in the early and middle stages of the event; however, had not let down as he had anticipated and in his opinion may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

**STRYKER FORTUNE** (A. Chan) – rider accidentally dropped his whip in the vicinity of the 300 metres and was reprimanded for carelessness under AR137(a).

#### **RACE 7: ADELAIDE GALVANISING HANDICAP - 1000 metres**

**MAGNUS KNIGHT** (R. Sakai) – jumped away awkwardly.

**STRAGUN** (A. Chan) – shifted in slightly in the vicinity of the 600 metres onto INVISIBLE GIRL and then shortly after was taken in further by WAR THUNDER. Rider reminded of his obligations when shifting ground.

**OAMARU OWL** (J. Holder) – shifted in onto WAR THUNDER approaching the 600 metres.

**STREETCAR ILLUSION** (K. Crowther) – slow to begin and shortly after lost its position when tightened onto INVISIBLE GIRL by TROGIR.

**TROGIR** (D. Caboche) – shifted out on jumping away onto STREETCAR ILLUSION. Improved into restricted room approaching the 600 metres between the heels of MAGNUS KNIGHT, which laid out slightly, and INVISIBLE GIRL. Shortly after TROGIR made the turn awkwardly and shifted out onto INVISIBLE GIRL. Rider reminded of his obligations and advised in future to ensure there was sufficient room prior to commencing to shift ground. A post-race veterinary examination revealed the gelding to be lame in the near foreleg and to abnormal upper respiratory noise. Trainer, Mr P. Stokes, was advised that a Veterinary Certificate of Fitness and the results of an laryngoscopic examination were required prior to a future trial or race.

**INVISIBLE GIRL** (J. Bowditch) – lost its position approaching the 600 metres when tightened between TROGIR, which shifted out, and STRAGUN, which shifted in and then was taken in.

**WAR THUNDER** (E. Boyd) – approaching the 600 metres was taken in onto STRAGUN by OAMARU OWL.

**RACE 8: FLEURIEU MILK COMPANY HANDICAP - 1400 metres**

**SPIRITOF ENDEAVOUR (USA)** (R. Sakai) – jumped away awkwardly and was slow into stride.

**LORD SMEDLEY** (D. Caboche) – contacted on jumping away and taken out onto WANTED DIVA.

**POLAR VORTEX** (A. Chan) – jumped away awkwardly and shifted out onto LORD SMEDLEY. In the vicinity of the 200 metres shifted out and bumped DOLLAR DOLLAR BILL.

**ANURADHA** (T. Pannell) – had difficulty obtaining clear ground from the entrance of the straight until inside the 200 metres.

**PRECISION STRIKE** (S. Fawke) – shifted in on jumping away and contacted WANTED DIVA.

**FRANCE'S BOY** (R. Clark) – raced keenly in the early and middle stages of the event when awkwardly placed inside the heels of LORD SMEDLEY.

**WANTED DIVA** (C. Parish) – tightened on jumping away between PRECISION STRIKE, which shifted in, and LORD SMEDLEY, which had been taken out.
