RACE 1: MID NORTH PARTY HIRE / SABOIS MAIDEN PLATE - 1600 metres

CHUBBY RAIN (O. Ridge) – bumped on jumping away when MISS VERNE jumped away awkwardly and shifted out. Raced keenly in the early and middle stages of the event.

LOSTARC (J. Kah) – in the vicinity of the 400 metres shifted out around heels to improve when insufficiently clear of TENOSSUH and inconveniencing that gelding taking it wider on the track. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended for a period to commence midnight Wednesday, 27 June 2018 to conclude midnight Wednesday, 4 July 2018, a period of three meetings.

SHIRLEY'S EAGLE (K. Lau) – jumped away awkwardly and shifted out brushing JACK'S SISTER. Pulled hard and raced keenly throughout the event. In the vicinity of the 300 metres shifted out when insufficiently clear of MISS VERNE, which had to check and lose its position. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended for a period to commence midnight Wednesday, 27 June 2018 and to conclude midnight Wednesday, 4 July 2018, a period of three meetings. A post-race veterinary examination revealed no visible abnormalities.

TENOSSUH (R. Clark) – in the vicinity of the 400 metres was bumped and inconvenienced when taken wider when LOSTARC shifted out when insufficiently clear.

JACK'S SISTER (D. Tourneur) – brushed on jumping away when SHIRLEY'S EAGLE jumped away awkwardly and shifted out.

MISS VERNE (R. Hurdle) – jumped away awkwardly and shifted out bumping CHUBBY RAIN. In the vicinity of the 300 metres had to be checked and lose its position when SHIRLEY'S EAGLE shifted out when insufficiently clear.

RACE 2: EVRIGHT.COM / SABOIS MAIDEN PLATE - 1050 metres

TOFFIATO (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

WONDER IF (NZ) (P. Gatt) – slow to begin. Raced keenly in the early and middle stages of the event. At the entrance to the straight appeared to clip heels when racing keenly. A post-race veterinary examination revealed no visible abnormalities.

ORANGES (K. Bishop) – raced greenly in the straight.

STREWTH (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

ROCK FORWARD (K. Lau) – a post-race veterinary examination revealed a small laceration to the off hind leg. First aid administered.

ROCKET SOX (D. Tourneur) – from the entrance of the straight until the vicinity of the 300 metres was held up for clear running. Approaching the 100 metres had to be momentarily steadied when attempting a run between FLOP and ORANGES, which was racing greenly.

RACE 3: HYLAND RACE COLOURS / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres

GREAT REBELLION (R. Hurdle) – jumped away awkwardly and shortly after the start was inconvenienced when THE NOTORIOUS jumped away awkwardly and shifted out.

THE GEELONG FLYER (D. Caboche) – approaching the 600 metres was inconvenienced when taken wider. Approaching the 200 metres rolled out marginally under pressure.

THE NOTORIOUS (S. Fawke) – jumped away awkwardly and shifted out bumping GREAT REBELLION. Approaching the 600 metres was inconvenienced when taken wider.

UNSHAKEABLE (J. Bowditch) – inconvenienced on jumping away when FIRST DIAMOND jumped away awkwardly and shifted out.

WAIKATO EXPRESS (R. Clark) – inconvenienced on jumping away when JAAMINT jumped away awkwardly and shifted in.

EXALTED MAXINE (D. Tourneur) – approaching the 600 metres was inclined to hang out inconveniencing THE GEELONG FLYER and THE NOTORIOUS, which were taken wider. A post-race veterinary examination revealed no visible abnormalities.

FIRST DIAMOND (J. Holder) – jumped away awkwardly and shifted out inconveniencing UNSHAKEABLE and WAIKATO EXPRESS.

JAAMINT (A. Jordsjo) – jumped away awkwardly and shifted in inconveniencing UNSHAKEABLE and WAIKATO EXPRESS. Approaching the 200 metres had to be steadied off the heels of THE GEELONG FLYER, which shifted out under pressure.

RACE 4: WALANDAN & MASON FARMING CLASS TWO HANDICAP - 1050 metres

EQUIDAME (K. Lau) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SHUCK (J. Bowditch) – a post-race veterinary examination revealed no visible abnormalities.

HARLEM CHILD (S. Fawke) – jumped away awkwardly and shifted in.

RACE 5: ROYAL HOTEL, BALAKLAVA/ TAD'S EMBROIDERY / SABOIS MAIDEN PLATE – 1300 metres

FLYING STRIDE (T. Pannell) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

TOFF HEART (R. Hurdle) – in the vicinity of the 800 metres contacted the running rail.

MISS EBONY ROSE (K. Bishop) – a post-race veterinary examination revealed no visible abnormalities.

LADY LA MANCHA (J. Bowditch) – a post-race veterinary certificate revealed the filly to be lame in the near hind leg. Trainer, Mr P. Jones, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

QUAZAAM (P. Gatt) – slow to begin.

RACE 6: TEAM WISS AGRONOMY BENCHMARK 60 HANDICAP - 1200 metres

TRUENO (A. Lindsay) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ZANAHARY (P. Gatt) – raced keenly in the early and middle stages of the event.

VIVALDI'S QUEST (J. Bowditch) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: PLAINS PRODUCER BENCHMARK 60 HANDICAP - 1400 metres

DOUBLE POCKETS (S. Cahill) – in the vicinity of the 200 metres had to be momentarily steadied when THE ANT'S PANTS shifted out marginally under pressure.

FREE THE WIND (J. Holder) – raced keenly in the early and middle stages of the event.

LUCKY WICK (J. Kah) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

THE ANT'S PANTS (R. Clark) – performed below expectations. A post-race veterinary examination revealed the filly to be shin sore in both front legs.

RACE 8: KBL SECURITY BENCHMARK 60 HANDICAP - 1600 metres

AAGAS (R. Sakai) – trainer, Mr R. Balfour, fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards.

ANURADHA (T. Pannell) – slow to begin.

WANTED BY ALL (J. Bowditch) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ANYPORTINASTORM (J. Potter) – raced keenly in the early and middle stages of the event.

SOCIAL SET (J. Holder) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

DOWNUNDER PRINCE (A. Jordsjo) – slow to begin.
