**TRACK:** Soft 7 (*Upgraded to a Soft 6 @ 2.40 pm retrospective to Race 4*)

**RAIL:** Out 1 metre 1800 metres to 400 metres, out 2 metres remainder.

**RACE 1: COOPERS BREWERY BENCHMARK 60 HANDICAP - 2100 metres**

**MR STEAL (NZ)** (A. Lindsay) - laid out in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**MICKIEM** (C. Quilty) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

Correct weight was delayed to allow the D. Tourneur (CHU CHU CHARLIE), placed second to view the photo finish.

**RACE 2: KALANGADOO CUP 14 OCTOBER / SABOIS MAIDEN PLATE – 1700 metres**

**DEXTER'S COMMAND** (P. Marks) – bumped on jumping away and was slow into stride when FLYING CONQUEROR jumped away awkwardly and shifted out.

**FLYING CONQUEROR** (D. Caboche) - jumped away awkwardly and shifted out bumping DEXTER'S COMMAND. Over-raced in the early and middle stages of the event.

**LAST ONE NAMED** (K. Lau) - slow to begin. In the vicinity of the 1500 metres had to be momentarily steadied when improving onto heels.

**MISS BOMBER BELLE** (A. Chan) – Trainer Mr D. Shepherd advised Stewards that he would instruct his rider to attempt to lead in this event.

**SHE'S MOXIE** (A. Jordsjo) – over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3: ADRIAN THOMAS INDUSTRIAL BENCHMARK 72 HANDICAP - 1300 metres**

**SAVE ME NED** (J. Huxtable) – rider reported the mare felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

**ANY GIVEN GLASS** (S. Fawke) - slow to begin.

**BAJAN** (K. Crowther) - slow to begin. Rider explained the gelding was at the end of its preparation and that may have contributed to its performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4: PENOLA RACING CLUB MEMBERSHIP CAMPAIGN / SABOIS MAIDEN PLATE**  
**- 1100 metres**

The start of this event was delayed approximately two minutes.

**BEAR PASS** (C. Quilty) – proved difficult to load.

**SCALLYWAG** (J. Huxtable) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**CURTAIN CALL** (K. Crowther) – proved difficult to load. Trainer advised a warning had been placed on the gelding.

**JUST WANTO RUN NOW** (P. Marks) – in the vicinity of the 50 metres shifted out when insufficiently clear of WONGA MISS. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 23 September and to conclude at midnight on Sunday, 30 September 2018: a period of three meetings.

**SIRIUS JOURNEY** (A. Chan) – dislodged rider en route to the barriers and galloped for a short distance. Underwent a pre-race veterinary examination and passed fit to race. Rider was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. Trainer advised a warning had been placed on the mare.

**WONGA MISS** (D. Caboche) – in the vicinity of the 50 metres had to be steadied and lost its position when JUST WANTO RUN NOW shifted out when insufficiently clear.

Correct weight was delayed to allow D. Caboche (WONGER MISS), placed fourth to view the vision in the straight.

**RACE 5: UBET / SABOIS MAIDEN PLATE - 1400 metres**

**BRINGME THE BUTLER** (K. Bishop) – raced ungenerously in the early and middle stages of the event.

**STORMANIA** (K. Lau) - slow to begin.

**TROUBLESOME LAD** (D. Tourneur) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**LEONESQUE** (C. Quilty) – in the vicinity of the 1100 metres shifted out when improved onto heels and inconvenienced SPEED ESPRIT, which was taken wider.

**SPEED ESPRIT** (A. Jordsjo) – in the vicinity of the 1100 metres was inconvenienced when taken wider when LEONESQUE improved onto heels and shifted out.

**RACE 6: KATNOOK ESTATE CLASS TWO HANDICAP - 1100 metres**

The start of this event was delayed approximately two minutes.

**NASEEB** (E. Finnegan) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**MANDJAR** (S. Fawke) – in the vicinity of the 400 metres was held up for clear running for a short distance. Inclined to lay in under pressure in the straight.

**DANGEROUS REBEL** (D. Tourneur) - slow to begin.

**MELBOURNE HERO** (A. Jordsjo) – reluctant to proceed to the barriers. Trainer, Mr J. Rowe was advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**RACE 7: MED ELECTRICAL SERVICES BENCHMARK 56 HANDICAP - 1700 metres**

**RED SENSATION** (C. Quilty) – had to momentarily steady at the entrance to the straight when COOL TARGET shifted out.

**CARSON (NZ)** (D. Caboche) – brushed on jumping away when GRETA AFFAIR jumped away awkwardly and shifted out.

**COOL TARGET** (A. Chan) – at the entrance to the straight shifted out and momentarily inconvenienced RED SENSATION. Rider reminded of his obligations when shifting ground in future.

**GRETA AFFAIR** (E. Finnegan) - jumped away awkwardly and shifted out brushing CARSON (NZ).

**RACE 8: FINNS FINE FOODS BENCHMARK 56 HANDICAP - 1400 metres**

**PARADISE COVE (USA)** (D. Tourneur) – inconvenienced on jumping away when DELIGHTFUL SCOOP jumped away awkwardly and shifted out and LICORICE BULLET jumped away awkwardly and shifted in.

**DELIGHTFUL SCOOP** (P. Marks) - jumped away awkwardly and shifted out inconveniencing PARADISE COVE (USA) and LILAC WINE.

**LILAC WINE** (K. Bishop) – was inconvenienced on jumping away when DELIGHTFUL SCOOP jumped away awkwardly and shifted out and LICORICE BULLET jumped away awkwardly and shifted in.

**LICORICE BULLET** (K. Crowther) - jumped away awkwardly and shifted in inconveniencing PARADISE COVE (USA) and LILAC WINE.
