**RACE 1: LUKE WILLIAMS BUCKS / SABOIS TWO-YEAR-OLD PLATE - 1000 metres**

**FANAAR (NZ)** (J. Duffy) – over-raced in the early and middle stages of the event.

**SEBRAKATE** (D. Tourneur) – laid in under pressure in the straight.

**TROODLES** (J. Kah) - jumped away awkwardly and over-raced in the early and middle stages of the event.

**RACE 2: HOLDFAST INSURANCE HANDICAP – 1950 metres**

**SNITZEPEG** (C. Symons) – laid in under pressure throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3: TERRY HOWE PRINTING HANDICAP – 1250 metres**

**IN HEART'S WAKE** (J. Kah) - rider examined by the First Care Medical Personnel after being kicked in the mounting yard and passed fit to fulfil her remaining engagements. Assistant Trainer Mr C. McEvoy was advised a warning had been placed on the filly regarding its pre-race manners.

**RIVERINA DANCER** (J. Duffy) – laid out throughout the event. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the filly performing satisfactorily in an Official Barrier Trial.

**AASIRA** (J. Holder) – in the vicinity of the 200 metres was disappointed for a run between IN HEART'S WAKE and RIVERINA DANCER and as a result had to shift in, in an attempt to improve into clear running.

**ICE GHOST** (A. Jordsjo) – laid in under pressure in the straight.

**RACE 4: ADELAIDE GALVANISING HANDICAP - 2250 metres**

**BENZ** (A. Jordsjo) – rider reported her mount began to weaken in the vicinity of the 500 metres and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 4: ADELAIDE GALVANISING HANDICAP - 2250 metres (Cont'd)**

**ATLANTICA** (A. Chan) – laid out throughout the event.

**OGUNDE** (R. Sakai) – laid out under pressure in the straight.

#### **RACE 5: METAL-LINK / NORMUS HOMES HANDICAP - 2250 metres**

**JOHNNY VINKO (NZ)** (J. Kah) – began awkwardly. Laid in under pressure in the straight.

**IGITUR** (D. Tourneur) – inside the 200 metres was obliged to shift wider on the track in an attempt to improve into clear running.

**SOLAR CROSS (GB)** (J. Martin) – awkward to begin. Laid out on entering the straight becoming awkwardly placed on the heels of JOHNNY VINKO, which laid in. When questioned regarding the performance of the gelding, he reported that after becoming awkwardly placed on heels on entering the straight, his mount weakened noticeably and finished the race off disappointingly. A post-race veterinary examination revealed no visible abnormalities.

**FANTASTIC MAGIC** (P. Gatt) – rider was dislodged post-race. Rider examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. A post-race veterinary examination revealed no visible abnormalities.

**THE GATTING BALL** (H. Coffey) – rider reported his mount raced greenly throughout the event. Laid out on entering the straight. Laid in over the concluding stages placing him at a disadvantage when attempting to ride his mount out to the finish. A post-race veterinary examination revealed no visible abnormalities.

**WICKED RHYTHM** (G. Cartwright) – over-raced in the early and middle stages of the event.

#### **RACE 6: STEFFO'S BUCKS HANDICAP - 1300 metres**

**EMBECEE LIL** (J. Martin) - Stewards declared EMBECEE a late scratching at 3.23 pm on veterinary advice after being fractious in its barrier. Trainer Mr R. Balfour was advised a warning had been placed on the mare. A post-race veterinary examination revealed the filly to be lame in the off hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**ANY GIVEN GLASS** (J. Holder) – laid in throughout the event. In the vicinity of the 1000 metres shifted in brushing the running rail. When questioned regarding the performance of the gelding, rider reported his mount failed to respond to his riding in the early stages of the event and added that even though his mount was under pressure throughout the race, ANY GIVEN GLASS responded to his riding in the straight and finished off in a positive manner. Trainer reported in her opinion ANY GIVEN GLASS may be benefited racing over a longer distances. A post-race veterinary examination revealed no visible abnormalities.

**MR HAMILTON** (T. Pannell) – laid out under pressure in the straight.

**MILORD** (H. Coffey) – Stewards declared MILORD a late scratching at 9.30 am on veterinary advice as the gelding was lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**ZANAHARY** (P. Gatt) – laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

#### **RACE 7: UBET HANDICAP - 1300 metres**

**HE'S A MORAL** (H. Coffey) – over-raced in the early stages of the event.

**RACE 7: UBET HANDICAP - 1300 metres (Cont'd)**

**ENKI** (A. Jordsjo) – over-raced in the early stages of the event. Momentarily inconvenienced on entering the straight as **MONTASER (NZ)** shifted out in an attempt to improve.

**GOING GAGA** (J. Kah) – laid in under pressure in the straight.

**MONTASER (NZ)** (J. Toeroek) – over-raced in the early stages of the event. Held up for clear running when entering the straight, shifted out and contacted **ENKI**.

**REDEEM BOUNTY** (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**JACKTHEGIANTSLAYER** (J. Maund) – raced in restricted room over the concluding stages between **WANTED BY ALL** and **COOL MAVERICK**.

**RACE 8: MO BARRY MEMORIAL HANDICAP - 1400 metres**

**TATOOSH** (K. Crowther) – when questioned regarding the performance of the gelding, rider reported that she was trapped three wide without cover throughout the event. She added rather than placing her mount under pressure in the early stages, elected to remain racing three wide rather than push forward and lead. Failed to respond to her riding from the vicinity of the 600 metres and was disappointing in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

**JIM'S JOURNEY** (A. Chan) - slow to begin. Over-raced in the early stages of the event.

**USTINOV'S FURY** (R. Hurdle) - Stewards declared **USTINOV'S FURY** a late scratching at 4.41 pm on veterinary advice as the gelding was lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 9: MYPUNTER.COM HANDICAP - 1550 metres**

**BY THE GRACE** (C. Caserta) - slow to begin and was hampered by **ROSELLI STING**, which shifted in and **WITH A BIT OF DASH**, which shifted out.

**ROSELLI STING** (R. Hurdle) - began awkwardly and shifted in contacting **BY THE GRACE**. Over-raced in the early stages of the event.

**MELBA'S MAESTRO** (J. Martin) – slow into stride.

**DIAPASON (NZ)** (T. Pannell) – when questioned regarding the performance of the mare, rider reported that his mount failed to travel at any stage of the event, began to weaken in the vicinity of the 600 metres and was disappointing in its finishing effort. A post-race veterinary examination revealed no visible abnormalities.

**WITH A BIT OF DASH** (G. Cartwright) - began awkwardly and shifted out contacting **BY THE GRACE**.

**AWAKE IN GRINZING (NZ)** (D. Tourneur) – in the vicinity of the 1100 metres had to be restrained after improving onto the heels of **ADATTO (NZ)**.
