**Report on Race Meeting held at the Penola Racecourse**  
**by the Penola Racing Club on Sunday, 14 October 2018**

**TRACK:** Good 4

**RAIL:** Out 1 metre 1800 metres to 400 metres, out 2 metres remainder.

**WEATHER:** Overcast

**RACE 1: PRINCE OF WALES HOTEL - MOTEL / SABOIS MAIDEN PLATE - 1700 metres**

**BRINGME THE BUTLER** (K. Bishop) – in the vicinity of the 1400 metres was obliged to be steadied as EURO GOLD shifted out when insufficiently clear. In the vicinity of the 500 metres was obliged to be steadied as ELITE LADY shifted out when insufficiently clear.

**EURO GOLD** (A. Jordsjo) – in the vicinity of the 1400 metres shifted in when insufficiently clear of BRINGME THE BUTLER. Rider severely reprimanded.

**ELITE LADY** (R. Clark) – over-raced in the early and middle stages of the event. In the vicinity of the 500 metres shifted out in an attempt to improve into clear running when insufficiently clear of BRINGME THE BUTLER. Rider reminded of her obligations to be clear when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

**PLAYFUL HOST** (D. Bates) – over-raced in the early and middle stages of the event.

**RACE 2: FITZY'S SPARE TRACTOR / SABOIS MAIDEN PLATE – 1400 metres**

**READY DEAL** (E. Finnegan) – in the vicinity of the 600 metres attempted to shift out when insufficiently clear of SKY LACE. Rider reminded of her obligations to be clear when attempting to shift ground. Laid out throughout the event. In the vicinity of the 200 metres shifted out under pressure when insufficiently clear of SKY LACE. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**TENOSSUH** (K. Crowther) – rider reported her mount felt awkward in its action throughout the event. A post-race veterinary examination revealed that the gelding had been galloped on the near fore bulb.

**OCTOBER JEWEL** (C. Puls) – laid out under pressure in the straight.

**SKY LACE** (R. Clark) – in the vicinity of the 600 metres was momentarily inconvenienced when READY DEAL attempted to shift out. In the vicinity of the 200 metres was momentarily inconvenienced after READY DEAL shifted out when insufficiently clear.

**RACE 3: THANK YOU DENIS DUFF / SABOIS MAIDEN PLATE - 1100 metres**

**BEAR PASS** (K. Bishop) – in the vicinity of the 700 metres had to be restrained after improving onto the heels of STRATEGIC AGENDA.

**PARVENIR** (C. Puls) – rider reported her mount hung out severely throughout the event. Trainer Mr K. Elford was advised that advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**GRASSMERE MISS** (R. Clark) – raced greenly in the early and middle stages of the event.

**RACE 3: THANK YOU DENIS DUFF / SABOIS MAIDEN PLATE - 1100 metres (Cont'd)**

**ROYAL RUE** (A. Jordsjo) – rider reported her mount felt awkward in its action over the concluding stages. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**TIZA** (D. Bates) - slow to begin.

**MANHATTAN MANNERS** (K. Crowther) – rider reported that in the vicinity of the 200 metres that the mare jumped a section of the track.

**RACE 4: MED ELECTRICAL SERVICES BM 60 HANDICAP- 1100 metres**

**DELIGHTFUL CAT** (D. Bates) - jumped away awkwardly, shifted out abruptly and hampered HASTA LA BOUNTY.

**HASTA LA BOUNTY** (G. Lo) – hampered on jumping away by DELIGHTFUL CAT, which shifted out abruptly. Raced greenly in the early stages of the event.

**TCHOTCHKE** (A. Chan) – was buffeted on entering the straight by DELIGHTFUL CAT, which rolled in marginally and BIRDS IN HAND, which laid out.

**ROCKSTAR RANGA** (E. Boyd) - began awkwardly. Laid out under pressure in the straight.

**BIRDS IN HAND** (R. Clark) – laid out from the vicinity of the 500 metres and continued to lay out under pressure in the straight.

**CHIC SALE** (C. Puls) - began awkwardly.

**RACE 5: COOPERS BREWERY KALANGADOO CUP BM 64 HANDICAP - 2100 metres**

**OLYMPIC ACADEMY** (G. Lo) – rider reminded of his obligations to ride his mount out to the finish. A post-race veterinary examination revealed no visible abnormalities.

**CHU CHU CHARLIE** (J. Lorensini) – after being fractious in the barriers, dropped its head when the start was effected and as a result was slow to begin.

**BRONSKI** (S. Fawke) – laid out throughout the event.

**RACE 6: KALANGADOO NETBALL CLUB PREMIERS 2018 BENCHMARK 60 HANDICAP  
- 1700 metres**

**HIGH ROLLA** (A. Chan) - hampered shortly after jumping away by GOLDEN RULE, which shifted out.

**CHALLICUM** (E. Boyd) – slow to begin. Over-raced in the early stages of the event. Laid out throughout the event. On entering the straight was inconvenienced when attempting to avoid the heels of the weakening ATOMIC KNIGHT. Rider reported her mount felt awkward in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**ATOMIC KNIGHT** (K. Crowther) – when questioned regarding the performance of the gelding, rider stated that her mount began to weaken from the vicinity of the 500 metres and ran to the line in a disappointing manner. Trainer Mr S. Gerbert could offer no explanation for the disappointing run and advised Stewards that he would report back on the condition of ATOMIC KNIGHT. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7: THE MIDFIELD GROUP BENCHMARK 60 HANDICAP - 1400 metres**

**ATHOS** (K. Lau) – stood flat-footed as the start was effected and as a result was slow to begin. Trainer Ms S. Murphy was advised a warning would be placed on the gelding.

**RACE 7: THE MIDFIELD GROUP BENCHMARK 60 HANDICAP - 1400 metres (Cont'd)**

**ACTION IN RIO (NZ)** (J. Lorensini) – raced in restricted room on entering the straight and laid out under pressure in the straight.

**ANCIENT HISTORY (IRE)** (E. Finnegan) – Stewards declared ANCIENT HISTORY a late scratching at 4.23 pm on veterinary advice after taking hold of its rider en route the barriers making contact with the outside running rail.

**WESSELS** (D. Bates) – held up for clear running on entering the straight and in the vicinity of the 200 metres shifted in abruptly in an attempt to improve into clear running. Raced in restricted room over the concluding stages and was unable to be fully tested to the line.

**DANNY WIZZ BANG (NZ)** (J. Potter) – over-raced in the early and middle stages of the event.
