### Conditions Governing Official S.A.J.C., O.R.C. and Provincial Barrier Trials

- Trials are to be conducted under the supervision of Stipendiary Stewards.
- No horse shall take part under any but the correct registered name and a stable return must be lodged prior to the closing time of entries.
- Nominations for all Trials are lodged with Trainers Service Centre (TSC) on 1800 138 704 or online via StableAssist.
- Nominations close at 11:00am two (2) days prior to the scheduled date, or on Friday if the trials are scheduled on a Monday.
- Any Trial may be abandoned if less than five nominations are received excluding two-year-old trials wherein four nominations will be required to ensure the trial is conducted.
- No horse will be substituted for the one originally nominated.
- Only Jockeys and Apprentices will be permitted to ride in Trials, unless permission is granted under LR21B.2
- Trainers MUST declare riders prior to 3:00pm on the day of nominations for the trials.
- Trials in the Metropolitan and Provincial Area commence at 9:00am (unless otherwise advised). Approximately 15 minute intervals will be scheduled between trials.
- Every rider shall wear the colours as stated on the Horse's Stable Return.
- Fields will not be altered following their finalisation, without the Stewards permission.



### Notice: Barrier Trials

(Country Barrier Trials will run after the last race on raceday)  
Effective immediately the administration of all barrier trials in South Australia will be brought into line with the way that races are administered. Trial nominations and payments will no longer need to be done through the Club holding the trials.

#### NOMINATIONS

Nominations for trials close at 11am on the day of acceptances for the race meeting.  
Nominations are to be lodged with the Trainers' Service Centre (TSC) on 1800 138 704 or online via StableAssist

#### PAYMENT FOR TRIALS

All payments are made through the Racing SA Payment System.

#### TRIALS ARE NOT SCHEDULED OR RUN, UNDER THE FOLLOWING CIRCUMSTANCES:

- Twilight Meetings, due to the length of the workday and logistical considerations of travel.
- At the Clubs or Stewards discretion due to extenuating circumstances.
- Unsafe weather or track conditions
- Country Cup race meetings

Note however, that Racing SA reserves the right to alter or vary any of the arrangements under their control, as individual circumstances permit.
