

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Wednesday, 3 April 2019

After arriving on course, Stewards were advised that there was a fault with the optics cable somewhere between Adelaide and Sydney, resulting in vision being unable to be broadcast off course. However, there was a possibility that the fault could be rectified given time for external technicians to ascertain and rectify the issue. Acting on this advice Stewards put all races back one race time and rescheduled Race 8 to be run at 5.25 pm.

RACE 1: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1700 metres

KARAOKE EXPRESS (R. Hurdle) - inconvenienced on jumping away.

BARRYMORE (D. Tourneur) - jumped away awkwardly and shifted in onto KARAOKE EXPRESS. Held up for clear running from the vicinity of the 500 metres until approaching the 100 metres when it was obliged to alter course to obtain clear ground.

BIG BUDS (T. Pannell) - jumped away awkwardly and shifted in onto THE BROWN DIVA. Raced wide without cover throughout the event.

COUNTRY COP (J. Toeroek) - raced keenly in the early and middle stages of the event. Brushed with MINT TO BE, which laid out under pressure over the concluding 200 metres.

GREAT REBELLION (M. Autier) - slow to begin.

MINT TO BE (C. Jones) - laid out under pressure over the concluding 200 metres brushing with COUNTRY COP.

THE BROWN DIVA (J. Maund) - inconvenienced on jumping away.



RACE 2: CRABB SHELLGRIT / SABOIS MAIDEN PLATE - 1200 metres

DR CHOCCY (D. Tourneur) - hung out rounding the home turn and shifted wider on the track. Rider reported that the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

THE ULSTERMAN (R. Hurdle) - shifted in on jumping away onto MR RANGER.

ULTIMATE REALITY (S. Cahill) - late scratching on veterinary advice at 1.35 pm that the gelding had lost its composure and was unable to be saddled.

CUT THE STRINGS (B. Vorster) - rider explained that the gelding had travelled well in the early and middle stages of the event; however, when placed under pressure in the vicinity of the 400 metres failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

LIPPSY SHUFFLE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

MR RANGER (K. Bishop) - inconvenienced on jumping away. In the vicinity of the 650 metres improved onto the heels of SERIOUS SPENDER and had to be steadied.

OLIVE GROVE (J. Holder) - jumped away awkwardly.

REGALO DI GAETANO (J. Toeroek) - rolled in towards WHERE'S THE BOSS in the vicinity of the 300 metres.

WHERE'S THE BOSS (J. Maund) - shifted in and away from REGALO DI GAETANO in the vicinity of the 300 metres and became awkwardly placed on the heels of BURNING THE CLOCK for a short distance.

RACE 3: BAROSSA CIDER CO / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

DEXTINY (J. Potter) - improved onto the heels of HUSHIANO inside the 100 metres and was obliged to alter course.

MISS FORBIDDEN (J. Huxtable) - jumped away awkwardly and shifted out brushing HUSHIANO.

COSMIC AWARD (T. Pannell) - jumped away awkwardly.

HUSHIANO (J. Maund) - jumped away awkwardly and shifted in brushing MISS FORBIDDEN.

REGAL DOMAIN (K. Bishop) - raced fiercely and greenly in the early and middle stages of the event and in the vicinity of the 600 metres shifted out contacting RITZY DIVA. A post-race veterinary examination revealed no visible abnormalities.

RITZY DIVA (A. Jordsjo) - inconvenienced in the vicinity of the 600 metres when contacted by REGAL DOMAIN.

SUGAR WITH THAT (D. Tourneur) - kicked in its float en route to the course. Underwent a prerace veterinary examination on arrival on course and found to be lame in the near hind leg. Acting on this advice Stewards withdrew SUGAR WITH THAT at 12.53 pm.

THE IRON LADY (C. Jones) - slow into stride. Rider reported that the filly was unable to maintain contact with the field in the early stages of the event despite her efforts; however, had finished the event off well.

VENTRILOQUISM (R. Clark) - jumped away awkwardly. Laid in under pressure in the straight.



RACE 4: COOPERS BENCHMARK 64 HANDICAP - 2100 metres

SHAKOPEE (GB) (S. Logan) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

ALL WELL (IRE) (A. Jordsjo) – jumped away awkwardly. Rider explained that it was her intention to lead in today's event; however, after forming the view passing the winning post on the first occasion that she would be unable to cross CAUSE WE CAN, she had elected to attempt to restrain and take cover behind that mare. She added that she was unable to do so as ALL WELL (IRE) continued to race fiercely, and for that reason she elected to position the gelding three-quarters of a length back to the outside of the mare.

RACE 5: HOLDFAST INSURANCE CLASS TWO HANDICAP - 1500 metres

BOHEMIAN FOREST (J. Holder) - had to be checked in the vicinity of the 1200 metres when SPLASH SOME CASH was taken in. Shortly afterwards commenced to race fiercely for several hundred metres.

PRINCE MONARCH (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

CARBONE (C. Lions) - jumped away awkwardly. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SPLASH SOME CASH (J. Potter) – hampered when taken in onto BOHEMIAN FOREST, in the vicinity of the 1200 metres by FIRST KISS. Stewards questioned J. Potter in relation to his tactics in today's event. Rider explained that he had been given no instructions as was normally the case with this horse, but he anticipated with the slightly longer journey and better barrier draw in today's event he would settle somewhere around midfield. He added that after jumping away well he found himself further forward than he had anticipated. He further added that at the gelding's previous run at Balaklava he was again given no instructions but he had settled further back due to the gelding's wide gate and it not beginning as well as runners to his inside. Trainer, Mr D. Page, confirmed that he does not give instructions to J. Potter on the gelding and allows him to ride it where comfortable.

WYUNA (T. Pannell) - held up for a number of strides in the vicinity of the 300 metres.

FIRST KISS (M. Autier) – in the vicinity of the 1200 metres shifted in when insufficiently clear of SPLASH SOME CASH, taking that horse in onto BOHEMIAN FOREST, which was forced to check. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 7 April 2019 and to conclude at midnight Saturday, 13 April 2019, a period of 3 meetings.

RACE 6: ANZAC DAY RACES - APRIL 25 FILLIES & MARES BENCHMARK 64 HANDICAP - 1100 metres

RUSTYDUSTYSUNSHINE (K. Lau) – lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

MAGNA BELLA (S. Cahill) - raced wide without cover throughout the event.

EXALTED MAXINE (A. Jordsjo) - raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SOCIAL MEDIA (S. Logan) - laid in under pressure in the straight.

ZUME FORWARD (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.



RACE 6: ANZAC DAY RACES - APRIL 25 FILLIES & MARES BENCHMARK 64 HANDICAP - 1100 metres (cont'd)

STAY SASSY (S. Fawke) - jumped away awkwardly and was slow to begin.

RACE 7: GOLDIN FARMS BENCHMARK 64 HANDICAP - 1700 metres

ACE ATTACK (C. Jones) - slow to begin. In the vicinity of the 600 metres shifted out slightly onto FRENCH RESPONSE. A post-race veterinary examination revealed no visible abnormalities.

CLASSIC WEIWEI (B. Vorster) - raced keenly in the early and middle stages of the event.

IGITUR (R. Clark) - jumped away awkwardly. A post-race veterinary examination revealed a minor laceration to the near fore cannon. First aid applied.

HOLY JUAN (S. Fawke) - shifted out at the entrance to the straight contacting FRENCH RESPONSE. Rider returned to scale 1 kg under the allotted weight. S. Fawke pleaded guilty to a charge under AR209(2)(b)(a) in that he was the person at fault in relation to the horse failing to carry the correct weight and was fined \$1000.

FRENCH RESPONSE (J. Holder) - had to take hold inside the 600 metres when racing in restricted room between the heels of KAZOOM (NZ) and ACE ATTACK, which shifted out slightly. Inconvenienced at the entrance to the straight when HOLY JUAN shifted out making contact with the filly. A post-race veterinary examination revealed a minor laceration to the near fore fetlock. First aid applied.

ZAALADD (L. Goomany) - laid out under pressure in the straight.

EXALTED JENNI (M. Autier) - slow to begin. Laid out under pressure in the straight. Rider accidentally dropped his whip in the vicinity of the 200 metres.

Following the race Stewards questioned S. Fawke (HOLY JUAN) in relation to returning to scale 1 kg under the allotted weight. After considering his explanation Stewards, acting under AR209(2)(a) disqualified HOLY JUAN, which had placed third. Acting under 209(2)(b)(a) Stewards declared the new placings to be:

1st No. 3 CLASSIC WEIWEI

2nd No. 4 IGITUR

3rd No. 7 FRENCH RESPONSE

4th No. 1 ACE ATTACK

RACE 8: KINGSFORD HOTEL BENCHMARK 60 HANDICAP - 1200 metres

BUCK'S ROW (J. Huxtable) - raced wide without cover throughout the event.

INCUBUS (NZ) (R. Clark) - had difficulty obtaining clear ground in the straight and in the vicinity of the 100 metres had be taken hold of when it improved onto the heels of ARCHWAY TO HEAVEN, which had commenced to give ground.

ARCHWAY TO HEAVEN (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

PORT TRIANO (D. Tourneur) - had difficulty obtaining clear ground in the straight.

WHITE JADE (S. Fawke) - laid out from the vicinity of the 600 metres until the entrance to the straight.



RACE 8: KINGSFORD HOTEL BENCHMARK 60 HANDICAP - 1200 metres (cont'd)

LAKHANI ROSE (J. Toeroek) - laid in under pressure in the straight.

MAXSAMIA (J. Potter) - jumped away awkwardly and was slow to begin.

PARTY SET (C. Lions) – laid in under pressure in the straight. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

CALL ME PENNY (D. McWhinney) - a post-race veterinary examination revealed no visible abnormalities.

KENTUCKY FIREBALL (L. Goomany) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.
