**RACE 1: DAVID WARD'S 50TH HANDICAP - 1000 metres**

**LI'L KONTRA** (C. MacFarlane) - hampered on jumping away. Raced keenly in the early and middle stages of the event. Laid out rounding the home turn. A post-race veterinary examination revealed minor lacerations to near hind leg First aid administered.

**KALAMON** (J. Toeroek) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**JOURNICA** (C. Jones) - hung out under pressure in the straight. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

**CARTIER TIARA** (T. Pannell) - jumped away awkwardly and was slow to begin.

**HEARTY LASS** (R. Clark) - jumped away awkwardly, shifted in abruptly hampering LI'L KONTRA, which was taken in onto STAR CENTRAL, which lost its position when taken in onto TROODLES.

**STAR CENTRAL** (J. Holder) - lost its position on jumping away.

**TROODLES** (B. Vorster) - inconvenienced on jumping away.

### **RACE 2: WINNING EDGE PRESENTATIONS HANDICAP - 1300 metres**

The start of this event was delayed approximately two minutes.

**LADY SILHOUETTE** (G. Cartwright) in the vicinity of the 900 metres shifted in and away from ZAGATO STAR onto MISS IDENTIFIED. Held up from the entrance to the straight until in the vicinity of the 250 metres.

**SWAMPLAND (NZ)** (C. MacFarlane) - stood flat-footed and was slow to begin. Trainer advised a warning had been placed on the mare.

**MISS IANO** (J. Holder) - severely hampered in the vicinity of the 400 metres when tightened onto LUCKY FLIPPER by MAGNUS MAGIC, which hung out.

**LUCKY FLIPPER** (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

**MISS IDENTIFIED** (J. Toeroek) - in the vicinity of the 900 metres had to be steadied and lost its position when it rolled out slightly at the same time as LADY SILHOUETTE shifted in slightly. A post-race veterinary examination revealed no visible abnormalities.

**MAGNUS MAGIC** (S. Fawke) - hung out rounding the home turn and in the vicinity of the 400 metres shifted out onto MISS IANO. Continued to lay out under pressure in the straight.

**ZAGATO STAR** (H. Grace) - fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and passed fit to race. Jumped away awkwardly. Rolled in, in the vicinity of the 900 metres onto LADY SILHOUETTE. Lost its near hind plate during the event.

### **RACE 3: 36° SOUTH HANDICAP - 2250 metres**

**AZURO (FR)** (L. Riordan) - in the vicinity of the 800 metres improved onto the heels of THE BEDOUIN (IRE) and shifted out inconvenienced GOLD MAESTRO. Rolled out and bumped GOLD MAESTRO approaching the 600 metres.

**CHIVADAHLLII** (C. Jones) - stepped in momentarily in the vicinity of the 300 metres onto MELI MELO.

**VALAC (IRE)** (T. Pannell) - laid out under pressure in the straight.

**IVAN GROZNY (FR)** (K. Bishop) - raced keenly in the early and middle stages of the event.

**MELI MELO** (J. Holder) - taken in, in the vicinity of the 300 metres onto LIGHT THE WAVES by CHIVADAHLLII.

**MITRUST** (D. Thornton) - slow to begin.

**LIGHT THE WAVES** (B. Vorster) - had to be steadied in the vicinity of the 300 metres when MELI MELO was taken in.

**THE BEDOUIN (IRE)** (H. Grace) - stood flat-footed and was slow to begin. Trainer advised a warning had been placed on the gelding.

**GOLD MAESTRO** (J. Maund) - raced keenly in the middle stages of the event. Inconvenienced in the vicinity of the 800 metres when taken wider by AZURO (FR). Approaching the 600 metres rolled in and bumped AZURO (FR).

**RACE 4: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1250 metres**

**EXALTED ADAM** (G. Cartwright) - slow to begin. Held up from the entrance to the straight until the vicinity of the 100 metres.

**STAR PATRIOT** (T. Pannell) - held up from the entrance to the straight until the 250 metres when it was obliged to steady momentarily and alter course as GOING GAGA shifted out.

**GOING GAGA** (C. MacFarlane) - became held up in the vicinity of the 250 metres when it improved onto the heels of KILOWATT and altered course to the outside in an attempt to obtain clear ground. In doing so shifted out onto STAR PATRIOT, which had to be steadied. Rider reprimanded. Shortly after became held up for a number of strides on the heels of TYCOON DANCER approaching the 100 metres and was obliged to alter course to that gelding's inside to obtain clear ground.

**CROCKETT** (B. Vorster) - raced keenly in the early stages of the event.

**PALE ALE** (A. Jordsjo) - raced keenly in the early stages of the event when racing in restricted room between the heels of TYCOON DANCER and CROCKETT. Continued to race keenly through the middle stages.

**KILOWATT** (K. Bishop) - had difficulty in obtaining clear ground from the entrance to the straight until approaching the 100 metres.

**RACE 5: HUGHES LIMOUSINES HANDICAP - 1300 metres**

**SPIELBERG** (D. Thornton) - jumped away awkwardly and shifted in contacting TWICE FORGOTTEN.

**ARISTOCRATIC MISS** (B. Vorster) - jumped away awkwardly and was slow to begin. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**AIGUILLETTE** (J. Holder) - held up from the vicinity of the 400 metres until approaching the 200 metres.

**HE WILL BOOM** (G. Cartwright) - raced keenly in the middle stages of the event. Difficulty in obtaining clear ground and from the vicinity of the 500 metres until near the 200 metres.

**STOLEN AWAY (NZ)** (T. Pannell) - a post-race veterinary examination revealed an elevated heart rate.

**CAZABILLIE** (J. Toeroek) - jumped away awkwardly. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**TWICE FORGOTTEN** (S. Fawke) - contacted on jumping away.

**RACE 6: RED ROCK RIBS - JUNE 22 AT MORPHETTVILLE HANDICAP - 1000 metres**

**CELTIC BLAST** (J. Huxtable) - reared as the start was effected dislodging its rider. Trainer, Mr R. Cully was advised the gelding would be required to jump away with the field in an Approval to Race Jump Out or Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: RED ROCK RIBS - JUNE 22 AT MORPHETTVILLE HANDICAP - 1000 metres (Cont'd)**

**MOOR WANTED** (L. Riordan) - raced wide without cover throughout the event. Rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**QUIDDICK** (J. Toeroek) - a post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer Mr D. Tootell was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**BY THE POUND** (S. Price) - held up for a number of strides in the vicinity of the 300 metres.  
**CHEVAUX** (J. Holder) - held up from the entrance to the straight until inside the 200 metres.

**BE MY STAR** (B. Vorster) - had difficulty obtaining clear ground from the entrance to the straight until near the 300 metres.

**RACE 7: TAB HANDICAP - 1550 metres**

**NASEEB** (C. Jones) - raced keenly in the early and middle stages of the event. Raced in restricted room for a number of strides approaching the 100 metres and was unable to be tested over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**ROBBIE'S STAR** (D. Thornton) - hampered on jumping away when tightened between LA LA LUCHIE and COLESBERG. Had difficulty obtaining clear ground in the straight and became held up over the concluding 50 metres.

**LA LA LUCHIE** (R. Clark) - jumped away awkwardly and shifted in. Difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 100 metres. Hampered when taken wider by DON'T DISMISS.

**COLESBERG** (C. MacFarlane) - jumped away awkwardly and shifted out. Raced keenly in the early and middle stages of the event. Inclined to shift about under pressure in the straight.

**JACKTHEGIANTSLAYER** (G. Cartwright) - raced wide without cover throughout the event.

**DON'T DISMISS** (D. Tourneur) - shifted out in the vicinity of the 100 metres onto LA LA LUCHIE. Rider reprimanded.

**RACE 8: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE HANDICAP - 1400 metres**

**DIAPASON (NZ)** (T. Pannell) - difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 250 metres.

**REVLIS** (J. Lorensini) - raced keenly in the early and middle stages of the event. Contacted by SKY PUNCH (NZ) in the vicinity of the 200 metres.

**SILENT ICE** (R. Hurdle) - raced keenly in the early and middle stages of the event. Raced in restricted room for a number of strides between the vicinity of the 1200 metres and the 1000 metres when EAST INDIAMAN shifted in slightly.

**BULLET KID** (K. Bishop) - raced keenly in the middle stages of the event.

**BUNGALALLY BELLE** (R. Clark) - declared a non-starter (refer below)

**EAST INDIAMAN** (B. Vorster) - shifted in slightly onto SILENT ICE in the vicinity of the 1200 metres. Rider reminded of his obligations when shifting ground.

**ENKI** (G. Cartwright) - raced wide without cover throughout the event.

**RACE 8: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE HANDICAP**  
**- 1400 metres (Cont'd)**

**SKY PUNCH (NZ)** (C. MacFarlane) - raced keenly in the early and middle stages of the event. Approaching the 200 metres improved into a run where in the opinion of the Stewards there was doubtful room and in doing so made contact with REVLIS. Shortly after was hampered and forced to take hold when GIGGLON rolled out. Approaching the 100 metres had to be steadied for a number of strides when GIGGLON rolled out.

**WITH A BIT OF DASH** (L. Riordan) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

**GIGGLON** (C. Jones) - raced wide without cover throughout the event. Rolled out in the vicinity of 200 metres onto SKY PUNCH (NZ) and again in the vicinity of the 100 metres. Rider reminded of her obligations and advised in future to make a greater effort to keep her mounts straight when they commence to shift ground. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Ms S Jaensch was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

Correct weight was delayed to allow Stewards to review the start in relation to BUGALALLY BELLE. After doing so, Stewards determined the mare was held by a Barrier Attendant as the start was effected and as such was denied a fair start. Stewards declared BUNGALALLY BELLE a non-starter acting under AR204.

**GENERAL**

Stewards questioned rider D. Tourneur in relation to him using an ipad (tablet) in the jockey's room. D. Tourneur pleaded guilty to a charge under AR218(4)(c) and was fined \$100. In arriving at this penalty, Stewards were able to confirm that the rider was using the tablet to play music and had not used it to transmit any information.

Stewards questioned rider Liam Riordan in relation to the ipad (tablet), who explained that it was his ipad, that he had used it in the plane en route to Adelaide and had placed it in his riding bag upon landing. After considering his explanation L. Riordan was reprimanded under AR218(4)(a).
