

# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 25 May 2019

TRACK: Good 4 (Track with some give in it)

Downgraded to a Soft 5 @ 11 am (Track with a reasonable amount of give in it)

Downgraded to a Soft 6 @ 12.03 am retrospective to Race 1 (Moist but not a badly affected

track)

RAIL: Out 2 metres from 1000 metres to the 400 metres true remainder.

# RACE 1: MEDALLION HOMES HANDICAP - 1000 metres

LITTLE RICH BOY (S. Fawke) - inconvenienced at the start.

**ROCCABASCERANA** (T. Pannell) - inconvenienced at the start and as a result was taken out onto LITTLE RICH BOY.

**PREDICTS** (R. Clark) - inconvenienced when taken wider by LITTLE RICH BOY on jumping away. Rider reported the filly raced greenly throughout the event.

**TRANSVERSALE** (D. Tourneur) - very awkward to begin, shifted out inconveniencing ROCCABASCERANA, which was taken out onto LITTLE RICH BOY, which was inconvenienced when taken out onto PREDICTS. Inclined to lay in, in the straight.

**TUBBY TWO TRACKS** (J. Toeroek) - underwent a pre-race veterinary examination on arrival at the barriers and was found to have mucous discharge from both nostrils. A late scratching by order of Stewards at 11.53 am on veterinary advice. Trainer advised the results of a endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

## RACE 2: WINNING EDGE PRESENTATIONS HANDICAP - 1250 metres

LATE CHARGE (J. Eaton) - over-raced in the early stages of the event.

MAZUREK (K. Bishop) - raced wide without cover throughout the event.

**CREATIVITY** (T. Pannell) - laid out in the straight. Rider explained the mare travelled well until shortly after the entrance to the straight where it commenced to lay out under pressure and finished the race off in a disappointing manner. He added that the mare pulled up in a distressed state after the winning post. A post-race veterinary examination revealed a slow post-race recovery.



#### RACE 3: ADELAIDE GALVANISING HANDICAP - 1300 metres

REGALO DI GAETANO (C. Jones) - inclined to lay in, in the straight.

**BOLD STAR** (R. Clark) - underwent a pre-race veterinary examination in the raceday stall area and passed fit to race.

KLIPPEN (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**VIETTI** (B. Vorster) - raced keenly in the early stages of the event.

**ORBOST** (K. Crowther) - rider explained that despite travelling well early, she was unable to take up a more forward position than intended. She stated she would have preferred to settle outside JAY JAY D'AR (NZ). She further added that the filly was dour and failed to finish the event off as expected. She also stated the filly made two distinct breathing noises in the straight. A post-race veterinary examination revealed no visible abnormalities.

## RACE 4: TERRY HOWE PRINTING HANDICAP - 1950 metres

ALL TOO HUIYING (J. Huxtable) - began awkwardly, shifted in and hampered IMPULSE DIAVOLO.

MISS IDENTIFIED (J. Toeroek) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**LOSTARC** (P. Gatt) - inclined to lay in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

**DAKTARI** (J. Potter) - A post-race veterinary examination revealed no visible abnormalities.

IMPULSE DIAVOLO (J. Maund) - hampered at the start.

## RACE 5: AUSTRALIAN TRAINERS' ASSOCIATION HANDICAP - 1400 metres

**POLAR VORTEX** (J. Huxtable) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200. Rider reported the gelding was disappointing with its effort in the straight.

**SEE ME EXCEED** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

CANNOT BE SERIOS (NZ) (J. Eaton) - lost its near fore plate during the event.

**HIDATSA** (G. Lo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 6: TAB HANDICAP - 1550 metres

FAST CASH (J. Eaton) - raced wide without cover throughout the event.

**BORRIS IN OSSORY** (R. Clark) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$100.

**SKY PUNCH (NZ)** (S. Cahill) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.



## RACE 6: TAB HANDICAP - 1550 metres (Cont'd)

**AWAKE IN GRINZING (NZ)** (A. Jordsjo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**LOOKING AROUND (NZ)** (J. Huxtable) - a post-race veterinary examination revealed no visible abnormalities.

ZANAHARY (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

MAXSAMIA (K. Bishop) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**SMART STILETTO** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 7: HOLDFAST INSURANCE HANDICAP - 1000 metres

MILE HIGH (P. Gatt) - underwent a pre-race veterinary examination in the raceday stall area and passed fit to race. Very Awkward to begin, shifted out and hampered ARROW LANE.

**ARROW LANE** (S. Fawke) - hampered at the start. Near the 300 metres was obliged to be steadied and altered course to the outside of INSTITUTION, which was weakening.

ILLUMICON (B. Vorster) - inclined to lay out from rounding the home turn.

**HELLO GORGEOUS (NZ)** (J. Holder) - had difficulty obtaining clear running from shortly after the entrance to the straight and until in the vicinity of the 150 metres.

**AKKACAN** (K. Cowan) - near the 700 metres was obliged to race in restricted room for several strides. Laid in, in the straight.

**DENNIS** (J. Eaton) - awkward to begin.

I AM GRACIE (K. Crowther) - awkward to begin, shifted out and hampered KING'S SPIRIT, which lost its position when tightened onto HELLO GORGEOUS NZ). Laid out near the 700 metres. Approaching the 100 metres was momentarily inconvenienced when awkward inside the heels of ZARACE, which laid in and shifted in. A post-race veterinary examination revealed no visible abnormalities.

ZARACE (A. Jordsio) - laid in. in the straight and shifted in momentarily near the 100 metres.

**INSTITUTION** (G. Lo) - commenced to weaken from shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

KING'S SPIRIT (J. Potter) - lost its position when hampered at the start.

# RACE 8: DONATE AT NJTAPPEAL.COM.AU HANDICAP - 1250 metres

**MAGNUS KNIGHT** (J. Huxtable) - began awkwardly, shifted out and contacted MISSCINO, which was hampered when tightened onto MARINA and as a consequence, MARINA was also hampered. Raced keenly for a short distance between the 1000 metres and the 700 metres.



# RACE 8: DONATE AT NJTAPPEAL.COM.AU HANDICAP - 1250 metres (Cont'd)

CHAROSSA (R. Hurdle) - very awkward and slow to begin. Approaching the 100 metres was obliged to be steadied when tightened between BY THE POUND, which shifted in under riding and MUSICAL QUERY, which shifted out and away from ROTHMOORE, which was inclined to lay out and shifted out. As a consequence, CHAROSSA was unable to maintain its position and had to be steadied. Thereafter, was hampered approaching the finish when tightened by OH MO, which shifted in under pressure resulting in CHAROSSA becoming awkward on the heels of BY THE POUND for several strides.

**BY THE POUND** (S. Price) - near the 800 metres got its head up and raced ungenerously for a short distance. Approaching the 100 metres shifted in under riding and tightened CHAROSSA onto MUSICAL QUERY. Rider severely reprimanded for shifting ground when insufficiently clear.

KNOTTED (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

**MUSICAL QUERY** (A. Jordsjo) - underwent a pre-race veterinary examination and passed fit to race. near the 100 metres shifted out and away from ROTHMOORE.

**OH MO** (D. Tourneur) - slow to begin. Raced keenly for a short distance in the vicinity of the 800 metres. Approaching the entrance to the straight raced in restricted room to the outside of MARINA for several strides. Approaching the finish was inclined to lay in, shifted in and tightened CHAROSSA onto the heels of BY THE POUND.

RAHEEBA (J. Toeroek) - rider reported the gelding over-raced during the event.

MARINA (S. Fawke) - hampered at the start. Raced ungenerously in the early stages of the event. Near the entrance to the straight when improving his position to the outside of CHAROSSA was obliged to race in restricted room for several strides when OH MO improved to its outside and as a consequence shorlty after the entrance to the straight had to be checked, clipped the heels of CHAROSSA and knuckled.

ROTHMOORE (J. Holder) - near the 100 metres shifted out for several strides.

MISSCINO (P. Gatt) - hampered at the start.

Correct weight was delayed to allow D. Tourneur (OH MO) and Trainer Mr S. Burford, to view the vision in the straight.
