## RACE 1: ATLAS EVENT AND PARTY HIRE / SABOIS FOUR-YEAR-OLD & OVER MAIDEN PLATE - 1050 metres

**WEDGEBROOK** (J. Maund) – hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**ALL THINGS NICE** (R. Hurdle) – held up for clear running from the vicinity of the 500 metres until inside the 400 metres.

**NASIFA** (T. Pannell) - in the vicinity of the 700 metres was obliged to be restrained after improving onto the heels of RITING ON THE WALL.

RITING ON THE WALL (K. Bishop) - shifted its near fore plate in running.

#### RACE 2: COOPERS CLASS TWO HANDICAP - 1400 metres

**CRONAUER (NZ)** (S. Cahill) - shifted out on jumping away contacting RAINMOTH.

**BUSKER'S BALLAD** (S. Price) – contacted on jumping away by AY OH WHEY OH, which shifted out, and as a result was taken across the heels of YOU ES MARSHAL and was obliged to be restrained.

**RAINMOTH** (K. Lau) - contacted on jumping away. Laid in under pressure in the straight.

SMART ALICK (D. Tourneur) - jumped away awkwardly and shifted in contacting RAINMOTH.



# RACE 2: COOPERS CLASS TWO HANDICAP - 1400 metres (Cont'd)

YOU ES MARSHAL (K. Bishop) - over-raced in the early and middle stages of the event.

**AY OH WHEY OH** (L. Goomany) – jumped away awkwardly and shifted out taking BUSKER'S BALLAD across the heels of YOU ES MARSHAL.

## RACE 3: HEINIGER / SABOIS THREE-YEAR-OLD BENCHMARK 60 HANDICAP - 1300 metres

**LUCKY BREAK** (J. Toeroek) – laid in under pressure in the straight. A post-race veterinary examination revealed the gelding had bled from both nostrils. Co-trainers, Mr R & Miss C. Jolly, were advised that as this was LUCKY BREAK's first bi-lateral bleed it would now be suspended from racing for a period of three months in accordance with AR79(4) and was required to gallop 1000 metres in the presence of a Steward prior to a future trial or race.

**CURTAIN CALL** (R. Hurdle) – held up for clear running from the vicinity of the 500 metres until inside the 400 metres.

**CROWN HARMONIUM** (S. Fawke) – refused to load. Stewards declared CROWN HARMONIUM a late scratching at 1.22 pm. Trainer, Mr J. Hickmott, was advised that the filly was required to load without delay in two consecutive Official Barrier Trials prior to a future race.

**BEDLOE'S ISLAND** (K. Bishop) - raced wide without cover throughout the event.

## RACE 4: TAB / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1050 metres

**COUNTER DRIVE** (J. Chau) – in the vicinity of the 500 metres shifted in when insufficiently clear of QUEEN'S SONG, which was taken in onto PAM'S JOURNEY, which was taken in onto KOODA MISCHIEF, which was forced to be checked. Shortly thereafter continued to shift in taking KOSTYA in onto UNDESIRE, which was forced to be checked. Rider reprimanded under AR131(a) and reminded of his obligations to be fully clear when shifting ground in future.

**KOODA MISCHIEF** (K. Bishop) – in the vicinity of the 500 metres was forced to be checked to avoid the heels of PAM'S JOURNEY, which was taken in by QUEEN'S SONG, which was taken in by COUTER DRIVE, which shifted in when insufficiently clear. KOODA MISCHIEF was also hampered by UNDESIRE, which was forced to be checked to avoid the heels of KOSTYA, which was taken in by COUTNER DRIVE.

**KOSTYA** (R. Hurdle) – laid in rounding the home turn. In the vicinity of the 500 metres was taken in onto UNDESIRE by COUNTER DRIVE, which shifted in.

**MONET** (L. Goomany) – refused to load. Stewards declared MONET a late scratching at 1.57 pm. Trainer, Mr A. Webster, was advised that the gelding was now required to load without delay in an Official Barrier Trial or Approval to Race Jump Out prior to a future race start.

**REBEL TANTRUM** (K. Cowan) – laid out rounding the home turn. Trainer, Ms S. Kotz, was advised that a warning had been placed on the gelding in relation to its pre-race manners after proving difficult to proceed to the barriers.

EVERY WISH (K. Lau) - jumped away awkwardly.

**PAM'S JOURNEY** (T. Pannell) – over-raced in the early stages of the event. In the vicinity of the 500 metres was taken in onto KOODA MISCHIEF by QUEEN'S SONG, which was taken in by COUNTER DRIVE, which shifted in when insufficiently clear.

**QUEEN'S SONG** (J. Holder) – in the vicinity of the 500 metres was taken in onto PAM'S JOURNEY, by COUNTER DRIVE, which shifted in when insufficiently clear.

# RACE 4: TAB / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1050 metres (Cont'd)

**UNDESIRE** (J. Toeroek) – in the vicinity of the 500 metres was forced to be checked to avoid the heels of KOSTYA, which was taken in by COUNTER DRIVE.

## RACE 5: ADELAIDE GALVANISING INDUSTRIES / SABOIS MAIDEN PLATE - 1400 metres

**NEAR MAGIC** (K. Lau) – in the vicinity of the 150 metres was obliged to be restrained to avoid the heels of HOLY TORMENT, which was hampered in front. Was unable to obtain clear running for the remainder of the event and ran to the line untested.

**RESPECTABLE** (J. Potter) - over-raced in the early and middle stages of the event.

**RISING THUNDER** (T. Pannell) – when questioned regarding the performance of the horse rider stated that the horse failed to travel at any stage of the event and was disappointing in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

**KEN'S THUNDER** (S. Cahill) – began awkwardly, shifted in and contacted BAD MOON RISING. Laid in under pressure in the straight. Held up for clear running from the vicinity of the 400 metres until inside the 100 metres.

**BAD MOON RISING** (S. Fawke) - hampered on jumping away by KEN'S THUNDER, which shifted in.

CALYPSO STORM (S. Logan) - laid out under pressure in the straight.

**HALMICH** (A. Jordsjo) – Trainer, Mr J. Hyam, was fined \$100 under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards. Mr Hyam was advised that the Thoroughbred Identification Card was required to be presented prior to a future race start. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HOLY TORMENT** (K. Cowan) – in the vicinity of the 100 metres was forced to be checked to avoid the heels of MOVANDI, which laid in despite the efforts of its rider.

**MOVANDI** (J. Holder) – laid in under pressure in the straight and in the vicinity of the 100 metres laid in despite the efforts of its rider hampering HOLY TORMENT. A post-race veterinary examination revealed no visible abnormalities. Mr T. Stokes, representing Mr P. Stokes, was advised that a warning had been placed on the filly in relation to hanging in.

**STAR QUEST** (J. Toeroek) - over-raced in the early and middle stages of the event.

## RACE 6: BARDRILL BENCHMARK 56 HANDICAP - 1200 metres

**SCOUT'S HONOUR** (S. Price) - in the vicinity of the 900 metres was obliged to be checked to avoid the heels of VENTRILOQUISM, which had to be checked to avoid the heels of FUGITIVE, which was taken in by CAPTAIN CALIFORNIA, which shifted in when insufficiently clear.

**CAPTAIN CALIFORNIA** (S. Cahill) – in the vicinity of the 900 metres shifted in when insufficiently clear of FUGITIVE, which was taken in onto VENTRILOQUISM, which was forced to be checked. In the incident SCOUT'S HONOUR, which was following VENTIRLOQUISM, was forced to be checked to avoid that runner's heels. ZAAZOE was also forced to be checked to avoid the heels of VENTRILOQUISM. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 1 June 2019 and to conclude midnight Saturday, 8 June 2019, a period of three meetings.



# RACE 6: BARDRILL BENCHMARK 56 HANDICAP - 1200 metres (Cont'd)

**VENTRILOQUISM** (J. Chau) – in the vicinity of the 900 metres was forced to be checked to avoid the heels of FUGITIVE, which was taken in by CAPTAIN CALIFORNIA. In the incident VENTRILOQUISM lost a number of strides. Lost its off hind plate in running. A post-race veterinary examination revealed no visible abnormalities.

**FUTAGO** (J. Holder) – began awkwardly. In the vicinity of the 900 metres was obliged to be steadied and shift wider on the track to avoid the heels of ZAAZOE.

**RUSHWA** (T. Pannell) - lost its near fore plate during the event.

**ANCIENT HISTORY (IRE)** (D. Tourneur) – began awkwardly. In the vicinity of the 900 metres was taken wider by FUTAGO, which was forced to take evasive action to avoid the heels of ZAAZOE. A post-race veterinary examination revealed the gelding to have bled from both nostrils. Trainer, Mr D. Saxon, was advised that as this was the ANCIENT HISTORY (IRE)'s first bi-lateral bleed it was now suspended for a period of three months in accordance with AR79(4) and was required to gallop 1000 metres in the presence of a Steward prior to a future trial or race.

**ZAAZOE** (J. Maund) – in the vicinity of the 900 metres was forced to be checked and lost considerable distance when avoiding the heels of VENTRILOQUISM. A post-race veterinary examination revealed no visible abnormalities.

**FUGITIVE** (S. Fawke) – awkward to begin. In the vicinity of the 900 metres was taken in by CAPTAIN CALIFORNIA onto VENTRILOQUISM, which was forced to be checked.

## RACE 7: TAYLORS WINES BENCHMARK 60 HANDICAP - 2200 metres

RUN FOR SUCCESS (T. Pannell) - jumped away awkwardly. Laid out under pressure in the straight.

**SHAKOPEE (GB)** (R. Hurdle) – held up for clear running from the vicinity of the 500 metres until approaching the 200 metres and was disappointed for a run between RUN FOR SUCCESS and DANOULI, which shifted out. Obtained clear running from approaching the 100 metres.

LA LA LUCHIE (J. Chau) - began awkwardly.

**DANOULI** (S. Fawke) - laid out under pressure in the straight.

**MAJESTIC RIDGE** (J. Potter) – slow to begin. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**CONNERMARA ROSE** (G. Lo) – in the vicinity of the 1800 metres rolled out contacting LORD GREYSON.

**ANOTHER MARTINI** (A. Jordsjo) – in the vicinity of the 1900 metres was momentarily inconvenienced by SHAKOPEE (GB), which rolled out, and RUN FOR SUCCESS, which was taken in by ALDOLPHIN, which shifted in marginally. Raced wide without cover throughout the event. Held up for clear running over the concluding stages of the event.

**LORD GREYSON** (S. Logan) – in the vicinity of the 1800 metres was momentarily inconvenienced by CONNERMARA ROSE, which shifted out, turning the hind-quarters of LORD GREYSON.

MANILOW (J. Maund) - held up for clear running from the 500 metres to the 400 metres.

#### RACE 8: HAULMARK TRAILERS BENCHMARK 60 HANDICAP - 1600 metres

GRAND ARMADA (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

**GORILLE** (T. Pannell) - laid in under pressure in the straight.



# RACE 8: HAULMARK TRAILERS BENCHMARK 60 HANDICAP - 1600 metres (Cont'd)

**QUAFFANY** (B. Vorster) - raced greenly when placed under pressure in the straight.

**UNSCOPEABLE** (K. Lau) – in the vicinity of the 800 metres dipped for no apparent reason. In the vicinity of the 400 metres was momentarily inconvenienced and obliged to be restrained to avoid the heels of COBBERS MATE, and forced to shift in to improve into clear running. A post-race veterinary examination revealed no visible abnormalities.

BARSHONTI (J. Holder) - laid in under pressure in the straight.

**COBBERS MATE** (S. Fawke) - in the vicinity of the 400 metres shifted out when insufficiently clear of UNSCOPEABLE. Rider reprimanded.

**PERCY KIWA** (D. Tourneur) - slow to begin.
