

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Bordertown Racecourse by the Bordertown Racing Club on Sunday, 25 August 2019

RACE 1: BORDER AG / SABOIS MAIDEN PLATE - 1550 metres

BURHAN (P. Gatt) - underwent a pre-race veterinary examination as the gelding had not raced in over a year and passed fit to race. In the vicinity of the 300 metres contacted by GOZZO, which rolled out.

GOZZO (D. Tourneur) - in the vicinity of the 300 metres rolled out and contacted BURHAN.

HASTA LA FIORENTE (J. Huxtable) - raced fiercely in the early and middle stages of the event.

SPIRIT OF CHARM (R. Clark) - dislodged rider in the mounting yard and contacted a perimeter fence. Rider was examined by the First Care Medical Personnel and passed fit to fulfil her engagement. Underwent a pre-race veterinary examination and passed fit to race. Raced keenly in the middle stages of the event. Approaching the 250 metres was momentarily held up on the heels of BURHAN, which began to weaken.

IRONIC SMILE (L. Neindorf) - laid in, in the straight.

RACE 2: O'CONNORS BENCHMARK 64 HANDICAP - 1550 metres

PARADISE COVE (USA) (A. Lindsay) - laid in, in the straight.

RIGHT AND READY (A. Jordsjo) - from the entrance in the straight was disappointed for clear running until the 300 metres. Rider explained shortly after straightening the gelding was inclined to lay out and over the concluding stages she had became concerned with its action. A post-race veterinary examination revealed no visible abnormalities.

TEMEYEZ (S. Fawke) - jumped away awkwardly and as a result was slow to begin.

MAGIC NAME (L. Neindorf) - raced keenly in the early and middle stages of the event.

RACE 3: MICHELLE'S PET & HOME SERVICE / SABOIS MAIDEN PLATE - 1300 metres

PROVOCATIVE MAN (R. Hurdle) - slow to begin. Rider explained after being slow to begin, he had to encouraged his mount to maintain contact with the field. He added that approaching the home turn, he elected stay on the fence and ride for luck rather than to attempt a run around the field. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Trainer Mr R. Wilson was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

ANY EXCUSE (K. Crowther) - approaching the 300 metres was momentarily held up on the heels of NIORD and was obliged to shift to the outside of that gelding to obtain clear ground.

GOOD GIRL BELLA (S. Fawke) - raced wide throughout the event. Raced greenly in the early stages . Laid out rounding the home turn.

GUANABA GIRL (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

LUCKY CLUB (T. Voorham) - in the vicinity of the 100 metres was bumped by TRIVIA.

TEXAS LIL (P. Gatt) - contacted a perimeter fence en route to the barriers. Underwent a pre-race veterinary examination and passed fit to race. Jumped away awkwardly. Held up for clear running from the 400 metres until the 200 metres.

TRIVIA (L. Neindorf) - laid in, in the straight. In the vicinity of the 100 metres shifted in and bumped LUCKY CLUB.

RACE 4: BORDERTOWN STONE SUPPLIES / SABOIS MAIDEN PLATE - 1100 metres

LIBERTY BLUE (S. Fawke) - raced fiercely throughout. Hung out from the 700 metres until the entrance to the home straight. Rider reported that he elected not to ride the gelding to the finish in his normal manner due to LIBERTY BLUE's racing manners. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr S. Whittle was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

LOHN RANGER (C. Lions) - contacted a perimeter fence en route to the barriers. Underwent a pre-race veterinary examination and passed fit to race. Raced greenly throughout. Laid out from the 600 metres.

KALAMON (P. Gatt) - shifted out on jumping away. Laid out from the 500 metres placing the rider at a disadvantage for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

MISS FLATLEY (E. Boyd) - raced keenly in the early stages of the event.

RAGTIME LIL (L. Goomany) - laid out from the 500 metres until the entrance to the straight.

RASUMADOLE (L. Neindorf) - slow to begin. laid in, in the straight placing its rider at a disadvantage.

RACE 5: LIVING TURF BENCHMARK 60 HANDICAP - 2000 metres

SILVER JEWEL (P. Gatt) - in the vicinity of the 1500 metres improved onto the heels of HASTA LA SPEC and was obliged to be steadied. Laid in, in the straight.

TOMMY GUN (S. Fawke) - approaching the 1500 metres was obliged to be steadied when improving onto the heels of CENTENARY SHOT.

RACE 5: LIVING TURF BENCHMARK 60 HANDICAP - 2000 metres

CENTENARY SHOT (R. Hurdle) - approaching the 1500 metres improved onto the heels of ZAALADD and was obliged to take hold.

COBBERS MATE (J. Potter) - held up for clear running between the 400 metres and the entrance to the straight.

BARSHONTI (R. Clark) - laid in, in the straight. In the vicinity of the 300 metres shifted in and bumped UNRELATED. A post-race veterinary examination revealed no visible abnormalities.

UNRELATED (D. Tourneur) - in the vicinity of the 300 metres bumped by BARSHONTI.

FREE THE WIND (K. Crowther) - raced keenly in the early and middle stages of the event. Rider explained in her opinion the horse did not back up from its most recent run at Gawler on the 21st of August. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: TATIARA CARPET CLEANING BENCHMARK 60 HANDICAP - 1100 metres

JUST A BIGGER DASH (L. Neindorf) - underwent a pre-race veterinary examination as it had not raced in 12 months and passed fit to race. Raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

FLAUBERT'S GIFT (J. Huxtable) - underwent a pre-race veterinary examination as it had not raced in 12 months and passed fit to race. Laid out throughout the event placing its rider at a disadvantage. A post-race veterinary examination revealed no visible abnormalities.

TECOFSKY (G. Lo) - laid in, in the straight.

TRIPLE ESS (J. Maund) - jumped away awkwardly. Raced in restricted room for a short distance in the vicinity of the 900 metres between PICAYUNE, which rolled in and PARTY SET, which rolled out.

AKERBOY (A. Jordsjo) - laid in, in the straight. Rider explained that her instructions were to take cover in the early stages of the event and make one run at them in the straight, She further added that approaching the 400 metres the gelding had improved into a run to the inside of TECOFSKY, which in her opinion due to the formation of the field she would unable to have clear running and would be more advantaged to wait and shift to the outside of TECOFSKY to gain a clear run to the line. At the entrance of the straight she was able to shift to the outside of TECOFSKY and had an unimpeded run to the finish. Trainer J. Searle confirmed these instructions. Stewards noted A Jordsjo's explanation. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow J. Potter (BEEJAY'S HERO) placed fourth to view the official footage.

RACE 7: MCCARTHY TRANSPORT BENCHMARK 56 HANDICAP - 1300 metres

OLATUNJI (J. Maund) - approaching the 100 metres raced in restricted room for a short distance between HARBOUR EXPRESS, which rolled out and WILLOCHRA, which rolled in.

HARBOUR EXPRESS (S. Fawke) - approaching the 100 metres rolled out tightening the running of OLATUNJI.

GARGAMEL (C. Lions) - jumped away awkwardly. Raced wide without cover throughout the event. Laid in from the 400 metres and shifted in, in the vicinity of the 200 metres into the running of DABAY. Rider reprimanded and advised to straighten her mounts sooner when they commence to shift ground.



RACE 7: MCCARTHY TRANSPORT BENCHMARK 56 HANDICAP - 1300 metres (Cont'd)

DABAY (R. Hurdle) - approaching the 200 metres obliged to be steadied to avoid the heels of GARGAMEL, which shifted in.

WILLOCHRA (L. Neindorf) - disappointed for clear running between the 500 metres and the 300 metres. Approaching the 100 metres rolled in and tightened the running of OLATUNJI.

HOLY TRILOGEY (T. Voorham) - refused to proceed to the barriers. Stewards declared HOLY TRILOGEY a late scratching at 4.54 pm. Trainer Mr S. Burford was advised a warning had been placed on the gelding.
