RACE 1: CAUDO WINES / SABOIS MAIDEN PLATE - 1600 metres

WICKED ALIBI (P. Gatt) - inclined to lay out in the straight.

CHAPPETTE (G. Lo) - laid in, in the straight.

DISTANT PROMISE (J. Chau) - approaching the 1000 metres commenced to race keenly and became awkwardly placed on the heels of HOLY SANGRIA for a number of strides. Thereafter near the 500 metres was obliged to be checked as HOLY SANGRIA, which had to be restrained when awkward on heels, shifted out into its running line.

GLORY GAME (R. Clark) - began very awkwardly with its head up in the air, thereafter continued to throw its head up in the air for some distance shortly after the start, placing its rider at a disadvantage, losing contact with the field and finished tailed off. Rider reported in her opinion. the filly resented the tongue-tie fitted as gear. In view of the filly's performance. Co-Trainer Mr L Macdonald was advised the filly would be required to prove tractable in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed the filly to be lame in the off foreleg. Co-Trainer Mr L. Macdonald was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.



#### RACE 1: CAUDO WINES / SABOIS MAIDEN PLATE - 1600 metres

**HOLY SANGRIA** (E. Boyd) - near the 500 metres rolled in, became awkwardly placed on the heels of FRANK GOES BOOM and when being restrained, shifted out into the running of DISTANT PROMISE, which had to be checked. Laid in, in the straight. Rider reported the filly was inclined to lay in, in the early stages of the event despite her efforts.

MASTER OF ZERPRISE (J. Toeroek) - near the 500 metres was obliged to alter course to the outside of DISTANT PROMISE after that horse was checked.

#### RACE 2: SCHWEPPES / SABOIS MAIDEN PLATE - 1200 metres

LOFTY TYCOON (R. Hurdle) - awkward to begin.

FOLLOW THE PROMPTS (J. Potter) - awkward to begin.

**AUSTIN RAIDER** (J. Holder) - laid in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**GOLDEN RIPPLES** (T. Voorham) - reared, awkward and slow to begin. Raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**MAYSHEWIN** (G. Lo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

#### RACE 3: HIT107 / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1050 metres

MY MISTER BROOKS (E. Boyd) - laid out throughout in the straight. Shifted out approaching the 200 metres.

CALL ME WENDALL (R. Hurdle) - slow to begin.

DARK SENTRY (R. Clark) - contacted at the start.

**DOUBLE BLUE** (D. Tourneur) - lost its off hind plate during the event.

**MOSHAVA DEE** (T. Pannell) - awkward to begin. Shifted in and contacted DARK SENTRY. Approaching the 400 metres rolled in momentarily and tightened ZIP AKEED, which was obliged to be checked losing its position. A post-race veterinary examination revealed no visible abnormalities.

**ZIP AKEED** (J. Chau) - approaching the 400 metres, after improving into a run between KRUPTONITE to its inside and MOSHAVA DEE to its outside, was obliged to race in restricted room for a number of strides, before being checked when tightened momentarily by MOSHAVA DEE, which rolled in. As a consequence ZIP AKEED was unable to maintain its positon. After inquiring into the incident, Stewards deemed no rider at fault in relation to the matter.

**POSSUM BORN** (G. Lo) - shifted in approaching the 200 metres and became awkward outside the heels of MY MISTER BROOKS, which shifted out after laying out.

#### RACE 4: TAB CLASS ONE HANDICAP - 1050 metres

MASTER CHUM (T. Voorham) - laid in, in the straight.



## RACE 4: TAB CLASS ONE HANDICAP - 1050 metres (Cont'd)

RAPID RAISER (J. Chau) - contacted at the start. In the vicinity of the 700 metres was momentarily inconvenienced by STAR PARFAIT, which shifted out abruptly and was taken a little wider on the track. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

**SECRET WAR** (J. Maund) - rider explained the gelding changed stride continuously throughout the event. Laid out in the straight.

**TAKEN OFF** (G. Lo) - shifted out near the 300 metres and thereafter again on several occasions to the finish and in doing so inconvenienced STAR PARFAIT on a number of occasions. Rider was severely reprimanded and advised to straighten his mounts when they commence to shift ground. A post-race veterinary examination revealed no visible abnormalities.

STAR PARFAIT (J. Holder) - Stewards permitted J. Holder to ride the filly 0.5 kg over its declared weight of 54kg. Awkward to begin, shifted out and contacted RAPID RAISER. Over-raced in the early stages and near the 700 metres got its head up, raced very ungenourously for a short distance and became awkward on the heels of ALPHA CHEW CHEW, as a consequence shifted out and inconvenienced RAPID RAISER. Laid in at various stages in the straight. Hampered by TAKEN OFF on several ocassions from the 300 metres to the finish as that horse continued to shift out.

**ALPHA CHEW CHEW** (K. Lau) - underwent a pre-race veterinary examination as it had not raced sind August 2018 and was passed fit to race.

# RACE 5: AAMI SKYBEAU STAYERS SERIES FINAL - 2500 metres

FLOW METER (R. Hurdle) - awkward to begin, shifted out and tightened BARBIE'S BOY.

**HASTA LA WAR** (T. Voorham) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**BOOMSTOCK (NZ)** (J. Holder) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

DR DEPENDABLE (R. Clark) - awkward to begin, shifted in and tightened BARBIE'S BOY.

**BARBIE'S BOY** (B. Vorster) - tightened at the start between FLOW METER and DR DEPENDABLE, which both shifted ground and as a consequence lost its position.

**LINE DANCER** (P. Gatt) - Stewards permitted P. Gatt to ride the filly 0.5 kg over its declared weight of 54kg. Laid in, in the straight. Shorlty after the entrance to the straight shifted in and near the 300 metres became awkward on the heels of KING VALOUR (NZ) for a number of strides.

**SAGAAB** (E. Boyd) - raced fiercely in the early and middle stages of the event. Rider dropped her whip near the 250 metres. A post-race veterinary examination revealed minor lacerations to both hind legs. First aid administered.

# RACE 6: PORSCHE CENTRE ADELAIDE BENCHMARK 60 HANDICAP - 1200 metres

**JUST A BIGGER DASH** (K. Lau) - began awkwardly, shifted in and contacted LITTLEBITFUNNY. Raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

TWO ODD SOX (S. Cahill) - laid out over the concluding stages.



#### RACE 6: PORSCHE CENTRE ADELAIDE BENCHMARK 60 HANDICAP - 1200 metres (Cont'd)

**RIBS** (E. Boyd) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr J. MacMillan was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

VALLIANO (D. Tourneur) - shortly after the entrance to the straight rider shifted out to improve his position tightening WITH GRAVY, onto LITTLEBITFUNNY, and taking its running resulting in T. Voorham, the rider of WITH GRAVY having to take hold and alter course to the inside of VALLIANO. Rider was found guilty of a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 15 November and to conclude at midnight on Friday, 22 November 2019: a period of four meetings.

**LITTLEBITFUNNY** (P. Gatt) - contacted at the start.

WITH GRAVY (T. Voorham) - held up for clear running from near the 400 metres until shortly after the entrance to the straight and obliged to race in restricted room between LITTLEBITFUNNY, which maintained its line and VALLIANO, which shifted out, and as a consequence, T. Voorham was obliged to take hold and alter course to the inside of that horse to obtain clear running when tightened by VALIIANO.

SAND CAT (J. Toeroek) - over-raced in the early stages of the event.

SONIC DEED (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**WALKABOUTCREEK** (J. Potter) - underwent a pre-race veterinary examination as it had not raced since June 2018 and passed fit to race.

### RACE 7: FURPHY BENCHMARK 60 HANDICAP - 1200 metres

IN THE FAST LANE (R. Hurdle) - raced keenly in the early stages of the event.

**THE RAVEN** (J. Potter) - held up for clear running rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

MUSICAL QUERY (T. Voorham) - held up for clear running from near the 400 metres until approaching the 200 metres.

**AMBIDAZZLE** (G. Lo) - held up for clear running from inside the 500 metres until near the 200 metres and thereafter approaching the 100 metres altered course to the outside of ROCK HARBOUR to improve its position and over the concluding stages raced in restricted room to the outside of ROCK HARBOUR, which rolled out marginally.

**SWANKYTOFF** (A. Jordsjo) - near the 200 metres shifted in under riding and tightened SPIRITED MATCH, which obliged its rider to take hold to avoid the heels of SWANKYTOFF losing its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 15 November and to conclude at midnight on Friday, 22 November 2019: a period of four meetings.

CARBONE (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

**SPIRITED MATCH** (K. Lau) - raced keenly in the early stages of the event. Near the 200 metres rider was obliged to take hold to avoid the heels of SWANKYTOFF, which shifted in and was unable to maintain its position when avoiding that horse's heels.



# RACE 7: FURPHY BENCHMARK 60 HANDICAP - 1200 metres (Cont'd)

Correct weight for this event was delayed to allow G. Lo (AMBIDAZZLE) and Mr T. Stokes, representing Trainer Mr P. Stokes, to view the vision in the straight. After doing so G. Lo lodged a protest against ROCK HARBOUR (B. Vorster) being declared the winner, on the grounds of alleged interference over the final 200 metres of the event. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards dismissed the protest. In determining the protest Stewards considered that when electing to alter course to the outside of ROCK HARBOUR, which shifted in, inside the 200 metres, G. Lo had not claimed that ground and still had ground available to the inside of ROCK HARBOUR but elected to shift to the outside of that horse and thereafter over the concluding stages when racing in restricted room to the outside of ROCK HARBOUR, was not hampered to an extent which materially affected his chances of obtaining the best possible place in the race.

### RACE 8: M&J CHICKENS BENCHMARK 64 HANDICAP - 1100 metres

**TOUCH** (J. Potter) - contacted and hampered at the start.

**BELZELLA** (B. Vorster) - contacted and inconvenienced near the 800 metres by ORBOST, which was taken out. Rider explained that after receiving a brush at the entrance to the straight, his horse became slightly unbalanced and thereafter failed to let down as expected. A post-race veterinary examination revealed no visible abnormalities.

**ORBOST** (T. Pannell) - proved fractious prior to the gates being released and was slow to begin. Near the 800 metres was tightened onto BELZELLA by VOD, which raced ungenerously, and shifted out.

TASTE OF DIAMONDS (D. Tourneur) - laid in, in the straight.

**SOPHINA DIVA** (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SASSY MANEUVER (R. Clark) - awkward to begin, shifted in and contacted TOUCH.

**VOD** (K. Lau) - near the 800 metres raced ungenerously rolled out onto ORBOST, which was hampered when tightened onto BELZELLA. Shortly thereafter when being restrained raced ungenerously for several strides.

# RACE 9: AAMI BENCHMARK 60 HANDICAP - 1800 metres

**GRABBING GLORY** (J. Chau) - a post-race veterinary examination revealed no visible abnormalities.

CHUBBY RAIN (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

**KARAOKE EXPRESS** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**SEATTLE SOUND** (J. Holder) - rider reported the gelding travelled well but when asked for an effort at the entrance to the straight, did not let down and was disappointing in its effort. A post-race veterinary examination revealed no visible abnormalities.

**BARRYMORE** (T. Voorham) - contacted near the 1400 metred by MISS HARMONIUM, which shifted out slightly.

**DESIDERO** (R. Hurdle) - a late scratching at 7.33 am by order of Stewards (refer General).

**OUTINTHESTREET** (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.



# RACE 9: AAMI BENCHMARK 60 HANDICAP - 1800 metres (Cont'd)

MISS HARMONIUM (J. Maund) - raced keenly in the early stages of the event. Near the 1400 metres shifted out slightly and contacted BARRYMORE.

## **GENERAL:**

DESIDERO was stood down from racing on Saturday, 2 November 2019 until it galloped a 1000 metres in the presence of a Steward. DESIDERO had already accepted for today's meeting as the acceptances closed on Friday, 1 November 2019 at 9.00 am and as a result Trainer Mr G. Young was advised that he would be required to scratch the gelding from today's event. Mr Young was reminded on two occasions by Stewards on Monday, 4 November 2019 that he must scratch prior to the 7.30am deadline. Stewards considered his explanation in relation to him failing to scratch by the required time and after doing so, laid a charge against him under LR19.1. Mr Young pleaded guilty and was fined \$100.
