STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse  
by the South Australian Jockey Club on Saturday, 14 December 2019

**RACE 1: LK ACCOUNTING SERVICES TWO-YEAR-OLD PLATE - 1050 metres**

**STENMARK** (C. Parish) - near the 100 metres was inconvenienced and obliged to be steadied when its running was taken by BRIBERY, which was inclined to lay in and shifted in. Rider explained he was comfortable with the position he obtained in running and whilst the colt travelled well in the early and middle stages, it failed to finish the event off in the manner he had anticipated. Lost its near hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

**EXTRA TIME** (J. Bowditch) - awkward to begin and raced very greenly in the early stages of the event.

**JACKS 'N' DANIEL'S** (E. Boyd) - slow to begin, thereafter commenced to race fiercely approaching the 900 metres and became awkwardly placed on the heels of STENMARK for a short distance. Inside the 700 metres when being restrained, commenced to shift out over the heels of BRIBERY and as a consequence, took the running of DIESEL 'N' DUST, which was obliged to race in restricted room for a number of strides. Thereafter, commenced to hang out, raced wide rounding the home turn and into the straight and continued to hang out in the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr R. Wilkinson was advised that in view of the gelding's racing manners it was required to perform to the satisfaction of the Stewards in Official Barrier Trial prior to a future race.

**NOT A ZAK (NZ)** (J. Toeroek) - awkward to begin.

**DIESEL 'N' DUST** (K. Crowther) - awkward to begin. Inside the 900 metres was obliged to race in restricted room inside ANOTHER AWARD, which commenced to race very keenly and shifted in, and had to be steadied. Thereafter inside the 700 metres was obliged to race in restricted room to the outside of JACKS 'N' DANIEL'S as that horse raced fiercely and shifted away from the heels of runners.

**ANOTHER AWARD** (J. Chau) - inside the 900 metres commenced to race fiercely for a short distance, shifted in momentarily and tightened DIESEL 'N' DUST.

**BRIBERY** (B. Vorster) - near the 100 metres was inclined to lay in, shifted in took the running of and hampered STENMARK, which had to be steadied. Rider reprimanded and advised to take greater care in future when his mounts commence to shift ground.

**SHE'S TRICKY** (T. Pannell) - lost its near hind plate during the event.

### **RACE 2: ZILZIE WINES HANDICAP - 1100 metres**

**MAGIC PHANTOM** (T. Voorham) - was inconvenienced shortly after the start by DESERT DREAMER, which began awkwardly and shifted out, and consequently was tightened onto KAYSERI (NZ) taking that horse out onto KALAMON. Thereafter over-raced in the early and middle stages of the event. Approaching the entrance to the straight, when inclined to lay out, attempted to improve its position and shifted out onto KAYSERI (NZ), which was racing to its immediate outside and as a consequence made contact with KAYSERI (NZ), resulting in both horses hindquarters being turned. As a consequence, shortly thereafter both horses shifted away from each other, shifted back in and made contact again resulting in their hindquarters being turned again. Rider was advised that in similar circumstances to allow her mount an opportunity to settle and balance up before attempting to shift riders to improve her position.

**HEARTY LASS** (B. Vorster) - awkward to begin. Raced wide without cover in the early stages of the event.

**DESERT DREAMER** (T. Pannell) - awkward to begin, shifted out onto MAGIC PHANTOM resulting in that horse shifting out and away from DESERT DREAMER onto KAYSERI (NZ), resulting in that horse being taken out onto KALAMON. As a consequence KAYSERI (NZ) was hampered and KALAMON lost its position. A post-race veterinary examination revealed no visible abnormalities.

**KAYSERI (NZ)** (P. Gatt) - hampered at the start when taken out by MAGIC PHANTOM onto KALAMON. Had its hindquarters turned on two separate occasions approaching the entrance to the straight by MAGIC PHANTOM, which attempted to shift out to improve its position.

**KALAMON** (J.Toeroek) - tightened and contacted shortly after the start by KAYSERI (NZ), which was taken out by MAGIC PHANTOM, which shifted out and away from DESERT DREAMER and as a consequence lost its position. Rider reported the gelding got its tongue over the bit and was inclined to hang out under pressure.

### **RACE 3: FURPHY HANDICAP - 1100 metres**

**MAGNUS KNIGHT** (S. Price) - laid out in the straight.

**TIARA STAR** (T.Pannell) - raced keenly and wide without cover in the early stages of the event and was inclined to lay in, in the straight.

**PALE ALE** (E. Boyd) - raced very keenly in the early and middle stages of the event.

**COSMIC RHAPSODY** (J. Toeroek) - held up for a short distance near the entrance to the straight.

### **RACE 4: METAL-LINK HANDICAP - 1600 metres**

The start of this event was delayed approximately two minutes

**DEBT COLLECTOR** (T. Voorham) - rider explained that she would have preferred to have settled a bit more forward in the event, however the gelding did not respond to her encouragement immediately after the start. She added when the pace quickened near the 800 metres, she was left flat-footed and did not travel into the race with the field as expected, however from rounding the home turn, the gelding commenced to respond to her riding and let down in the manner expected and finished the race off strongly.

**BRAMFIELD** (C. Parish) - a post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer, Mr D. Carrison, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**BORRIS IN OSSORY** (S. Logan) - rider explained her instructions were to lead, improve her position and attempt to skip clear from near the 800 metres. She stated she was able to comply with her instructions however, found a very easy lead in the early stages and in hindsight may have been better served to wait for the field to take closer order before attempting to skip clear mid-race.

#### **RACE 4: METAL-LINK HANDICAP - 1600 metres (Cont'd)**

**SHROUDED IN MIST** (B. Vorster) - pulled its near fore plate at the barriers and required to be reshod. Underwent a pre-race veterinary examination and was passed fit to race.

#### **RACE 5: AAMI HANDICAP - 2019metres**

**MELI MELO** (K. Crowther) - raced wide without cover in the early stages of the event.

**BERTWHISTLE** (D. Tourneur) - rider explained when approaching the entrance to the straight he considered his options to improve, was conscious of the position of **WANTED BY ALL**, which had shifted out on entering the straight and for that reason owing to his position near the heels of that runner, elected to alter course to improve to the inside of that horse. After doing so and commencing to improve, **WANTED BY ALL** rolled back to his position and as a consequence, he was unable to improve his position for some distance when held up inside the heels of **WANTED BY ALL** and behind **ADATTO** (NZ), which was not improving in the run. He added near the 200 metres when a run appeared to develop between **ADATTO** (NZ) and **WANTED BY ALL**, which rolled out momentarily, he considered improving into that run, however, as **ADATTO**(NZ) rolled out, he anticipated that run might close and as a consequence he was again obliged to be held up on the heels of **ADATTO** (NZ). When asked whether he had any option to improve to the inside of **ADATTO** (NZ) inside the 100 metres, he stated that in his opinion the run to the inside of **ADATTO** (NZ) was too tight a run to attempt. Consequently he stated his mount was untested to the line in the circumstances. A post-race veterinary examination revealed no visible abnormalities.

**DR DEPENDABLE** (J. Bowditch) - raced keenly in the early stages of the event.

**WANTED BY ALL** (J. Toeroek) - rolled out near the entrance to the straight and again rolled out near the 200 metres

**BLUE BEAR** (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**EPERDUMENT** (C. Parish) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ADATTO (NZ)** (J. Chau) - Stewards permitted J. Chau to claim only 2.5 kg of his 3 kg allowance. He was fined \$200 under AR143(14)(a) for failing to claim his full allowance. In addition J. Chau was advised his minimum riding weight would be adjusted from 51kg to 51.5kg effective 16 December 2019. Raced keenly in the early stages of the event. Near the 200 metres rolled out. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 6: SCHWEPPE'S HANDICAP - 1050 metres**

**I'M TOO HOT** (G. Lo) - rider explained he was instructed to lead in the event and from a wide barrier he was obliged to encourage his mount in the early stages to enable him to cross the field to get to the fence and lead as instructed. He added after obtaining the lead, the gelding travelled well until after the entrance to the straight where it commenced to weaken and finished the race off poorly. A post-race veterinary examination revealed no visible abnormalities.

**BE MY STAR** (T.Voorham) - awkward to begin and shortly thereafter threw its head up in the air for a number of strides and raced ungenerously.

**GOUGERS** (T. Pannell) - inclined to lay out in the straight.

**CRIMSON TYCOON** (J. Bowditch) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7: ADELAIDE GALVANISING CHRISTMAS HANDICAP - 1200 metres**

**LAGERFELD** (Z.Spain) - a post-race veterinary examination revealed an elevated heart rate and a slow recovery.

**BENZ** (K. Crowther) - laid in, in the early part of the straight.

**NIPPERKIN** (C. Parish) - raced wide without cover throughout the event.

**EF TROOP** (B. Vorster) - raced keenly in the early stages of the event.

**COLUMBIA** (T. Pannell) - inside the 900 metres was hampered by EXALTED TRAIL, which was obliged to shift out to avoid the heels of MISS JANE.

**AIGUILLETTE** (E. Boyd) - Trainer Mr J. MacMillan advised Stewards prior to the event of a change of tactics that being that he would instruct his rider to attempt to settle mid-field in this event. A post-race veterinary examination revealed no visible abnormalities.

**MISS JANE** (D. Tourneur) - raced keenly in the early stages of the event. Inside the 900 metres shifted in and crossed the running of EXALTED TRAIL, which was obliged to take hold and alter course to the outside of that horse's heels and in doing so EXALTED TRAIL shifted out onto COLUMBIA, which was taken out and hampered. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

**REGALO DI GAETANO** (J. Toeroek) - lost its near hind plate during the event.

**EXALTED TRAIL** (J. Potter) - inside the 900 metres was obliged to be steadied when crossed by MISS JANE and as a consequence shifted out onto COLUMBIA hampering that horse.

**RACE 8: TWILIGHT RACES AT MORPHETTVILLE, FRIDAY DECEMBER 20 2019 HANDICAP**  
**- 1600 metres**

**NASEEB** (B. Vorster) - raced keenly in the early stages of the event. Inside the 300 metres was inclined to lay in, shifted in momentarily brushed with BWUVA, which was taken in across the running of ROSELLI STING resulting in that horse having to take hold to avoid the heels of BWUVA.

**ICE GHOST** (J. Bowditch) - rider explained he intended settling a little more forward than he did in today's event and was hoping to be in the first four to five runners however, owing to the formation of the field in the early stages and the fact that he would have been obliged to race wide without cover to obtain that position, he elected to take cover in the early stages, which obliged him to settle back in the field. He added the horse travelled well in the middle stages of the event and he followed NASEEB into the straight and after electing to improve to the outside of that runner, the gelding raced flat and failed to respond to his riding as anticipated. A post-race veterinary examination revealed no visible abnormalities.

**ROSELLI STING** (R. Hurdle) - inside the 300 metres after shifting out to improve was obliged to take hold to avoid the heels of BWUVA, which shifted in and away from NASEEB.

**RAGING QUEEN** (K. Crowther) - laid in, in the straight.

**BWUVA** (D.Tourneur) - inside the 300 metres after shifting out to improve after being brushed by NASEEB, which shifted in momentarily, shifted in into the running line of ROSELLI STING, which had to take hold.
