**RACE 1: TAB HANDICAP - 1500 metres**

**AURMAN ZOU** (A. Jordsjo) - laid out from near the 500 metres until the entrance to the straight.

**BALLAST** (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. Rider reported the gelding was inclined to lay in, in the straight.

**BWUVA** (J. Chau) - raced keenly in the early stages of the event. Became held up for clear running from in the vicinity of the 300 metres when awkwardly placed on the heels of BALLAST and was only able to obtain clear ground approaching the 200 metres. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**FULL TILT** (K. Bishop) - laid out rounding the home turn.

**LEONARDA** (A. Kelly) - awkward and slow to begin. Raced keenly in the early and middle stages of the event. Near the 400 metres became awkwardly placed outside the heels of FULL TILT, which laid out and rolled out. As a consequence had to be momentarily steadied and was obliged to shift wider on the track to obtain clear running.

**RACE 2: CORNERSTONE STUD HANDICAP - 1200 metres**

The start of this event was delayed approximately four minutes

**PICARGO** (J. Chau) - inside the 300 metres became awkwardly placed on the heels of ROSE TIARA for a number of strides. Had difficulty obtaining clear ground until approaching the 100 metres when inclined to lay in behind JUST ZERENE.

### **RACE 2: CORNERSTONE STUD HANDICAP - 1200 metres (Cont'd)**

**AIR MARSHAL** (T. Pannell) - slow to begin. Hung out severely under pressure in the straight, A post-race veterinary examination revealed mild tying up in its hindquarters. Trainer, Mr W. Clarken, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**IT'S A SHAME** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**ROSE TIARA** (J. Holder) - kicked out in the mounting yard and kicked AUTUMN SLENDOUR. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Rider reported the filly failed to let down in the straight. A post-race veterinary examination revealed no visible abnormalities.

**AUTUMN SLENDOUR** (G. Lo) - kicked in the mounting yard by ROSE TIARA, and had its near fore plate replaced at the barriers by the Farrier. Underwent a pre-race veterinary examination and was passed fit to race. Jumped away awkwardly and shifted about under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities. Lost its near fore plate during the event.

**JUST ZERENE** (J. Maund) - over-raced in the early and middle stages of the event.

### **RACE 3: TERRACE FUCTION CENTRE MAIDEN PLATE - 1200 metres**

The start of this event was delayed approximately two minutes.

**LI'L HANK** (S. Fawke) - near the 1100 metres was inconvenienced for a number of strides by SEEMINGLY DISCREET, which shifted in.

**MANOR KING** (J. Potter) - approaching the 600 metres became awkwardly placed on the heels of ANNIKA for a number of strides and had to be steadied. A post-race veterinary examination revealed no visible abnormalities.

**OUR TREASURE TROVE** (J. Chau) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**ANNIKA** (J. Toeroek) - Stewards permitted J. Toeroek to ride the filly 0.5 kg over its declared weight of 54kg. Held up for a short distance near the entrance to the straight and was only able to obtain clear running approaching the 200 metres.

**JIVE BABY** (T. Pannell) - slow to stride.

**SEEMINGLY DISCREET** (J. Holder) - near the 1100 metres shifted in and inconvenienced LI'L HANK for a number of strides.

### **RACE 4: KAESLER WINES STONEHOUSE SHIRAZ HANDICAP - 1700 metres**

**BACK POCKET** (R. Hurdle) - raced keenly in the early and middle stages of the event.

**PAT THE WEAPON** (G. Lo) - raced keenly in the early and middle stages of the event.

**DESIDERO** (P. Gatt) - inclined to lay out in the straight.

**TROOPER'S PLOY** (S. Fawke) - had difficulty obtaining clear ground from near the 500 metres until inside the 200 metres.

### **RACE 5: MARX REAL ESTATE HANDICAP - 2100 metres**

**DR DEPENDABLE** (J. Chau) - raced keenly in the early and middle stages of the event.

### **RACE 5: MARX REAL ESTATE HANDICAP - 2100 metres**

**LOSTARC** (P. Gatt) - raced keenly in the middle stages of the event.

**FLOW METER** (S. Fawke) - jumped away awkwardly. Was disappointed for clear running when attempting a run between **SEE THE MASTER (IRE)** and **COBBERS MATE** in the vicinity of the 200 metres and was obliged to alter course to the outside of these runners to obtain clear ground.

**EPERDUMENT** (J. Potter) - laid out under pressure in the straight.

**SEE THE MASTER (IRE)** (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

**COBBERS MATE** (T. Pannell) - Stewards permitted T. Pannell to ride the gelding 0.5 kg over its declared weight of 54kg.

### **RACE 6: THANK YOU CFS HANDICAP - 1100 metres**

**BURNING THE CLOCK** (L. Neindorf) - jumped away awkwardly.

**PANDEIA** (S. Logan) - raced keenly in the early stages of the event.

**KILOWATT** (J. Toeroek) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Raced wide without cover throughout the event.

**LA VITA** (J. Holder) - held up for clear running for a short distance at the entrance to the straight.

**SCARE CAMPAIGN** (P. Gatt) - inclined to rear on jumping away.

**EMMY AWARDS** (S. Fawke) - Stewards permitted S. Fawke to ride the mare 0.5 kg over its declared weight of 54kg. Re-saddled on arrival at the barriers.

### **RACE 7: COOPERS HANDICAP - 1200 metres**

**OAMARU OWL** (L. Neindorf) - lost its off hind plate during the event. Began very awkwardly, shifted out and contacted the hindquarters of **PROUD WOLF**. Thereafter raced keenly in the early and middle stages of the event. From near the 900 metres commenced to hang out and hung out until near the entrance to the straight resulting in **OAMARU OWL** being awkwardly placed on the heels of runners at various stages in the middle stages of the event, placing L. Neindorf at a disadvantage. Rider explained it was his instructions and intention to settle forward and lead in the event but owing to the manner in which the gelding began and its racing manners shortly thereafter, he was unable to take up that position.

**SET TO SPARKLE** (J. Maund) - approaching the 800 metres rolled in and momentarily inconvenienced **MYSTICANO**. Rider explained the mare travelled well in the early stages but when placed under pressure in the straight, became awkward in its action and did not finish the race off as expected. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Co-Trainer, Mr. C. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**ENOUGH SWAGGER** (J. Holder) - raced wide without cover throughout the event. Raced keenly in the early and middle stages of the event.

**PROUD WOLF** (O. Ridge) - had its hindquarters contacted at the start. Raced wide without cover throughout the event.

**KABINI** (P. Gatt) - inside the 800 metres was contacted by MYSTICANO, which became awkward on heels of runners. Hung out from near the 500 metres and for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7: COOPERS HANDICAP - 1200 metres (Cont'd)**

**FRANCE'S BOY** (S. Fawke) - raced keenly in the early and middle stages of the event.

**MYSTICANO** (J. Chau) - lost its near hind plate during the event. Approaching the 800 metres was momentarily inconvenienced inside the heels of SET TO SPARKLE as that horse rolled in and thereafter was awkward on the heels of SET TO SPARKLE for some distance, rolled in and contacted KABINI.

**RACE 8: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1500 metres**

The start of this event was delayed approximately two minutes

**NASEEB** (T. Voorham) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

**TABLE OF WISDOM** (J. Potter) - a late scratching by order of Stewards at 5.02 pm acting on veterinary advice after the gelding became fractious in its barrier stall after being loaded and broke through the front of its stall. TABLE OF WISDOM was quickly recaptured and returned to behind the barriers. Underwent a pre-race veterinary examination and declared unfit to race. Trainer Mr D. O'Leary was advised the gelding would be required to prove tractable in an Approval to Race Jump Out or an Official Barrier Trial prior to accepting for a future race. Rider examined by the First Care Medical Personnel and ruled fit to fulfil his remaining engagements.

**GOOD 'N' FAST** (P. Gatt) - lost its off hind plate during the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Co-Trainer, Mr D. Hayes, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**GREYCLIFFE (NZ)** (J. Toeroek) - raced fiercely in the early and middle stages of the event and was inclined to shift about when being restrained.

**JESTER HALO** (J. Holder) - stood flat-footed as the gates were released and missed the start losing several lengths. Trainer Mr D. Kolpin was advised a warning had been placed on the mare in relation to jumping on terms with the field.

**ROSELLI STING** (J. Chau) - laid in under pressure in the straight.

**SEABABE** (T. Pannell) - Stewards permitted T. Pannell to ride the mare 0.5 kg over its declared weight of 54kg.

**RACE 9: HOLDFAST INSURANCE HANDICAP - 1200 metres**

**MAGNUS KNIGHT** (A. Jordsjo) - contacted on jumping away.

**DANGER DEAL** (J. Chau) - shifted out on jumping away and contacted MAGNUS KNIGHT.

**TWO ODD SOX** (T. Pannell) - had difficulty obtaining clear running from shortly after the entrance to the straight until approaching the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

**SUNRISE DANCER** (J. Holder) - inclined to lay out in the straight.

**GALCRUM** (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

**SIR JOHNSON** (J. Toeroek) - over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.
