**RACE 1: LAWRENCE & HANSON / SABOIS TWO-YEAR-OLD HANDICAP - 1000 metres**

**KOODA TROOPER (NZ)** (S. Logan) - hung out rounding the home turn. Inclined to lay out in the straight.

**RIGHT TURN** (L. Neindorf) - awkward to begin.

**CONGE** (J. Chau) - hung in, in the straight.

**HAYZELLE** (E. Boyd) - slow to begin. Raced keenly in the early and middle stages of the event. Inclined to lay in, in the straight.

**RACE 2: WEST COAST FIRST AID SUPPLIES / SABOIS MAIDEN PLATE - 1000 metres**

**OUR JOURNEYMAN** (S. Logan) - underwent a pre-race veterinary examination as it had not raced for over 12 months and passed fit to race.

**ULTIMATE VIEW** (J. Chau) - laid in, in the straight.

**SOXTOBEYOU** (S. Fawke) - brushed at the start by SHANE, which shifted in, and as a result shifted away from this runner making contact with the running rail. Raced keenly in the early and middle stages of the event. Rider reported he could offer no explanation as to the performance of the gelding as when asked for an effort it failed to respond to his riding. A post-race veterinary examination revealed the gelding to have tied up in the hindquarters. Trainer Mr B. Lear was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race

**RACE 2: WEST COAST FIRST AID SUPPLIES / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)**

**AMERICAIN SAPHIRE** (E. Annells) - a post-race veterinary examination revealed no visible abnormalities.

**IMBOSSIBLE** (K. Bishop) - raced wide without cover throughout the event. Hung out rounding the home turn. Rider reported the mare hung out throughout the event.

**QUICKER THAN SLICK** (M. Collett) - in the vicinity of the 200 metres rider was obliged to shift inside of **ULTIMATE VIEW**, which was laying in.

**SCARY GO ROUND** (G. Lo) - hung out rounding the home turn. Laid out in the straight. Rider reported the mare hung out throughout the event.

**SHANE** (J. Potter) - shifted in marginally on jumping away brushing **SOXTOBEYOU**.

**RACE 3: LINCOLN RURAL SUPPLIES BENCHMARK 80 HANDICAP - 1960 metres**

**NEVA DOUBT US** (L. Neindorf) - raced keenly in the early stages of the event. Laid in, in the straight.

**LADY CONQUISTADOR** (T. Pannell) - when questioned rider explained that in his opinion he had timed his run well in the endeavour to catch the leader in the event, however his run came to an end in the vicinity of the 50 metres, and when asked for a further effort failed to respond to his riding.

**SHINSEKI** (J. Chau) - Laid in, in the straight.

**THE FOUR CEES** (K. Bishop) - Laid in throughout the event.

**QUEEN'S PALACE** (S. Logan) - reared as the start was effected and as a consequence was slow to begin.

**RASHYATHERE** (S. Fawke) - Stewards permitted S. Fawke to ride the gelding 0.5kg over the allotted weight. Rider was fined \$200 under AR190(4). Shortly after the start shifted in to obtain cover. Raced keenly in the early and middle stages of the event.

**WICKED KID** (J. Potter) - shortly after the start shifted in to obtain cover. Raced keenly in the early stages of the event. Inclined to lay in, in the straight.

**RACE 4: PORT LINCOLN GOURMET MEATS BENCHMARK 80 HANDICAP - 1390 metres**

**DEBEERSONUS** (T. Pannell) - laid in, in the straight.

**HANK'S NEPHEW** (E. Annells) - tightened on jumping between **LEONARDA**, which shifted out and **ARTFUL RAMBLER**, losing its position. Raced keenly in the early stages of the event.

**VICTOR VICTOR** (J. Potter) - shortly after the start shifted in to obtain cover. Inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**MIRTHDALE** (K. Bishop) - raced keenly in the early stages of the event.

**LEONARDA** (S. Logan) - began awkwardly, shifted out onto **HANK'S NEPHEW** tightening that runner. In the vicinity of the 200 metres had difficulty obtaining clear running until approaching the 100 metres.

**TASKMASTER** (E. Boyd) - raced wide without cover throughout the event.

**RACE 5: LINCOLN ESTATE WINES CLASS TWO HANDICAP - 1390 metres**

**CALL ME HERBIE** (S. Fawke) - rider reported the gelding did not finish the event as expected. A post-race veterinary examination revealed no visible abnormalities.

**WITCH KID** (G. Lo) - laid in under pressure in the straight. Laid out under pressure over the concluding stages.

Correct weight was delayed to allow J. Potter (MARIANNE RUBY) placed second to view the official vision. After doing so J. Potter lodged an objection against WITCH KID (G. Lo) placed first, alleging interference over the final 300 metres. After considering the evidence disclosed, viewing the official footage and acting on their own observations, Stewards *dismissed* the protest.

**RACE 6: AVIS PORT LINCOLN BENCHMARK 66 HANDICAP - 1210 metres**

The start of this race was delayed approximately 3 minutes.

**KINGSON** (M. Collett) – began awkwardly, shifted in contacting STORM VOYAGER. Raced wide without cover throughout the event. Inclined to lay in, in the straight.

**DOCTOR DOOLITTLE** (R. Hurdle) – began awkwardly.

**HARDINGTON (GB)** (S. Fawke) - contacted the perimeter fence on leaving the mounting yard. Underwent a pre-race veterinary examination and passed fit to race. Began awkwardly and was slow to begin.

**JAAMINT** (J. Potter) - became fractious in the barrier. Underwent a pre-race veterinary examination and passed fit to race.

**FEARLESS AL** (J. Chau) - began awkwardly. Laid in, in the straight.

**RACE 7: MITTYS BENCHMARK 58 HANDICAP - 1000 metres**

**TINTAGEL ROCKER** (J. Chau) - laid out in the straight.

**STAR PARFAIT** (S. Logan) - laid in under pressure over the concluding stages. Rider reminded of her obligations to correct her mount when commencing to shift ground.

**ARTFUL AMBITION** (K. Bishop) - began awkwardly and was slow to begin.

**BOTTLE AND BIRD** (E. Boyd) - rider was required to take hold over the concluding stages as STAR PARFAIT laid in.

**LASANTA** (S. Fawke) - began awkwardly and was slow to begin.
