

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Penola Racecourse by the Penola Racing Club on Wednesday, 26 February 2020

RACE 1: DYLAN WALKER CONSTRUCTION / SABOIS MAIDEN PLATE - 1700 metres

BULCMENE (S. Fawke) - lad in, in the straight.

STEELCAPSTILETTOS (S. Logan) - began awkwardly.

UNCLE BOB (L. Neindorf) - knuckled badly on jumping away resulting in the rider almost being dislodged and became unbalanced after bumping the hindquarters of WHISKEY BOSS.

WHISKEY BOSS (E. Boyd) - became very unbalanced at the start when bumped by UNCLE BOB.

LILARLY (T. Voorham) - approaching the 300 metres became unbalanced when racing tightly to the inside of BULCMENE, which rolled in slightly.

TRY TRY TRY (D. Tourneur) - the mare had bled from both nostrils. Trainer, Mr J. Opperman, was advised that as this was the mare's first bi-lateral bleed TRY TRY TRY would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

DANAYI (J. Potter) - proved difficult to settle in the early stages of the event.

RACE 2: DIGIORGIO FAMILY WINES / SABOIS MAIDEN HANDICAP - 1400 metres

CAPTAINZWAYZE (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

GEORGINA GOLD (R. Hurdle) - shortly after the start became unbalanced when buffeted between RUNNING TIDE and DARK DEXTER

RUNNING TIDE (L. Neindorf) - bumped GEORGINA GOLD shortly after the start.

DARK DEXTER (A. Tomita) - shortly after the start bumped GEORGINA GOLD.



RACE 2: DIGIORGIO FAMILY WINES / SABOIS MAIDEN HANDICAP - 1400 metres (Cont'd)

TONS OF FUN (P. Gatt) - Stewards permitted P. Gatt to ride the filly 0.5 kg over its declared weight of 54.5 kg. Raced wide without cover throughout the event.

RACE 3: ADRIAN THOMAS INDUSTRIAL / SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately four minutes.

STRIDING MAN (P. Gatt) - began awkwardly. Approaching the 100 metres, laid in and had to be eased off the heels of TAKSIM GIRL. Approaching the winning post, eased off the heels of POSSUM BORN and thereafter shifted in abruptly. Laid in under pressure in the straight.

SUPERHOOPS (D. Tourneur) - slow to begin.

GETONIT (M. Collett) - laid in under pressure in the straight. Held up for clear running in the vicinity of the 300 metres. Inconvenienced over the concluding stages and taken out by TAKSIM GIRL.

TAKSIM GIRL (E. Boyd) - slow to begin. Had difficulty obtaining clear running from the 550 metres until the entrance to the straight. Contacted NJORD when improving in the vicinity of the 300 metres. Shifted out over the concluding stages and inconvenienced GETONIT.

NJORD (J. Maund) - had to be reshod at the barriers by the Farrier. Underwent a pre-race veterinary examination and passed fit to race.

RACE 4: MED ELECTRICAL BENCHMARK 56 HANDICAP - 1100 metres

AZZURO BIANCO (J. Potter) - in the vicinity of the 1000 metres was taken out after being bumped LANCASTER SOUND. Approaching the winning post eased to avoid the heels of DEFORCE, which shifted out.

DEFORCE (J. Maund) - jumped out at the start and bumped LANCASTER SOUND. Hung out throughout the event. Rider reported his mount hung out throughout and was unable to ride his mount out in his normal manner over the concluding stages. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr R. Nicholson was advised a warning had been placed on the gelding in relation to its racing manners.

LANCASTER SOUND (R. Hurdle) - after being bumped by DEFORCE shortly after the start, shifted out abruptly for a number of strides and in doing so made contact with AZZURO BIANCO. Rider reported throughout the race, the gelding had a tendency to lay out and away from DEFORCE, when that gelding hung out.

WONAEAMIRRI (S. Fawke) - began awkwardly. Rider reported that near the 200 metres, his mount laid in and he changed course outwards after being disappointed for a run between LA TESORA and AZZURO BIANCO due to both horses shifting ground under pressure. He added that after shifting out, the gap between ASSURO BIANCO and LA TESORA opened and as a result, he shifted in, and obtained clear running between those horses.

STRATEGIC SPICE (L. Neindorf) - slow to begin.

LA TESORA (D. Tourneur) - knuckled shortly after the start.

RACE 5: FESTIVAL HIRE BENCHMARK 56 HANDICAP - 1700 metres

DARILJON (L. Neindorf) - Trainer notified Steward of a change in tactics in that if circumstances permit, for the gelding to settle in a mid-field position. Slow into stride. Bumped by SNAPTOF resulting in the gelding settling towards the rear of the field. Approaching the 300 metres had to be eased for a number of strides when held up on the heels of NEAR MAGIC, which was giving ground.

SNAPTOF (P. Gatt) - jumped away awkwardly and bumped DARLIJON.

NEAR MAGIC (S. Fawke) - rider reported that his mount failed to respond to his riding when placed under pressure near the 1000 metres and as he felt something was amiss he eased the gelding down over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

O'MIZZNA (E. Finnegan) - rider reported the mare laid in, in the straight.

A QUIET DRINK (R. Hurdle) - approaching the 1400 metres shifted in and inconvenienced EUDORA.

EUDORA (K. Crowther) - approaching the 1400 metres was taken in by A QUIET DRINK and became awkward on heels for a short distance thereafter.

RIGHT AND READY (J. Potter) - knuckled on jumping away. Raced wide without cover throughout the event.

RACE 6: PENOLA CUP SUNDAY 12TH APRIL 2020 BENCHMARK 62 HANDICAP - 2100 metres

EL DESPERADO (L. Niendorf) - began awkwardly. In the vicinity of the 400 metres was checked when held up for clear running and becoming awkwardly placed on the heels of HASTA LA SPEC.

SANDHILL STAR (K. Crowther) - raced keenly in the early stages of the event. Raced wide without cover throughout the event. A post-race veterinary examination revealed the gelding to be lame near foreleg. Trainer, Mr S. Turner, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. First aid administered.

HASTA LA FIORENTE (D. Tourneur) - raced keenly in the early stages of the event.

LE DUPE (S. Fawke) - jumped in at the start and crowded DYADAMO. Shortly after passing the 400 metres was checked when crowded for room between HASTA LA SPEC, which shifted out slightly when commencing to give ground and CENTENARY SHOT, which was taken in slightly by HASTA LA FIORENTE, which shifted in when improving.

DYADAMO (J. Maund) - marginally slow to begin and was then crowded between I'LL BE GONE and LE DUPE, which jumped in at the start. A post-race veterinary examination revealed no visible abnormalities.

AZDAJA (E. Boyd) - laid in under pressure in the straight.

RACE 7: COOPERS BREWERY BENCHMARK 62 HANDICAP - 1400 metres

BROBAK (G. Lo) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

RIKIBOBBY (L. Neindorf) - in the vicinity of the 1200 metres shifted in when insufficiently clear resulting in SPOTAKOVA having to be eased to avoid the geldings heels. Rider reprimanded. In the vicinity of the 1100 metres shifted in when insufficiently clear resulting in LONG VIEW having to be eased. Rider reprimanded. In the vicinity of the 400 metres shifted out when insufficiently clear resulting in KEYSOR having to be eased to avoid heels. Rider reprimanded.

RACE 7: COOPERS BREWERY BENCHMARK 62 HANDICAP - 1400 metres (Cont'd)

ROCKTHEBLOCK (P. Gatt) - Trainer advised of a change in tactics in that his instructions were to settle in a more forward position if circumstances permit. Settled in a forward position. In the vicinity of the 800 metres was eased after becoming awkward on the heels of BROBAK.

DAKTARI (N. Farley) - lost ground at the start after jumping away awkwardly. A post-race veterinary examination revealed the gelding to be lame near foreleg. Trainer, Mr S. Lenehan, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. First aid was administered.

LONGMIRE (R. Hurdle) - jumped away awkwardly.

KEYSOR (J. Potter) - approaching the 400 metres eased to avoid the heels of RIKIBOBBY, which shifted out when improving.

SPOTAKOVA (J. Maund) - Stewards permitted J. Maund to ride the filly 0.5 kg over its declared weight of 54kg. Raced keenly in the early stages of the event. Eased near the 1200 metres to avoid the heels of RIKIBOBBY, which shifted in.
