**RACE 1: S.A SHIPARD & D.E. BEATTIE MEMORIAL / SABOIS MAIDEN PLATE - 1200 metres**

**FLYING LOCO** (C. Lions) - jumped away awkwardly.

**LADY HUNTSMEN** (M. Collett) - a post-race veterinary examination revealed filly to be lame in both forelegs. Trainer, Mr T. Haddy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**RACE 2: CEDUNA FORESHORE HOTEL / WEST COAST FUEL BENCHMARK 58 HANDICAP - 1200 metres**

**WEDGEBROOK** (D. McWhinney) - shifted out on jumping away onto **MAGNUS MAGIC**. Inclined to lay in under pressure in straight. A post-race veterinary examination revealed no visible abnormalities.

**MAGNUS MAGIC** (C. Lions) - brushed on jumping away by **WEDGEBROOK**, which shifted out.

**TILBURY** (E. Annells) - slow into stride. Inclined to lay in under pressure in the straight. Rider reported, in her opinion, the mare was exhibiting signs of being in season. A post-race veterinary examination revealed the mare to be in season.

**RACE 3: PENONG HOTEL / THEVENARD HOTEL BENCHMARK 52 HANDICAP - 1400 metres**

**ASH ROAD** (M. Collett) - knuckled on jumping away and as a result was slow into stride. Thereafter, rider elected to stay wide in the back straight to avoid kickback.

**CRAZY CULPRIT** (C. Lions) - underwent a pre-race veterinary examination on arrival at barrier and was passed fit to race.

**EMMY AWARDS** (D. McWhinney) - rider pleaded guilty under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 meters and was reprimanded .

**RACE 4: FAR WEST FARMERS PENONG CUP - 1600 metres**

**IT'S HUMPHREY** (M. Collett) - slow to begin.

**ONWARD** (L. Annells) - inclined to lay out under pressure over the concluding stages, and as a result, rider was unable to ride her mount out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

**ABBI FEDE** (C. Lions) - slow to begin.

**HARDINGTON** (GB) (D. McWhinney) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5: GYPSUM RESOURCES AUSTRALIA / PENONG STATION BENCHMARK 52 HANDICAP - 1000 metres**

**DEVOTED PROSECUTOR** (D. McWhinney) - underwent a pre-race veterinary examination as the gelding had not raced since October 2015 and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

**KAILUA** (C. Lions) - a post-race veterinary examination revealed no visible abnormalities.

**ALPHA MINT** (M. Collett) - held up rounding the home turn and shifted out to obtain clear ground in the vicinity of the 300 meters.
