# RACE 1: GOOLWA CENTRAL MEATS / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1100 Metres

PERUVIAN EXPRESS (D. Caboche) - laid out under pressure in the straight.

**BAY WAVE** (J. Opperman) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

MY MISTER BROOKS (K. Bishop) - laid out under pressure approaching the finish. A post-race veterinary examination revealed no visible abnormalities.

**PACIFIC RIM** (L. Neindorf) - Stewards acting under AR165(1) declared PACIFIC RIM a late scratching at 11.46 am as the colt had not arrived on course by the prescribed time. Assistant Trainer Mr T. Stokes pleaded guilty to a charge under AR165(1) and was reprimanded.

# RACE 2: TALKING HAIR AND BEAUTY / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1200 Metres

**FOLLOW THE PROMPTS** (C. Lions) - raced three wide without cover throughout the event. Laid out in the straight.

**ALITTLEBITOFREBA** (J. Potter) - jumped away awkwardly and as a result was slow to begin. Approaching the 300 metres was taken wider by NIKE BELLE and bumped NANAMU.



# RACE 2: TALKING HAIR AND BEAUTY / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1200 Metres (Cont'd)

**DITZY DANIELLA** (E. Annells) - raced keenly in the early and middle stages of the event. Laid out from the 400 metres until the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

**NANAMU** (E. Finnegan) - raced keenly in the early and middle stages of the event. In the vicinity of the 300 metre was bumped by ALITTLEBITOFREBA.

**NIKE BELLE** (L. Neidnorf) - inside the 300 metres rolled out taking ALITTLEBITOFREBA wider. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

PARTY MAID (J. Holder) - rider accidentally dropped his whip in the vicinity of the 150 metres.

#### RACE 3: FINNISS GENERAL STORE MAIDEN PLATE - 1350 Metres

**BAD HABITS** (D. Tourneur) - jumped away very awkwardly shifted in and as a result was slow to begin. Trainer Mr J. Hyam was advised a warning had been placed on the gelding in relation to its racing manners. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

BAR VINO (E. Boyd) - jumped away slowly.

TAKE IT UP A GIA (J. Potter) - laid out approaching the finish.

**EXALTED FIRE** (S. Logan) - laid out from the 600 metres until the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 4: SPRINGFIELD FARM / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 Metres

AARVI'S WISH (T. Voorham) - jumped away awkwardly shifted out tightening SHE'S DREAMING.

**EXPERIOR** (K. Crowther) - on jumping away shifted in tightening SHE'S DREAMING. Shortly after the start, the rider's saddle shifted to the off side placing K. Crowther at a disadvantage for the remainder of the event.

KATE'S VALLEY (D. Tourneur) - jumped away awkwardly and bumped ENVYEM. Laid in, in the straight.

LIVELY LASS (E. Boyd) - laid out from the 600 metres.

**VON SAGA** (J. Toeroek) - Trainer Mr T. Doudle was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. Stewards advised Mr Doudle that he would be required to produce the TIC prior to accepting for a future race.

ENVYEM (S. Logan) - shifted in on jumping away and bumped KATE'S VALLEY.

**SHE'S DREAMING** (J. Maund) - shortly after the start was tightened between AARVI'S WISH, which shifted out and EXPERIOR, which shifted in and lost its position.

### RACE 5: FLEURIEU MILK RATING 0-58 HANDICAP - 1100 Metres

**DOUG'S JOURNEY** (A. Lindsay) - laid in, in the straight.

**RANGER FRANK** (D. Tourneur) - rider explained he was obliged to ride the gelding along throughout as the gelding is better suited over longer distances. A post-race veterinary examination revealed no visible abnormalities.

CARTIER TIARA (B. Vorster) - laid in, in the straight.

**SYLVAN CREST** (M. Collett) - jumped away awkwardly, shifted out and bumped TASTE OF DIAMONDS. Raced wide without cover throughout the event. Rider explained after being wide throughout and the gelding being first up from a spell, she was of the opinion, SYLVAN CREST would be better suited over a longer distance and would benefit from the run in today's event. A post-race veterinary examination revealed no visible abnormalities.

TASTE OF DIAMONDS (C. Lions) - bumped on jumping away by SYLVAN CREST.

ICECRUSHER (J. Holder) - jumped away awkwardly.

#### RACE 6: NORTHPOINT FLEURIEU RATING 0-58 HANDICAP - 2065 Metres

**IKNOW WHERE YOULIV** (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

**WICKED RHYTHM** (P. Gatt) - rider explained that after being caught three wide in the early stages of the event, he elected to roll forward to gain a position close to the fence.

MONTEFERRANTE (B. Vorster) - laid in, in the straight.

**SILVER JEWEL** (J. Toeroek) - rider reported the mare pulled hard in the early stages of the event and when asked for an effort in the straight, was one paced and for that reason elected not to ride the mount out in his normal manner over the final 100 metres. Rider reminded of his obligation to ride his mount out to the finish.

#### RACE 7: STRATHALBYN SMALL ENGINES BENCHMARK 58 HANDICAP - 1600 Metres

**ZOUNAMI** (B. Vorster) - Stable advised that they would instruct the rider to attempt to ride the gelding more patiently in the early stages. Settled mid-field. Shortly after the start was obliged to be steadied away from the heels of SHINING BRIGHTLY, which shifted out. Raced wide without cover in the early and middle stages.

**BIG CALL** - underwent a pre-race veterinary examination on arrival at the barriers and ruled unfit to start. A late scratching by order of Stewards at 3.38 pm on veterinary advice as the mare was found to be lame in the near foreleg. Trainer, Mr P. Moody was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**HOLY SANGRIA** (J. Holder) - on jumping away was inconvenienced and taken wider bumping SHINING BRIGHTLY.

**BLINKY O'REILLY** (J. Maund) - rider reprimanded under AR131(b) as he failed to ride his mount out to the finish. A post-race veterinary examination revealed no visible abnormalities.

**FANTASTIC MAGIC** (K. Bishop) - jumped away awkwardly shifted out inconveniencing HOLY SANGRIA. Laid out throughout the event. Raced keenly in the early stages of the event.

**SHINING BRIGHTLY** (S. Fawke) - on jumping away was inconvenienced and taken wider by HOLY SANGRIA.



#### RACE 8: PEARLE BOUTIQUE BENCHMARK 54 HANDICAP - 1350 Metres

HIGH MIST (M. Collett) - slow to begin. Laid out in the straight.

**KNAVESMIRE** (L. Neindorf) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

REDEEKA (J. Opperman) - jumped away awkwardly and as a result was slow to begin.

MISS ARTIER (R. Hurdle) - raced wide without cover throughout the event.

**SPIRITED MATCH** (A. Lindsay) - raced keenly in the early and middle stages of the event. Rolled about under pressure in the straight.
