

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 30 May 2020

RACE 1: HOLDFAST INSURANCE HANDICAP - 1250 Metres

SO YOU CAN (J. Holder) - raced keenly in the early stages of the event.

THE KRONE (B. Vorster) - raced keenly in the early stages of the event and laid out from near the 600 metres.

AFRICAN AWESOME (T. Voorham) - rider dislodged en route to the barriers. T. Voorham was examined by the First Care Medical Personnel and passed fit to fulfil her engagement. A post-race veterinary examination revealed no visible abnormalities.

CAPRICORN RIDGE (P. Gatt) - raced keenly in the early stages of the event. Inclined to lay in, in the early part of the straight.

SUPER STRIKER (C. Jones) - approaching the 1000 metres got its head up when awkwardly placed on the heels of CAPRICORN RIDGE as the pace slackened slightly. As a consequence raced ungenerously for several strides and thereafter laid out from near the 200 metres.

RACE 2: WINNING EDGE PRESENTATIONS HANDICAP - 1400 Metres

PRETTY GLASS (T. Voorham) - contacted at the start by FLOP, which began awkwardly and shifted out.

ENKI (S. Cahill) - held up for clear running from near the 400 metres until in the vicinity of the 300 metres.

FLOP (S. Logan) - awkward to begin, shifted out onto PRETTY GLASS contacting that horse. Laid out rounding the home turn. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.



RACE 2: WINNING EDGE PRESENTATIONS HANDICAP - 1400 Metres (Cont'd)

TOFF LOVE (B. Vorster) - rider explained that his instructions were to be forward with cover if possible, and to be mindful that the gelding has a tendency to over-race in the early stages. He added that while he was able to comply with his instructions to take up a forward position, he was unable to obtain cover in the early stages, but nevertheless settled nicely in running in the early and middle stages, however from in the vicinity of the 600 metres the gelding was off the bridle and failed to respond to his riding and commenced to give ground after entering the straight, and as a consequence, he stopped riding his mount competitively from near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

NO PAROLE (E. Boyd) - rider reported the gelding was inclined to change stride during the event and although racing a bit greenly, did not feel comfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

ELUSIVE NATURE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3: M&J CHICKENS HANDICAP - 1950 Metres

BERTWHISTLE (K. Crowther) - raced wide without cover in the early stages. Rider explained that her instructions were, having regard for her wide barrier, to be positive early to obtain a more favourable position in running in the early stages. She stated that after being trapped wide in early stages of the event, she was obliged to work forward to obtain a position near the lead shortly thereafter.

BUSKER'S BALLAD (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200. Rider was reminded to ride his mounts out fully to the finish in future.

RAPID RAISER (L. Neindorf) - over-raced in the early stages of the event. Raced wide without cover in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

BUDGET KING (J. Toeroek) - over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SET TO CRUISE (R. Hurdle) - was momentarily disappointed for clear running on entering the straight when racing behind RAPID RAISER and inside BUSKER'S BALLAD. As a consequence was obliged to shift to the inside of RAPID RAISER to obtain clear running.

DESERT MINTY (P. Gatt) - performed poorly. Rider explained the gelding may have got its tongue over the bit and chocked down in running, and for that reason he did not persevere with his riding from near the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: ADELAIDE GALVANISING HANDICAP - 1000 Metres

FORTUNE FOLLOWS (T. Pannell) - approaching the 200 metres was contacted by BRIMARVI ROOBOY, which was tightened after that horse received pressure from GLORY GAME to its inside and as a consequence was hampered for a number of strides.

DIMAGGIO (B. Vorster) – was fractious in its barrier and as a consequence was very awkward to begin losing two to three lengths at the start. Shortly after the entrance to the straight when attempting to improve its position between OUTPOST and MAGIC PHANTOM was inconvenienced by MAGIC PHANTOM, which commenced to lay in and shifted in, resulting in contact between these two horses and DIMAGGIO becoming awkwardly placed outside the heels of OUTPOST. Shortly thereafter DIMAGGIO in an attempt to maintain its position and improve to the outside of OUTPOST shifted out and contacted MAGIC PHANTOM resulting in that horse's hindquarters being turned and it shifting out and away onto GLORY GAME, which reacted and shifted out and away onto BRIMARVI ROOBOY resulting in that horse being tightened onto FORTUNE FOLLOWS and being severely hampered for several strides approaching the 200 metres.



RACE 4: ADELAIDE GALVANISING HANDICAP - 1000 Metres (Cont'd)

MAGIC PHANTOM (L. Neindforf) - Stewards acceded to a request from Trainer Mr J. O'Connor to allow the gelding to race without a cross-over nose band, which was part of its declared gear. Mr O'Connor was found guilty of a charge under AR206(2) for failing to obtain Stewards permission for a gear change prior to acceptance time and was fined \$200. Raced keenly in the early stages of the event. Laid in shortly after the entrance to the straight, shifted in and contacted DIMAGGIO and shortly thereafter, approaching the 200 metres, was contacted and had its hindquarters turned by DIMAGGIO, which shifted out, and as a consequence shifted out onto GLORY GAME taking that horse on an outward course.

LARKHAM (C. Jones) - awkward to begin, shifted out and contacted MRS HYDE.

MAGNO (D. Tourneur) - raced keenly in the early stages of the event.

BRIMARVI ROOBOY (J. Holder) - approaching the 200 metres was severely hampered for several strides when tightened between GLORY GAME, which was taken out by MAGIC PHANTOM and FORTUNE FOLLOWS, which maintained its line. Lost it's off fore plate during the event.

MRS HYDE (S. Logan) - contacted at the start. Lost it's off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

GLORY GAME (T. Voorham) - approaching the 200 metres was taken out by MAGIC PHANTOM, which shifted out after being contacted by DIMAGGIO and as a consequence shifted out onto BRIMARVI ROOBOY tightening that horse onto FORTUNE FOLLOWS for several strides.

RACE 5: TAB HANDICAP - 1300 Metres

MIDNIGHT STORM (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

PERSIAN EMPIRE (NZ) (P. Gatt) - contacted and tightened at the start.

BAR GEM (E. Boyd) - contacted at the start by PERSIAN EMPIRE (NZ), which was taken out and as a consequence became awkward on the heels of DIXON STREET and was unable to maintain its position. Thereafter raced keenly in the middle stages of the event.

BRAY STREET BOSS (T. Pannell) - near the entrance to the straight was inconvenienced by MISS MOSH, which shifted out to improve. When questioned rider explained his instructions were to allow the gelding to balance up in the early stages, and to be mindful it has a tendency to overrace. He added that it was his intention to settle mid-field if possible however, after beginning only fairly and having regard for the pace in the event and the formation of the field, he was unable to settle mid-field and was obliged to settle back of mid-field with cover. He stated that mid-race, near the 600 metres, when asked for an effort the gelding failed to respond in the manner he expected. He added the gelding failed to finish the event off and was very disappointing. A post-race veterinary examination revealed no visible abnormalities.

MARINA (S. Fawke) - near the 900 metres shifted in and hampered DIXON STREET, which had to be restrained when racing keenly. Rider was reminded of his obligations when shifting ground.

DIXON STREET (L. Neindorf) - raced keenly in the early stages and near the 900 metres was hampered by MARINA, which shifted in.

CUPID'S BOW (NZ) (B. Vorster) - awkward to begin, shifted out, contacted and tightened PERSIAN EMPIRE (NZ) onto BAR GEM.

MISS MOSH (J. Potter) - near the entrance to the straight shifted out to improve at an acute angle and momentarily inconvenienced BRAY STREET BOSS. Rider was severely reprimanded and advised to take greater care when shifting ground in future.



RACE 5: TAB HANDICAP - 1300 Metres (Cont'd)

QUICK BISCUIT (K. Bishop) - raced keenly in the early stages for a short distance.

RACE 6: AAMI HANDICAP - 1550 METRES

JOURNEYGIRL (T. Pannell) - inside the 800 metres was inconvenienced for a number of strides by OFFICE JIM, which shifted out slightly and as a consequence was taken wider for a short distance before shifting back in near the 600 metres.

OFFICE JIM (L. Neindorf) - when question regarding his riding from approaching the 800 metres, rider explained it was his intention to shift out wider and obtain a position outside of FULTON STREET at that stage of the event, as he considered that horse would not take him into the straight and shifted to the outside of PREDICTS. It was noted that this shift momentarily inconvenienced JOURNEYGIRL. He added that he intended to maintain his position to the outside of PREDICTS however, near the 600 metres his mount was inclined to roll in and rolled back in behind the heels of PREDICTS and at the same time JOURNEYGIRL improved to his outside which forced him to remain in a position trailing PREDICTS for a short distance, and as a consequence was only able to improve his position in running from near the 500 metres. He further stated that his mount was a little one paced in running and while it finished the race off in a respectable manner, did not sprint home.

SKILLFUL STEPS (J. Toeroek) - raced keenly in the early stages of the event.

EXALTED DEE (C. Jones) - raced wide without cover in the middle stages of the event.

PREDICTS (S. Fawke) - raced keenly in the early stages of the event.

BALDY (E. Finnegan) - near the 900 metres commenced to over-race when awkward on the heels of DREAMED and thereafter commenced to lay out significantly rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: ADELAIDE APPEALS COMMITTEE HANDICAP - 1000 Metres

TERBIUM (L. Neindorf) - contacted at the start by SCHILLDORA, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

BENZ (S. Cahill) - near the entrance to the straight shifted out to improve and inconvenienced SCHILLDORA.

EQUAL LOVE (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

BRIMARVI VEHERO (D. Tourneur) - near the 100 metres shifted in abruptly of its own accord and was immediately corrected by its rider.

SCHILLDORA (J. Toeroek) - rolled in at the start and contacted TERBIUM. Near the entrance to the straight was momentarily inconvenienced when taken out by BENZ, which shifted out to improve.

WHITE KAPS (A. Jordsjo) - knuckled at the start and as a result was slow to begin. Rider reported it was her intention to settle more forward during the event however, as a consequence of the manner in which the gelding began, she was unable to take up a forward of mid-field position and was obliged to settle further back in running.

HE IS GOLDEN (J. Potter) - awkward to begin.



RACE 8: FURPHY HANDICAP - 1250 Metres

AUSSIE JACK (C. Jones) - awkward to begin. Shifted in at the start and contacted NORDIC PRIDE. A post-race veterinary examination revealed no visible abnormalities.

KINGSGROVE (D. Tourneur) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Co-Trainer Ms J. Frew was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future, approval to race jump out, trial or race.

ROTHMOORE (P. Gatt) - Stewards acceded to a request from Trainer Mr R. Moore for the gelding to be a late scratching, having regard for the earlier track upgrade to a Good 4. Mr Moore's submission was that the gelding was not suited to racing on firmer ground and would have been better suited on a soft track. ROTHMOORE was declared a late scratching by order of Stewards at 3.00 pm.

LOFTY TYCOON (E. Finnegan) - raced keenly in the early stages of the event.

NORDIC PRIDE (K. Crowther) - tightened and contacted at the start between AUSSIE JACK and AQUANAUT, which both began awkwardly and shifted ground, and as a consequence was unable to maintain its position immediately after the start. Near the 700 metres, when racing to the inside of BIRD OF WAR, was tightened as that horse was obliged to shift in when being taken in by SAND CAT, which shifted in momentarily. As a consequence NORDIC PRIDE had to be checked and was unable to maintain its position.

GOD'S PENNY (L. Neindorf) - rider accidentally dropped his off side rein near the 300 metres.

SAND CAT (C. Lions) - near the 700 metres momentarily shifted in onto BIRD OF WAR taking that horse in onto NORDIC PRIDE, resulting in NORDIC PRIDE having to be checked and losing its position. Rider was severely reprimanded and advised to take greater care when her mounts commence to shift ground in future. Near the 100 metres laid out and shifted out resulting in LACE AND WHISKEY being taken out onto the heels of PALE ALE and having to be checked to avoid that horse's heels. Stewards were satisfied that C. Lions had taken corrective measures as soon as her mount commenced to lay out and consequently took no further action.

LACE AND WHISKEY (T. Pannell) - rider was dislodged en route to the barriers, examined by the First Care Medical Personnel and passed fit to fulfil his engagement. Near the 100 metres was tightened onto the heels of PALE ALE by SAND CAT, which laid out and shifted out and had to be checked to avoid the heels of PALE ALE. A post-race veterinary examination revealed no visible abnormalities.

BIRD OF WAR (B. Vorster) near the 700 metres when racing to the inside of SAND CAT was taken in by that horse as it shifted in momentarily and as a consequence, shifted in onto NORDIC PRIDE, which had to be checked.

WHEN STARS ALIGN (T. Voorham) - rider was examined by the First Care Medical Personnel on arrival at the barriers and was passed fit to fulfil her engagement.

AQUANAUT (J. Potter) - underwent a pre-race veterinary examination and was passed fit to race. Awkward to begin, shifted out and contacted NORDIC PRIDE.

RACE 9: 36° SOUTH BEEF HANDICAP - 1000 Metres

EXALTED GOLD (S. Logan) - shortly after the start shifted in to take up a more forward position, and crossed the running of PANDEIA, which was inconvenienced and had to be steadied. As a consequence PANDEIA was obliged to shift to the outside of EXALTED GOLD. Rider was severely reprimanded and advised to take greater care when shifting ground. Laid out rounding the home turn.

KINGSON (T. Voorham) - over-raced in the early stages and raced very ungenerously for a short distance approaching the 700 metres.



RACE 9: 36° SOUTH BEEF HANDICAP - 1000 Metres (Cont'd)

PAPALET (C. Jones) - over-raced in the early stages of the event. Near the 800 metres was obliged to shift to the outside of DEVONTE, which shifted in to obtain a more forward position. Laid out in the straight. Over the concluding stages, when being corrected when laying out, shifted into the running line of ANAMNESIS, which was hampered.

PANDEIA (D. Caboche) - awkward to begin. Shortly after the start was inconvenienced and had to be steadied when crossed by EXALTED GOLD, which shifted in.

ON APPRO (S. Cahill) - underwent a pre-race veterinary examination as the mare had not raced since July 2019 and was passed fit to race. Awkward to begin. Rider explained he had no specific instructions other than to allow the mare to jump well and hold a spot early, but not to lead in the event. He stated he was comfortable with the position obtained in running however, on straightening, was unable to make ground on EXALTED GOLD when finishing the event off.

THE PUBLIKIN (P. Gatt) - contacted at the start. Raced keenly in the early and middle stages of the event.

ANAMNESIS (K. Zechner) - shifted out shortly after the start onto PAPALET, which was tightened onto RUSHWA, which was tightened onto the heels of PANDEIA, resulting in RUSHWA losing its position. Over-raced in the early and middle stages of the event. Over the concluding stages, was hampered for several strides by PAPALET, which shifted in after being corrected.

ALMADRAVA (K. Crowther) - awkward to begin, shifted out and contacted THE PUBLIKIN. Overraced in the early stages of the event. Was disappointed for clear running from near the 300 metres until inside the 200 metres.

GWENT (C. Lions) - was disappointed for clear running from inside the 300 metres until inside the 200 metres.

RUSHWA (T. Pannell) - tightened shortly after the start and lost its position. Held up for clear running form near the entrance to the straight until approaching the 100 metres.

DEVONTE (A. Jordsjo) - near the 800 metres shifted in to take up a more forward position and crossed the running of PAPALET, which when racing keenly was obliged to be steadied and shifted to the outside of DEVONTE'S heels. Rider was severely reprimanded and advised to take greater care in future when shifting ground.
