Report on Race Meeting held at Bordertown Racecourse  
by the Millicent Racing Club on Sunday, 31 May 2020

**TRACK:** Soft 5  
Downgraded to a Soft 6 at 11.00 am *(Track with a reasonable amount of give in it)*  
*(Moist but not a badly affected track)*

**RAIL:** Out 2 metres from 1550m to 1200 metres, True Remainder.

**WEATHER:** Overcast

**RACE 1: E SMART ELECTRICAL SABOIS MAIDEN PLATE - 1550 Metres**

LOPE DE PARIS (S. Fawke) - over-raced throughout the event.

OUR JOURNEYMAN (T. Voorham) - inclined to lay in under pressure in the straight.

THE MASTER BLASTER (D. Caboche) - made the turn in the vicinity of the 1300 metres awkwardly.

SISTER DEE (E. Finnegan) - raced keenly in the early and middle stages of the event.

STRYKER STAR (C. Jones) - raced wide without cover throughout the event. Laid in under pressure in the straight.

RIVER (S. Logan) - rider explained that the filly was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: WATTLE RANGE COUNCIL SABOIS MAIDEN/CLASS 1 PLATE - 2000 Metres**

The start of this event was delayed approximately seven minutes owing to RAPID RIDE becoming cast in its barrier.

BUCKEYE NATION (J. Potter) - approaching the 400 metres when weakening was obliged to be eased when tightened inside of LAST ONE NAMED.

## **RACE 2: WATTLE RANGE COUNCIL SABOIS MAIDEN/CLASS 1 PLATE - 2000 Metres (Cont'd)**

**LAST ONE NAMED** (S. Fawke) - in the vicinity of the 1100 metres was permitted to stride forward by its rider to take up a position in the lead. Approaching the 400 metres was taken in slightly by **COSTA MAYA** onto **BUCKEYE NATION**.

**RAPID RIDE** - during the loading process the gelding became cast in its barrier for some time. Underwent a pre-race veterinary examination which ruled the gelding unfit to race. Acting on this advice Stewards withdrew **RAPID RIDE** at 1.13 pm. Following this event on inspection of Barrier 7, it was noted that barrier was unable to be used for the remainder of the day due to damage following **RAPID RIDE** becoming cast. Trainer, Mr A. Beswick, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**SWANKYTOFF** (A. Jordsjo) - approaching the 400 metres rolled in slightly onto **COSTA MAYA**, which was tightened onto **LAST ONE NAMED**, which was taken in slightly onto **BUCKEYE NATION**, which was obliged to be eased when weakening. Rider was reminded of her obligations under AR131(a) and advised to take greater care in future. Laid in under pressure in the straight.

**COSTA MAYA** (J. Maund) - approaching the 400 metres became tight between **LAST ONE NAMED** and **SWANKYTOFF**, which rolled in.

**REGAL DOMAIN** (K. Bishop) - over-raced in the early stages of the event.

**SCARFACE CURIO** (D. Tourneur) - laid in under pressure in the straight.

**STAR QUEST** (P. Gatt) - jumped away very awkwardly shifted out and as a result rider made heavy contact with the outside barrier partition on his right shoulder placing him at a disadvantage for the remainder of the event. Following this event rider was permitted not to weigh in in accordance with AR208(3)(b) as he was being attended to by the First Care Medical Personnel and was ruled unfit to fulfil his engagement in Race 3 and will be reassessed following that race. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow Stewards to view the vision of the start in relation to **STAR QUEST** (P. Gatt).

## **RACE 3: MILLICENT TOYOTA SABOIS MAIDEN PLATE - 1000 Metres**

The start of this event was delayed approximately five minutes owing to the delay experienced in the previous event.

**AMUSING MAGNUS** (K. Zechner) - in the vicinity of the 900 metres shifted in marginally on **DAZZLING HARMONY**, which was obliged to be steadied. Rider was severely reprimanded under AR131(a) and advised to take greater care in future.

**JAYWICK** (D. Tourneur) - jumped away awkwardly.

**LIKE A HEARTBEAT** (J. Opperman) - laid in under pressure in the straight.

**DAZZLING HARMONY** (A. Lindsay) - in the vicinity of the 900 metres was obliged to be steadied as **AMUSING MAGNUS** shifted in marginally. In the vicinity of the 800 metres shifted out when being corrected in onto **WYNTER LADY**.

**SHELLSHOCKED** (E. Annells) - raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**WYNTER LADY** (A. Jordsjo) - in the vicinity of the 800 metres was obliged to be steadied as **DAZZLING HARMONY** shifted out when being corrected.

Following the running of this race P. Gatt was re-examined by the First Care Medical Personnel and ruled unfit to fulfil his remaining engagements.

**RACE 4: 3MP STEEL, ROOFING AND SHED SUPPLIES SABOIS MAIDEN HANDICAP**  
**- 1200 Metres**

The start of this event was delayed approximately two minutes.

**WONGA FLYER** (J. Potter) - shortly after the start was inconvenienced by **EXPERIOR** and shifted in to obtain cover.

**EAST CAPE** (A. Lindsay) - jumped away awkwardly.

**EXPERIOR** (K. Crowther) - shortly after the start rolled out onto **WONGA FLYER**, which was inconvenienced. A post-race veterinary examination revealed no visible abnormalities.

**WINTER HARBOUR** (J. Maund) - jumped away awkwardly, shifted out taking **CHARADE** wider. Held up for clear running from in the vicinity of the 400 metres until in the vicinity of the 300 metres when racing between **ACE OF CLUBS** and **OUT PROVEN** and shifted out and bumped with **OUT PROVEN** on a number of occasions.

**ACE OF CLUBS** (A. Jordsjo) - raced wide without cover throughout the event.

**OUT PROVEN** (J. Holder) - in the vicinity of the 300 metres bumped with **WINTER HARBOUR**, which shifted out when looking to improve on a number of occasions and thereafter laid in under pressure.

**SIMPLY VEIN** (S. So) - slow to begin.

**TRIVAGO GIRL** (S. Fawke) - laid in under pressure in the straight.

**BLACK CHEVAL** (M. Collett) - jumped away awkwardly.

**CHARADE** (S. Logan) - laid in under pressure in the straight. In the vicinity of the 200 metres became awkwardly placed on the heels of **WINTER HARBOUR** and **OUT PROVEN** for a short distance.

**RACE 5: DI GIORGIO FAMILY WINES BM 58 HANDICAP - 1550 Metres**

**BRIGHT BELLE** (L. Halliday) - over-raced in the early and middle stages of the event.

**DOUBLE POCKETS** (L. Neindorf) - slow to begin. Rider explained his instructions were to settle more forward in today's event preferably one out one back, however, after beginning slow and the early formation of the race, he elected to settle where comfortable and allow his mount to stride freely as it does have a tendency to over race when being restrained. A post-race veterinary examination revealed no visible abnormalities.

**SIRIUS JOURNEY** (K. Zechner) - laid out under pressure in the straight.

**BULLET KID** (A. Jordsjo) - laid in under pressure in the straight.

**RACE 6: JOHN CHAY LIVESTOCK BM68 HANDICAP - 1200 Metres**

**RHYTHMATIC** (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

**SAVE ME NED** (C. Jones) - held up for clear running for a short distance rounding the home turn.

**MY MOTHER SAYS** (E. Boyd) - on jumping away restrained from it wide barrier and shifted in to obtain cover. At the entrance to the straight was taken wider by **SPACE EQUITY**.

### **RACE 6: JOHN CHAY LIVESTOCK BM68 HANDICAP - 1200 Metres (Cont'd)**

**SPACE EQUITY** (A. Lindsay) - required to be reshod on arrival on course. In the vicinity of the 600 metres became awkward in its action for a short distance. Rounding the home turn hung out and took MY MOTHER SAYS wider, which was obliged to shift in to obtain clear running and thereafter continued to hang out. Rider was reminded of her obligations under AR131(a) and advised to take greater care in future.

**DABAY** (S. Fawke) - raced keenly in the early and middle stages of the event.

### **RACE 7: 3MP SABOIS + MILLICENT CUP - 2000 Metres**

**WOOLSTHORPE STORE** (C. Jones) - underwent a pre-race veterinary examination as it had not raced since 19 May 2019 and passed fit to race. In the vicinity of the 150 metres was inconvenienced when tightened between EXALTED RUTH, which rolled out and SASUN, which rolled in.

**GIGGLON** (M. Collett) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**DYAGILEV** (J. Maund) - weakened from approaching the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

**SASUN** (E. Finnegan) - in the vicinity of the 150 metres rolled in onto WOOLSTHORPE STORE.

**EXALTED RUTH** (J. Holder) - in the vicinity of the 150 metres rolled out onto WOOLSTHORPE STORE.

**HASTA LA FIORENTE** (T. Voorham) - over-raced throughout the event and got its head up on a number of occasions when being restrained. Dipped inside the 400 metres for no apparent reason. A post-race veterinary examination revealed no visible abnormalities.

**MUNTHAM MISSILE** (D. Tourneur) - inclined to lay out under pressure in the straight.

**SPIEGEL GROVE** - injured itself in the float en route to the course. Underwent a pre-race veterinary examination on arrival on course who ruled the gelding to have suffered an injury to the head and would be unfit to race. Acting on this advice Stewards withdrew SPIEGEL GROVE at 12.13 pm. Trainer Mr D. Magro was advised a veterinary certificate of fitness is required prior to the gelding accepting for a future trial or race.

**CENTENARY SHOT** (S. Fawke) - shortly after the start shifted in to obtain cover.

### **RACE 8: 3MP SHED'S, CARPORTS & VERANDA'S BM 58 HANDICAP - 1000 Metres**

When the barriers were being transported between races, they inadvertently went through the outside running rail and as a result, the rail was required to be fixed and barriers 6 and 10 were unable to be used due to damage during the incident. As a consequence, the start of this event was delayed approximately nine minutes.

**RODNEY** (A. Jordsjo) - raced wide without cover throughout the event. Hung out from in the vicinity of the 400 metres until the finish. Rider reported the gelding did not feel comfortable in its action during the event and for this reason elected not to ride her horse out over the final 150 metres. A post-race veterinary examination revealed no visible abnormalities.

**MAGICHELL** (D. Tourneur) - held up for clear running from the entrance to the straight until the 200 metres and from thereafter laid in for the remainder of the event.

**MISS CATASTROPHI** (J. Potter) - was kicked by another runner behind the barriers. Underwent a pre-race veterinary examination and passed fit to race. Shortly after the start shifted in to obtain cover.

**RACE 8: 3MP SHED'S, CARPORTS & VERANDA'S BM 58 HANDICAP - 1000 Metres (Cont'd)**

**RUSTYDUSTYSUNSHINE** (C. Jones) - held up for clear running from rounding the home turn until in the vicinity of the 200 metres.

**LICORICE BULLET** (K. Bishop) - shortly after the start shifted in to obtain cover. Laid in under pressure in the straight.

**RACE 2: WATTLE RANGE COUNCIL SABOIS MAIDEN/CLASS 1 PLATE - 2000 Metres**

**RAPID RIDE** - On Monday, 1 June 2020 Trainer Mr A Beswick reported that on return to his stable the gelding was slightly lame in the off side stifle and will be assessed in the coming days and a decision will be made in relation to continuing on with the gelding's preparation.
