Report on Race Meeting held at Gawler Racecourse  
by the Gawler & Barossa Jockey Club on Wednesday, 3 June 2020

**TRACK:** Soft 6 (Moist but not a badly affected track)

**RAIL:** Out 6 metres Entire, Sectional 612 metres

**RACE 1: TERRACE FUNCTION CENTRE MAIDEN HANDICAP - 1522 Metres**

**JAY PEE BEE (NZ)** (J. Potter) - laid out under pressure from the 400 metres onwards.

**TOSCA ROCKS** (R. Hurdle) - raced keenly in the early and middle stages of the event.

**KRUPTONITE** (J. Holder) - began awkwardly.

**MISS CON DELAGO** (B. Vorster) - laid in, in the straight. Rider reported the filly travelled well until placed under pressure from near the 400 metres and was disappointing over the concluding stages.

**RACE 2: GBJC MEMBERS - HOPE TO SEE YOU SOON / SABOIS DISTANCE MAIDEN PLATE - 2132 Metres**

**OUR JOURNEYMAN** (J. Holder) - as the start was affected the gelding became restless in its barrier and placed its near hind leg on the barrier partition, as a result OUR JOURNEYMAN began very awkwardly and lost considerable ground.

**WHYS** (S. Fawke) - became fractious in its barrier, reared and momentarily became cast. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on this advice, Stewards declared WHYS a late scratching at 12.47 pm. Trainer Mr T. Day was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial or Approval to Race jump out prior to accepting for a future race.

**STAR QUEST** (A. Jordsjo) - began awkwardly. Laid out in the home straight.

**BLINKIN READY NOW** (A. Lindsay) - began awkwardly.

**RACE 2: GBJC MEMBERS – HOPE TO SEE YOU SOON / SABOIS DISTANCE MAIDEN PLATE**  
**- 2132 Metres (Cont'd)**

**KADASHI** (S. Logan) - raced keenly in the early and middle stages of the event.

Correct weight was delayed to allow Stewards to view the start of the race to ascertain whether OUR JOURNEYMAN was denied a fair start. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards declared OUR JOURNEYMAN a runner.

**RACE 3: TAB / SABOIS MAIDEN PLATE - 1200 Metres**

**IT'S MAGIC** (S. Fawke) - rider reported his mount laid out from the 800 metres onwards. A post-race veterinary examination revealed the gelding had swelling over the eye. First aid administered.

**KANZO** (D. Tourneur) - raced wide without cover throughout the event.

**KEN'S THUNDER** (A. Jordsjo) - rider reported her mount travelled well in the early stages however, did not respond to her riding in the home straight.

**KUNANYI** (D. Tootell) - underwent a pre-race veterinary examination as the gelding has not raced for over 12 months and passed fit to race. Began awkwardly. Approaching the 900 metres raced keenly and had to be eased after becoming awkward on the heels of STYLE GURU (NZ).

**STYLE GURU (NZ)** (R. Hurdle) - jumped out at the start and bumped AUSSIE SOJOURN. Laid out in the straight.

**THE WONDERFUL CAT** (K. Zechner) - bled from both nostrils. Trainer, Ms J. Virgin, was advised that as this was the gelding's first bi-lateral bleed THE WONDERFUL CAT would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

**ARCTIC FLORA** (E. Finnegan) - slow to begin. Trainer Mr R. Atkinson was advised a warning had been placed on the mare. Difficulty obtaining clear running from near the 500 metres until approaching the 250 metres.

**BLACK DIAMONDS** (K. Bishop) - eased down by its rider over the concluding stages. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer Mr M. Moosha was advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

**AUSSIE SOJOURN** (T. Pannell) - bumped by STYLE GURU (NZ) on jumping away. Near the 1000 metres raced keenly and had to be eased off the heels of THE WONDERFUL CAT. Laid out rounding the home turn and continued to do so for the remainder of the event.

**RACE 4: GAWLER CUP – FRIDAY OCTOBER 23RD BENCHMARK 54 HANDICAP - 1732 Metres**

**REINVIGORATE (NZ)** (B. Vorster) - rider explained when asked for an effort near the 700 metres, his mount failed to respond and was disappointing thereafter. A post-race veterinary examination revealed no visible abnormalities.

**FLYING ARION** (J. Toeroek) - rider reported his mount laid in from the 500 metres. When laying in near the 300 metres had to be eased off the heels of SCOUT'S HONOUR. A post-race veterinary examination revealed no visible abnormalities.

**RACE 4: GAWLER CUP – FRIDAY OCTOBER 23RD BENCHMARK 54 HANDICAP**  
**- 1732 Metres (Cont'd)**

**RED VALENTINE (NZ)** (D. Caboche) - crowded on jumping away between SCOUT'S HONOUR and FLYING ARION, both which shifted ground. Rider reported that despite his urgings, the gelding was reluctant to stretch out in the early stages and subsequently took no competitive part in the event. Trainer Mr T. Doudle was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial or Official Jump out prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**TAKSIM GIRL** (T. Pannell) - near the 1500 metres had to be eased off the heels of REINVIGORATE (NZ). Passing the 1200 metres was bumped by SAMSTAG.

**SAMSTAG** (D. Tourneur) - passing the 1200 metres became awkward inside the heels of REINVIGORATE (NZ), which shifted in and bumped TAKSIM GIRL. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SCOUT'S HONOUR** (E. Finnegan) - raced wide without cover throughout the event. Rider accidentally dropped her whip in the vicinity of the 200 metres.

**RACE 5: COOPERS BREWERY BENCHMARK 60 HANDICAP - 1522 Metres**

**HIGH MIST** (M. Collett) - when over-racing near the 1100 metres had to be eased off the heels of ANCIENT HISTORY (IRE). Laid out rounding the home turn.

**ANCIENT HISTORY (IRE)** (T. Pannell) - had difficulty obtaining clear running from near the 500 metres until shortly after passing the 250 metres.

**BIG CALL** (E. Boyd) - rider reported her mount slipped behind on jumping away, resulting in the mare being slow into stride. Approaching the 1200 metres had to be eased when awkwardly placed between HIGH MIST and L'AMARYBELLE. Raced wide without cover from the 1100 metres. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: THANK YOU TRIMBOLI SERVICES RATING 0-58 HANDICAP - 1200 Metres**

**ROTHMOORE** (J. Holder) - jumped away inwards and bumped GO FOR IT.

**DASKULYA** (K. Bishop) - Lost its near hind plate during the event. Raced keenly in the early and middle stages of the event.

**OUR BENEVENTO** (L. Neidndorf) - the tongue-tie was dislodged in the mounting yard and refitted on arrival at the barrier. Rider reported his mount was one paced over the final stages after having travelled well throughout the event.

**GO FOR IT** (D. Tootell) - bumped by ROTHMOORE at the start.

**DOWNS AFTER DARK** (A. Lindsay) - near the 800 metres DASKULYA had to be checked to avoid the heels of DOWNS AFTER DARK, which shifted in when insufficiently clear. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 10 June and to conclude at midnight on Wednesday, 17 June 2020: a period of three meetings.

**DEXTER'S NIBBLE** (S. Fawke) - contacted on the hindquarters and became unbalanced when bumped by SECRET CHARGE near the 300 metres.

**RACE 6: THANK YOU TRIMBOLI SERVICES RATING 0-58 HANDICAP - 1200 Metres (Cont'd)**

**SECRET CHARGE** (K. Zechner) - Mr S. Grivell advised stewards prior to the event of a change in tactics in that he would instruct his rider to race in the lead if circumstances permitted. After passing the 300 metres eased to avoid the heels of **DOWNS AFTER DARK**, which when tiring rolled out slightly and as a result made contact with **DEXTER'S NIBBLE**.

**FLORID** (E. Boyd) - near the 800 metres eased out after becoming awkward on the heels of **OUR BENEVENTO**. Rider reported her mount hung in, in the straight, resulting in her being unable to ride the gelding out in her normal manner.

**THRONES** (D. Caboche) - near the 300 metres eased off the heels of **DEXTER'S NIBBLE**.

**RACE 7: SUPPORT LOCAL BUSINESSES 0 - 58 HANDICAP - 1200 Metres**

**AQUANAUT** (J. Potter) - laid out rounding the home turn and throughout the remainder of the event.

**SCARE CAMPAIGN** (T. Voorham) - slow to begin.

**CARBONE** (R. Hurdle) - raced wide without cover throughout the event.

**CRY OUT LOUD** (M. Collett) - raced keenly in the early stages of the event.

**RACE 8: HOLDFAST INSURANCE BROKERS CLASS TWO HANDICAP - 1100 Metres**

**TAPPIN' THOMAS** (J. Toeroek) - near the 100 metres shifted in to avoid the heels of **SOUR CREAM**, which rolled out.

**SIR JOHNSON** (E. Finnegan) - laid in, in the straight resulting in the rider having to stop riding and straighten the gelding on a number of occasions. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$100.

**CIBACHROME** (R. Hurdle) - shortly after the start dipped. Near the 800 metres shifted in and away from **SOUR CREAM** as a result crowding **TWICE FORGOTTEN**.

**TWICE FORGOTTEN** (L. Neindorf) - near the 800 metres eased when crowded between **TAJAVEDO** and **CIBACHROME**, which shifted in and away from **SOUR CREAM**, which shifted in.

**PICAYUNE** (A. Jordsjo) - prior to the event rider reported that she had pain in her right foot as a result of making contact with the barrier when her mount **STAR QUEST** jumped away awkwardly in Race 2. Subsequently A. Jordsjo was examined by the First Care Medical Personnel and ruled fit to fulfil her engagement. Rider reported her mount laid out rounding the home turn.

**SOUR CREAM** (K. Crowther) - shifted out approaching the 100 metres and inconvenienced **TAPPIN' THOMAS**. A post-race veterinary examination revealed no visible abnormalities.
