Report on Race Meeting held at Murray Bridge Racecourse

TRACK: Soft 6 (Moist but not a badly affected track)
Upgraded to a Soft 5 at 10.45 am (Track with a reasonable amount of give in it)

RAIL: Out 10 metres from 800 metres to winning post, 5 metres remainder

RACE 1: SPRY CIVIL CONSTRUCTION BENCHMARK 72 HANDICAP - 1400 Metres

The start of this event was delayed approximately one minute due to a delay with an interstate race (Kilcoy).

CROCKETT (L. Neindorf) - rider explained when rounding the home turn, that his mount was inclined to shift out and away from PUTTING ON AIRS, which was attempting to shift out when looking to improve.

CANNY MOVE (C. Jones) - over-raced in the early and middle stages of the event and got its head up on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

OH MO (D. Tourneur) - hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ELUSIVE ROSE (B. Vorster) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

AHMAD (E. Finnegan) - became awkward in its action from in the vicinity of the 600 metres until in the vicinity of the 400 metres. Rider explained her mount did not handle making the turn from the 600 metres to the 400 metres, from that point on when tested in the straight, failed to let down as she had anticipated and was awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: TAB / SABOIS MAIDEN PLATE - 1000 Metres

BADOS (J. Potter) - raced keenly in the early and middle stages of the event.

RACE 2: TAB / SABOIS MAIDEN PLATE - 1000 Metres (Cont'd)

LIVELY LASS (E. Boyd) - held up for clear running from the entrance to the straight until in the vicinity of the 200 metres and from then on had difficulty obtaining clear ground until inside the 100 metres, where it became held up for clear running until the finish.

DRESSMAKER (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

ENLIST (L. Neindorf) - in the vicinity of the 150 metres rolled in onto **MRS MOURINHO**, which was obliged to be steadied. Rider reminded of his obligations under AR131(a) and advised to take greater care in future.

SARNIA (M. Collett) - a post-race veterinary examination revealed no visible abnormalities.

ANOTHER AWARD (J. Holder) - held up for a short distance in the vicinity of the 300 metres and was obliged to shift out to obtain clear running.

MRS MOURINHO (K. Crowther) - inside the 400 metres was disappointed for a run between **VIRAGO MISS** and **DRY VALLEY** and shifted in. In the vicinity of the 150 metres improved into a run to the inside of **ENLIST** and was obliged to be steadied for a number of strides as that gelding laid in.

RACE 3: CARLTON DRAUGHT / SABOIS MAIDEN PLATE - 1400 Metres

BAD HABITS (D. Tourneur) - as the start was affected stood flat-footed and was slow to begin, losing several lengths. Trainer Mr J. Hyam was advised a warning had been placed on the gelding in relation to the way it began.

FOLLOW THE PROMPTS (C. Lions) - raced wide without cover throughout the event.

OUT PROVEN (J. Holder) - hung in severely from the entrance to the straight until the finish and proved difficult for the rider to ride his mount out in his normal manner. Stable representative Mr B. Jaensch was advised a warning had been placed on the mare in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

WURLIES LASTCHANCE (T. Voorham) - laid in under pressure in the straight.

GOLDEN RIPPLES (T. Pannell) - raced keenly in the early and middle stages of the event and got its head up on a number of occasions.

MR WOLF (B. Vorster) - jumped away awkwardly and shifted in onto **GOLDEN RIPPLES**, which was inconvenienced when tightened onto **NIKE BELLE**.

NIKE BELLE (J. Toeroek) - jumped away awkwardly and shifted out onto **GOLDEN RIPPLES**, which was inconvenienced when tightened onto **MR WOLF**. Rider reported the filly hung in under pressure in the straight.

PACIFIC RIM (L. Neindorf) - a post-race veterinary examination revealed a lower than expected heart rate.

SHE'S DREAMING (A. Jordsjo) - held up for clear running from in the vicinity of the 500 metres until inside the 400 metres.

RACE 4: IRONGATE / SABOIS PLUS BENCHMARK 58 HANDICAP - 2000 Metres

CENTENARY SHOT (J. Opperman) - inclined to lay in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: IRONGATE / SABOIS PLUS BENCHMARK 58 HANDICAP - 2000 Metres (Cont'd)

SWANKYTOFF (A. Jordsjo) - laid in under pressure in the straight.

COBBERS MATE (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

AMMO LOCO (S. Fawke) - held up for clear running from the 600 metres until the entrance to the straight. Inside the 200 metres bumped with FANTASTIC MAGIC, which was inclined to hang out and shifted out.

FANTASTIC MAGIC (K. Bishop) - raced keenly in the early and middle stages of the event. Hung out under pressure in the straight. Inside the 200 metres shifted out and bumped AMMO LOCO.

RACE 5: WEDDINGS AT BRIDGES EVENT CENTRE BENCHMARK 62 HANDICAP - 900 Metres

The start of this event was delayed approximately one minute.

QUIDDICK (J. Toeroek) - rider reported the mare was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

STREETCAR STRANGER (P. Gatt) - hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SONIC DEED (D. Tourneur) - from its wide barrier attempted to shift in to obtain cover.

HEAVEN ONLY KNOWS (K. Crowther) - proved difficult to load. Trainer Mr B. Bogarts was advised a warning had been placed on the mare in relation to its barrier manners.

MIHANY (E. Finnegan) - raced wide without cover throughout the event.

PAM'S JOURNEY (B. Vorster) - underwent a pre-race veterinary examination on arrival on course and passed fit to race.

RACE 6: BRIDGES EVENT CENTRE CLASS TWO HANDICAP - 1400 Metres

CHONCAPE (K. Bishop) - jumped away awkwardly and shifted out onto AURMAN ZOU, which lost its position. Raced keenly in the early and middle stages of the event. Hung out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

MULLAGHMORE (D. Caboche) - near the 300 metres was obliged to be eased when tightened onto DR DEE DEE as MISS ARTIER rolled out.

AURMAN ZOU (A. Jordsjo) - on jumping away lost its position when tightened onto CRYPTO CURRENCY as CHONCAPE jumped away awkwardly and shifted out.

NORDIC PRIDE (K. Crowther) - raced keenly in the early and middle stages of the event.

DR DEE DEE (L. Neindorf) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

MISS ARTIER (R. Hurdle) - near the 300 metres rolled out onto MULLAGHMORE, which was obliged to be eased when tightened onto DR DEE DEE. Rider was reminded of his obligations under AR131(a) and advised to take greater care in future.

MULGA LIL (NZ) (J. Opperman) - shortly after the start shifted in to obtain cover.

LADY DRAKE (NZ) (J. Maund) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: BRIDGES EVENT CENTRE CLASS TWO HANDICAP - 1400 Metres (Cont'd)

WILLIAM'S QUEST (M. Collett) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. Rider pleaded guilty to a charge under AR132(6)(c) in that she used her whip out of contention and was reprimanded.

ZUME FORWARD (D. Tourneur) - shortly after the start from its wide barrier shifted in to obtain cover.

RACE 7: FIBRETRACK BENCHMARK 58 HANDICAP - 1200 Metres

BEEOKAY (S. Logan) - underwent a pre-race veterinary examination on arrival on course as it had raced on Saturday, 6 June 2020 at Morphetville Parks and passed fit to race. Rider was questioned in relation to the tactics adopted in today's event. She stated the intention was to settle in a one out one back position given the pace in today's race and good barrier draw. She added in her opinion, the gelding began well and found itself in the lead without much effort. Trainer Mr G. Young confirmed the instructions provided.

BROADWAY AND FIRST (M. Collett) - held up for clear running from the entrance to the straight until in the vicinity of the 300 metres.

HEROES QUEST (K. Zechner) - jumped away awkwardly, shifted out and bumped **SPACE EQUITY**. Over-raced in the early and middle stages of the event. In the vicinity of the 150 metres when shifting out to improve, shifted out onto **REDEEKA**, which was inconvenienced. Rider reminded of his obligations under AR131(a) and advised to take greater care in future. A post-race veterinary examination revealed a laceration to the near foreleg. First aid administered.

WOULDA THOUGHT SO (E. Finnegan) - jumped away awkwardly, shifted in and bumped **SPACE EQUITY**. Over-raced throughout the event. Weakened from in the vicinity of the 100 metres. Rider reported the gelding over-raced in the early and middle stages of the event and when she exposed the gelding at the top of the straight, she thought she had obtained the lead too soon and as a result, **WOULDA THOUGHT SO** weakened from just prior to the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

CHAPPETTE (K. Crowther) - on jumping away bumped with **CONCONI**, which jumped away awkwardly and shifted out. Shortly after shifted in to obtain cover. Inclined to lay in under pressure in the straight. In the vicinity of the 50 metres when improving was obliged to be checked when awkwardly placed on the heels of **WOULDA THOUGHT SO**, which was weakening. A post-race veterinary examination revealed no visible abnormalities.

REDEEKA (T. Pannell) - shortly after the start shifted in to obtain cover. In the vicinity of the 150 metres was inconvenienced and obliged to shift in as **HEROES QUEST** shifted out.

CONCONI (C. Jones) - jumped away awkwardly, shifted out and bumped **CHAPPETTE**.

ICECRUSHER (J. Holder) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

SPACE EQUITY (A. Lindsay) - on jumping away bumped with **HEROES QUEST** and **WOULDA THOUGHT SO**, which both shifted ground.
