

# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 20 June 2020

TRACK: Soft 6 (Moist but not a badly affected track)

Downgraded to a Soft 7 at 12.20 pm (Rain affected track that will chop out)

(Rain affected track that horses will get into)

RAIL: Out 12 metres 1200 metres to winning post, 8 metres remainder, sectional 616 metres

#### RACE 1: HOLDFAST INSURANCE HANDICAP - 1050 Metres

**ROPPONGI** (S. Cahill) - laid in under pressure in the straight. In the vicinity of the 150 metres shifted in onto SURE AM INVINCIBLE. Rider reminded of his obligations when shifting ground. Stewards questioned the rider in relation to his riding over the concluding 30 metres. After doing so, Stewards charged S. Cahill under AR131(b) in that he failed to ride his horse out to the end of the race. S. Cahill pleaded guilty and was fined \$ 400. A post-race veterinary examination revealed no visible abnormalities.

**SUNSHINES** (T. Pannell) - jumped away awkwardly. Had to be steadied in the vicinity of the 150 metres when ROPPONGI shifted in. Rider reported the filly reported the filly felt sore in front in the straight. A post-race veterinary examination revealed no visible abnormalities.

**DAILY SPIRIT** (J. Holder) - slow to begin. Laid in under pressure in the straight. In the vicinity of the 100 metres was contacted by KIRINIA, which shifted out.

**INSTANT CELEBRITY** (K. Crowther) - inconvenienced shortly after the start when L'IL PIPER shifted in. Rounding the home turn had to be steadied momentarily when KIRINIA shifted out. Had difficulty obtaining clear ground from the entrance to the straight until near the 200 metres when racing in restricted room between the heels of ROPPONGI and KIRINIA.

**KIRINIA** (J. Toeroek) - shifted out rounding the home turn onto INSTANT CELEBRITY. Rider was severely reprimanded. Shifted out approaching the 100 metres and contacted DAILY SPIRIT

**L'IL PIPER** (D. Tourneur) - shifted in shortly after the start onto INSTANT CELEBRITY. Hung out from the vicinity of the 700 metres. A post-race veterinary examination revealed the filly to be lame in the near hind leg. Trainer, Mr J. Hyam, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.



#### RACE 2: AAMI HANDICAP - 1600 Metres

**BLACK TOFF AFFAIR** (T. Pannell) - rider explained that in his opinion the gelding had not handled the track condition. A post-race veterinary examination revealed the gelding to be lame near hind leg. Co-Trainer, Mr M. Price, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**ROCK HARBOUR** (K. Crowther) - held up from inside the 600 metres until near the 300 metres. Laid in under pressure in the straight.

VACANT BLOCK (A. Jordsjo) - laid out under pressure over the concluding stages.

IN HEART'S WAKE (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SVETLANA'S ARROW (S. Logan) - laid out under pressure in the straight.

#### RACE 3: TAB THREE-YEAR-OLD MAIDEN PLATE - 1200 Metres

FINAL CHANCE (D. Caboche) - laid out under pressure in the straight.

**PEARL DRAGON** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

ZEBONET (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

BORN TO PLAY (B. Vorster) - dipped on jumping away.

NANAMU (E. Finnegan) - slow into stride.

**PARTY MAID** (J. Toeroek) - laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SARNIA** (K. Crowther) - rider reminded of her obligations in riding her mounts out to the end of the race in accordance with AR131(b).

**ZEGRESTO** (S. Fawke) - raced keenly in the early and middle stages of the event. Laid out under pressure over the concluding 400 metres.

# **RACE 4: TAB HANDICAP - 1800 Metres**

CRACKSMAN (T. Pannell) - shifted out on jumping away onto FIGHT FOR FREEDOM.

**ELUSIVE ROSE** (C. Jones) - had difficulty obtaining clear ground from the vicinity of the 600 metres until near the 300 metres.

**ZOUNAMI** (B. Vorster) - raced keenly in the early and middle stages of the event. Rider explained the gelding travelled well in the early stages of the event however, when placed under pressure inside the 800 metres had failed to respond to his riding. He added ZOUNAMI had made excess respiratory noise in the straight. A post-race veterinary examination revealed no visible abnormalities.

**FIGHT FOR FREEDOM** (A. Jordsjo) - inconvenienced on jumping away. Raced keenly in the early and middle stages of the event. In the vicinity of the 1200 metres improved onto the heels of NORDIC PRIDE and had to be steadied.



# RACE 4: TAB HANDICAP - 1800 Metres (Cont'd)

**DOMESDAY MAGIC** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

BALDY (K. Zechner) - raced keenly in the early and middle stages of the event.

# RACE 5: ADELAIDE GALVANISING HANDICAP - 1200 Metres

**ZALMONA** (T. Voorham) - raced fiercely in the early and middle stages of the event. In the vicinity of the 700 metres shifted out onto ENKI.

**ARKHAM KNIGHT** (P. Gatt) - Trainer Mr J. MacMillan advised Stewards prior to the event of a change of tactics that being that he would instruct the rider to attempt to settle further back in today's event than the gelding had at its most recent start. Settled back.

**NIPPERKIN** (E. Finnegan) - shifted in slightly in the vicinity of the 200 metres onto EXTREME THRILL. Rider reminded of her obligations when shifting ground.

**ENKI** (J. Holder) - inconvenienced in the vicinity of the 700 metres when taken out by ZALMONA onto WINNING PARTNER, which shifted in slightly. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

WINNING PARTNER (B. Vorster) - raced keenly in the early and middle stages of the event.

**EXTREME THRILL** K. Crowther) - momentarily inconvenienced in the vicinity of the 200 metres when NIPPERKIN shifted in. Rider explained in her opinion the gelding had not handled the track condition and had commenced to weaken of its own accord from the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 6: FURPHY HANDICAP - 1050 Metres**

**OCTANE** (K. Crowther) - inconvenienced on jumping away when ATOMIC LOKADE shifted out slightly. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

**FANCY RUMBLE** (A. Jordsjo) - hampered on jumping away when tightened onto SILVERHAWK by BAYOU.

**SYMPHONETTE** (D. Caboche) - laid out under pressure in the straight.

**BAYOU** (J. Toeroek) - shifted in on jumping away onto FANCY RUMBLE. Rider reported the mare laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ATOMIC LOKADE (B. Vorster) - shifted out on jumping away onto OCTANE.

SILVERHAWK (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow P. Gatt (ZARACE) to view the vision in the straight.

# RACE 7: ZILZIE WINES HANDICAP - 1800 Metres

CHAROSSA (T. Voorham) - raced keenly in the early and middle stages of the event.

**BOX ON COLLINS** (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.



# RACE 7: ZILZIE WINES HANDICAP - 1800 Metres (Cont'd)

**BREAK AND ENTER** (P. Gatt) - approaching the 200 metres shifted out abruptly momentarily unbalancing the rider.

**BEA TEMPTED** (K. Crowther) - rider reported the mare became awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

PRETTY GLASS (J. Potter) - raced wide without cover throughout the event.

**KORODON (NZ)** (J. Toeroek) - Stewards permitted J. Toeroek to ride the filly 0.5 kg over its declared weight of 54kg.

**DREAMED** (D. Tourneur) - a post-race veterinary examination revealed the mare to be lame in both hind legs. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

EXALTED RUTH (S. Logan) - raced keenly in the early and middle stages of the event.

# RACE 8: CAUDO VINYARD HANDICAP - 1050 Metres

The start of this event was delayed approximately three minutes.

**GIVE ME A DOLLAR** (S. Cahill) - Stewards acceded to a request from Trainer Mr S. Bates that the mare be scratched due to the track downgrade. GIVE ME A DOLLAR was a late scratching at 3.01 pm by order of Stewards.

**HUSHIANO** (K. Crowther) - raced wide without cover throughout the event. Rider explained that she had been instructed to take up a position outside the leader, if possible, however after jumping away a touch tardy, the mare was unable to muster early speed and for this reason she had elected to position the horse where it was comfortable rather than to continue to apply pressure. Trainer Mr D. Koch confirmed that the instructions were to race forward.

**SONO DOLCE** (T. Pannell) - jumped away awkwardly.

**SONIC DEED** (D. Tourneur) - lost tis near fore plate en route the barriers and required to be reshod. Underwent a pre-race veterinary examination and passed fit to race. Jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

CIBACHROME (R. Hurdle) - raced wide without cover throughout the event.

PONTYPAUL (D. Tootell) - jumped away extremely awkwardly missing the start several lengths.

WONDER IF (NZ) (J. Toeroek) - laid in under pressure in the straight.

Correct weight was delayed to allow D. Tootell (PONTYPAUL) to put a submission to Stewards that the mare be declared a non- runner. After considering his submission, taking evidence from the starter and assistant starter, Stewards deemed that PONTYPAUL a runner in accordance with AR204.

#### RACE 9: SCHWEPPES HANDICAP - 1200 Metres

**KING RED** (E. Finnegan) - raced wide without cover throughout the event. Rider reported the gelding felt uncomfortable in its action behind from the vicinity of the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

I'M A LEGEND (A. Jordsjo) - slow to begin. Raced keenly in the early and middle stages of the event. Held up from the vicinity of the 600 metres until near the 300 metres.

JUST CHIPPING AWAY (K. Crowther) - contacted on jumping away.



# RACE 9: SCHWEPPES HANDICAP - 1200 Metres (Cont'd)

**CONCONI** (E. Boyd) - rounding the home turn shifted out and away from KING RED onto LIPPSY SHUFFLE.

GLORY GAME (J. Holder) - raced wide without cover throughout the event.

HIGH MIST (T. Pannell) - rider explained that he had been instructed to maintain a positon on the rail in the early stages of the event from barrier one however, it had been his intention to shift wider in the straight from rounding the home turn. He stated the gelding had not travelled in the early and middle stages of the event and was not responding to his riding and for this reason formed the opinion that there would be no benefit in attempting to shift HIGH MIST to the middle of the track. A post-race veterinary examination revealed no visible abnormalities.

**LIPPSY SHUFFLE** (J. Toeroek) - had to momentarily steady at the entrance to the straight when CONCONI shifted out.

TWICE FORGOTTEN (K. Zechner) - shifted out on jumping away onto JUST CHIPPING AWAY.

COUNTER SPIN (D. Tootell) - slow into stride. Momentarily held up rounding the home turn.
