RACE 1: HAPPY 21ST LAUREN PAUES HANDICAP - 1100 Metres

CARRY THE MUSKET (P. Gatt) - slow to begin.

WAR CHEVAL (S. Fawke) - rider reported the gelding was disappointing in its finishing effort.

ALLEZ SUR LE GRIS (K. Crowther) - very awkward to begin and shifted in onto SHE'S STYLISH, which was hampered. Raced greenly in the straight.

SHE'S STYLISH (K. Zechner) - hampered at the start. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

CONGE (J. Eaton) - Raced keenly in the early stages of the event. Laid in throughout the event. Rider reported the filly hung in badly during the event. A post-race veterinary examination revealed no visible abnormalities.

THREE TEARS (A. Jordsjo) - raced keenly in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. Rider reported the filly felt awkward in its off foreleg on return to scale. A post-race veterinary examination revealed a slow post-race recovery.

WHO RUNS THE WORLD (B. Vorster) - raced wide without cover from inside the 800 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: TAB MAIDEN PLATE - 1100 Metres

THE BULL MCCABE (T. Pannell) - approaching the 900 metres was obliged to take action and shifted out wider on track owing to NARRATIVE STAR, to its inside, being taken out by SILVER ON RED, which raced fiercely and shifted out. As a consequence THE BULL MCCABE raced wider on the track for a short distance.

SILVER ON RED (K. Crowther) - awkward to begin. Shortly after the start commenced to race very keenly, and thereafter inside the 1000 metres raced fiercely for some distance and shifted out onto NARRATIVE STAR, which was over-racing, and as a consequence made contact with NARRATIVE STAR, approaching the 900 metres, taking that horse wider on the track. Thereafter the gelding commenced to hang out and hung out for the remainder of the event and as a consequence raced very wide on the track for the remainder. Trainer Mr D. Jolly was advised the gelding would be required to race in a tractable manner and to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

LYRICKIN'S DREAM (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

MISSED ME (D. Caboche) - reared and fell over in the mounting yard. Underwent a pre-race veterinary examination which revealed the mare to be lame in its off hind leg. Acting on this advice Stewards ordered MISSED ME be a late scratching at 12.02pm on veterinary advice.

NARRATIVE STAR (B. Vorster) - awkward to begin. Inside the 1000 metres commenced to over-race and shortly thereafter, approaching the 900 metres, was contacted and taken wider by SILVER ON RED, which raced fiercely and shifted out.

THE HAITIAN POET (R. Hurdle) - Trainer Mr J. MacMillan advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to attempt to ride the gelding from a position back in the field.

RACE 3: BARRINGTONBOOKMAKING.COM HANDICAP - 1200 Metres

MAGIC REWARD (T. Voorham) - rider reported the mare was very disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

PANDEIA (D. Caboche) - contacted at the start.

WITH PLEASURE (A. Jordsjo) - shifted out on jumping away and contacted PANDEIA.

GALCRUM (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

MABEL JOSEPHINE (S. Logan) - underwent a pre-race veterinary examination and was passed fit to race. Raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

ICECRUSHER (J. Eaton) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: G&J CIVIL HANDICAP - 2100 Metres

BOX ON COLLINS (B. Vorster) - Co-Trainer Mr C. McEvoy advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to ride the gelding patiently in the early stages in an attempt to obtain cover. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: G&J CIVIL HANDICAP - 2100 Metres (Cont'd)

MANZALA (J. Eaton) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

MUNTHAM MISSILE (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

EXALTED RUTH (S. Logan) - raced keenly in the early stages of the event. Inclined to lay in, in the straight.

HAPPY ATOM (E. Boyd) - slow to begin.

SAMSTAG (S. Fawke) - rider dropped his whip inside the 400 metres

RACE 5: TAYLOR & FORGIE FUNERAL DIRECTORS HANDICAP - 1500 Metres

CROCKETT (J. Eaton) - rider reported the horse had chocked down in running over the concluding stages. A post-race veterinary examination revealed an excess upper respiratory noise. Co-Trainer Mr C. McEvoy was advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

STAR STATUS (C. Jones) - approaching the 1200 metres improved onto the heels of **BACK POCKET**, which had commenced to over-race, and as a consequence became awkward on the heels of **BACK POCKET**, got its head up and raced keenly for a short distance thereafter before being obliged to shift to the outside of **BACK POCKET**.

SIGN OF USSURI (B. Vorster) - awkward to begin. Shifted in under pressure over the concluding stages and brushed with **ANALYTICA** (NZ). Rider reported the gelding hung in, in the straight.

ANALYTICA (NZ) (J. Holder) - brushed over the concluding stages by **SIGN OF USSURI**, which laid in and shifted in.

SUPER SWOOP (T. Voorham) - slipped behind on jumping away and as a consequence was awkward to begin. Inside the 200 metres was tightened between **ELUSIVE NATURE**, which laid out and shifted out, and **BACK POCKET** which laid in and shifted in. As a consequence T. Voorham had to steady her mount for several strides and was unable to improve her position and was obliged to shift to the outside of **BACK POCKET** to improve.

COFFEE AMOUR (A. Jordsjo) - near the 1200 metres became momentarily awkward inside the heels of **SIGN OF USSURI**, which rolled in and had to be steadied.

ELUSIVE NATURE (T. Pannell) - inside the 400 metres commenced to lay out and rolled out, became awkward inside the heels of **ANALYTICA** (NZ) and was momentarily inconvenienced. In the vicinity of the 200 metres continued to lay out, shifted out and tightened **SUPER SWOOP** onto **BACK POCKET**. Rider explained the mare travelled well until near the 400 metres where it commenced to lay out and tire, and as a consequence he did not persevere with his riding from inside the 200 metres. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer Mr W. Clarken was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

BACK POCKET (J. Maund) - re-saddled on arrival at the start. Over-raced in the early stages of the event and became ungenerous for a short distance near the 1200 metres. In the vicinity of the 200 metres laid in, shifted in and tightened **SUPER SWOOP** onto **ELUSIVE NATURE**.

RACE 6: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1700 Metres

CALL ME SHAMUS (P. Gatt) - rider explained his instructions provided by stable representative Mr T. Stokes was to settle back in running. He added whilst he was able to settle back as instructed, the gelding did not finish the event off from inside the 600 metres and was disappointing. He further explained that at its previous start at Morphettville Parks, his instructions provided by Mr T. Stokes, were to allow the gelding to settle where comfortable. When questioned regarding the instructions provided to P. Gatt today, Mr T. Stokes confirmed the instructions provided and in the circumstances was found guilty by Stewards of a charge under AR100(1)(a) for failing to provide Stewards with prior notification of a change in instructions and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

GETOUTTHEWAY (C. Jones) - awkward and slow to begin.

JUST ROLLING (K. Crowther) - slow to begin. Shifted in under pressure approaching the 100 metres.

ZOUNAMI (T. Pannell) - rider reported the gelding failed to respond to his riding from near the 600 metres and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

FIGHT FOR FREEDOM (D. Tourneur) - raced keenly for a short distance in the vicinity of the 1400 metres.

ART MUSIC (D. Caboche) - laid out in the straight.

BUCKEYE NATION (E. Boyd) - raced wide without cover from inside the 1400 metres for some distance.

RACE 7: COOPERS XPA HANDICAP - 1100 Metres

CROWN FONTEIN (J. Eaton) - rider reported the gelding never travelled during the event and made excess respiratory noises. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer Mr J. Hickmott was advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

CELTIC BLAST (R. Hurdle) - awkward to begin.

BRIMARVI VEHERO (D. Tourneur) - underwent a pre-race veterinary examination and was passed fit to race. On arrival at the barriers had to be re-plated as it had lost it's near fore plate and was re-examined by the veterinary surgeon and was passed fit to race.

FANCY RUMBLE (A. Jordsjo) - laid out in the straight.

DANGER DEAL (J. Holder) - awkward to begin.

CALL ME CURTIS (T. Voorham) - awkward to begin.

RACE 8: GBJC THANKS IT'S MEMBERS HANDICAP - 1200 Metres

The start of this event was delayed approximately two (2) minutes.

CLASSY JAYBEE (J. Eaton) - awkward to begin.

AIR MARSHAL (T. Pannell) - shifted about under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: GBJC THANKS IT'S MEMBERS HANDICAP - 1200 Metres (Cont'd)

SILVER LINING (S. Logan) - Trainer Mr W. Clarcken advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to be aggressive in the early stages and take up a forward position in running. A post-race veterinary examination revealed no visible abnormalities.

THE NATURAL (B. Vorster) - raced keenly in the early stages of the event.
RENOUF (D. Tournour) - raced keenly in the early stages of the event.

SHARPLY ATTIRED (K. Bishop) - Trainer Mr J. Macmillan advised Stewards prior to the event of a change in tactics that being that he would instruct his rider to ride the filly back in the event.

RACE 9: CORNERSTONE STUDE HANDICAP - 1200 metres

BEEOKAY (S. Logan) - inside the 1000 metres was momentarily tightened by **DOCTOR DOOLITTLE**, which shifted in, and as a consequence was inconvenienced. Shortly thereafter was contacted and hampered by **CALL ME DEXTER**, which shifted out. Near the 200 metres was inconvenienced by **DYNASTIC** which was taken out. Approaching the 100 metres rolled in slightly onto **DYNASTIC**, which rolled out slightly of its own accord, resulting in **DYNASTIC** having to be steadied when inconvenienced inside the heels of **BEEOKAY**.

GOING GAGA (A. Jordsjo) - raced keenly in the early stages of the event. Near the 800 metres raced in restricted room for a short distance between **MAY BE FATE**, which maintained its line and **BEEOKAY**, which rolled out and as a consequence **GOING GAGA** was obliged to be steadied for several strides.

DOCTOR DOOLITTLE (R. Hurdle) - inside the 1000 metres shifted in slightly onto **BEEOKAY**, which was inconvenienced for a number of strides. Laid out from near the entrance to the straight, shifted out approaching the 200 metres and brushed with **DYNASTIC**, which was shifting about. As a consequence **DYNASTIC** was taken out onto **BEEOKAY**, which was inconvenienced. Approaching the 100 metres laid out, shifted out into the running line of **DYNASTIC**, which after initially steadying owing to the inwards shift by **BEEOKAY** to its outside, was then obliged to be further steadied when tightened by **DOCTOR DOOLITTLE**. Rider was severely reprimanded in respect of the incident near the 100 metres and advised to take greater care in future when his mounts commenced to shift ground.

SPLASH SOME CASH (D. Caboche) - inside the 500 metres was obliged to be checked when awkward on the heels of **CALL ME DEXTER** as that horse clipped the heels of a runner in front and knuckled, as a consequence was severely hampered and lost its position.

DYNASTIC (J. Toeroek) - approaching the 200 metres when shifting about, was inconvenienced and taken a little wider by **DOCTOR DOOLITTLE**, which shifted out, and as a consequence shifted onto **BEEOKAY**. Thereafter near the 100 metres, rolled out slightly and was inconvenienced when initially tightened by **BEEOKAY**, which rolled in and had to be steadied, and thereafter had to be further steadied when tightened by **DOCTOR DOOLITTLE**, which laid out and shifted out. As a consequence was unable to maintain its position.

ALIRIS (T. Voorham) - inside the 500 metres was obliged to be steadied for several strides when awkward on the heels of **SPLASH SOME CASH** as that horse was impacted on by **CALL ME DEXTER**, which clipped heels and knuckled and as a consequence was unable to maintain its position.

CALL ME DEXTER (S. Fawke) - inside the 500 metres when racing behind **DOCTOR DOOLITTLE**, improved into tight running to the inside of that horse, and shortly thereafter clipped that horses heels and knuckled severely resulting in this gelding becoming severely hampered and losing its position. As a consequence **SPLASH SOME CASH** and **ALIRIS**, which were following, were both hampered. In assessing the incident Stewards could not attribute any direct blame on any one rider and took no further action.

RACE 9: CORNERSTONE STUDE HANDICAP - 1200 metres (Cont'd)

WOUNDED SOLDIER (NZ) (K. Zechner) - lost its near fore plate during the event. Laid in, in the straight.

PIVOTAL FORCE (K. Crowther) - raced wide without cover in the early and middle stages of the event.
