RACE 1: SPRING RACING CARNIVAL AT MORPHETTVILLE- OCT. 10 - NOV 3. HANDICAP - 1400 metres

AQUEDUCT (NZ) (J. Eaton) - awkward to begin, shifted out, contacted and hampered SCORPIUS. Raced keenly in the early stages of the event.

ROYALTY (B. Vorster) - on arrival at the barriers had its tongue tie refitted.

SCORPIUS (J. Holder) - contacted and hampered at the start. Inclined to lay out in the straight.

KARPOOL KHAN (NZ) (A. Jordsjo) - raced keenly in the early stages of the event.

RACE 2: SYDNEY ROBERT MCDONALD MEMORIAL HANDICAP - 1000 metres

CELTIC BLAST (J. Holder) - was awkward to begin. Over-raced in the early stages of the event.

SEEMINGLY DISCREET (K. Crowther) – from in the vicinity of the 750 metres shifted in and tightened DOMINATION, which was obliged to race in restricted room for a short distance and being hampered. Thereafter, near the 700 metres continued to shift in slightly into the running line of DOMINATION, which had to be checked to avoid the heels of SEEMINGLY DISCREET, losing its position. Rider pleaded guilty to a charge of Careless Riding under AR131(a) and was suspended from riding in races for a period to commence at midnight Saturday, 5 September and to conclude at midnight Wednesday, 16 September 2020, a period of four (4) race meetings. K. Crowther reported that it was not her intention to lead in this event; however, owing to the lack of pace in the early stages and given the manner in which the mare began she had no option but to take up a forward position in running.

DOMINATION (D. Tourneur) - near the 750 metres was initially tightened by SEEMINGLY DISCREET, which shifted in, and was obliged to race in restricted room inside that horse for a short distance, and approaching the point of the turn near the 700 metres had to be checked to avoid the heels of SEEMINGLY DISCREET, which encroached into its running line. As a consequence DOMINATION brushed the running rail and was unable to maintain its position. A post-race veterinary examination revealed no visible abnormalities.



RACE 3: TERRY HOWE PRINTING HANDICAP - 1000 metres

GREAT LEVELLER (P. Gatt) - was awkward to begin.

ALLEBOOM (J. Eaton) - was awkward to begin, shifted out and contacted PIMM'S PARTY. Laid out in the straight.

PIMM'S PARTY (J. Holder) - contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

STRIP CLUB (T. Voorham) - faltered for no apparent reason near the 700 metres and failed to finish the event off in a competitive manner. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: SCHWEPPES MAIDEN PLATE - 1000 metres

KISHSTAR (J. Holder) - raced keenly in the early stages. Approaching the 100 metres rolled in onto SWEET MINSKY (NZ).

SELF SUFFICIENT (P. Gatt) - laid in, in the early part of the straight.

SPARKUP (J. Toeroek) - was awkward to begin, shifted out and contacted BRAZEN BITS. Laid in, in the straight.

SWEET MINSKY (NZ) (T. Voorham) - raced keenly in the early stages of the event. Approaching the 100 metres had to be momentarily steadied when awkward on the heels of KISHSTAR, which rolled in.

ZIPADEE (D. Tourneur) – laid out throughout the event. Rider explained that his instructions were, if the mare jumped well and found a forward position to allow it to settle in that position. A post-race veterinary examination revealed no visible abnormalities.

CHAMPAGNE AFFAIR (J. Eaton) - raced keenly in the early stages of the event. Laid out in the straight.

GALAXY KEEPER (NZ) (K. Crowther) – raced keenly in the early stages of the event. Inclined to lay out rounding the home turn. Raced greenly in the straight.

SHADOW BOOM (S. Logan) - near the 700 metres was awkwardly placed on the heels of SWEET MINSKY (NZ) and had to be restrained. Laid out over the concluding stages of the event.

BRAZEN BITS (D. Caboche) - was awkward to begin, shifted in and contacted SPARKUP. Shortly thereafter commenced to buck and bucked for a short distance placing its rider at a disadvantage. Trainer, Mr B. Cozamanis, was advised that in view of the filly's racing manners it would now be required to race in a tractable manner in an Official Barrier Trial before its next race start. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: TAB HANDICAP - 1250 metres

ZAGATO STAR (D. Tourneur) - raced wide without cover in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SHOJIKI (K. Crowther) - rider explained that the filly raced flat in its manner and explained the stable advised that the filly may now be freshened up. A post-race veterinary examination revealed no visible abnormalities.

EMINENT SON (T. Voorham) - raced keenly in the early stages of the event.



RACE 6: AAMI HANDICAP - 1000 metres

TAKEN OFF (K. Crowther) – rider was dislodged en route to the barriers. K. Crowther was examined by the First Care Medical personnel on arrival at the barriers and passed fit to fulfil her engagement. Held up for clear running from near the 400 metres until in the vicinity of the 100 metres and was obliged to shift to the inside of MAGIC SUNSET to obtain clear running. Shifted ground slightly after the winning post. Rider reminded of her obligations when shifting ground.

THOMPSON'S REWARD (P. Gatt) – was slow to begin. Shifted ground slightly after the winning post. Rider reminded of his obligations when shifting ground.

EXALTED MAXINE (J. Holder) - underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

MAGIC SUNSET (T. Pannell) - which had not raced since September 2019 underwent a pre-race veterinary examination and was passed fit to start. Obliged to be steadied shortly after the winning post when racing in restricted room between THOMPSON'S REWARD and TAKEN OFF, which both shifted ground slightly.

AKKACAN (S. Logan) – trainer, Mr J. B. O'Connor, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle more forward in running. Held up for clear running from near the 400 metres until near the 300 metres. In the vicinity of the 200 metres, when improving to the outside of RIZSKI, became disappointed for clear running between RIZSKI and TAKEN OFF for several strides.

RACE 7: HOLDFAST INSURANCE HANDICAP - 1950 metres

MORE THAN EVER (NZ) (B. Vorster) - had difficulty obtaining clear running from near the entrance to the straight until in the vicinity of the 300 metres where it was obliged to shift out over the heels of JAGUARY (NZ) to obtain clear running. Thereafter, approaching the 100 metres, B. Vorster was accidentally struck on his arm by the whip of S. Fawke.

DR DEPENDABLE (T. Voorham) - in the vicinity of the 1700 metres, at the crossing, shifted in when insufficiently clear, taking ENBARR in onto CLASSY JOE, resulting in ENBARR being tightened and CLASSY JOE having to be checked when tightened for galloping room to the inside of ENBARR. Rider pleaded guilty to a charge of Careless riding under AR131(a) and was suspended for a period to commence midnight Wednesday, 9 September and to conclude midnight Wednesday, 16 September 2020, a period of 3 meetings.

CLASSY JOE (J. Maund) - in the vicinity of the 1700 metres, at the crossing, was obliged to be checked when tightened by ENBARR as that horse was taken in by DR DEPENDABLE, which shifted in when insufficiently clear. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty Stewards had regard for the totality of the whip use of J. Maund, noting that he had only used his whip on two occasions over the last 100 metres of the event.

FLOW METER (S. Fawke) - in the vicinity of the 100 metres S. Fawke accidentally struck B. Vorster, the rider of MORE THAN EVER (NZ) over the arm with his whip. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the whip use of S. Fawke, noting that he had only used his whip on five occasions over the last 100 metres of the event.

ENBARR (K. Crowther) - near the 1700 metres, at the crossing, was taken and tightened by DR DEPENDABLE which shifted in.



RACE 8: ADELAIDE GALVANISING HANDICAP - 1550 metres

VON COSTA GLASS (S. Logan) – raced wide without cover from near the 1000 metres. Rider was reprimanded under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres. In determining penalty Stewards had regard for the totality of the whip use of S. Logan, noting that she had only used her whip on four occasions over the last 100 metres of the event.

EAST INDIAMAN (B. Vorster) - co-trainer, Mr T. McEvoy, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to ride the gelding more patiently in the early stages of the event.

TERRITORY TITAN (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

PELOTON (NZ) (J. Eaton) - raced keenly in the early stages of the event. Near the 600 metres rolled out and hampered FINAL HEARING, which had to be steadied for a number of strides. Rider was reprimanded and advised to take greater care when shifting ground.

FINAL HEARING (T. Pannell) - near the 600 metres had to be steadied for a number of strides after being tightened by PELOTON (NZ) which rolled out.

PAGHMAN (J. Toeroek) – was awkward to begin and over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: FURPHY HANDICAP - 1550 metres

CANNOT BE SERIOS (NZ) (J. Eaton) – raced keenly in the early stages of the event. In the vicinity of the 1300 metres shifted in resulting in RED DYNAMO having to be momentarily checked. Rider was severely reprimanded for shifting ground when insufficiently clear.

RED DYNAMO (NZ) (D. Caboche) - in the vicinity of the 1300 metres had to momentarily checked away from the heels of CANNOT BE SERIOS (NZ) which shifted in. A post-race veterinary examination revealed that the gelding had bled from both nostrils. Co-trainers, Mr J. Dunn and Miss K. Bishop, were advised that as this was the gelding's first bi-lateral bleed, RED DYNAMO (NZ) would now be suspended from being trained, exercised or galloped on any racecourse for a period of two months, and from racing for a period of three months in accordance with AR79(4) and thereafter would be required to complete a satisfactory gallop over 1000 metres, in the presence of a Steward, prior to accepting for a future race.

SPLASH SOME CASH (S. Logan) - raced wide without cover for a short distance in the middle stages of the event.


MEEHNI (B. Vorster) - was awkward to begin and shifted in onto AUSTIN RAIDER, which was tightened onto LINE DANCER.

LINE DANCER (T. Pannell) - was awkward to begin and shifted out onto AUSTIN RAIDER, which was tightened onto MEEHNI.

BIG CALL (J. Potter) - was awkward and slow to begin. Became awkward on the heels of FLYING PIERRO near the 350 metres for a number of strides and was obliged to shift to that horses outside to obtain clear running.

AUSTIN RAIDER (A. Jordsjo) - tightened at the start between MEEHNI and LINE DANCER, which both began awkwardly and shifted ground.

Correct weight for this event was delayed to allow Stewards to view the vision in relation to the start of BIG CALL. After viewing the vision Stewards were satisfied that BIG CALL had not been denied a fair start.
