

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 19 September 2020

RACE 1: ECO SKIP HIRE HANDICAP - 1600 Metres

ALLUSION (B. Vorster) - inside the 600 metres rolled out onto ARAY OF SUNSHINE, which was tightened onto CANFORD, resulting in that horse's hindquarters being contacted and turned. Rider was reminded of his obligations when shifting ground. Inside the 300 metres was inconvenienced when taken in by ICE GHOST, which was inclined to lay in and shifted in and became held up on the heels of SOMERSET MAUGHAM (IRE) for several strides and was obliged to shift to the outside of ICE GHOST to obtain clear running. Near the 200 metres when shifting out to obtain clear running, took CANFORD wider on the track for a number of strides.

ICE GHOST (K. Crowther) - awkward to begin, shifted out and contacted ARAY OF SUNSHINE, which was hampered. Raced keenly in the middle stages of the event. Inside the 300 metres was inclined to lay in, shifted in and inconvenienced ALLUSION for several strides.

SOMERSET MAUGHAM (IRE) (T. Pannell) - laid out over the concluding stages.

CANFORD (D. Tourneur) - inside the 600 metres was contacted by ARAY OF SUNSHINE, which rolled out when taken out by ALLUSION, and had its hindquarters contacted and turned. Near the 200 metres was taken wider by ALLUSION for a number of strides as that horse shifted out to improve.

ARAY OF SUNSHINE (E. Boyd) – contacted and hampered at the start. Inside the 600 metres was taken out by ALLUSION, rolled out onto CANFORD, resulting in ARAY OF SUNSHINE making contact with the hindquarters of CANFORD. As a consequence, when being tightened and after contacting the hindquarters of CANFORD, was obliged to be steadled and was unable to maintain its position.



RACE 2: TAB THREE-YEAR-OLD MAIDEN PLATE - 1200 Metres

IMPOSSIBLE ACTION (J. Toeroek) - was awkward to begin, shifted in and contacted the hindquarters of QUIETLY DISCREET, which was hampered. Was inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

JONQUEST (J. Holder) - was inclined to lay out rounding the home turn.

KEEP ON BOPPING (K. Crowther) - raced very ungenerously and over-raced in the early stages of the event. Inclined to lay out rounding the home turn and thereafter raced greenly in the straight. When questioned regarding her instructions, rider explained she was instructed to attempt to obtain cover in the early stages. She added, after beginning slightly awkwardly, she initially allowed the colt to get into stride, however, thereafter restrained in an attempt to obtain cover and as a consequence, the colt got its head up and over-raced. A post-race veterinary examination revealed no visible abnormalities.

SELF SUFFICIENT (P. Gatt) - when being restrained shortly after the start, got its head up and raced ungenerously for a number of strides. Was inclined to lay in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

VANCOUVER VELVET (C. Jones) - was awkward to begin. Shifted out shortly after the start and contacted the hindquarters of QUIETLY DISCREET.

QUIETLY DISCREET (T. Pannell) - contacted and hampered at the start.

RACE 3 FURPHY HANDICAP - 1600 Metres

CANNOT BE SERIOS (NZ) (J. Eaton) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

DR DEE DEE (K. Crowther) - when questioned regarding her instructions, rider stated she was instructed to try and lead during the event and after jumping away on terms, she made an effort to take up a leading position but was conscious of not getting into a speed battle. She added the gelding hung out throughout the event and proved difficult and uncomfortable to ride at various stages. When further questioned with regard to her riding in the straight and the reasons for not riding her mount out fully over the final 200 metres of the event, rider stated she was conscious of the manner in which the gelding laid out and became concerned if she commenced her normal riding manner, the gelding would lay out severely and shift out, and for that reason, did not ride the gelding out in her normal manner. While Stewards noted her explanation, rider was advised to ride her mounts out in a manner that does not invite question by Stewards and was further advised under AR114(2)(a) to ensure she reports anything which may affect her horses running in a race immediately on return to scale. A post-race veterinary examination revealed no visible abnormalities.

KARPOOL KHAN (NZ) (D. Caboche) - was slow to begin. Was inclined to lay out for a short distance near the 400 metres.

SPLASH SOME CASH (J. Potter) - raced wide without cover throughout the event.

CONCONI (C. Jones) - was held up for clear running from inside the 400 metres until approaching the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

MEEHNI (B. Vorster) - inside the 600 metres, when attempting to improve between DR DEE DEE, to its inside and KALAMON, was unable to do so, had to be restrained, became held up for a number of strides and was obliged to shift to the outside of DR DEE DEE and KALAMON near the 400 metres to improve its position. Laid in for a short distance near the 100 metres, resulting in B. Vorster having to stop riding and straighten his mount.



RACE 4: ADELAIDE GALVANISING HANDICAP - 1050 Metres

The start of this event was delayed approximately three minutes.

READY SUNSHINE (C. Jones) - raced keenly in the early stages of the event.

CHUCKY (T. Pannell) - was held up for clear running from near the entrance to the straight until near the 150 metres where it was obliged to shift to the outside of LA VITA to obtain clear running.

LIKE A HEARTBEAT (A. Jordsjo) - proved fractious in its barrier stall after being loaded, got its head down and became wedged between the lower part of its front barrier gates. After being released, underwent a veterinary examination and was declared unfit to start. Acting on this advice LIKE A HEARTBEAT was declared a late scratching by order of Stewards at 2.01 pm. Co-Trainer Mr D. Clarken was advised the gelding would be required to prove tractable in an Official Barrier Trial prior to accepting for a future race.

RIZSKI (J. Eaton) - was awkward to begin. Was unable to obtain clear running from shortly after the entrance to the straight until near the 100 metres where it was obliged to shift out to obtain clear running.

EXALTED GOLD (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

MAGIC PHANTOM (S. Logan) - from near the 800 metres got its head up and over-raced for a short distance.

ANCIENT HISTORY (IRE) (B. Vorster) - was awkward to begin.

RACE 5: AAMI HANDICAP - 1200 Metres

MIDSHIPS (NZ) (J. Toeroek) - was awkward to begin.

TRIDENT (NZ) (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

CARLALUISA (J. Holder) - shortly after the entrance to the straight, was disappointed for clear running when racing behind EXALTED LAURETTA and to the outside of ANAMNESIS and became held up for a number of strides, before shifting to the outside of EXALTED LAURETTA to improve its position. When questioned, rider stated that he was initially disappointed after straightening, was intent on following BUONA SERA into the straight and for that reason was patient to allow an option to the outside of EXALTED LAURETTA to develop to follow BUONA SERA. Stewards noted shortly after the entrance to the straight, when CARALUISA trailed EXALTED LAURETTA, a run had developed to the inside of EXALTED LAURETTA between that horse and ANAMNESIS and when questioned about why he had not elected to take that run, J. Holder stated he was unaware of that run as it developed owing to him being focused on improving to the outside of EXALTED LAURETTTA, in an attempt to follow BUONA SERA into the run. Stewards advised J. Holder that he is to ride in a manner to allow himself opportunity to explore options as they present rather than being single minded.

BUONA SERA (T. Pannell) - was awkward to begin. Raced keenly in the middles stages of the event.

CLAPTONE (D. Tourneur) - raced wide without cover in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.



RACE 6: SPRING RACING CARNIVAL AT MORPHETTVILLE- OCT. 10 - NOV 3. HANDICAP - 1100 Metres

POYSED TO REIN (J. Toeroek) - near the 100 metres was obliged to be severely checked and became severely unbalanced when avoiding the heels of JUST CHIPPING AWAY, which shifted in when taken in by LADY PAVLI CHENKO, which shifted in. In the incident POYSED TO REIN was slightly impacted by AMBIDAZZLE to its inside as that horse shifted out marginally.

AMBIDAZZLE (J. Holder) - shifted out approaching the 100 metres, momentarily tightened POYSED TO REIN and was immediately corrected. After being corrected, was awkwardly placed between the heels of runners and was unable to be fully tested to the finish.

MAGIC SUNSET - Following the track upgrade to a Good 3, trainer Mr W. Clarken made a submission to Stewards to allow the mare to be a late scratching owing to the track upgrade. Stewards acceded to his request and declared MAGIC SUNSET a late scratching by order of Stewards at 2.53 pm.

VON SAGA (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

GRINZINGER EXPRESS (NZ) (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

JUST CHIPPING AWAY (K. Crowther) - approaching the 100 metres was taken in and shifted in and away from LADY PAVLI CHENKO, as that horse improved to its outside and shifted in, and as a consequence, shifted in onto POYSED TO REIN, which became tightened for galloping room between that horse's heels and AMBIDAZZLE, which shifted out slightly.

GALCRUM (J. Maund) - began very awkwardly and contacted the right side of its barrier gate on jumping away. A post-race veterinary examination revealed no visible abnormalities.

LADY PAVLI CHENKO (P. Gatt) - approaching the 100 metres shifted in under riding and as a consequence, shifted in onto JUST CHIPPING AWAY, which was initially taken in and then shifted in and away from LADY PAVLI CHENKO onto POYSED TO REIN tightening that horse onto AMBIDAZZLE which shifted out slightly. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 26 September and to conclude at midnight on Saturday, 3 October 2020: a period of three meetings.

RACE 7: ZILZIE HANDICAP - 2000 Metres

CLASSY JOE (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres. In determining penalty, Stewards considered the totality of the use of the whip by J. Maund and noted that he used his whip on 13 occasions over the last 100 metres. In the circumstances having regard for his record, he was fined \$400.

TIBETAN (NZ) (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer M. Hickmott was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

ACE OF CLUBS (C. Lions) - raced wide without cover for a short distance from inside the 1600 metres.

CAMPOBASSO (NZ) (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

ROCK THE BOWLER (J. Eaton) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RESURGE (B. Vorster) - laid out in the straight.



RACE 7: ZILZIE HANDICAP - 2000 Metres (Cont'd)

DARLAMAX (J. Holder) - laid in, in the straight.

PLACE ME RIGHT (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by D. Tourneur and noted that he only used his whip on two occasions over the last 100 metres.

RACE 8: TAB W H WYLIE HANDICAP - 1100 Metres

EF TROOP (B. Vorster) - brushed with GARNER for a number of strides racing to the 800 metres. A post-race veterinary examination revealed no visible abnormalities.

GARNER (J. Holder) - brushed with EF TROOP for a number of strides, racing to the 800 metres and raced keenly in the early stages of the event. Rider explained the gelding travelled well during the event and in his opinion he was in a winning position at the top of the straight, however, the gelding did not let down in the manner he expected and was disappointing in its finishing effort. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr G. Richards, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

SHAMINO (P. Gatt) - was slow to begin.

ARKHAM KNIGHT - was declared a late scratching at 3.25 pm by order of Stewards after acceding to a request by Trainer Mr J. MacMillan that the gelding be declared a late scratching owing to the track upgrade to a Good 3.

SEEMINGLY DISCREET - was a late scratching at 10.15 am by order of Stewards acting on advice from Mr T. Stokes, acting on behalf of Mr P. Stokes, that the mare was lame in its off hind leg and that a stable veterinarian would provide a veterinary certificate in this regard.

RACE 9: PIKE & JOYCE HANDICAP - 1100 Metres

COLUMBIA (D. Caboche) - underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

MAGNA BELLA (C. Jones) - was awkward to begin. Had difficulty obtaining clear running for several strides shortly after the entrance to the straight and was momentarily held up for clear running inside the 200 metres.

ONE MORE JACK (J. Potter) - over-raced in the early stages of the event.

PORT VALE (O. Ridge) - underwent a pre-race veterinary examination as it had not raced since October 2019 and was passed fit to race. Rider reported that in his opinion, the gelding chocked down in running and did not finish the race off over the concluding stages. Near the 1000 metres shifted in and crossed the running of AADELAD, which was inconvenienced, resulting in AADELAD having to be restrained to avoid the heels of PORT VALE. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 20 September and to conclude at midnight on Sunday, 27 September 2020: a period of three meetings. A post-race veterinary examination revealed an elevated heart rate.

MISS JANE (S. Logan) - over-raced in the early stages of the event. Was inclined to lay out in the straight.

BELLOMO (T. Voorham) - was awkward and slow to begin.



RACE 9: PIKE & JOYCE HANDICAP - 1100 Metres (Cont'd)

AADELAD (J. Toeroek) - near the 1000 metres was inconvenienced and had to be restrained to avoid the heels of PORT VALE, which shifted in. Thereafter, as a consequence, AADELAD got its head up and commenced to race ungenerously for a short distance.
