Report on Race Meeting held at Strathalbyn Racecourse

RACE 1: HARRY OF ALL TRADES / SABOIS DISTANCE MAIDEN PLATE - 2050 Metres

IRONICAL (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

AYLIN (NZ) (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

MYSTIC ENDEAVOUR (S. Logan) - raced keenly in the early and middle stages of the event. In the vicinity of the 800 metres commenced to race wide without cover for the remainder of the event.

NGAIRE (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

ROUGH BEAUTY (J. Maund) - laid in under pressure in the straight.

RACE 2: WELCOME BACK TO RACING AT STRATH / SABOIS MARES MAIDEN PLATE - 1100 Metres

BON PEGASUS (T. Pannell) - over-raced in the early stages of the event.

KRUPTONITE (S. So) - jumped away awkwardly, shifted out and bumped MUG'S GAME. Shortly after the rider lost her footing from her off side iron for a number of strides, and was awkward in the saddle prior to her regaining the iron.

LEAVE IT TO ME (K. Zechner) - jumped away awkwardly. Hung in under pressure in the straight.

MUG'S GAME (J. Maund) - jumped away awkwardly, shifted in and bumped KRUPTONITE.. A post-race veterinary examination revealed no visible abnormalities.

SCOPEN SUCCESS (J. Potter) - raced wide without cover throughout the event.

RACE 2: WELCOME BACK TO RACING AT STRATH / SABOIS MARES MAIDEN PLATE
- 1100 Metres (Cont'd)

DYNAMIC BELLE (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3: STRATH SMALL ENGINES / SABOIS MAIDEN PLATE - 1200 Metres

HI SMOKEY (J. Potter) - on jumping away bumped with JAGERNAUT, which shifted out.

JAGERNAUT (T. Pannell) - jumped away awkwardly, shifted out and bumped HI SMOKEY. Laid out under pressure in the straight.

HENRY THE BRUCE (J. Maund) - jumped away awkwardly, shifted out and bumped KNEE SLAPPER.

KENDELL'S PRIDE (S. So) - shortly after the start became awkward on the heels of GIRLINTHEMIRROR for a short distance.

SARNIA (P. Gatt) - shortly after the start, from its wide barrier, shifted in to obtain cover. Held up for clear running from inside the 200 metres until in the vicinity of the 100 metres when racing between KNEE SLAPPER and THE BULL MCCABE. Had difficulty obtaining clear ground over the concluding stages of the event.

BRIABELLA (S. Logan) - raced wide without cover throughout the event.

CUZZEN (K. Crowther) - on arrival at the barriers, appeared to have blood in its nostril. Underwent a pre-race veterinary examination and found a small cut to the inside of the nostril and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

APPLIED (K. Zechner) - shortly after the start, from its wide barrier, shifted in to obtain cover.

KNEE SLAPPER (S. Fawke) - on jumping away bumped with HENRY THE BRUCE, which shifted out. Hung out rounding the home turn.

RACE 4: COMMERCIAL HOTEL CLASS 2 HANDICAP - 1200 Metres

OUR BOY BAILEY (D. Tourneur) - over-raced in the middle stages of the event.

BOOMER BEACH (J. Holder) - rider explained in relation to the gelding's disappointing performance, that it felt short in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

MY MATE SONNY (E. Boyd) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RISING THUNDER (C. Jones) - shortly after the start rolled out. Inclined to lay out under pressure in the straight.

LUCKY DOG (A. Jordsjo) - shortly after the start rolled in.

SPACE EQUITY (J. Opperman) - slightly slow to begin. Shortly after was unable to improve its position as LUCKY DOG rolled in and RISING THUNDER rolled out.

HOLY TORMENT (S. Logan) - in the vicinity of the 1000 metres, was inclined to lay in and shifted in onto JACK'S SISTER, which was hampered when tightened onto SUNMATE. Rider was reprimanded under AR131(a) and advised to take greater care in future.

RACE 4: COMMERCIAL HOTEL CLASS 2 HANDICAP - 1200 Metres (Cont'd)

JACK'S SISTER (C. Lions) - jumped away awkwardly. In the vicinity of the 1000 metres was hampered when tightened onto SUNMATE as HOLY TORMENT, which was inclined to lay in, shifted in and from that point on, raced wide without cover throughout the event. Hung out under pressure in the straight.

RACE 5: TALKING HAIR AND BEAUTY RATING 0-58 HANDICAP - 1100 Metres

LOHN RANGER (S. Logan) - hung in under pressure in the straight. Rider reported the gelding did not feel comfortable in its action over the concluding stages of the event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer Mr J. MacMillan was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

ARCHWAY TO HEAVEN (T. Voorham) - jumped away very awkwardly. Lost its off hind plate during the event.

SAND CAT (C. Lions) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

DOMESDAY MAGIC - became unruly in the mounting, reared and dislodged its rider. Rider was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements. As J. Eaton was indisposed Stewards declared DOMESDAY MAGIC a late scratching at 3.38 pm. Trainer Mr G. Kluske was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

ENVYEM (D. Tootell) - slow into stride. Over-raced throughout the event.

FABULOUS FLIPPER (P. Gatt) - kicked by another runner behind the barriers. Underwent a pre-race veterinary examination and passed fit to race. Rider was dislodged during this incident, was examined by the First Care Medical Personnel and passed fit to fulfil his engagement. Rider reported the mare did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: FLEURIEU MILK COMPANY RATING 0-58 HANDICAP - 1600 Metres

FLYING PIERRO (J. Toeroek) - from the vicinity of the 1000 metres, raced wide without cover for the remainder of the event.

HIGHLY DECORATED (S. Fawke) - jumped away awkwardly, shifted in and bumped ALIRIS.

IS THAT SO (P. Gatt) - rider became concerned with the gelding's action over the concluding stages of the event and for that reason, he elected to restrain his mount quickly and dislodged prior to returning to the mounting yard. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. First aid administered. Co-Trainer Mrs S. Jaensch was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

ALIRIS (T. Voorham) - on jumping away bumped with QUICK BISCUIT and HIGHLY DECORATED, which both shifted ground.

LORD ROSENTHAL (D. Tourneur) - laid in under pressure in the straight.

LITTLEBITFUNNY (M. Collett) - rider reported the gelding may not have handled today's track conditions.

QUICK BISCUIT (A. Jordsjo) - jumped away awkwardly, shifted out and bumped ALIRIS.

RACE 7: NORTHPOINT FLEURIEU BENCHMARK 62 HANDICAP - 1350 Metres

MR STYLISH (K. Crowther) - jumped away awkwardly, shifted out and bumped STRYKE IN STYLE.

LOOKING AROUND (NZ) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RAPID RAISER (J. Holder) - held up for clear running from approaching the 400 metres until the entrance to the straight. Rider reported that he had concerns with the gelding's action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

STRYKE IN STYLE (S. Logan) - on jumping away bumped with MR STYLISH, which shifted out. Held up for clear running from in the vicinity of the 500 metres until in the vicinity of the 400 metres.

PIVOTAL FORCE (J. Toeroek) - proved fractious in the mounting yard, reared and dislodged its rider. Rider examined by the First Care Medical Personnel and ruled uninjured in the event. Given the actions of the horse, Stewards declared PIVOTAL FORCE a late scratching at 4.45 pm. Co-Trainer Mr G. Kent was advised a warning had been placed on the gelding in relation to its pre-race behaviour.

AUSSIE JACK (M. Collett) - rider reported the gelding did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

ANNIKA (T. Voorham) - jumped away awkwardly. Approaching the 800 metres shifted in when insufficiently clear of SPIRITED MATCH, which was obliged to be checked to avoid the heels of that mare. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 26 September and to conclude at midnight on Saturday, 4 October 2020: a period of four meetings. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SPIRITED MATCH (S. So) - approaching the 800 metres was obliged to be checked to avoid the heels of ANNIKA, which shifted in when insufficiently clear. Shortly after commenced to race fiercely and shifted out to obtain clear running. Lost its off hind plate during the event.
