Report on Race Meeting held at Naracoorte Racecourse

RACE 1: TAB CLASS 2 HANDICAP - 1200 Metres

MAGNETIC EDGE (S. Fawke) - laid out in the straight. Inconvenienced BUBBLERAP over the concluding stages. Rider was reminded of his obligations and advised to straighten his mounts sooner when they commence to shift ground.

BUBBLERAP (J. Opperman) - inconvenienced over the concluding stages. Rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. Rider also pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

MONTPENSIER (S. Logan) - laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

BELEURA DEMON (M. Collett) - laid out from the 300 metres.

Correct weight was delayed to allow J. Opperman (BUBBLERAP), placed second to view the vision in the straight.

RACE 2: WATTLE RANGE COUNCIL SABOIS MAIDEN PLATE - 1100 Metres

DR CHOCCY (D. Caboche) - jumped away awkwardly.

LODED DIPER (S. Logan) - jumped away awkwardly and shifted out.

LUCIAN (J. Opperman) - laid out under pressure over the concluding stages. Rider pleaded guilty under AR132(b)(a) for using his whip forward of the horse's shoulder as was reprimanded.

FASHION DESIGNER (L. Halliday) - laid in, in the straight.

RACE 2: WATTLE RANGE COUNCIL SABOIS MAIDEN PLATE - 1100 Metres (Cont'd)

SCHLEER (E. Boyd) - lost its near fore plate during the event.

RACE 3: OMNIZAR BENCHMARK 58 HANDICAP - 1100 Metres

CANIDAE (S. Fawke) - rider reported after jumping away well, the gelding could not maintain its mid-field position given the fast pace of the race in the early and middle stages despite his efforts.

MONTRE (S. Logan) - jumped away awkwardly and shifted in. Laid in, in the straight. In the vicinity of the 200 metres, hung in tightening the running of **BENOVSKY**. In the vicinity of the 150 metres rolled in taking **BENOVSKY** in.

TIZA (C. Jones) - jumped away slowly.

SNAPTOF (E. Boyd) - inconvenienced at the start by **WORLD FORCE**. Laid in from the 700 metres.

BENOVSKY (L. Halliday) - at the entrance to the home straight was disappointed for a run between **MONTRE** and **TIZA**. In the vicinity of the 200 metres elected to switch to the inside of **MONTRE**, which shifted in and became tightened for running and obliged to race in restricted room for a short distance thereafter. In the vicinity of the 150 metres was taken in by **MONTRE**, which rolled in and inconvenienced **WORLD FORCE**.

WORLD FORCE (J. Potter) - jumped away awkwardly, shifted out and inconvenienced **SNAPTOF**. In the vicinity of the 150 metres was obliged to be steadied to avoid the heel of **BENOVSKY**. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: THE MIDFIELD GROUP SABOIS MAIDEN PLATE - 1430 Metres

The start of this event was delayed approximately three minutes.

BONIFACE (NZ) (M. Collett) - laid in from the 800 metres. A post-race veterinary examination revealed no visible abnormalities.

LUCADONIS (K. Opperman) - slow into stride.

WONGA FLYER (S. Fawke) - slow to begin.

LADY ADELE - a late scratching at 1.47 pm by order of Stewards acting on veterinary advice as the mare had a minor infection to its near side wither.

STRYKER STAR (L. Halliday) - sat down in the gate prior to jumping away. Underwent a pre-race veterinary examination and passed fit to race. Laid out in the straight. Co-Trainer Mr K Post was advised a warning would be place on the gelding regarding its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: COOPERS BREWERY BENCHMARK 66 HANDICAP - 1430 Metres

NONE BETTER (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

BRIGHT BELLE (M. Collett) - raced keenly in the middle stages of the event.

RACE 6: ADRIAN THOMAS INDUSTRIAL BENCHMARK 54 HANDICAP - 1200 Metres

REVOLUTION BABY (S. Logan) - slow into stride.

BASSONS (L. Halliday) - laid out and raced wide throughout the event.

OUTINTHESTREET (K. Crowther) - laid in, in the straight.

RAYLEIGH (S. So) - inclined to lay in, in the straight.

**RACE 7: DIGIORGIO FAMILY WINES JERICHO CUP QUALIFIER BENCHMARK 75 HANDICAP
-3160 Metres**

MATAS (J. Eaton) - rider reported the mare never travelled throughout and laid out in the straight. She added in her opinion that MATAS may not have handled the heavy track conditions in today's event. A post-race veterinary examination revealed no visible abnormalities.

MAGUS MAN (S. So) - Trainer Mr G. Young advised Stewards prior to the event in a change of tactics that being that he would advise the rider to attempt to lead in today's event. Settled on pace.

KARAOKE EXPRESS (K. Zechner) - raced keenly in the middle stages of the event.

RACE 8: MP AIR-CON & EXCAVATION BENCHMARK 58 HANDICAP - 1430 Metres

PEWTER (S. Fawke) - rider explained the gelding travelled well in the early and middle stages however, when placed under pressure from the 700 metres, PEWTER did not respond to his riding. He added that in his opinion, the gelding may not have handled today's heavy track conditions. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

IKNOW WHERE YOULIV (S. So) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

THE GREAT MARTINI (J. Opperman) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

GROSVENOR BRIDGE (NZ) (D. Tourneur) - approaching the 400 metres became awkwardly placed on the heels of PEWTER for a short distance.
