**RACE 1: JP CABINETS BENCHMARK 66 HANDICAP - 1390 Metres**

**PERFECT COMMAND** (S. So) - raced wide without cover throughout the event.

**TROGIR** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**KINGSON** (K. Zechner) - slow to begin. Over-raced in the early and middle stages of the event.

**RACE 2: AVIS PORT LINCOLN / SABOIS MAIDEN PLATE - 1000 Metres**

The start of this event was delayed approximately two minutes.

**EIGHT OVER EIGHT** (S. Fawke) - on jumping away bounded. Laid out under pressure in the straight.

**CENTREFIELD** (J. Potter) - rider reminded of his obligations under AR131(b) in relation to riding his mounts out to the finish.

**KAMALA KHAN** (K. Zechner) - on arrival at the barriers was required to be resaddled. Raced keenly in the early and middle stages of the event.

**RIGHT TURN** (K. Crowther) - jumped away awkwardly. Hung in under pressure in the straight. Near the 200 metres shifted out to gain clear running.

**ROCK STORM** (E. Boyd) - slow into stride.

**THE BIG GOODBYE** (J. Toeroek) - raced wide without cover throughout the event.

### RACE 2: AVIS PORT LINCOLN / SABOIS MAIDEN PLATE - 1000 Metres (Cont'd)

**BRAZEN HEAD** (M. Collett) - on arrival at the barriers the bridle was required to be adjusted. Inclined to lay out under pressure in the straight.

**CONGE** (E. Annells) - laid in throughout the event.

**STRIP CLUB** (S. So) - jumped away awkwardly and shifted out.

**BADOS** (C. Jones) - refused to proceed to the start. Stewards declared BADOS a late scratching at 1.11 pm. Trainer, Mr B. Clarke, was advised that the gelding was required to complete an Official Barrier Trial to the Stewards' satisfaction prior to accepting for a future race.

### RACE 3: DEMPSEY'S SADDLERY & FEED / SABOIS MAIDEN PLATE - 1000 Metres

The start of this event was delayed approximately five minutes.

**ROCKFACE LOUIE** (T. Pannell) - on arrival at the barriers the tongue-tie was required to be adjusted. During the process ROCKFACE LOUIE proved unruly. Trainer Mr M. White, representing Trainer Mr D. Carrison, was advised that a warning had been placed on the gelding. Raced keenly in the early and middle stages of the event and got its head up on a number of occasion when being restrained.

**ANJAH** (E. Boyd) - hung in under pressure in the straight.

**DRESSMAKER** (K. Crowther) - jumped away awkwardly, shifted out and bumped YEAH YEAH NAH. Rider reported in relation to her mounts performance that the mare did not feel comfortable in its action during the event and for this reason she elected not to ride DRESSMAKER out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

**I GOT STRINGS** (J. Potter) - refused to load. Acting on this advice Stewards declared I GOT STRINGS a late scratching at 1. 55 pm. Trainer Mr M. White, representing trainer Mr D. Carrison, was advised that the mare was now required to load without delay in an Official Barrier Trial prior to accepting for a future race.

**LEAVE IT TO ME** (D. Caboche) - laid in under pressure in the straight.

**SCARY GO ROUND** (J. Toeroek) - presented in the mounting yard without a cross-over noseband, which was required under its approved gear. Acting under AR106(2) Stewards issued trainer, Mr R. King a reprimand and advised him to ensure his horses were presented to race in the correct gear in future. Laid in under pressure in the straight.

**TERELLI** (T. Voorham) - rider explained in relation to the mare's performance that TERELLI travelled well during the event; however, when asked for an effort failed to let down and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

**ZARAFSHAN** (S. Logan) - laid out under pressure in the straight.

**CARALUE** (A. Jordsjo) - hung out throughout the event.

**MY CAT BALLOU** (L. Halliday) - raced wide without cover throughout the event.

**YEAH YEAH NAH** (E. Annells) - proved difficult to load. Trainer Mr M. White, representing trainer, Mr D. Carrison, was advised that the filly was now required to load to the Stewards' satisfaction in an Official Barrier Trial prior to a future race. On jumping away bumped with DRESSMAKER, which shifted out, and shortly afterwards had its hindquarters turned out.

#### **RACE 4: LIBERTY RURAL PORT LINCOLN BENCHMARK 58 HANDICAP - 1000 Metres**

**ROCK HARD** (E. Annells) - laid in under pressure in the straight.

**OBLIQUE LINE** (S. Logan) - shortly after the start was crowded between CHOUX BACQUAT (NZ) and SOCIAL MEDIA, which rolled out. Near the 900 metres the gelding lifted its head and struck S. Logan in the face. Following this event S. Logan was examined by the First Care Medical personnel and was ruled unfit to fulfil her engagement in Race 5 and would be reassessed following this event.

**PEACE CLOUD** (C. Jones) - underwent a pre-race veterinary examination as it had not raced for 12 months and passed fit to race. Hung throughout the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr B. Clarke, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race. Mr Clarke advised Stewards that he would recommend to the owners the gelding be retired.

**STORM VOYAGER** (T. Pannell) - jumped away awkwardly, shifted in and bumped KISHSTAR. Held up for clear running from the 400 metres until in the vicinity of the 200 metres.

**SCENIC MINT** (J. Toeroek) - raced wide without cover throughout the event.

**KISHSTAR** (D. Caboche) - jumped away awkwardly, shifted out and bumped STORM VOYAGER. When questioned in relation to the mare's poor performance D. Caboche explained that KISHSTAR raced flat in today's event and failed to respond to his riding from in the vicinity of the 600 metres, and he was disappointed with its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

**SOCIAL MEDIA** (E. Boyd) - shortly after the start rolled out. Inclined to lay out under pressure in the straight.

**SERIOUS MOONLIGHT** (T. Voorham) - slow to begin. Laid in under pressure in the straight.

#### **RACE 5: BRIAN HARVEY AGENCIES BENCHMARK 80 HANDICAP - 1000 Metres**

The start of this event was delayed approximately two minutes.

**BRAMFIELD** (T. Pannell) - shortly after the start lost its position when awkwardly placed on the heels of WOTUWANT, which shifted out abruptly.

**TINTAGEL ROCKER** (L. Halliday) - over-raced throughout the event. Near the 700 metres dipped for no apparent reason. Held up for clear running from in the vicinity of the 400 metres until near the 200 metres when racing between PANDEIA and GO THE JOURNEY, then shifted in, in an attempt to gain clear running, and from near the 200 metres until near the 100 metres raced in restricted room to the inside of GO THE JOURNEY.

**LADY CONQUISTADOR** (E. Boyd) - rounding the home turn was tightened between ARTFUL RAMBLER and MIRTHDALE, which rolled out.

**MIRTHDALE** (K. Zechner) - held up for clear running from in the vicinity of the 400 metres until the entrance to the straight. Rolled out rounding the home turn.

**BELLOMO** (K. Crowther) - jumped away awkwardly.

**WOTUWANT** (J. Potter) - Stewards permitted J. Potter to ride the gelding 0.5 kg over its declared weight of 54 kg. On arrival at the barrier the tongue tie was required to be adjusted. Shortly after the start shifted out abruptly onto BRAMFIELD, which was awkward on the heels of that gelding and lost its position. A post-race veterinary examination revealed no visible abnormalities.

Following this event S. Logan was re-examined by the First Care Medical personnel and passed fit to fulfil her remaining engagements.

### **RACE 6: TUNARAMA COACHLINES CLASS ONE HANDICAP - 1210 Metres**

**THE MASTER** (K. Crowther) - in the vicinity of the 150 metres bumped with TIME WARRIOR, which shifted in and away from ARTFUL AMBITION.

**TIME WARRIOR** (R. Hurdle) - in the vicinity of the 150 metres shifted in and away from ARTFUL AMBITION, which rolled in, and bumped THE MASTER.

**COPPERFIELDS** (S. Fawke) - a post-race veterinary examination revealed skin abrasions to its near fore fetlock.

**ARTFULABEERS** (T. Pannell) - shortly after the start was unable to improve its position when awkwardly placed between COPPERFIELDS and VILANELLE, which both shifted ground.

**MY MATE SONNY** (J. Potter) - shortly after the start shifted in to obtain cover. Raced keenly in the early and middle stages of the event. Hung in under pressure in the straight and near the 70 metres shifted in and bumped with ARTFUL AMBITION on a number of occasions.

**KISSABLE EIGHT** (L. Halliday) - shortly after the start shifted in to obtain cover.

**ARTFUL AMBITION** (K. Zechner) - in the vicinity of the 150 metres rolled in onto TIME WARRIOR, which shifted in and away from the gelding. Near the 70 metres rolled out and bumped with MY MATE SONNY on a number of occasions.

**VILANELLE** (S. Logan) - approaching the 100 metres was obliged to be momentarily steadied when awkwardly placed on the heels of TIME WARRIOR and THE MASTER, which came together and bumped.

**GIVEPEACE A CHANCE** (T. Voorham) - shortly after the start shifted in to obtain cover.

### **RACE 7: DBC COMPUTING SOLUTIONS BENCHMARK 62 HANDICAP - 1210 Metres**

The start of this event was delayed approximately eight minutes.

**MAGNUS MAGIC** (S. Fawke) - jumped away awkwardly. Shortly afterwards shifted in to obtain cover and approaching the 1000 metres continued to shift in taking JACKPOT JOHNNY in over a number of strides. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground in the early stages in future. Laid in under pressure in the straight.

**JUSTICA** (J. Toeroek) - jumped away awkwardly.

**FEARLESS AL** (S. Logan) - as the start was effected stood in the gates and dipped, jumped away very awkwardly and as a result dislodged its rider. S. Logan was examined by the First Care Medical personnel and was ruled unfit to fulfil her remaining engagements.

**MY MOTHER SAYS** (L. Halliday) - failed to muster speed during the event. A post-race veterinary examination revealed no visible abnormalities.

**TAJAVEDO** (E. Boyd) - inclined to shift about under pressure in the straight.

**JACKPOT JOHNNY** (M. Collett) - approaching the 1000 metres was taken in over a number of strides by MAGNUS MAGIC, which shifted in.

**HOW JAMMY'S THAT** (S. So) - lost its near hind plate en route to the barriers and was required to be reshod prior to the event. Underwent a pre-race veterinary examination and was passed fit to start.

**THE MOSHIRE** (K. Crowther) - raced wide without cover throughout the event.

**RACE 8: LOCAL LIQUID RATING 0-58 HANDICAP - 1390 Metres**

**EMOJI** (K. Zechner) -weakened from inside the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

**JAY PEE BEE (NZ)** (A. Jordsjo) - in the vicinity of the 400 metres was obliged to be steadied as **CRAZY CULPRIT** rolled out and **LEONARDA** rolled in marginally. Hung in under pressure in the straight. Near the 50 metres was inconvenienced and was hampered when **CRAZY CULPRIT** rolled out.

**CRAZY CULPRIT** (J. Potter) - near the 1300 metres shifted in onto **ART MUSIC**, which was eased momentarily. Inside the 400 metres rolled out onto **JAY PEE BEE (NZ)**, which was obliged to be steadied when tightened onto **LEONARDA**, which rolled in momentarily. Rider was severely reprimanded under AR131(a) and advised to take greater care in future. Inside the 100 metres rolled out under riding onto **JAY PEE BEE (NZ)**, which was hampered. Rider was reprimanded under AR131(a) and advised to take greater care in future.

**SPENCER GULF** (K. Crowther) - jumped away awkwardly and as a result was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**ART MUSIC** (E. Annells) - near the 1300 metres was eased momentarily as **CRAZY CULPRIT** shifted in. Raced keenly in the early and middle stages of the event.

**RACE 9: MCDONALDS PORT LINCOLN BENCHMARK 54 HANDICAP - 1000 Metres**

**MY LESSON** (L. Halliday) - hung out rounding the home turn.

**AVORA SUN** (M. Collett) - on jumping away bumped with **CHINESIS**, which shifted in.

**CHINESIS** (S. Logan) - on jumping away shifted in and bumped **AVORA SUN**.

**SON OF CITY** (T. Voorham) - shortly after the start shifted in to obtain cover.
