Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 28 November 2020

RACE 1: ADELAIDE GALVANISING TWO-YEAR-OLD PLATE - 1050 Metres

JIMMYS EDGE (R. Hurdle) - laid out from inside the 600 metres and as a consequence raced wide rounding the home turn and into the straight and in doing so took WITNESS GREATNESS wider on the track. Rider explained the gelding commenced to lay out and as a consequence he was unable to make the turn into the straight properly. He added the gelding finished the race off poorly and in his opinion, may have been shin sore. A post-race veterinary examination revealed no visible abnormalities.

STRATISFACTION (T. Voorham) - proved fractious in the mounting yard prior to proceeding to the barriers and dislodged T. Voorham who was uninjured in the incident.

BLERIOT (K. Zechner) - was slow to begin.

CAPITAL RAIDER (K. Crowther) - was inclined to lay out over the concluding stages.

LAST ZERPRISE (B. Vorster) - raced greenly in the straight. Laid in over the concluding stages.

WITNESS GREATNESS (J. Eaton) - taken wider by JIMMYS EDGE at the entrance to the straight for a short distance.

ZAKYBREE (S. Logan) - was slow to begin. Raced greenly during the event and was inclined to lay out rounding the home turn. A post-race veterinary examination revealed a haematoma on the lower near fore canon.

RACE 2: TAB HANDICAP - 2500 Metres

POET'S LANDING (NZ) (J. Eaton) - shifted out near the 900 metres and inconvenienced GALAHAD GURU. Rider was reminded of her obligations when shifting ground in future. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by J. Eaton and noted that she used her whip on two occasions over the last 100 metres. A post-race veterinary examination revealed no visible abnormalities.

HASTA LA FIORENTE (D. Tourneur) - raced keenly in the middle stages of the event. Inclined to lay out in the straight.

FLOW METER (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by S. Fawke and noted that he used his whip on six occasions over the last 100 metres.

NEVA DOUBT US (S. Logan) - raced keenly in the middle stages of the event.

GALAHAD GURU (J. Holder) - was inconvenienced near the 900 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by J. Holder and noted that he used his whip on three occasions over the last 100 metres.

RACE 3: SOUL GROWERS HANDICAP - 1100 Metres

IDEAS MAN (P. Gatt) - was awkward to begin, shifted out and contacted ZEDUKI, which was tightened onto SHOW SOME DECORUM, which was awkward to begin and shifted in.

SHOW SOME DECORUM (T. Pannell) - was awkward to begin and shifted in at the start.

ZEDUKI (M. Collett) - was tightened at the start between IDEAS MAN and SHOW SOME DECORUM, which both began awkwardly and shifted ground and as a consequence, knuckled after being tightened. Rider reported, after knuckling, the gelding felt awkward in its action and failed to raise a gallop. A post-race veterinary examination revealed no visible abnormalities.

SIYAADEH (B. Vorster) - shifted out making the turn near the 700 metres and became awkward inside the heels of SHOW SOME DECORUM for several strides.

RACE 4: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DEC 18 HANDICAP - 1600 Metres

FAROOQ (D. Tourneur) - raced wide without cover in the early and middle stages of the event.

ROSELLI STING (K. Crowther) - raced keenly in the early stages of the event. Inclined to lay in, in the straight.

BLACK SYRAH (C. Jones) - was slow to begin.

DIVANATION (B. Vorster) - underwent a pre-race veterinary examination as it had not raced since September 2019 and was passed fit to race.

RACE 5: FURPHY HANDICAP - 1800 Metres

CAMPOBASSO (NZ) (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: FURPHY HANDICAP - 1800 Metres (Cont'd)

SKILLFUL STEPS (P. Gatt) - was held up for clear running from inside the 600 metres until near the 300 metres.

DON'T DISMISS (C. Lions) - laid out in the straight.

AFRICAN AWESOME (J. Holder) - raced keenly in the early stages and laid in over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

LITTLEBITFUNNY (D. Caboche) - Stewards permitted D. Caboche to ride the filly 0.5 kg over its declared weight of 54kg.

RACE 6: ACCOLADE WINES HANDICAP - 1100 Metres

BEEOKAY (S. Logan) - Stewards acceded to a request from Trainer Mr G. Young for this horse to race equipped with blinkers. Mr. Young submitted that he requested a gear change prior to acceptance time.

RANGER FRANK (R. Hurdle) - laid in over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

EXALTED LAURETTA (C. Jones) - Trainer Mr G. Young advised Stewards prior to the event of a change of tactics that being that he would instruct his rider to attempt to settle back with cover from its wide barrier.

ISSARA (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

READY SUNSHINE - prior to the event, Trainer Mr R. Balfour, made a submission to Stewards to allow the gelding to be declared a late scratching owing to the track upgrade from a Good 4 to a Good 3. Stewards acceded to his request and declared READY SUNSHINE a late scratching at 2.41pm.

FOUR OF A KIND (K. Crowther) - laid in, in the straight.

RACE 7: ROADSIDE SERVICES CITY OF MARION STAKES - 1200 Metres

TOO GOOD TOO HARD (J. Holder) - laid out in the straight. Rider explained his instructions were to allow the mare to settle where comfortable and that he had anticipated, on an exposed form, he would settle back in the field. He added after obtaining cover shortly after the start, he was comfortable with his position in running, however, was obliged to shift out wider and commence his run from inside the 600 metres, and further added that the mare a tough run into the race when not being able to follow another runner into the straight. He added that the mare did not finish the race off in a strong fashion. A post-race veterinary examination revealed no visible abnormalities.

I REMEMBER YOU (J. Toeroek) - Stewards permitted J. Toeroek to ride the mare 0.5 kg over its declared weight of 54kg. A post-race veterinary examination revealed no visible abnormalities.

JENTICO (B. Vorster) - raced a little keenly for a short distance approaching the 800 metres.

KENYAN WONDER (K. Zechner) - over-raced in the early and middle stages of the event.

RACE 8: PETER ELBERG FUNERALS HANDICAP - 1600 Metres

WYLIE OL' COYOTE (S. Logan) - was inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: PETER ELBERG FUNERALS HANDICAP - 1600 Metres (Cont'd)

TIGNANELLO (NZ) (J. Eaton) - in the vicinity of the 250 metres was tightened by **RAPID RAISER** which shifted out to improve and as a consequence was tightened onto **WYLIE OL' COYOTE** and had to be checked for several strides to avoid the heels of **RAPID RAISER** and lost its position.

LI'L HANK (D. Tourneur) - raced keenly in the early stages of the event.

CASHIN' CHEX (NZ) (K. Crowther) - proved fractious after being loaded into its barrier stall, was removed and underwent a pre-race veterinary examination and was passed fit to race.

RAPID RAISER (P. Gatt) - in the vicinity of the 250 metres shifted out to improve and tightened **TIGNANELLO (NZ)** onto **WYLIE OL' COYOTE** resulting in **TIGNANELLO (NZ)** having to be checked for several strides to avoid **RAPID RAISER'S** heels, losing its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on 2 December and to conclude at midnight on 11 December 2020: a period of five meetings.

STAN THE CADDY (T. Pannell) - rider reported the gelding never travelled during the event and was disappointing in its finish. A post-race veterinary examination revealed no visible abnormalities.

ZAGATO STAR - prior to the event, Trainer Mr R. Balfour, made a submission to Stewards to allow the mare to be declared a late scratching owing to the track upgrade from a Good 4 to a Good 3. Stewards acceded to his request and declared **ZAGATO STAR** a late scratching at 2.41pm.

RACE 9: WINNING EDGE PRESENTATIONS HANDICAP - 1200 Metres

HEARTY LASS (C. Jones) - approaching the 1000 metres was momentarily inconvenienced by **MAID IN MILAN**, which shifted in to improve.

LA VITA (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

MAID IN MILAN (J. Maund) - approaching the 1000 metres shifted in to improve onto **HEARTY LASS** momentarily inconveniencing that horse. Rider was reminded of his obligations when shifting ground.

WOULDA THOUGHT SO (K. Zechner) - a post-race veterinary examination revealed no visible abnormalities.
