**RACE 1: MEMBERS OF BUNG FRITZ SOCIETY / SABOIS MAIDEN PLATE - 1500 Metres**

**APPLIED** (J. Holder) - held up from the vicinity of the 500 metres until the entrance to the straight. Was forced to race in restricted room for a number of strides in the vicinity of the 200 metres when awkwardly placed between SMILING ASSASSIN and OUR JOURNEYMAN, which both shifted ground slightly.

**BURNING HARD** (L. Halliday) - jumped away awkwardly.

**OUR JOURNEYMAN** (E. Boyd) - rolled out slightly in the vicinity of the 200 metres.

**SMILING ASSASSIN** (T. Pannell) - in the vicinity of the 700 metres was inconvenienced when contacted by ALITTLEBITOFREBA. Inclined to lay in under pressure in the straight, and in the vicinity of the 200 metres shifted in slightly.

**ALITTLEBITOFREBA** (Z. White) - raced keenly in the early and middle stages of the event. In the vicinity of the 700 metres shifted out and contacted SMILING ASSASSIN. Rider was advised in future to make a greater effort to restrain her mount and come back, rather than pass her predicament onto other riders.

**SMART VISION** (M. Vassallo) - rider explained that the mare was one-paced throughout the event, that he had struggled to maintain contact with the field in the middle stages and in his opinion the mare would be better suited over a longer distance. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: COOPERS BREWERY BENCHMARK 62 HANDICAP - 2100 Metres**

**MANHATTAN GANGSTER** (C. Jones) - slow to begin.

**THE RED SEA** (T. Pannell) - inclined to lay out under pressure in the straight.

**I'M BULLETPROOF** (J. Eaton) - raced keenly in the early and middle stages of the event.

**RACE 2: COOPERS BREWERY BENCHMARK 62 HANDICAP - 2100 Metres (cont'd)**

**FREE ATBARA** (C. Lions) – rider reported that the mare travelled well in the early and middle stages of the event; however, when placed under pressure at the entrance to the straight failed to respond to her riding and was disappointing. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Co-trainers, Mrs S & Mr J Jaensch, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**RACE 3: 4 WAY FRESH PRODUCE BENCHMARK 54 HANDICAP - 1700 Metres**

**LAMMA HILTON** (E. Annells) – a post-race veterinary examination revealed no visible abnormalities.

**SCOTCH O'CLOCK** (T. Pannell) – rider reported that the gelding had not appreciated the track condition and may have jarred up. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr D. Magro, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**TATTIES** (M. Collett) – was eased from the event at the entrance to the straight. Underwent a post-race veterinary examination which revealed the mare had bled from both nostrils. Trainer, Mr A. Beswick, was advised that as this was the mare's first bi-lateral bleed TATTIES would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

**RACE 4: GAWLER CHRISTMAS RACES SAT 19TH DECEMBER / SABOIS MAIDEN PLATE - 1100 Metres**

**POWERFUL FLYER** (S. Fawke) – fractious on arrival at the barriers. Trainer, Mr L. Jarvis, was advised that a warning had been placed on the gelding in relation to its pre-race manners. Rider reported that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure in the vicinity of the 600 metres failed to respond to his riding and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

**CELESTIAL ILLUSION** (J. Toeroek) – laid in under pressure in the straight and in the vicinity of the 50 metres was momentarily inconvenienced when POLLYANNA shifted out.

**LA RAPIDE** (D. Tourneur) – trainer, Mr A. Clarcken, advised Stewards prior to the event of a change of tactics in that he would instruct the rider to attempt to obtain a position midfield with cover if possible. Settled midfield with cover. Contacted on jumping away by ALOTAFUN.

**POLLYANNA** (T. Pannell) – laid out under pressure over the concluding 100 metres.

**ALOTAFUN** (B. Vorster) – proved difficult to load. Trainer, Mr S. Cahill, was advised that a warning had been placed on the filly. Shifted in on jumping away onto LA RAPIDE. Inclined to shift about under pressure in the straight.

**RACE 5: ULTRA TUNE / KINGSFORD HOTEL BENCHMARK 54 HANDICAP - 1100 Metres**

**READY SUNSHINE** (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

**OLIVE GROVE** (J. Opperman) – had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres.

**RACE 5: ULTRA TUNE / KINGSFORD HOTEL BENCHMARK 54 HANDICAP - 1100 Metres (cont'd)**

**BUBBLES MCGINTY** (J. Toeroek) - was momentarily inconvenienced in the vicinity of the 150 metres when it laid in at the same time as AVORA SUN laid out. In the vicinity of the 100 metres J. Toeroek was forced to stop riding and alter course to avoid the heels of AVORA SUN, which shifted out.

**ZOUSTORM** (D. Tootell (Snr)) - jumped away awkwardly and slow to begin. Trainer, Mr D. Tootell (Snr), was advised that a warning had been placed on the gelding in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

**ARCTIC BLAZE** (C. Jones) - laid out under pressure in the straight.

**AVORA SUN** (K. Zechner) - laid out under pressure in the straight and in the vicinity of the 150 metres shifted out slightly at the same time as BUBBLES MCGINTY rolled in slightly. Continued to lay out under pressure and in the vicinity of the 100 metres shifted out onto BUBBLES MCGINTY. Rider was severely reprimanded and advised in future that he would be required to stop riding and make an attempt to straighten his mounts sooner than he had on this occasion.

**FAY'S JOY** (A. Jordsjo) - raced wide without cover throughout the event.

**RACE 6: GAWLER HI-BEAM CARWASH BENCHMARK 62 HANDICAP - 1500 Metres**

**TEE TRAIN** (S. Cahill) - inconvenienced and taken wider when contacted by OUR DEEP AGENDA in the vicinity of the 800 metres.

**OUR DEEP AGENDA** (K. Zechner) - in the vicinity of the 800 metres became awkwardly placed on the heels of MR EPIC and shifted out contacting TEE TRAIN, which was inconvenienced when taken wider. Rider was advised in future that he would be required to attempt to restrain his mount and come back rather than pass his predicament onto other riders.

**MIRKWOOD FOREST** (S. So) - rider reported that the horse felt awkward in its action on pulling up and return to the mounting yard. A post-race veterinary examination revealed no visible abnormalities.

**ZAGATO STAR** (D. Tourneur) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. First aid administered. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**MISSALLURE** (J. Holder) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr P. Stokes, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**RACE 7: JOHNSON & DARE BENCHMARK 52 HANDICAP - 1500 Metres**

**MANOR KING** (Z. White) - raced wide without cover throughout the event.

**SUPERHOOPS** (J. Opperman) - raced keenly in the early and middle stages of the event.

**SYLVAN CREST** (K. Crowther) - raced keenly in the early and middle stages of the event.

**MINNAMOSA (NZ)** (E. Boyd) - raced keenly in the early and middle stages of the event. Hung out from the vicinity of the 600 metres until the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**NEWBAY FLYER (NZ)** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 8: CORNERSTONE STUD BENCHMARK 58 HANDICAP - 1200 Metres**

**DOMINATION** (J. Opperman) - inconvenienced on jumping away when contacted by JACJAC JACQUI. Rider could offer no explanation for the gelding's performance. A post-race veterinary examination revealed no visible abnormalities.

**COMMANDING DIVA** (T. Pannell) - rider reported that the mare never travelled and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

**CARTIER TIARA** (M. Collett) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200 metres.

**GALCRUM** (D. Caboche) - raced wide without cover throughout the event.

**JACJAC JACQUI** (P. Gatt) - shifted in on jumping away onto DOMINATION. Rider reported that the mare travelled well in the early and middle stages of the event; however, when placed under pressure in the straight had not responded to his riding and he had become concerned with its action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**PANZER PRINCESS** (A. Jordsjo) - rider accidentally dropped her whip inside the 200 metres.
