RACE 1: CHOOK'S LITTLE WINE TOURS / SABOIS MAIDEN PLATE - 2050 Metres

SONAR ECHO (M. Collett) - jumped away awkwardly and shifted out bumping LOVE ME HARDER. Raced keenly in the early and middle stages of the event.

CAPRICORN RIDGE (P. Gatt) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. In the vicinity of the 100 metres bumped REGAL TRIUMPH.

REGAL TRIUMPH (D. Tourneur) - in the vicinity of the 100 metres was bumped by CAPRICORN RIDGE, which laid in under pressure.

DITZY DANIELLA (D. Stra) - a post-race veterinary examination revealed no visible abnormalities.

LOVE ME HARDER (A. Jordsjo) - bumped on jumping away by SONAR ECHO. Raced keenly in the early and middle stages of the event.

RACE 2: COMMERCIAL HOTEL BENCHMARK 54 HANDICAP - 1100 Metres

FERGIE (P. Gatt) - approaching the 100 metres was momentarily inconvenienced when **FABULOUS FLIPPER** rolled in marginally. A post-race veterinary examination revealed no visible abnormalities.

FABULOUS FLIPPER (C. Jones) - approaching the 100 metres rolled in marginally under pressure momentarily inconveniencing **FERGIE**. Rider reminded of her obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

GRAND HOST (K. Crowther) - inconvenienced when taken wider at the start by **RAHEEBA**, which jumped away awkwardly and shifted out.

RAHEEBA (J. Maund) - jumped away awkwardly and shifted out inconveniencing **GRAND HOST**, which was taken wider. Raced keenly in the middle stages of the event.

RACE 3: FLEURIEU MILK COMPANY / SABOIS C,G&E MAIDEN PLATE - 1200 Metres

BEWDY MATE (R. Hurdle) - in the vicinity of the 1100 metres shifted in when insufficiently clear of **EVER ONWARD**, which was taken in onto **GUNFIREINTHECITY**, which had to be momentarily steadied. Rider severely reprimanded under AR131(a) for careless riding. Raced greenly throughout the event.

EVER ONWARD (P. Gatt) - raced greenly throughout the event. In the vicinity of the 1100 metres was inconvenienced when taken in by **BEWDY MATE**. As a result **GUNFIREINTHECITY** had to be momentarily steadied.

GUNFIREINTHECITY (C. Lions) - in the vicinity of the 1100 metres had to be momentarily steadied when **EVER ONWARD** was taken in by **BEWDY MATE**, which shifted in.

KEETTOM (A. Jordsjo) - in the vicinity of the 600 metres was inconvenienced when taken wider by **EVER ONWARD**, which was racing greenly and hung out. At the entrance to the straight was further inconvenienced when taken wider by **EVER ONWARD**, which continued to race greenly and shifted out.

BOLT BY (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: STRATH SMALL ENGINES BENCHMARK 64 HANDICAP - 1350 Metres

SUPER STRIKER (R. Hurdle) - performed below expectations. Rider explained xx A post-race veterinary examination revealed the gelding to have atrial fibrillation. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the filly performing satisfactorily in an Official Barrier Trial.

CARBONE (S. So) - inside the 200 metres had to be steadied and lost its position when **KEYSOR** shifted out when insufficiently clear.

KEYSOR (Z. White) - inside the 200 metres shifted out when insufficiently clear of **CARBONE** resulting in that horse having to be steadied and lose its position. Rider pleaded guilty of a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight Saturday, 19 December 2020 and to conclude at midnight Saturday, 26 December 2020, a period of three meetings.

RACE 5: PEARLE BOUTIQUE / SABOIS F&M MAIDEN PLATE - 1200 Metres

ANJAH (E. Boyd) - in the vicinity of the 500 metres was inconvenienced when taken wider.

RACE 5: PEARLE BOUTIQUE / SABOIS F&M MAIDEN PLATE - 1200 Metres (cont'd)

HEAVENLY AWARD (J. Maund) - jumped away awkwardly.

COMFORT GIRL (R. Hurdle) - slow to begin. In the vicinity of the 500 metres was inconvenienced when taken wider.

CASHHERIFYACAN (L. Halliday) - in the vicinity of the 500 metres was inconvenienced when taken wider.

SEE YOU LATER NOW (C. Lions) - raced keenly and ungenerously throughout the event. In the vicinity of the 500 metres shifted out inconveniencing ANJAH, COMFORT GIRL and CASHHERIFYACAN, which were all taken wider. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr D. Hewitt, was advised that the filly was now required to complete an Official Barrier Trial to the satisfaction of the Stewards prior to a future race start.

RACE 6: MILANG CARAVAN PARK BENCHMARK 52 HANDICAP - 1200 Metres

THANASI (J. Opperman) - laid in under pressure in the straight.

GET IN THE BOWL (Z. White) - slow to begin. Raced keenly in the early stages of the event.

CALYPSO STORM (B. Vorster) - laid out under pressure in the straight.

RACE 7: SUBLIME COFFEE ON BRAY STREET HANDICAP - 1600 Metres

RISING THUNDER (J. Maund) - held up for clear running from the vicinity of the 600 metres until the vicinity of the 200 metres. Approaching the 50 metres brushed with TRIVAGO GIRL. Rider was found guilty of a charge under AR131(b) in that he failed to ride his mount out to the finish of the race and was fined \$200.

TRIVAGO GIRL (M. Collett) - approaching the 50 metres brushed with RISING THUNDER.

DENOMINATOR (NZ) (J. Opperman) - took charge of its rider en route to the barriers, and capture after a short distance. Underwent a pre-race veterinary examination and passed fit to start.

RACE 8: MERRY CHRISTMAS TO ALL BENCHMARK 54 HANDICAP - 1600 Metres

BUBBLERAP (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

MINNAMOSA (NZ) (E. Boyd) - raced keenly in the early stages of the event. Inclined to lay out rounding the home turn.
