

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Naracoorte Racecourse by the Naracoorte Racing Club on Sunday, 27 December 2020

RACE 1: S AND T CHAIR HIRE/ SABOIS+ MAIDEN/ CLASS 1 PLATE - 2000 Metres

FAST DEALER (D. Tourneur) - underwent a pre-race veterinary examination as the gelding had raced on Wednesday, 23 December 2020 and was passed fit to race. Rider explained that FAST DEALER travelled well throughout the event until placed under pressure at the entrance to the straight, didn't let down as expected and was disappointing to the finish. A postrace veterinary examination revealed the gelding to be lame in the off foreleg. Co-Trainer, Mr J. Frew, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

PELADERA (J. Holder) - raced keenly in the early and middle stages of the event.

TAKSIM GIRL (C. Jones) - inclined to lay in, in the straight.

RACE 2: SPORTSPOWER NARACOORTE / SABOIS MAIDEN PLATE - 1430 Metres

FENCELINE (D. Tourneur) - held up for clear running from the 400 metres until the 150 metres. Rider explained that his instructions were to allow the gelding to settle where comfortable and to improve from the 400 metres. He reported that FENCELINE travelled well throughout the event however, from the 400 metres became held up for clear running and at the entrance to the straight, when attempting to improve between TROUBLED TIMES and YANKEE PRINCESS, was disappointed for a run when both runners shifted ground marginally. Shortly thereafter, he then elected to shift to the outside of TROUBLED TIMES in an attempt to obtain clear running and was further disappointed between TROUBLED TIMES and BON PEGASUS, which shifted in and was only able be tested over the final 150 metres.

ALL POINTS (J. Eaton) - slow to begin. A postrace veterinary examination revealed no visible abnormalities.

BON PEGASUS (S. Metcalfe) - raced keenly in the early and middle stages of the event. Laid out from the 400 metres until the 300 metres. Shifted in at the entrance to the straight and tightened the running of FENCELINE.



RACE 3 CALLAGHAN FAMILY BENCHMARK 54 HANDICAP - 1000 Metres

RODNEY (K. Zechner) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

CREATIVE VISION (G. O'Loughlin) - Stewards permitted G. O'Loughlin to ride the filly 0.5 kg over its declared weight of 54kg. Underwent a pre-race veterinary examination as it had not raced for almost 12 months and was passed fit to race. Raced three wide throughout the event.

RACE 4: NED AND NAN WALKER AND SUE SKEER LIVE LIFE TO THE FULLEST MEMORIAL / SABOIS MAIDEN HANDICAP - 1200 Metres

ALBROCO (J. Holder) - jumped away awkwardly and as a result was slow to begin.

ANOTHER FREE GLASS (D. Caboche) - raced keenly in the middle stages of the event.

CASHHERIFYACAN (K. Zechner) - jumped away awkwardly, shifted out and inconvenienced SCENIC HOST. Raced keenly in the early and middle stages of the event.

SCENIC HOST (J. Maund) - inconvenienced on jumping away.

DOUBLE BURNER (J. Eaton) - underwent a pre-race veterinary examination as the gelding had not raced in over 12 months and was passed fit to race.

RACE 5: HENSCHKE INDUSTRIES BENCHMARK 62 HANDICAP - 1200 Metres

OUR BENEVENTO (J. Holder) - jumped away awkwardly. Shifted out and inconvenienced QUIET CLASS. Laid out rounding the home turn. Rider reported after laying out rounding the home turn, the mare lost its action at the entrance to the straight and was disappointing to the finish. A postrace veterinary examination revealed no visible abnormalities.

QUIER CLASS (K. Zechner) - inconvenienced on jumping away.

LONGMIRE (Opperman) - jumped away awkwardly.

RUBY QUE (D. Caboche) - in the vicinity of the 100 metres shied in and away from PERSIAN HONEY after accidentally being struck in the head by the whip by the rider of PERSIAN HONEY.

PERSIAN HONEY (J. Eaton) - laid in, in the straight. In the vicinity of the 100 metres accidentally struck the head of RUBY QUE with her whip.

RACE 6: NARACOORTE RECYCLABLES BENCHMARK 68 HANDICAP - 1430 Metres

MISTA HOLYFIELD (G. O' Loughlin) - raced keenly in the early and middle stages of the event.

WURLIES LASTCHANCE (D. Caboche) - Stewards permitted D. Caboche to ride the filly 0.5 kg over its declared weight of 54kg.

RACE 7: MUNRO AND GRIGG BENCHMARK 54 HANDICAP - 1430 Metres

HASTA LA DREAMS (J. Holder) - inside the 1000 metres was obliged to be restrained after improving off heels as the pace slackened. Held up for clear running from the 400 metres until the 200 metres.

BUBBLERAP (P. Gatt) - had difficulty obtaining clear ground rounding the home turn.

ARKAMUN (E. Boyd) - laid in, in the straight.



RACE 7: MUNRO AND GRIGG BENCHMARK 54 HANDICAP - 1430 Metres (Cont'd)

LOOSE LIP LLOYD (G. O'Loughlin) - raced wide without cover throughout the event.

OUTINTHESTREET (K. Crowther) - inside the 1000 metres was obliged to be restrained after improving onto heels as the pace slackened.

BIT OF A FLIRT (D. Caboche) - Stewards permitted D. Caboche to ride the filly 0.5 kg over its declared weight of 54kg. Inside the 1000 metres was obliged to be restrained after improving onto heels as the pace slackened. Raced keenly in the early and middle stages of the event.
