Report on Race Meeting held at Port Lincoln Racecourse  
by the Port Lincoln Racing Club on Sunday, 10 January 2021

**TRACK:** Good 4 (Track with some give in it)  
Upgraded to a Good 3 at 2.56 pm retrospective to Race 5  
(Track with good grass coverage and cushion)

**RAIL:** Out 3 metres from the 800 metres to winning post, out 2 metres remainder.

**WEATHER:** Fine

**RACE 1: MORPHETTVILLE EQUINE CLINIC / SABOIS MAIDEN PLATE - 1750 Metres**

**CANIMAN** (S. So) - rider reported that the gelding never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**GET AROUND HIM** (S. Fawke) - slow to begin. Approaching the 1500 metres got its head up while being restrained and shortly after was obliged to be steadied away from the heels of RASHYATHERE, then over-raced in the middle stages of the event.

**OUR RUPERT** (R. Hurdle) - in the vicinity of the 1500 metres was obliged to be restrained for a short distance away from the heels of DISS 'N' DAT. A postrace veterinary examination revealed a slower post-race recovery.

**RASHYATHERE** (J. Toeroek) - inside the 1500 metres shifted in across the running of GET AROUND HIM. Rider was reminded of his obligations and advised in future to only shift ground when entitled to do so.

**TICKET TO TEXAS** - a late scratching at 11.06 am by order of Stewards due to travel difficulties.

**DISS 'N' DAT** (D. Caboche) - laid out rounding the home turn.

**RIGHT TURN** (S. Metcalfe) - laid in throughout. At the entrance to the straight was momentarily held for a run to the inside of BURNING HARD. Approaching the 100 metres elected to shift out to out to obtain clear running until the finish.

**RACE 2: TUNARAMA COACHLINES / SABOIS MAIDEN PLATE - 1210 Metres**

The start of this event was delayed approximately five minutes.

**BADOS** (S. Logan) - laid out throughout the event.

**RACE 2: TUNARAMA COACHLINES / SABOIS MAIDEN PLATE - 1210 Metres (Cont'd)**

**FOLLOW THE PROMPTS** (R. Hurdle) - shortly after the start commenced to buck. Trainer representative Mr S. Grivell was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**LUCKY MISFORTUNE** (A. Jordsjo) - jumped away awkwardly. Rider explained the gelding made excess respiratory noises throughout the event and never travelled. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr R. Dawson was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**LOOKING AT YOU KID** (D. Caboche) - underwent a pre-race veterinary examination and passed fit to race. Reared as the start was affected and as a result was slow to begin.

**ROCK STORM** (E. Annells) - dislodged its rider at the gates. Rider was examined by the First Care Medical Personnel and was ruled unfit to ride. Stewards ordered ROCK STORM a late scratching at 1.04 pm. Mr D. Carrison was advised a warning had been placed on the mare in regards to its pre-race behaviour.

**TELEPORTATION** (C. Lions) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

After the running of the race E. Annells was re-examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

Correct weight was delayed to allow Stewards to view the vision of the start.

**RACE 3: SCALLYWAGS TOYS & NURSERY / SABOIS MAIDEN PLATE - 1210 Metres**

**BARB WIRE** (R. Hurdle) - in the vicinity of the 1100 metres shifted in and across the running of TIDEWAY. Rider was severely reprimanded under AR131(a).

**ANJAH** (E. Boyd) - tightened and lost its position on jumping away between VIRAGO MISS, which shifted out and TIDEWAY.

**DRESSMAKER** (K. Crowther) - jumped away awkwardly, shifted in and tightened TIDEWAY.

**TIDEWAY** (E. Annells) - tightened and lost its position on jumping away between DRESSMAKER, which shifted in and ANJAH. In the vicinity of the 1100 metres was obliged to take hold to avoid the heels of BARB WIRE, which shifted in. At the entrance to the straight was obliged to be steadied when taken wider by CONGE out onto the heels of ZARAFSHAN.

**CONGE** (B. Price) - at the entrance to the straight, shifted out taking TIDEWAY wider. Rider was reprimanded under AR131(a) and advised in future to only shift ground when entitled to do so. Rider was severely reprimanded under AR131(b) in that he failed to ride his mount out to the finish. A postrace veterinary examination revealed no visible abnormalities.

**VIRAGO MISS** (D. Caboche) - shifted out on jumping away tightening ANJAH onto TIDEWAY. A postrace veterinary examination revealed no visible abnormalities.

**RACE 4 HYGAIN - FEEDING CHAMPIONS BENCHMARK 80 HANDICAP - 1390 Metres**

**PAULO PACE** (K. Crowther) - slow to begin.

**MIDNIGHT BRAWLER (NZ)** - underwent a pre-race veterinary examination on arrival on course and was found to be lame in the near foreleg. First aid administered. Acting on this advice Stewards ordered MIDNIGHT BRAWLER a late scratching at 12. 50 pm.

**RACE 4 HYGAIN - FEEDING CHAMPIONS BENCHMARK 80 HANDICAP - 1390 Metres (Cont'd)**

OLD TRIESTE (S. Logan) - slow to begin.

**RACE 5 DAVE ROWETT MEMORIAL BENCHMARK 64 HANDICAP - 1210 Metres**

VICTOR VICTOR (S. Metcalfe) - rider explained the gelding never travelled throughout the event and in her opinion, the gelding may have worked itself up too much prior to being loaded. A post-race veterinary examination revealed no visible abnormalities.

KINGSON (E. Annells) - raced keenly in the early stages of the event. Had difficulty obtaining clear ground between the 400 metres and the 300 metres.

FEARLESS AL (S. Logan) - jumped away awkwardly.

ARTFUL AMBITION (K. Zechner) - raced keenly in the middle stages of the event.

**RACE 6: MITAVITE - LEADERS IN EQUINE NUTRITION BENCHMARK 58 HANDICAP - 1750 Metres**

BONIFACE (NZ) (A. Jordsjo) - rider explained the gelding travelled well in the early stages of the event however, after taking the lead shortly after entering the straight BONIFACE (NZ) switched off and shifted about. She added that after placing the gelding under pressure inside the 600 metres, it commenced to give ground and approaching the 100 metres, did not continue to ride out to the line. A post-race veterinary examination revealed no visible abnormalities.

CALL ME HERBIE (S. Metcalfe) - held up from the 400 metres until the 300 metres on the heels of BONIFACE (NZ).

**RACE 7: AVIS BENCHMARK 54 HANDICAP - 1210 Metres**

DASKULYA (A. Jordsjo) - rider explained the gelding raced flat throughout the event.

GALAXY FALLS (E. Annells) - jumped away awkwardly. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

RAHEEBA (S. Metcalfe) - knuckled on jumping away.

BRAZEN HEAD (C. Lions) - jumped away awkwardly and as a result was slow to begin. Approaching the 50 metres was disappointed for a run between SECRET CHARGE, which rolled out and ARTFULABEERS, was obliged to shift to the inside of SECRET CHARGE in an attempt to gain clear running and raced in restricted room to the finish.

SPIRITOS (B. Price) - in the vicinity of the 600 metres was obliged to be steadied away from the heels of DASKULVA.

**RACE 8: MITTY'S BENCHMARK 54 HANDICAP - 1210 Metres**

SCARY GO ROUND (L. Annells) - jumped away awkwardly, shifted out and inconvenienced CHOUX BACQUAT (NZ).

VILANELLE (k. Crowther) - jumped away awkwardly.

SERIOUS MOONLIGHT (C. Lions) - shortly after the start raced in restricted room between CHOUX BACQUAT (NZ) and TINNY BAR BLUE, when both runners shifted ground and was obliged to be eased.

**RACE 8: MITTY'S BENCHMARK 54 HANDICAP - 1210 Metres (Cont'd)**

**CHOUX BACQUAT (NZ)** (A. Jordsjo) - inconvenienced on jumping away. Raced wide throughout the event.

**RACE 9: GREAT NORTHERN SUPER CRISP BENCHMARK 58 HANDICAP - 1000 Metres**

**TINTAGEL ROCKER** (B. Price) - held up from the 300 metres until the finish.

**FOSSHIO** (J. Toeroek) - shortly after the start raced in restricted room between **BEDLOE'S ISLAND** and **ARTISTIC ESCAPE** as both runners shifted ground and was obliged to be eased. Rider explained his instructions were to take up a forward position however, after jumping away the gelding did not have the early pace that it showed at its last start. He added after receiving pressure shortly after the start, he was obliged to ease, resulting in **FOSSHIO** having to settle in a rearward position.

**HEAVENS FLIGHT** (E. Boyd) - raced keenly in the early stages of the event.

**BEDLOE'S ISLAND** (S. Logan) - approaching the 600 metres got its head up while being restrained. Inside the 200 metres became disappointed for a run to the inside of **TINTAGEL ROCKER** and was held up until inside the 100 metres, where she was able to switch the gelding to the outside of **TINTAGEL ROCKER** to obtain clear running to the line.

**TUNGKETTA** (K. Crowther) - Stewards questioned the rider in relation to her tactics adopted in today's event. She reported her instruction were to be neutral on the mare from the wide gate and to allow **TUNGKETTA** to settle where comfortable, similar to the tactics provided at its most recent start. Rider explained that after jumping away from the wide gate, the mare did not bridle up like at its last start from an inside barrier and given the pace of the runners to her inside, she was obliged to settle at the back of the field. She added that **TUNGKETTA** was off the bridle in the early and middle stages of the event. Stewards further questioned why she maintained a wide line on the track, she stated that given the formation of the field and early speed of the race, she was of the opinion that if she elected to ride closer to the fence, and attempt to ride for luck in the latter part of the race, she would more likely become held up as the on-pace runners commenced to weaken. She further stated **TUNGKETTA** is a big striding mare that would benefit being kept comfortable out wide with cover so she could make an uninterrupted run in the straight and for that reason, she maintained the wide run until the entrance to the straight, where she allowed the mare to work home down the outside of the field. She then further added the mare although dower, finished the race off well and in her opinion, **TUNGKETTA** would be better suited over a longer journey.

**WILLANDER PRINCESS** (A. Jordsjo) - underwent a pre-race veterinary examination and passed fit to race. Raced wide without cover throughout the event.
