Report on Race Meeting held at Streaky Bay

Saturday, 27 March 2021

RACE 1: LETCHER MORONEY CHARTERED ACCOUNTANTS & YOUR FINANCIAL EDGE
BENCHMARK 54 - 1200 Metres

VICTORY SPOILS (A. Livesey) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr M White, was advised that a Veterinary Certificate of Fitness is required prior to a future trial or race.

CHATAFOX (E. Wong) - laid in under pressure in the straight.

JACKPOT JOHNNY (F. Atkinson) - appeared to resent the kick-back in the early and middle stages of the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ZAAZOE (E. Annells) - rider reported the mare was disappointing in its efforts in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: CHRIS GEORGIU BUILDING MAIDEN PLATE - 1000 Metres

BEERS ON BILL (B. Price) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

GET AROUND HIM (F. Atkinson) - laid out under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr B. Lear, was advised that a Veterinary Certificate of Fitness is required prior to a future trial.

FULL ON DUKE (D. Tootell (Snr)) - on jumping away was brushed by TYPAR, which shifted in. Raced keenly in the early and middle stages of the event.


LADY HUNTSMEN (A. Chung) - underwent a pre-race veterinary examination as it had not raced since April 2020 and was passed fit to race.

TYPAR (E. Wong) - jumped away awkwardly, shifted in and brushed with FULL ON DUKE.

Correct weight was delayed to allow E. Annells (I GOT STRINGS), placed second, to view the official image for first place.

RACE 3: RODEO BY THE SEA BENCHMARK 62 HANDICAP- 1000 Metres

Correct weight was delayed to allow A. Chung (TILBURY) to view the vision in the straight.



RACE 4: CLEARWATER COVE ESTATE BENCHMARK 62 HANDICAP - 1400 Metres

The start of this event was delayed approximately two minutes.

ROAR (D. Tootell (Snr)) - slow to begin.

TREMBLING (F. Atkinson) - held up for clear running for a short distance approaching the 300 metres and had to be steadied when attempting to improve into a run inside ART MUSIC where, in the opinion of Stewards, there was insufficient room to do so. Rider was severely reprimanded under AR131(a) and advised to only take runs where there is sufficient room in future. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr B. Lear, was advised a Veterinary Certificate of Fitness is required prior to a future trial or race.

ART MUSIC (A. Livesey) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr M. White, was advised that a Veterinary Certificate of Fitness is required prior to a future race or trial.

TUNGKETTA (E. Annells) - a post-race veterinary examination revealed the mare to have an open wound on the off side stifle. Trainer, Mr D. Carrison, was advised that a Veterinary Certificate of Fitness is required prior to a future trial or race.

FLYING LOCO (A. Chung) - proved extremely difficult to load. Trainer, Mr T. Haddy, was advised that the gelding would now be required to load without delay in an Official Barrier Trial or Approval to Race Jump-out prior to accepting for a future race.

THE LEPRECHAUN (E. Wong) - on jumping away dipped. A post-race veterinary examination revealed a laceration to the near fore fetlock.

RACE 5: XXXX GOLD & STREAKY BAY COMMUNITY HOTEL STREAKY BAY CUP - 1800 Metres

IT'S HUMPHREY (E. Wong) - commenced to weaken from near the 500 metres. Hung out under pressure in the straight and proved difficult to ride out over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

GIVEPEACE A CHANCE - late scratching at 2:09 pm by Order of Stewards as there was no available rider.

KORODON (NZ) (A. Chung) - laid in under pressure in the straight.

BELLS 'N' BOWS (F. Atkinson) - slow to begin. In the vicinity of the 1500 metres had to be steadied when it improved onto heels of CHARLTON and shifted out. Laid in under pressure in the straight.


RELAXED (C. Lions) - a post-race veterinary examination revealed that the gelding to have a minor laceration on its near foreleg.

CHARLTON (B. Price) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by B. Price and noted that he used his whip on one occasion over the final 100 metres of the event.

BEACH GOD (E. Annells) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

HARDASHIAN - late scratching at 2:09 pm by order of Stewards as there was no rider available.

RACE 6: QUALITY WOOL AND APPRECIATED SUPPORTERS BENCHMARK 54 - 1800 Metres



BARB WIRE (E. Annells) - raced keenly in the early and middle stages of the event and raced wide without cover throughout the event. Inclined to lay in under pressure in the straight.

TYCOON FLUTTER (NZ) (D. Tootell (Snr)) - slow to begin.

HOST ESPRIT (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

BURNING HARD - late scratching at 2:39 pm by order of Stewards as there was no rider available.

WICKED KID (E. Wong) - jumped away awkwardly.
