## RACE 1: HARRY OF ALL TRADES MAIDEN PLATE - 2055 Metres

TRISTDAL (J. Potter) - from its wide barrier shifted in to obtain cover.

HUMPBACK (S. Logan) - raced keenly in the early stages of the event. Near the 50 metres dipped for no apparent reason.

CEFFYL MOR (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 2: GOOLWA HOTEL MAIDEN PLATE - 1600 Metres

DALAKARA (J. Potter) - S. Cahill pleaded guilty to a charge under AR190(3) in that he was overweight and had to be replaced on the gelding and was reprimanded.

JUSTEDEE (J. Holder) - held up for clear running from near the 400 metres until near the 300 metres when racing between DIXIE WHISTLER and REGAL TRIUMPH. Rider explained that after being held up from near the 400 metres until near the 300 metres the gelding only let down fairly and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.



## RACE 2: GOOLWA HOTEL MAIDEN PLATE - 1600 Metres (cont'd)

SMILING ASSASSIN (A. Chung) - in the vicinity of the 1400 metres shifted in on an acute angle resulting in DIXIE WHISTLER shifting in and away from that gelding onto RUGER ROSE, which was obliged to be checked and lost its position when tightened onto REGAL TRIUMPH, which was inconvenienced. Rider was severely reprimanded for careless riding under AR131(a) and advised in future to not shift in at such acute angles. Laid out under pressure in the straight.

REGAL TRIUMPH (D. Tourneur) - in the vicinity of the 1400 metres was inconvenienced when tightened onto JUSTEDEE as RUGER ROSE was taken in. Laid in under pressure in the straight.

FUNCKIA (K. Crowther) - slow into stride.

DIXIE WHISTLER (D. Stra) - near the 1400 metres shifted in and away from SMILING ASSASSIN, which shifted in at an acute angle, onto RUGER ROSE, which was obliged to be checked and lost its position when tightened onto REGAL TRIUMPH.

RUGER ROSE (A. Jordsjo) - near the 1400 metres was obliged to be checked and lost its position when taken in by DIXIE WHISTLER onto REGAL TRIUMPH.

## RACE 3: SOUTH COAST MARINE & CARAVAN UPHOLSTERY MAIDEN PLATE - 1100 Metres

The start of this event was delayed approximately three minutes.

COMPANY (E. Wong) - beaten approximately 45.3 lengths. Trainer, Mr S. Schrader, was advised that a warning had been placed on the gelding in relation to being uncompetitive.

COUSIN JACK (J. Holder) - in the adjoining barrier stall to SAVILLE, which became fractious and kicked out. Removed from the barriers and underwent a pre-race veterinary examination and passed fit to start. Rider reported that the gelding did not feel comfortable in its action on return to scale. A post-race veterinary examination revealed that the gelding had strained its off fore superficial digital flexor tendon. First aid administered. Trainer, Mr J. Hyam, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

UTAH JOE (K. Crowther) - which had not raced since May 2020 underwent a pre-race veterinary examination on arrival on course and was passed fit to start. On jumping away bumped with TATEYAMA, which shifted out. Shortly after the start was restrained to attempt to take up a position at the rear of the field.

SAVILLE (B. Price) - became fractious in its barrier after being loaded and became cast for some time. Underwent a pre-race veterinary examination and was ruled unfit to start. Acting on this advice Stewards withdrew SAVILLE at 1.21 pm. Trainer, Mr G. Lesnikowski, was advised that the colt would be required to complete an Official Barrier Trial to the satisfaction of the Stewards prior to a future race start.

SHE'S A TOFF (S. Logan) - hung out under pressure in the straight.

TATEYAMA (J. Eaton) - jumped away awkwardly, shifted out and bumped UTAH JOE.

Following the running of this event B. Price was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagements. B. Price was transported to hospital for further observations. B. Price was advised that he was required to submit a medical clearance prior to riding trackwork, jump-outs, trial or races.

## RACE 4: COMMERCIAL HOTEL MAIDEN PLATE - 1100 Metres

The start of this event was delayed approximately three minutes.

OOLONG GAZE (A. Chung) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr K. Sweeney, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.





#### RACE 4: COMMERCIAL HOTEL MAIDEN PLATE - 1100 Metres (cont'd)

PENTIRE'S SPIRIT (NZ) (J. Toeroek) - approaching the finish shifted out abruptly and bumped MISCHIEVOUS TYCOON resulting in that filly becoming unbalanced and being taken out onto CHEH CHEH CHARLEE, which was hampered.

CHEH CHEH CHARLEE (J. Holder) - hung in under pressure in the early part of the straight. Approaching the finish was severely hampered as MISCHIEVOUS TYCOON was taken out.

SUGAR GLIDER (S. Fawke) - proved difficult to load. Trainer, Mr S. Whittle, was advised that a warning had been placed on the mare in relation to its barrier manners. Jumped away awkwardly, shifted in and bumped SEE YOU LATER NOW.

SEE YOU LATER NOW (E. Annells) - on jumping away bumped with SUGAR GLIDER, which shifted in. Approaching the 400 metres became awkwardly placed between the heels of MISS LANGTRY and CHEH CHEH CHARLEE.

MISCHIEVOUS TYCOON (J. Potter) - approaching the finish bumped with PENTIRE'S SPIRIT (NZ), which shifted out abruptly, and as a result was hampered and taken wider.

Correct weight for this event was delayed to allow the Stewards to view the vision in the straight.

#### RACE 5: STRATH SMALL ENGINES BENCHMARK 54 HANDICAP - 1100 Metres

SANBUCK (E. Annells) - approaching the 400 metres was awkwardly placed on the heels of EQUICHUNK for a short distance. Held up for clear running from the entrance to the straight until near the 200 metres.

TANJA'S DREAM (A. Chung) - shortly after the start attempted to buck for a short distance. Trainer, Mr T. Doudle, was advised that a warning had been placed on the filly in relation to its manners.

SQUADRON LEADER (J. Potter) - contacted a perimeter fence on leaving the mounting yard. Underwent a pre-race veterinary examination and was passed fit to start.

ATUM (J. Holder) - at the request of its rider underwent a pre-race veterinary examination on arrival at the barriers and found to be lame in the near foreleg. Acting on this advice Stewards withdrew ATUM at 2.28 pm. Trainer, Mr R. Daniel, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

PARISIANS (J. Eaton) - which had not raced since February 2020 underwent a pre-race veterinary examination on arrival on course and was passed fit to start.

LICORICE BULLET (F. Atkinson) - had difficulty obtaining clear ground from shortly after the entrance to the straight until near the 100 metres when awkwardly placed on the heels of TURF TAPPER and was obliged to shift out to obtain clear running.

Following the running of this event S. Cahill was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagements. S. Cahill was advised that he was required to submit a medical clearance prior to riding trackwork, jump-outs, trial or races.

#### RACE 6: FLEURIEU MILK COMPANY FILLIES AND MARES 0-58 HANDICAP - 1100 Metres

The start of this event was delayed approximately two minutes.

GHETTO (D. Tourneur) - passing the 400 metres attempted to improve to the outside of JACJAC JACQUI, however, became awkwardly placed on the heels of that mare as THE PUBLIKIN improved around GHETTO.

HONEY GO LIGHTLY (B. Vorster) - jumped away awkwardly.

L'IL PIPER (J. Toeroek) - at the request of its rider underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. A post-race veterinary examination revealed no visible abnormalities.



RACE 6: FLEURIEU MILK COMPANY FILLIES AND MARES 0-58 HANDICAP - 1100 Metres  
(cont'd)

THE PUBLIKIN (D. Tootell (Snr)) - in the vicinity of the 400 metres contacted with GHETTO.

JACJAC JACQUI (A. Chung) - raced wide without cover throughout the event.

AMBERTONE (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

HEART OF EDEN (S. Fawke) - underwent a pre-race veterinary examination and passed fit to start. Refused to load. Acting on this advice Stewards withdrew HEART OF EDEN at 3.06 pm. Trainer, Mr B. Potter, was advised that the mare would now be required to complete an Official Barrier Trial to the satisfaction of the Stewards prior to a future race start.

RACE 7: NORTHPOINT FLEURIEU 0-64 HANDICAP - 1200 Metres

STRYKE IN STYLE (B. Vorster) - approaching the 200 metres shifted out.

GREETINGS NED (J. Holder) - in the vicinity of the 800 metres raced in restricted room between RIZSKI and CALL ME DEXTER, which rolled out.

HARBOUR EXPRESS (A. Livesey) - on jumping away shifted in.

ANNIKA (J. Eaton) - on jumping away was tightened between SEMINOLES (NZ) and HARBOUR EXPRESS, which shifted in. Rider explained in relation to the mare settling further forward in today's event that she was instructed to ensure ANNIKA begins well. She added that the mare jumped well and after begin caught wide in the early stages without cover she elected to allow her mount to stride forward to obtain a position on pace. A post-race veterinary examination revealed no visible abnormalities.

SEMINOLES (NZ) (A. Jordsjo) - approaching the 200 metres was momentarily inconvenienced as STRYKE IN STYLE shifted out.

CALL ME DEXTER (S. Fawke) - in the vicinity of the 800 metres rolled out. Held up for clear running from near the 100 metres until near the 50 metres when racing between RIZSKI and HARBOUR EXPRESS.

MRS MOURINHO (K. Crowther) - slow to begin. Rider explained in relation to the filly's performance that it may not have handled today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: LANGHORNE CREEK WINE REGION BENCHMARK 54 HANDICAP - 1350 Metres

CARBONE (J. Potter) - jumped away awkwardly.

UNCLE BOB (S. Fawke) - hung in under pressure in the straight.

HILUMIERE (K. Crowther) - as no suitable apprentice rider was available Stewards permitted K. Crowther to replace B. Price in this event. Slow to begin.

DOMESDAY MAGIC (D. Tootell (Snr)) - approaching the 800 metres dipped for no apparent reason.

EUROGEM (K. Zechner) - at the request of its rider underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start.

LITTLEBITFUNNY (A. Chung) - laid out under pressure in the straight.
