RACE 1: D&G TYRES BENCHMARK 72 HANDICAP - 1867 Metres

ANALYTICA (NZ) (R. Hurdle) - trainer, Mr. T. Doudle, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to take the lead if possible. Settled on pace.

GRINZINGER STAR (NZ) (A. Livesey) - raced keenly in the early and middle stages of the event.

SIZZLING BULLET (B. Price) - laid out under pressure in the straight.

GALAXY FALLS (J. Potter) - rider was reprimanded under AR185 in that he added arm guards to his gear after weighing out, resulting in him weighing in overweight.

CHICK IN CHARGE (F. Atkinson) - bled from both nostrils. Trainer, Mr B. Hannigan, was advised that as this was the mare's first bi-lateral bleed CHICK IN CHARGE would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

RACE 2: MICK HAMMILL TRANSPORT & MELROSE HOLIDAY UNITS MAIDEN HANDICAP - 1200 Metres

QUANDOQUANDOQUANDO (E. Boyd) - reared on jumping away and thereafter lost its position when tightened between FOX COUNTRY and ARABIAN DAWN resulting in QUANDOQUANDOQUANDO clipping the heels of FOX COUNTRY. Over-raced in the early and middle stages of the event and laid out rounding the 800 metre turn. Inside the

800 metres raced in restricted room to the inside of IKARA which rolled in. Near the 200 metres was contacted by FOX COUNTRY.

TWO BEERS (C. Lions) - shifted out on jumping away and contacted JAKAZONE. Rider explained the gelding changed strides on a number of occasions entering the straight and did not feel comfortable in its action inside the 100 metres. From this point on the gelding commenced to lay out and proved difficult to ride out over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

HUSSHABAH (F. Atkinson) - shortly after the start clipped the heels of GILHANINA. Hung out throughout the event. Trainer, Mr J. Cannon, was advised that a warning had been placed on the mare for hanging out. A post-race veterinary examination revealed no visible abnormalities.

GILHANINA (E. Annells) - Shifted out on jumping away onto ARABIAN DAWN. Shortly thereafter shifted in and away from ARABIAN DAWN onto HUSSHABAH which clipped heels.

ARABIAN DAWN (K. Zechner) - jumping away was taken out by GILHANINA onto QUANDOQUANDOQUANDO. Lost an off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

FOX COUNTRY (A. Livesey) - contacted on jumping away and taken in onto QUANDOQUANDOQUANDO. Laid in rounding the home turn. Near the 200 metres shifted in and contacted QUANDOQUANDOQUANDO.

IKARA (M. Vassallo) - jumped away awkwardly. In the vicinity of the 800 metres shifted in and tightened QUANDOQUANDOQUANDO.

JAKAZONE (J. Potter) - contacted and taken wider on jumping away by TWO BEERS, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

YANKEE PRINCESS (B. Price) - shifted in on jumping away onto FOX COUNTRY.

RACE 3: RANGES COUNTRY CLOTHING FODDER & SADDLERY MAIDEN PLATE - 1498
Metres

AMAKINSKY (F. Atkinson) - underwent a pre-race veterinary examination as the gelding had not raced since February 2019 and was passed fit to race. Rider reported that in her opinion the gelding felt uncomfortable in its action and changed strides on a number of occasions. A post-race veterinary examination revealed no visible abnormalities. Stewards had concern with the action of the geldings off foreleg and had advised trainer, Ms. K. Duffie, not to nominate again until a Racing SA industry Veterinarian has made a recommendation to the stewards.

BURNING HARD (S. So) - jumped away awkwardly.

JUSTEDEE (E. Boyd) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

KID KINGDOM (R. Hurdle) - shifted out on jumping away onto AMAKINSKY.

ALWAYS SOMETIMES (K. Zechner) - shifted out on jumping away contacting SLIPPED UP. Laid in under pressure rounding the home turn. Laid in rounding the home turn. In the vicinity of the 400 metres tightened ALALTUN for a number of strides.





RACE 3: RANGES COUNTRY CLOTHING FODDER & SADDLERY MAIDEN PLATE - 1498 Metres (Cont'd)

REGAL TRIUMPH (M. Vassallo) – dipped on jumping away. Thereafter, tightened by ALALTUN which shifted in and KID KINGDOM which shifted out. Hung in under pressure in the straight and was unable to be fully tested to the line. A post-race veterinary examination revealed no visible abnormalities.

SLIPPED UP (B. Price) - contacted on jumping away.

ALALTUN (NZ) (C. Lions) – jumped away awkwardly. In the vicinity of the 400 metres was awkwardly placed for a number of strides to the inside of ALWAYS SOMETIMES which laid in.

POCKET PENNY (E. Wong) – jumped away awkwardly. Laid out under pressure in the straight.

RACE 4: PORT AUGUSTA ISUZU BENCHMARK 58 HANDICAP- 1600 Metres

BELLOMO (D. Stra) – contacted on jumping away by BAD MOON RISING which shifted out.

I'M KENNY (K. Zechner) – shifted in on jumping away contacting DESIDERO.

BAD MOON RISING (C. Lions) – shifted out on jumping away onto BELLOMO. Near the 1400 metres taken wider by JAY PEE BEE. Laid in under pressure in the straight. Lost an off hind plate during in running.

DESIDERO (B. Price) – jumped away awkwardly, shifted out onto I'M KENNY. Laid out under pressure in the straight.

DUKE OF CHRISTOPHE (J. Potter) – slow to begin.

JAY PEE BEE (NZ) (A. Livesey) – near the 1400 metres shifted out taking BAD MOON RISING and ICE HUNT wider on the track. Rider reported that the gelding never travelled well in today's event and was disappointing.

TIZA (E. Annells) – laid in under pressure in the straight. Rider reported that the gelding was disappointing in its efforts. A post-race veterinary examination revealed no visible abnormalities.

ICE HUNT (S. So) – jumped away awkwardly. In the vicinity of the 1400 metres taken wider by BAD MOON RISING.

RACE 5: PETER KITTLE FLYING DOCTOR CUP BENCHMARK 62 HANDICAP - 1200 Metres

DISSOLUTE (S. Metcalfe) – approaching the 800 metres was hampered when BRIZZILIAN was taken in by DOMINATION.

BRAZILLIANT (S. So) – approaching the 800 metres had to be checked when DOMINATION shifted in when insufficiently clear.

DOMINATION (D. Tootell (Snr)) – jumped away awkwardly. Approaching the 800 metres shifted in when insufficiently clear of BRAZILLIANT which was obliged to be checked and taken in making contact with DISSOLUTE which was hampered. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight on 18 July 2021 and to conclude at midnight on 31 July 2021; a period of four meetings.





RACE 5: PETER KITTLE FLYING DOCTOR CUP BENCHMARK 62 HANDICAP - 1200 Metres (Cont'd)

TIME WARRIOR (R. Hurdle) - jumped away awkwardly.

TIGNANELLO (NZ) (B. Price) - Rider reported that in his opinion the gelding felt uncomfortable in its action in today's event. A post-race veterinary examination revealed no visible abnormalities.

LITTLE AL (K. Zechner) - Rider reported that in his opinion the gelding felt uncomfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

NEVER YOU MIND (E. Boyd) - lost its position shortly after jumping away when NORDIC LASS shifted in. Hung out under pressure in the straight.

NORDIC LASS (A. Livesey) - shortly after the start shifted in onto NEVER YOU MIND.

CHONCAPE (C. Lions) - jumped away awkwardly. Rider reported that in her opinion the gelding may have resented the kick back in running.

RACE 6: MJ GELDART DESIGNER JEWELLER BENCHMARK 54 HANDICAP - 1396 Metres

BIGNOTA (E. Annells) - in the vicinity of the 1100 metres changed stride and shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

GIRLINTHEMIRROR (A. Livesey) - Jumped away awkwardly and was contacted by CHUCKLES which shifted out. Near the 1100 metres was checked and lost position when CHUCKLES was taken wider.

SIR COEN (E. Wong) - near the 1100 metres raced in restricted room for a short distance when tightened between GIRLINTHEMIRROR and INDIAN MO.

CHUCKLES (C. Lions) - Shifted out jumping away and contacted GIRLINTHEMIRROR. Near the 1100 metres was taken wider by BIGNOTA onto GIRLINTHEMIRROR and SIR COEN.

INDIAN MO (D. Stra) - near the 1100 metres was taken in by YOU ES MARSHAL onto SIR COEN. A post-race veterinary examination revealed no visible abnormalities.

YOU ES MARSHAL (S. Metcalfe) - near the 1100 metres shifted in tightening INDIAN MO. Rider was reminded of her obligations to leave sufficient racing room for the runners to her inside.

JACKPOT JOHNNY (E. Boyd) - on jumping away had to be steadied away from the heels of HARDASHIAN.

COLD GOLD (J. Potter) - underwent a pre-race veterinary examination on arrival at the barrier and was found to be lame in the off hind leg. Stewards declared COLD GOLD a late scratching at 3:46pm. Trainer, Mr. C. Harrison was advised that a Veterinary Certificate of Fitness is required prior to any future race or trial.

UNSCOPEABLE (F. Atkinson) - laid out under pressure in the straight.

HARDASHIAN (S. So) - Shifted in on jumping away onto JACKPOT JOHNNY.



RACE 7: ROSSIGNS & MULTI PRINT BENCHMARK 54 HANDICAP - 1100 Metres

ROCKATANSKY (A. Livesey) - A post-race veterinary examination revealed no visible abnormalities.

RACE 7: ROSSIGNS & MULTI PRINT BENCHMARK 54 HANDICAP - 1100 Metres (Cont'd)

RODNEY (E. Boyd) - contacted on jumping away. Shortly thereafter was obliged to shift to the outside of ANOTHER WHISPER and was awkwardly placed on heels for a short distance.

CASE CLOSED (F. Atkinson) - on arrival at the track underwent a pre-race veterinary examination which revealed the gelding to have swelling and lameness to the near hind fetlock. Stewards declared CASE CLOSED a late scratching at 1:30pm. Trainer, Mr. M. Moosha was advised that a Veterinary Certificate of Fitness is required prior to any future race or trial.

ANOTHER WHISPER (D. Tootell (Snr)) - on jumping away shifted out and contacted RODNEY.

OUR TREASURE TROVE (E. Wong) - was inclined to lay out under pressure in the straight. Over the concluding stages of the event, had to be corrected by its rider when it rolled out momentarily into DOUG'S JOURNEY line.

DOUG'S JOURNEY (B. Price) - rider was unable to fully test his mount out over the concluding stages when OUR TREASURE TROVE laid out momentarily.

KIROSHIMA (C. Lions) - near the 600 metres was hampered when MR PIQUET laid out for a short distance.

WILLIAM'S QUEST (D. Stra) - jumped away awkwardly, shifted out abruptly.
