RACE 1: LIBERTY OIL PORT LINCOLN BENCHMARK 76 HANDICAP - 1000 Metres

RUBY'S REWARD (K. Zechner) - a post-race veterinary examination revealed no visible abnormalities.

MESSERSCHMITT (A. Jordsjo) - on jumping away was inconvenienced as LA PETITE ROUSSE shifted out. Rider reported that the gelding was disappointing in today's event.

ROCK HARD (E. Annells) - inclined to rear on jumping away and as a result was slow to begin.

LA PETITE ROUSSE (A. Chung) - jumped away awkwardly and shifted out. Laid out under pressure in the straight.

RACE 2: LINCOLN ESTATE WINES MAIDEN HANDICAP - 1000 Metres

CROWNED KING (A. Chung) - jumped away awkwardly.



RACE 2: LINCOLN ESTATE WINES MAIDEN HANDICAP - 1000 Metres (cont'd)

STREETWIZE SUZIE (A. Jordsjo) - shortly after jumping away shifted in onto TWO HANDS. Inside the 400 metres and inside the 300 metres dipped for no apparent reason. A post-race veterinary examination revealed a slow post-race recovery and an elevated heart rate.

TWO HANDS (E. Annells) - on jumping away was taken in.

CHASING STARS (T. Voorham) - hung in throughout the event.

SHAKE MY BEAUTY (E. Boyd) - as no other rider was available at the weight Stewards permitted E. Boyd to ride the mare 0.5 kg over its declared weight of 54.0 kg. Jumped away awkwardly. Near the 400 metres laid out for a short distance. Rider reported that the mare did not feel comfortable in its action prior to entering the home straight and changed strides on a number of occasions, and for this reason she had elected not to ride SHAKE MY BEAUTY out in her normal manner. A post-race veterinary examination revealed an abnormal upper respiratory noise. Trainer, Mr H. Montgomerie, was advised that the results of an endoscopic examination and a Veterinary Certificate of Fitness were required prior to a future trial or race.

TELEPORTATION (K. Sardelic) - slightly slow to begin and shortly after lost its position when tightened onto SWEET MINSKY (NZ) as TWO HANDS was taken in.

RACE 3: PROFAB MAIDEN PLATE - 1250 Metres

The start of this event was delayed approximately three minutes.

BURNING HARD (E. Boyd) - jumped away awkwardly.

DELIGHTFUL LAD (S. Logan) - rider explained in relation to the gelding's performance that it raced greenly throughout the event and would benefit from racing over further distances. A post-race veterinary examination revealed no visible abnormalities.

HILL ROAD RAIDER (A. Jordsjo) - hung in under pressure from the straight.

ONEMORE MARSHALL (M. Aitken) - jumped away awkwardly, shifted in and bumped MARGIN OF ERROR. Over-raced in the early and middle stages of the event and got its head up when begin restrained.

VANCOUVER VELVET (K. Zechner) - jumped away awkwardly.

MARGIN OF ERROR (D. Caboche) - on jumping away lost its position when ONEMORE MARSHALL shifted in.

ARTFUL CATE (G. Lo) - refused to load. Late scratching at 2.33 pm. Trainer, Ms S. Williams, was advised that the mare was now required to load without delay in either an Approval to Race Jump-out or an Official Barrier Trial prior to a future race start.

POCKET PENNY (E. Wong) - a post-race veterinary examination revealed no visible abnormalities.

MISCHIEVOUS TYCOON (K. Sardelic) - dislodged its rider en route to the barrier and cantered free for some distance completing a lap of the course riderless prior to being captures by the Clerk of the Course. Acting on veterinary advice Stewards declared MISCHIEVOUS TYCOON a late scratching at 2.27 pm. Trainer, Mr G. Kluske, was advised that a warning had been placed on the filly in relation to its pre-race behaviour. K. Sardelic was examined by the First Care Medical personnel and passed fit to fulfil his remaining engagements.

RACE 4: TUNARAMA COACHLINES BENCHMARK 58 HANDICAP - 1350 Metres

ZAMBRANO (E. Wong) - laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

ONWARD (C. Lions) - raced keenly in the middle stages when being restrained.





RACE 4: TUNARAMA COACHLINES BENCHMARK 58 HANDICAP - 1350 Metres (cont'd)

HAYZELLE (J. Toeroek) - on jumping away contacted DUKE OF CHRISTOPHE, which shifted out. Laid in under pressure in the straight.

DUKE OF CHRISTOPHE (C. Murray) - jumped away awkwardly shifted out and bumped HAYZELLE.

RACE 5: ECOCLEAN BENCHMARK 64 HANDICAP - 1750 Metres

BONIFACE (NZ) (A. Chung) - near the 1400 metres got its head up when being restrained when awkwardly placed on the heels of NEAR MAGIC.

GIVEPEACE A CHANCE (T. Voorham) - made contact with an outside running rail en route to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. T. Voorham was examined by the First Care Medical personnel and passed fit to fulfil her remaining engagements.

MISS ELEGANCE (E. Wong) - near the 200 metres dipped for no apparent reason.

HAND TO HAND (NZ) (C. Murray) - Stewards permitted C. Murray to ride the gelding 0.5 kg over its declared weight of 54.5 kg. Passing the 200 metres dipped for no apparent reason.

DAM RELIABLE (NZ) (G. Lo) - became fractious in its tie-up stall pre-race. Underwent a pre-race veterinary examination and was ruled unfit to start. First aid administered. Acting on this advice Stewards withdrew DAM RELIABLE (NZ) at 2.05 pm. Trainer, Mr B. Lear, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

NEAR MAGIC (C. Lions) - raced wide without cover throughout the event.

OBLIQUE LINE (S. Logan) - laid out over the concluding stages of the event.

STURT'S PRIDE (E. Annells) - raced keenly in the early stages when being restrained.

RACE 6: JOHN'S QUICK CLEAN BENCHMARK 52 HANDICAP - 1350 Metres

CRAZY CULPRIT (C. Lions) - inclined to lay out under pressure in the straight.

WINTER HARBOUR (E. Wong) - jumped away awkwardly and was slow to begin. Inclined to lay out under pressure in the straight.

MR PIQUET (E. Annells) - a post-race veterinary examination revealed an abnormal upper respiratory noise. Trainer, Mr M. Cornell, was advised that the results of an endoscopic examination and a Veterinary Certificate of Fitness were required prior to a future trial or race. Mr Cornell advised that he would recommend to the owners that MR PIQUET now be retired.

ROAR (G. Lo) - rider pleaded guilty to charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by G. Lo and noted that he used it on two occasions over the concluding 100 metres of the event.

ART MUSIC (S. Logan) - underwent a pre-race veterinary examination on arrival on course and was found to be lame in the near foreleg and would be unfit to start. Acting on this advice Stewards declared ART MUSIC a late scratching at 1.00 pm. Trainer, Mr M. White, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

JAY PEE BEE (NZ) (E. Boyd) - hung in throughout the event.

BRAZEN HEAD (D. Caboche) - hung out rounding the home turn.



RACE 7: BK & BJ SOUTHAM TV & LINE INSTALLATION BENCHMARK 62 HANDICAP - 1210
Metres

FESTIVAL OF LIGHT (C. Lions) - after being loaded the bridle required readjustment. Shortly after the start was inconvenienced and obliged to be restrained when awkwardly placed on the heels of AMANI FARASI. Near the 1100 metres dipped for no apparent reason.

RED DYNAMO (NZ) (A. Chung) - near the 400 metres contacted the running rail for a short distance.

DIAMONDS ARE (E. Wong) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

MR WHITACRE (M. Aitken) - on jumping away was tightened onto BLAZING BULLET as COMPARDY shifted out. Over-raced in the early and middle stages of the event.

BLAZING BULLET (D. Caboche) - on jumping away was tightened onto AMANI FARASI as MR WHITACRE was taken out. Hung out rounding the home turn.

COMPARDY (T. Voorham) - jumped away awkwardly, shifted out and contacted MR WHITACRE.

RACE 8: LINCOLN SOUTH CRICKET CLUB 75TH ANNIVERSARY CLASS TWO HANDICAP - 1000
Metres

IKARA (K. Sardelic) - on jumping away was taken wider by I'M OH SO PRETTY.

FIRE THUNDER (E. Annells) - jumped away very awkwardly, shifted in and bumped CONFINEMENT, and as a result lost its position.

FREE WILMA (K. Zechner) - rider reminded of his obligations under AR131(b) and advised to ensure he rides his mounts out to the end of the race. A post-race veterinary examination revealed no visible abnormalities.

LEAVE IT TO ME (E. Wong) - rider reported that the mare hung in under pressure in the straight.

CONFINEMENT (M. Aitken) - on jumping away bumped with FIRE THUNDER, which shifted in.

WAR CHEVAL (S. Logan) - raced keenly in the middle stages of the event.

I'M OH SO PRETTY (G. Lo) - jumped away awkwardly and shifted out taking IKARA wider. Raced wide without cover throughout the event.
