Report on Race Meeting held at Penola Racecourse

## RACE 1: DI GIORGIO FAMILY WINES BENCHMARK 54 HANDICAP - 1700 Metres

CARAK (S. Callow) - slow to begin (3 lengths). Crowded near the 1400 metres and had to be checked on the inside of HARBOURING, which shifted in. Momentarily held up near the 200 metres behind O'MIZZNA and to the inside of YULONG AWESOME.

RANGER CEE JAY (P. Gatt) - fractious in the barriers. Underwent a pre-race veterinary examination and passed fit to race.

HARBOURING (R. Hurdle) - shifted in near the 1400 metres when racing keenly and becoming awkwardly placed close to the heels of HASTA LA PRINCE, resulting in CARAK, on its inside being crowded and checked. Rider was reprimanded. Rider explained that the horse travelled okay in the early and middle stages however, after he shifted out to improve near the 700 metres, the gelding failed to respond as expected and proved disappointing. A post-race veterinary examination revealed no visible abnormalities.

YULONG AWESOME (K. Crowther) - hung in, in the straight.

## RACE 2: REDMAN WINES MAIDEN HANDICAP - 1400 Metres

BOB'S REWARD (A. Jordsjo) - raced keenly in the early and middle stages of the event.

HONOUR DE HERO - Acting on a report from trainer D Bowman that the mare was fractious en-route to the course, the mare underwent a pre-race veterinary examination which revealed laceration to its near fore pastern. Stewards subsequently withdrew HONOUR DE HERO at 12.11 pm on veterinary advice.

PUNT ROAD (B. Price) - hung out in the straight and proved difficult to ride.



RACE 2: REDMAN WINES MAIDEN HANDICAP - 1400 Metres (Cont'd)

WILD SONNET (E. Boyd) - Acting on a report from trainer J Giles that the mare was fractious en-route to the course, the mare underwent a pre-race veterinary examination which revealed minor lacerations to its head and blood from its left nostril. Stewards subsequently withdrew WILD SONNET at 12.28 pm on veterinary advice.

METAMORPHIC MISS (D. Tourneur) - slow to begin. Shifted in slightly near the 200 metres.

AIM TO PLEASE (K. Cowther) - momentarily crowded near the 200 metres between BOB'S REWARD and METAMORPHIC MISS, which shifted in slightly.

RACE 3: BRAND & SONS WINES MAIDEN PLATE - 1100 Metres

BAY WATER (D. Caboche) - hung in, in the straight and proved difficult to ride.

DON'T TEST ME (S. Logan) - underwent a pre-race veterinary examination as the gelding had not raced for over 1 year and passed fit to race. Trainer Mr G. Lynch was reprimanded under AR165 for failing to arrive on course by the prescribed time.

JUNGLE FLIGHT (E. Wong) - jumped away awkwardly, shifted in and bumped HENRY'S FAITH.

DUSTIN DHAHRAN (K. Crowther) - rider reported the mare raced greenly throughout the event.

HENRY'S FAITH (C. Jones) - bumped at the start by JUNGLE FLIGHT on its outside.

MIZZ BEEBEEFF (E. Boyd) - raced in restricted room near the 900 metres between JUNGLE FIGHT and DUSTIN DHAHRAN, which shifted in slightly. Raced keenly from the 900 metres to the 400 metres and shifted ground on several occasions when being restrained.

RACE 4: BALNAVES OF COONAWARRA BENCHMARK 58 HANDICAP - 1100 Metres

TARASQUE (P. Gatt) - raced keenly in the early and middle stages of the event.

RODNEY (K. Zechner) - shifted in at the start and bumped ITS ALL GOSSIP. A post-race veterinary examination revealed the gelding suffered colic due to heat stress. First aid was administered.

IT'S ALL GOSSIP (R. Hurdle) - bumped at the start by RODNEY on its outside.

RACE 5: BANKS THARGO COONAWARRA BENCHMARK 58 HANDICAP - 2100 Metres

ZABEXTRA (NZ) (K. Walters) - a post-race veterinary examination revealed no visible abnormalities.

SENTRY GATE (K. Crowther) - raced three wide in the early stages of the event and work forward to sit outside the leader near the 1600 metres.

DAM RELIABLE (NZ) (E. Finnegan) - weakened noticeably from the 800 metres. Rider reported the mare pulled in the early stages however, commenced to give ground from that point and made respiratory noises, which concerned her. A post-race veterinary examination revealed no visible abnormalities however he reported the mare may have choked down.

OLIFOET (NZ) (J. Potter) - Stewards permitted J. Potter to ride the gelding 0.5 kg over its declared weight of 54kg.

RACE 6: 36° SOUTH COONAWARRA VIGNERONS CUP - 1700 Metres

HASTA LA FIORENTE (J. Opperman) - weakened from the 450 metres finishing a distant last. Rider reported the gelding never travelled throughout the event, laid out and felt awkward in its action. A post-race veterinary examination revealed the gelding suffered atrial fibrillation. Trainer Mrs S. Murphy advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

RACE 6: 36° SOUTH COONAWARRA VIGNERONS CUP - 1700 Metres (Cont'd)

STAR JAN (D. Tourneur) - rider explained it was his initial intention to try and lead in today's event however, he was happy with his on-pace position. He added the tempo of the race was strong throughout and consequently the mare was unable to finish the race off as expected. A post-race veterinary examination revealed the mare was tied up in its action

MISTA HOLYFIELD (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54kg. Raced keenly in the middle stages of the event.

RACE 7: LECONFIELD COONAWARRA BENCHMARK 68 HANDICAP - 1300 Metres

MAGIC REWARD (K. Zechner) - raced wide rounding the home turn.

ENLIST (K. Crowther) - slow to begin.

YOU ES MARSHAL (E. Wong) - near the 900 metres bumped the running rail and became unbalanced.

DENOMINATOR (NZ) (E. Finnegan) - Stewards permitted E. Finnegan to ride the gelding 0.5 kg over its declared weight of 54kg. Rider was reprimanded under AR190(2) for not making the request to ride overweight by the prescribed time.

RACE 8: BRAND'S LAIRA BENCHMARK 54 HANDICAP - 1300 Metres

BEAUMIS (T. Voorham) - slow to begin (3 lengths)

TRUPORTH (D. Caboche) - bled from both nostrils. Trainer, Mr B. Carraill, was advised that as this was TRUPORTH'S first bi-lateral bleed it would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

RICHEDE (E. Boyd) - laid in, in the straight.

THE LADIES MAN (B. Price) - raced keenly in the middle stages of the event and got its head up when being restrained.

SNAPTOF (P. Gatt) - Stewards permitted P. Gatt to ride the mare 0.5 kg over its declared weight of 54kg.

AZZURO BIANCO (E. Wong) - held up for clear running near the 400 metres behind THE LADIES MAN and to the inside of SPANGIRL and when attempting to shift out to obtain clear running, bumped with SPANGIRL.
