

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville
Racecourse by the South Australian Jockey Club on
Saturday, 12 February 2022

TRACK: Good 4

RAIL: Out 10 metres 1200 metres to winning post, out 4 metres 2000 metres to 1800 metres, out 7 metres remainder.

WEATHER: Fine.

RACE 1: PIKE & JOYCE HANDICAP - 1100 Metres

MANHATTEN TIMES (J. Eaton) - jumped away awkwardly. Rounding the turn inside the 600 metres became awkward in its action for a number of strides.

KOLOKAR (NZ) (J. Toeroek) - laid out under pressure in the straight.

BRAZANO (J. Potter) - when questioned in relation to the gelding's performance, rider explained that in his opinion the gelding should now be spelled. A post-race veterinary examination revealed no visible abnormalities.

JUSTAKIDD (R. Hurdle) - over raced and got its head up when being restrained in the middle stages of the event.

RACE 2: TAB ADELAIDE CUP DAY - MONDAY MARCH 14 HANDICAP - 2037 Metres

CALL ME SHAMUS (M. Poy) - rolled out near the 200 metres over a number of strides.

SHOCK ALERT (NZ) (T. Voorham) - jumped away awkwardly. When questioned in relation to the gelding's performance, rider explained that it may not have handled the quick back up from its race on Sunday, 6 February 2022 at Naracoorte. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Co-trainer, Mr J. Dodgson, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.



RACE 2: TAB ADELAIDE CUP DAY - MONDAY MARCH 14 HANDICAP - 2037 Metres (cont'd)

ALL HARD WOOD (M. Lloyd) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. When questioned in relation to her settling position in the early stages, rider explained that her mount had commenced well and that there was good speed from her outside therefore she allowed SHOCK ALERT (NZ) to cross inside the 1800 metres. She added that her mount commenced to race keenly once crossed and therefore she elected to roll out from a position on the rail to settle in a position one off the rail trailing VINTAGE DIESEL (NZ). She further added that the tempo slackened mid-race and she was able to allow her mount to commence a run at a tempo that was more suitable to the gelding's racing pattern from inside the 900 metres. Steward's noted M. Lloyd's explanation. A post-race veterinary examination revealed the gelding to be lame in the off foreleg and had a lower than expected heart rate. Co-trainer, Mr J. Hickmott, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

LUTZ (P. Gatt) - raced keenly in the middle stages of the event. Held up for clear running from the 600 metres until approaching the 200 metres when racing between SHOCK ALERT (NZ) and VINTAGE DIESEL (NZ) and was obliged to shift out to obtain clear running. Laid in under pressure in the straight.

SO BENE (B. Vorster) - held up for clear running from rounding the home turn until approaching the 200 metres where it rolled out to commence a run between BUSKER'S BALLAD and CALL ME SHAMUS, which rolled out. As a result, SO BENE was inconvenienced when taken wider and only obtained clear running from the 100 metres.

BLUE BEAR (D. Caboche) - over raced in the middle stage of the event.

Correct weight for this event was delayed to allow B. Vorster (SO BENE), placed second, and Trainer, Mr A. Clarken, to view the vision in the straight.

RACE 3: DOMINANT MAIDEN PLATE - 1200 Metres

BIG SUE (B. Price) - raced wide from the 600 metres.

CLASSY KENNY (J. Maund) - over raced in the early and middle stages of the event.

SEA OF SECRETS (C. Rawiller) - following the declaration of acceptances Trainer, Mr R. Balfour, made a gear application to remove visors and add winkers to the gelding's race gear. Stewards accepted this request and acting under AR206(2) fined Mr R. Balfour \$200. Near the 100 metres became awkwardly placed between the heels of COURAGEOUS HEARTS and EVENTUALLY, which hung in. As a result, was not fully tested to the line.

COURAGEOUS HEARTS (T. Voorham) - rider reported that she would have preferred to gain cover; however, her mount raced fresh being first up in today's event.

TEA RAV (NZ) (R. Hurdle) - knuckled on jumping away and as a result rider became unbalanced and TEA RAV (NZ) lost ground.

EVENTUALLY (B. Vorster) - raced keenly in the middle stages of the event. Hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

FONSALETTE (NZ) (J. Eaton) - rounding the home turn was held up for clear running until near the 200 metres. Had difficulty obtaining clear running from inside the 100 metres and as a result was not fully tested to the line.

PETRA'S GIRL (J. Potter) - raced wide without cover throughout the event.

DON'T TEST ME (A. Lynch) - slow to begin. Rider could offer no explanation in relation to the gelding's disappointing performance. A post-race veterinary examination revealed no visible abnormalities.





RACE 4: THE JUNCTION HANDICAP - 1600 Metres

The start of this event was delayed approximately one minute owing to an interstate delay (Gold Coast).

MORTY (L. Neindorf) - shortly after the start lost its position as NAKHEEL shifted in.

STAN THE CADDY (C. Rawiller) - near the 250 metres rolled out onto COWLEY'S CREEK.

COWLEY'S CREEK (J. Potter) - from the 1000 metres raced wide without cover. Near the 250 metres was momentarily inconvenienced as STAN THE CADDY rolled out.

HARLEYS MOVEN (R. Hurdle) - near the 100 metres shifted out abruptly and from that point on continued to lay out for the remainder of the event, proving difficult to ride out.

REVUE (B. Vorster) - rider explained in relation to the gelding's performance that it raced off the bridle and may not have been suited to the strong tempo in today's event. A post-race veterinary examination revealed no visible abnormalities.

NAKHEEL (B. Price) - jumped away awkwardly and shifted in onto MORTY. When questioned in relation to rounding the home turn when the mare appeared to shift out from a position near the rail, rider stated that his instructions were to lead in today's event and set a strong tempo as, in the stable's opinion, the mare is very one paced and they were of the intention to make it a staying test. He added that the mare travelled well during the event and he felt coming into the home turn that he would allow his mount to roll into the event and quicken. He further added that he felt it was best for him to continue to ride with the mare in the straight as it was inclined to lay out; however, he was unaware of how far he had shifted out. Stewards noted B. Price's explanation. Stable representative Mr L. Weekley confirmed the instructions.

RACE 5: GRAND SYNDICATES - SUPPORTING SA RACING HANDICAP - 1200 Metres

DEFIANT DANCER (C. Rawiller) - near the 600 meters was taken wider by ONE MORE JACK as HE'S XCEPTIONAL shifted out. Hung out rounding the home turn.

TERBIUM (L Neindorf) - following the declaration of acceptances assistant Trainer, Mr T. Stokes, acting for Trainer, Mr P. Stokes, made a gear application to add blinkers to the gelding's race gear. Stewards accepted this request and acting under AR206(2) fined Mr P. Stokes \$200. Knuckled on jumping away, stumbled and was awkward for a number of strides.

ONE MORE JACK (J Potter) - shortly after the start was tightened between STREET LIFE and RIVER TWAIN, which shifted in. Near the 600 metres was taken wider by HE'S XCEPTIONAL.

STREET LIFE (E Finnegan) - between the 650 metres and 550 metres was inconvenienced when awkwardly placed on the heels of HE'S XCEPTIONAL, which had become awkward in its action and shifted out abruptly despite the efforts of its rider. Near the 500 metres was obliged to be checked as HE'S XCEPTIONAL shifted back in after being corrected. From the 50 metres was held up and untested to the line.

RIVER TWAIN (B Price) - shortly after the start rolled out and bumped TERBIUM and shortly after shifted in onto ONE MORE JACK, which was tightened. Lost its off hind plate during the event.

HE'S XCEPTIONAL (B Vorster) - between the 650 metres and the 550 metres became very awkward in its action when placed to the inside of RIVER TWAIN, shifted out abruptly onto ONE MORE JACK, despite the efforts of its rider. Near the 500 metres when being corrected shifted in onto STREET LIFE, which was obliged to be checked and lost ground. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mr T. Busuttin, was advised that a warning had been placed on the gelding in relation to its racing manners.

PORT VALE (O Ridge) - lost its near fore plate and off hind plate during the event.





RACE 6: FURPHY HANDICAP - 1600 Metres

TERRITORY TITAN (A. Jordsjo) - laid in under pressure in the straight. Rider reported that the gelding raced keenly in today's event and was difficult to restrain. A post-race veterinary examination revealed no visible abnormalities.

OUR DESTRIER (B. Price) - rider reported the gelding had breathing difficulties during the event. A post-race veterinary examination revealed no visible abnormalities.

PEARL BANDIT (T. Voorham) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by T. Voorham and noted that she did not use it over the final 100 metres of the event.

BASARWA (NZ) (T. Pannell) - made heavy contact with the running rail on exiting the mounting yard and dislodged its rider. Underwent a pre-race veterinary examination and was passed fit to start. T. Pannell was examined by the First Care Medical personnel and was declared fit to ride.

THINK WINNING (B. Vorster) - reared on jumping away and was slow to begin approximately one to two lengths.

RACE 7: PREMIER'S PLATE (FORMERLY BIRTHDAY CUP) - 2037 Metres

HASTA LA WAR (T. Voorham) - raced keenly in the early and middle stages of the event. Held up for clear running from near the 300 metres until near the 200 metres when racing between BEA TEMPTED and DEXTER YOU DEVIL.

DEXTER YOU DEVIL (T. Pannell) - when questioned in relation to the gelding's performance, rider explained that it travelled well in the early and middle stages of the event; however, lacked a turn of foot and may not have been suited to the tempo of today's event. A post-race veterinary examination revealed lame in the off hind leg. Trainer, Mr S. Cahill, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

WYCLIF (GB) (J. Toeroek) - raced keenly in the early and middle stages of the event.

RESURGE (B. Vorster) - inclined to lay out in the under pressure in the straight.

RACE 8: CANADIAN CLUB HANDICAP - 1100 Metres

MUNSTER (NZ) (M. Lloyd) - laid in, in the early part of the straight.

ALL IN WAR (C. Rawiller) - inclined to hang out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

EFFORTKAT (J. Toeroek) - on jumping away shifted in and bumped EM BRYAN. Near the 200 metres had difficulty obtaining clear ground for a short distance, became held up for clear running and was untested to the line when racing between GYPSY CROWN and DAILY SPIRIT.

GENERAL MINT (J. Potter) - held up for clear running from the entrance to the straight until near the 200 metres.

EM BRYAN (A. Lynch) - on jumping away shifted out and bumped EFFORTKAT.

RACE 9: THOMAS FARMS SUPPORTING SAROA HANDICAP - 1300 Metres

The start of this event was delayed approximately one minute.

MODEAR (A. Chung) - rider explained in relation to the mare's performance that it travelled well in the early and middle stages of the event; however, from the 600 metres when asked to improve, came off the bridle and was disappointing to the finish. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr J. O'Connor, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RACE 9: THOMAS FARMS SUPPORTING SAROA HANDICAP - 1300 Metres (cont'd)

THRILL KILL (L. Neindorf) - rider reported that the gelding was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

PICARGO (C. Rawiller) - approaching the finish was taken in onto TURFITT by APACHE STAR, which was taken in.

YOUNG JIMMY (B. Price) - difficult to load. Trainer, Mr D. Dodson, was advised that a warning had been placed on the gelding in relation to its barrier manners. Laid out under pressure in the straight.

COOL MAGNUM (J. Maund) - laid out rounding the home turn. Approaching the finish shifted in when insufficiently clear of APACHE STAR, which lost its position when tightened onto PICARGO, which was tightened and taken in onto TURFITT and steadied to the line. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Wednesday, 16 February 2022 and to conclude midnight Sunday, 20 February 2022, a period of 3 meetings.

SPARKUP (J. Toeroek) - slow to begin approximately three to four lengths. Co-trainer, Mr R. Jolly, was advised that a warning had been placed on the gelding in relation to its starting manners.

ANNIKA (J. Eaton) - on request of its rider underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Following the event, Trainer, Mr M. Huxtable, advised Steward's that the mare was in season.

ULTIMATE VICTORY (T. Pannell) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed the gelding to have cardiac arrhythmia. Trainer, Mr. P. Blanch was advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

APACHE STAR (M. Poy) - approaching the finish lost its position when tightened onto PICARGO as COOL MAGNUM shifted in when insufficiently clear.

TURFITT (M. Lloyd) - over raced throughout the event.

Correct weight for this event was delayed to allow C. Rawiller (PICARGO), placed fifth and Trainer, Mr R. Balfour, to view the vision in the straight.
