TRACK: Soft 5 (Track with reasonable amount of give in it)
Upgraded to a Good 4 at 3.03 pm retrospective to Race 3 (Track with some give in it)

RAIL: Out 3 metres 800 metres to 400 metres, true remainder.

RACE 1: TRIMBOLI SERVICES TWO YEAR OLD BENCHMARK 62 HANDICAP - 1100 Metres

SUPER SHARP (J. Eaton) – jumped a discoloured section of the track inside the 700 metres. Laid in under pressure in the straight.

SEVEN SECRETS (T. Voorham) - laid out under pressure in the straight. Lost its off hind plate during the event.

RACE 2: 2022 CORNERSTONE STUD BAROSSA CUP (HEAT 5 PROVINCIAL SUPER SERIES) - 2100 Metres

BRIABELLA (M. Collett) - jumped away awkwardly and shifted in shortly after the start. Raced keenly in the early and middle stages of the event. Lost its near side bubble cheeker in the vicinity of the 1600 metres.

CONQUEST OF TEARS (B. Price) - raced keenly in the early and middle stages of the event.

SAWTELL (NZ) (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54.5kg. Slow to begin. Rider reported the gelding made excess respiratory noise from near the 700 metres and he had become concerned with its action in the straight and for that reason had not ridden out SAWTELL (NZ) in his normal manner. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr G. Lynch was advised that a warning had been placed on the gelding in relation to its being competitive. Trainer was also advised that a veterinary certificate of fitness would be required prior to accepting for a future trial or race.

RACE 3: TAB MAIDEN PLATE - 1100 Metres

SEAFARING (NZ) (S. Logan) - inconvenienced on jumping away when tightened between VOODOO MOON, which shifted in and MAGICAL EFFORT, which shifted out. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

A FEW GOOD MEN (P. Gatt) - near the 150 metres was inconvenienced when contacted by IL DON CAVALLO.

BYWATERS ROAD (J. Maund) - near the 200 metres was inconvenienced when contacted by VOODOO MOON and was forced to race in restricted room until the concluding stages of the event.

IL DON CAVALLO (C. Rawiller) - slow to begin. Near the 150 metres shifted out to improve and in doing so, contacted A FEW GOOD MEN.

MONAGHAN'S BOY (R. Hurdle) - stepped a discoloured section of the track inside the 700 metres.

VOODOO MOON (T. Voorham) - shifted in on jumping away onto SEAFARING (NZ).

FREEDOM DAY (B. Vorster) - laid in under pressure in the straight. Near the 200 metres shifted in and bumped BYWATERS ROAD.

MAGICAL EFFORT (A. Lindsay) - jumped away awkwardly and shifted out onto SEAFARING (NZ).

NORTHERN SKY (M. Lawrence) - rider explained the filly travelled well in the early and middle stages of the event however, when asked for an effort in the straight, had raced greenly and was unable to sprint with the field. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: TERRACE FUNCTION CENTRE MAIDEN PLATE - 1700 Metres

BONJOUR BLUE (B. Vorster) - Trainer representative Mr T. Stokes advised Stewards of a change in tactics in that he would instruct the rider to attempt to obtain a position forward of mid-field, with cover if possible. Settled mid-field. Jumped away awkwardly and shifted in onto NISKIE LATANIE. Momentarily inconvenienced near the 300 metres when SOUTHERN SWOOP laid in.

LEICA TROOPER (M. Lawrence) - rider reported the gelding never travelled and when asked for an effort, was disappointing. She added that in her opinion, the gelding felt sore behind. A post-race veterinary examination revealed no visible abnormalities.

SIX FOOT SONG (M. Collett) - had difficulty obtaining clear ground from near the 500 metres until near the 200 metres. Raced in restricted room over the concluding stages when awkwardly placed between the heels of BONJOUR BLUE and SHEZ BETTY.

RED ROOF (S. Metcalfe) - laid in under pressure in the straight.

SOUTHERN SWOOP (T. Voorham) - raced wide without cover throughout the event. Laid in under pressure in the straight. Near the 300 metres shifted in onto BONJOUR BLUE.

NISKIE LATANIE (J. Eaton) - slow to begin and shortly after was inconvenienced when BONJOUR BLUE shifted in. Raced fiercely in the early and middle stages of the event.

VINO DECASA NOSTRA (NZ) (S. Logan) - became held up from near the 500 metres until the 300 metres.

RACE 5: HOLDFAST INSURANCE BROKERS MAIDEN/CLASS ONE PLATE - 2100 Metres

The start of this event was delayed approximately two minutes.

DANRENA (E. Annells) - raced keenly in the middle stages of the event.

MEREWETHER BEACH (R. Hurdle) - required to have its cross over nose band refitted in the mounting yard.

RACE 5: HOLDFAST INSURANCE BROKERS MAIDEN/CLASS ONE PLATE - 2100 Metres (Cont'd)

QUEBECOIS (J. Eaton) - jumped away awkwardly. Inconvenienced when contacted by SO BENE near the 100 metres.

SO BENE (B. Vorster) - laid out under pressure over the concluding 200 metres and near the 100 metres shifted out and contacted QUEBECOIS.

OPUS DAI (J. Potter) - Stable representative Mr N. O'Shea advised of a change in tactics in that he would instruct the rider to attempt to settle behind mid-field if possible. Settled last. A post-race veterinary examination revealed no visible abnormalities. Stable representative Mr N. O'Shea was advised that the mare would be required to be competitive in an Official Barrier Trial prior to accepting for a future race.

RACE 6: COOPERS BREWERY CLASS TWO HANDICAP - 1500 Metres

PENWORTHAM (P. Gatt) – rider explained from the wide barrier he was forced to settle a touch further back than he had anticipated. He added the gelding travelled well in the early stages however, came off the bridle near the 700 metres and hit a flat spot. He added when asked for an effort at the entrance to the straight, PENWORTHAM did not respond as he had anticipated and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

MAY'S WEST (M. Lawrence) - raced keenly in the early and middle stages of the event. Near the 300 metres attempted a run to the outside of BARBRA'S WISH however, shortly after laid back in across that filly's heels and became awkwardly placed for several strides.

IRONICAL (A. Lindsay) - raced wide without cover throughout the event.

DR COPPER (J. Maund) - momentarily held up at the entrance to the straight.

GO BALLISTIC (J. Potter) - raced fiercely in the early and middle stages of the event. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

REBEL LEE (T. Voorham) - inclined to lay in under pressure in the straight.

RACE 7: MATRIX SOLAR SOLUTIONS BENCHMARK 54 HANDICAP - 1200 Metres

CHICO FIESTRO (J. Maund) - jumped away awkwardly.

ALEDA (J. Doyle) - laid out under pressure in the straight.

BIGNOTA (B. Price) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by B. Price and noted that he used it on eight occasions over the concluding 100 metres of the event.

FERGIE (T. Voorham) – laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by T. Voorham and noted that she used it on three occasions over the concluding 100 metres of the event.
