## RACE 1: THE JIM BARRY WINES FILLIES & MARES MAIDEN PLATE - 1100 Metres

SHAKE MY BEAUTY (M. Collett) - raced keenly in the early and middle stages of the event. Laid out from near the 800 metres.

VENDETTA (A. Lindsay) - jumped away awkwardly, shifted in and contacted STELLA POLARIS.

NERRIVIK (C. Murray) - jumped away awkwardly. Near the 400 metres, when improving to the outside of APACHE FOX, shifted out abruptly.

STELLA POLARIS (S. Callow) - jumped away awkwardly, shifted out and contacted VENDETTA. Hung out from near the 600 metres. Trainer J. Cannon was advised a warning had been placed on the filly in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

## RACE 2: TAB RATING 0 - 58 HANDICAP - 1100 Metres

HEZ WEST (J Doyle) - a post-race veterinary examination revealed no visible abnormalities.

FESTIVAL OF LIGHT (M. Collett) - slow to begin. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

RUSTYDUSTYSUNSHINE (N. Yuen) - laid in under pressure in the straight.



### RACE 3: THE COUNTRY RACING SA COLTS GELDINGS & ENTIRES MAIDEN PLATE

- 1100 Metres

The start of this event was delayed approximately one minute.

SERBIAN PRINCE (D. Caboche) - contacted on jumping away. Over-raced in the middle stages of the event. Hung in under pressure in the straight and for this reason proved difficult to ride out over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

APACHE KISS (A. Lindsay) - jumped away awkwardly and was slow to begin, shifted out and contacted SERBIAN PRINCE.

FIELD HUNTER (C. Atkinson) - held up from near the 200 metres until approaching the 100 metres.

INOTELL (L. Overall) - jumped away awkwardly.

SHALWESEE (N. Yuen) - underwent a pre-race veterinary examination after becoming fractious in the barriers and was passed fit to race. Near the 1000 metres bumped with OUT INCOGNITO, which was taken wider. Near the 100 metres rider accidentally dropped her whip. Rider explained when question in relation to the performance that the gelding was on the wrong leg and laid out rounding the home turn, and when placed under pressure was disappointing to the finish. Co-Trainer, Mr Jolly was advised a warning had been placed on the gelding in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

OUT INCOGNITO (S. Callow) - raced keenly in the early and middle stages of the event. Near the 1000 metres bumped with SHALWESHEE and as a result was taken wider. A post-race veterinary examination revealed no visible abnormalities.

### RACE 4: JIM BARRY WINES MAIDEN HANDICAP - 1800 Metres

TABLE OF DREAMS (C. Atkinson) - near the 1600 metre shifted in when insufficiently clear of KID KINGDOM tightening the running of that gelding and as a result KID KINGDOM had to be checked. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 18 April 2022 and to conclude at midnight on Monday, 25 April 2022: a period of three meetings. Held up from the vicinity of the 200 metres until approaching the 150 metres. Near the 100 became awkwardly placed on the heels of TOUCH MY HEART until approaching the finish.

KID KINGDOM (A. Lindsay) - jumped away awkwardly, shifted out contacting GREY FOLLY. Near the 1600 metres had to be checked when tightened by TABLE OF DREAMS which shifted in when insufficiently clear. Approaching the 1100 metres was hampered when awkwardly placed on the heels of PARVANI for a short distance and had to be restrained as a result.

MAKE IT A DOUBLE (D. Caboche) - near the 1600 metres was hampered when taken out by GRINZINGER QUEEN onto SING KEN KEN.

PORTO RAFTI (L. Overall) - over-raced in the early and middle stages of the event and near the 1600 metres got its head up for a number of strides.

ANDAI STEPPES (NZ) (C. Murray) - raced wide without cover in the early and middle stages of the event.

MAURICE ROAD (M. Collett) - near the 1600 metres shifted out onto GRINZINGER QUEEN which was taken wider.

GRINZINGER QUEEN (S. Metcalfe) - near the 1600 metres was taken wider by MAURICE ROAD onto MAKE IT A DOUBLE. Near the 300 metres became disappointed for a run between ANDAI STEPPES (NZ) and MAKE IT A DOUBLE, which laid out.

PARVANI (N. Yuen) - Approaching 1100 metres improved onto the heels of TOUCH MY HEART and was restrained in doing so hampered KID KINGDOM, which became awkwardly placed on the heels of MISS ELEGANCE for a number of strides. An inquiry into an incident near the 50 metres will be opened involving TOUCH MY HEART to allow N. Yuen to be present at a later date.



RACE 4: JIM BARRY WINES MAIDEN HANDICAP - 1800 Metres (Cont'd)

SPIRITED MARY - declared a late scratching by order of Stewards at 8.27 am due to no rider being available.

GREY FOLLY (J. Doyle) - jumped away awkwardly and was slow to begin. Shortly thereafter was hampered when tightened between KID KINGDOM and SING KEN KEN, which both shifted ground.

SING KEN KEN (P. Crich) - jumped away awkwardly shifted in onto GREY FOLLY. Near the 1600 metres had to be checked off the heels of MAKE IT A DOUBLE.

TOUCH MY HEART (S. Callow) - near the 50 metres had to be checked when PARVANI shifted in. An inquiry into this incident will be opened to allow N. Yuen to be present at a later date.

RACE 5: BIG SCREEN VIDEO 0 - 58 HANDICAP - 1800 Metres

HARRY HOT PANTS (S. Metcalfe) - near the 300 metres had to be steadied for a number of strides to avoid the riderless horse MISS ELEGANCE.

I'M KENNY (L. Overall) - over-raced in the middle stages of the event. An inquiry into an incident near the 1400 involving MISS ELEGANCE will be opened at a later date to allow N. Yuen to be present. An inquiry into an incident near the 800 metres involving MISS ELEGANCE will be opened at a later date to allow N. Yuen to be present.

MISS ELEGANCE (N. Yuen) - near the 1400 metres was obliged to take hold when I'M KENNY shifted in. An inquiry into this incident will be opened a later date to allow N. Yuen to be present. Near the 800 metres I'M KENNY appeared to contact with MISS ELEGANCE resulting in the mare becoming unbalanced and the rider being dislodged. An inquiry into this incident will be opened at a later date to allow N. Yuen to be present. N. Yuen was attended to by the First Care Medical personnel and was transported to hospital for further assessment and observation. A post-race veterinary examination revealed no visible abnormalities.

SWANKYTOFF (C. Murray) - near the 800 metres was hampered and obliged to take hold in an attempt to avoid the dislodged rider, losing several lengths. A post-race veterinary examination revealed no visible abnormalities.

KOBE PRINCESS - a late scratching on vets at 8.52 am acting on confirmed advice from Trainer Mr D. O'Leary that the mare had a subcutaneous swelling to the off side neck. Trainer Mr O'Leary was advised that a veterinary certificate of fitness would be required prior to future trial or race. Stewards took evidence from Mr O'Leary and club veterinary officer Dr. D. Anderson. An inquiry was adjourned in relation to the matter.

FRIDAY FUNDAY (A. Lindsay) - over-raced in the early and middle stages of the event.

LITTLEBITFUNNY (D. Caboche) - Stewards permitted the gelding to race without pacifiers in today's event.

Due to the delay in relation to the ambulance transporting N. Yuen to hospital following the running of Race 5, the race times for the remainder of the meeting were amended as follows:

Race 6: 4:30pm

Race 7: 5:00pm


RACE 6: 5CS AND MAGIC FM RATING 0 - 62 HANDICAP - 1200 Metres

The start of this event was delayed approximately 10 minutes.

NOTICE ME (L. Overall) - near the 800 metres rolled in inconveniencing IMPULSE DIAVOLO. Laid in under pressure in the straight.

OLIVE GROVE (A. Lindsay) - jumped away awkwardly. Laid in under pressure in the straight.





RACE 6: 5CS AND MAGIC FM RATING 0 - 62 HANDICAP - 1200 Metres (Cont'd)

COMMANDO MISS (S. Metcalfe) - near the 300 metres became awkwardly placed on the heels of LADY BERLINETTA for a short distance.

IMPULSE DIAVOLO (C. Murray) - near the 800 metres was inconvenienced when NOTICE ME rolled in.

DUSTIN DHAHRAN (S. Callow) - underwent a pre-race veterinary examination after becoming fractious in the barriers and was passed fit to race. Raced keenly in the early and middle stages of the event. Near the 300 metres shifted out when insufficiently clear of LADY BERLINETTA, which had to be checked and as a result, COMMANDO MISS was hampered when awkwardly placed on the heels of LADY BERLINETTA. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 25 April 2022 and to conclude at midnight on Sunday, 1 May 2022: a period of three meetings. Trainer Mr G. Lynch was advised a warning had been placed on the mare in relation to its barrier manners.

CASINO ANGEL (J. Doyle) - hung out under pressure in the straight.

LADY BERLINETTA (M. Collett) - near the 300 metres had to be checked when DUSTIN DHAHRAN shifted out when insufficiently clear.

RACE 7: SC HEINRICH AND CO BENCHMARK 52 HANDICAP - 1200 Metres

The start of this event was delayed approximately 5 minutes.

DAZZLING HARMONY (S. Callow) - jumped away awkwardly, shifted out and contacted GRAVITY. Laid in under pressure in the straight.

ICE HUNT (D. Caboche) - near the 300 metres became disappointed for a run between GRAVITY and INDAIN MO as a result had to be restrained and shifted in to obtain clear ground.

AFTER YOU (M. Collett) - jumped away awkwardly, shifted in and contacted NIKE BELLE. Near the 200 metres had to be steadied when GRAVITY shifted out when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

NIKE BELLE (C. Atkinson) - contacted on jumping away.

INDIAN MO (L. Overall) - on jumping away got its head up whilst being restrained for a short distance. Inside the 200m shifted in before being corrected by its rider.

GRAVITY (S. Metcalfe) - near the 200 metres shifted out when insufficiently clear of AFTER YOU, which had to be steadied. Rider was reprimanded under AR131(a) and advised to take greater care and to ensure she was sufficiently clear when attempting to shift ground in future.
